REGISTRATION CONDITIONS

Purpose:

The purpose of this registration is to establish the inventory of breeding cattle with the intent of aiding in the implementation of the Cull Animal Program.

Animals to be Registered

- Breeding bulls and cows over 30 months of age or cows that have had at least one calf,
- Sheep ewes and rams over 12 months of age or ewes that have had a lamb,
- Animals must have been owned by the registrant on September 1, 2003.

Eligible Registrants

- This registration is open only to residents of Newfoundland and Labrador.
- Registrants must have held title to Eligible Animals on September 1, 2003.

Registrations:

- The registration form must be completed by the owner(s) of the breeding herd.
- Only one submission of the Livestock Registration Form will be accepted.
- Registration forms must be submitted to the Department of Forest Resources and Agrifoods and postmarked no later than January 31, 2004.
