AUDITORS' REPORT

Pursuant to the Elections Act of Saskatchewan

Mr. Luke Schmidt Chief Official Agent for the Progressive Conservative Party of Saskatchewan

We have audited the fiscal return of the Progressive Conservative Party of Saskatchewan for the year ended December 31, 2006. This return is the responsibility of the party's management. Our responsibility is to express an opinion on the return based on our audit.

Except as explained in the following paragraph, we conducted our audit in accordance with generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the return is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the return. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall return presentation.

In common with other registered political parties, the party derives revenue from donations, contributions and fund raising projects, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, our verification of these revenues was limited to the amounts recorded in the records of the party and we were not able to determine whether any adjustments might be necessary to these revenues.

In our opinion, except for the effect of adjustments, if any, which we might have determined to be necessary had we been able to satisfy ourselves concerning the completeness of the revenues referred to in the preceding paragraph, the return of the Progressive Conservative Party of Saskatchewan presents fairly, in all material respects, the financial transactions required by Section 210 to be detailed in the Party's return, for the year ended December 31, 2006, in accordance with Section 210 requirements
