We have audited the Registered Political Party's fiscal period return for the year ended December 31, 2006. This financial information is your responsibility as official agent for the party. Our responsibility is to express an opinion on this financial information based on our audit.

We conducted our audit in accordance with generally accepted auditing standards. Generally accepted auditing standards require that we plan and perform an audit to obtain reasonable assurance whether the financial information is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial information. An audit also includes assessing the accounting principles used and significant estimates made by the official agent of the party, as well as evaluating the overall presentation of the financial information.

Due to the inherent nature of the transactions of political parties, the completeness of contributions and other revenue and expenses is not susceptible to satisfactory audit verification. Accordingly, our verification of these amounts was limited to the amounts recorded in the party's accounting records.

In our opinion, the Registered Political Party's fiscal period return of the Saskatchewan Marijuana Party presents fairly, in all material respects, the information contained in the financial records on which it is based.
