AUDITORS' REPORT

The Saskatchewan Party Fund Inc. Chief Official Agent for The Saskatchewan Party

We have audited the fiscal period return for **THE SASKATCHEWAN PARTY** for the year ended December 31, 2006. This return is the responsibility of the Party's Chief Official Agent. Our responsibility is to express an opinion based on our audit.

Except as explained in the following paragraph, we conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the return is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the return. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall return presentation.

Due to the nature of the types of transactions inherent in an organization of this type, it is impracticable through auditing procedures to determine that the accounting records include all transactions for the fiscal period. Accordingly, our verification of these transactions was limited to the amounts recorded in the accounting records of the registered political party and we were not able to determine whether any adjustments might be necessary to those transactions.

In our opinion, except for the effects of adjustments, if any, which we might have determined to be necessary had we been able to satisfy ourselves concerning the completeness of the transactions referred to in the preceding paragraph, the return of The Saskatchewan party present fairly, in all material respects, the financial transactions of the Party required by Section 250 of the Election Act, 1996 to be detailed in the Party's return, for the year ended December 31, 2006.
