#### **AUDITOR'S REPORT**

To the Chief Official Agent of the Western Independence Party of Saskatchewan

I have audited the fiscal period return of the Western Independence Party of Saskatchewan for the year ended December 31, 2006. This return is the responsibility of the chief official agent. My responsibility is to express an opinion on the return based on my audit.

Except as explained in the following paragraph, I conducted my audit in accordance with generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the return is free of material misstatement. Auditing also includes assessing the accounting principles used and significant estimates made by the chief official agent, as well as evaluating the overall return presentation.

Because of insufficient records of members and contributions, I was unable to determine the completeness of the income and cash. Accordingly, I was not able to determine whether any adjustment might be necessary to income and cash accounts.

In my opinion, except for the effect of adjustments, if any, which I might have determined to be necessary had I been able to satisfy myself with respect to the balance of the income and cash accounts described in the preceding paragraph, the return presents fairly, in all material respects, the financial transactions of the Western Independence Party of Saskatchewan for the year ended December 31, 2006, in accordance with section 250 of The Election Act, 1996.
