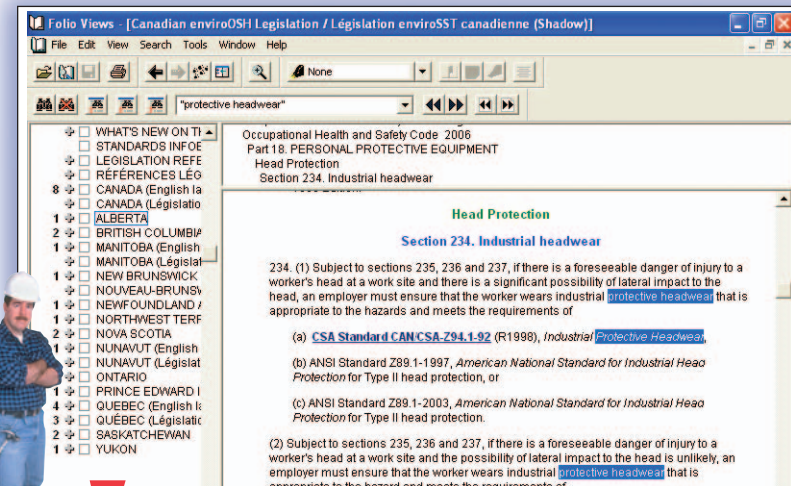


CCOHS – a trusted source
