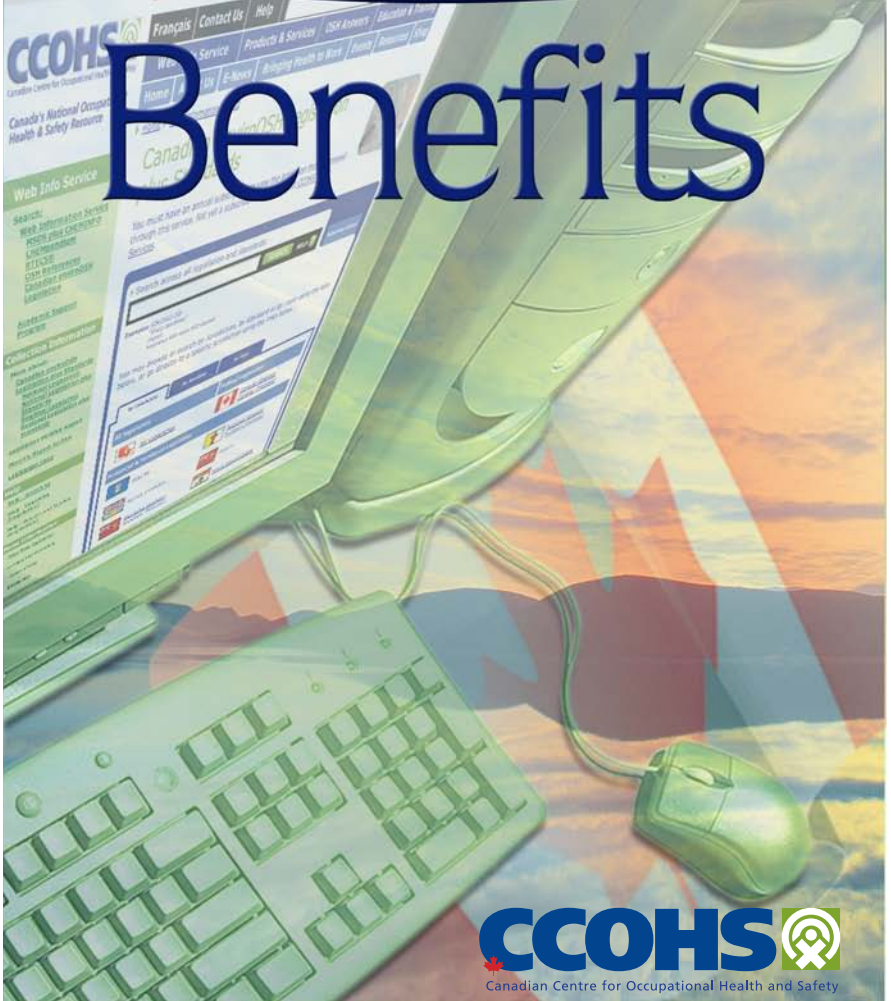

Acts, regulations and amendments may be widely available on the Internet, but that's where compliance begins, not ends. Here are **17 reasons to sign up** for CCOHS's Canadian enviroOSH Legislation.

## We give you your time back

1. **Find out what's new when it happens** – no more multi-site searching for new acts and regulations. Canadian enviroOSH Legislation's monthly update service consolidates all new announcements so that you don't have to.
2. **Keep on top of changes.** We monitor proposed amendments by checking bills of the various legislatures. The monthly update service uses highlighted text to identify changes in bill status and provides links to government websites containing copies of the bills.

We then make the proclaimed sections available, in full text, through the Canadian enviroOSH Legislation service.

6. **Find what you're looking for.** A bill title is often a poor indicator of any act(s) it amends. Our update service lists all relevant acts for each bill.
7. **Get the bottom line.** Canadian enviroOSH Legislation's update service identifies amended legislation, summarizes the amendments' significance, provides links to the full text legislation, and uses highlighted text to identify the changes.
