## NAC launches Theatre Renewal Campaign

We have blasted off! On January 23, the National Arts Centre Foundation launched a three-year, \$3-million Theatre Renewal Campaign. In support of this campaign, donors are invited to "take a seat" and have their name or that of a loved one placed on a seat in the Theatre for ten years or more. It's a unique opportunity for NAC donors and patrons to support creativity and innovation in Dance, English Theatre and French Theatre while leaving behind recognition of their generous gift.

Funds raised will support physical renovations to the Theatre and will also invest in the artistic disciplines that use the space. Over the summer, our Theatre will be renovated to include new seats, increased legroom and new carpeting as well as improved sightlines. The National Arts Centre will direct \$1 million of its capital reserve for this project. Samples of the new seats have been on display outside the Annual Fund Office since February. We encourage you to drop by, try out the seats and learn more about the campaign.


This campaign will also invest \$2 million in the artistic disciplines

that use the Theatre: Dance, English Theatre and French Theatre. When you support this campaign you can direct your donation toward one or all of the following funds: the *New Works Fund*, the *Performance Fund* or the *Behind the Scenes Fund*.

 The New Works Fund will assist with new play development ~ from commissioning playwrights to hosting festivals like On the Verge. The fund will assist with the commissioning of new dance works, investing in talented Canadian choreographers and dancers.

- The *Performance Fund* will allow the NAC to continue to attract world-class Canadian and international dance performances as well as continue to attract the finest performers to our stage.
- The *Behind the Scenes Fund* will allow us to devote more resources to set design, wardrobe, prop development, and apprenticeship training.

To "take a seat" in this campaign, you can make a one-time donation of \$3,000 (or \$3,600 pledged over three years). We encourage you to support this campaign and to assist artistic development and innovation at the National Arts Centre.





## Atlantic Celebration

Between April 22 and May 4, 2003, more than 400 of the best established and emerging artists from the East Coast will head to the nation's capital for the Atlantic Scene – the first in a series of biennial regional festivals by the National Arts Centre, showcasing the best in Canadian arts and culture from coast to coast.

These artists will appear in 15 venues in Ottawa-Gatineau (including the NAC), performing a wide range of musical genres such as classical, pop, jazz, blues, folk, Celtic, Acadian and more. Atlantic Scene will also feature French and English theatre, stand-up comedy, dance, and a look at Atlantic Canadian film. A visual arts exhibit, literary readings and culinary delicacies from the East Coast will also be part of this great showcase.

Some programming highlights include: The East Side Comedy featuring Canada's Showcase comedy genius Rick Mercer, and the hilarious Ron James and others; hip hop/rock artist Buck 65; Alan Dovle of Great Big Sea; NACO Celtic Pops performing with Natalie MacMaster and Men of the Deeps; noon hour recitals of classical music; a concert featuring renowned soprano Measha Bruggergosman; a number of Acadian performances for francophone audiences; and the Confederation Centre for the Arts acclaimed production of Anne of Green Gables.

It's easy to see how Atlantic Scene will transform Ottawa-Gatineau into a window on East Coast culture, history, values, and traditions.

So come and join the party in the Nation's Capital this spring and make the Atlantic Scene your scene.


### **Donor Profile**



# Gifts of **RRSP or RRIF**

**Question:** Is it possible to designate the NAC Foundation as beneficiary of my RRSP or RRIF?

Answer: Absolutely. New changes to the *Income Tax Act* make it easier for a donor to contribute RRSPs and RRIFs to charities after death. A charitable donation tax receipt may be claimed on the deceased person's return for the direct donation of the proceeds of an RRSP or an RRIF to a charity, such as the National Arts Centre Foundation. All you need to do is make the NAC Foundation the designated beneficiary of the RRSP or RRIF.

When you designate the NAC Foundation to be the beneficiary of either your insurance proceeds or your RRSP/RRIF, you also ensure that the insurance/RRSP/RRIF proceeds are not subject to probate tax.

## Gift planning has its rewards

While some of us don't have to think twice about making a gift in support of our favourite charity; for others, it requires more consideration. In either case, slowing down the process gives you options that could result in what might be your personal gift of a lifetime.

Through the thoughtful practice of "planned giving", you can make an extraordinary difference in the future of the National Arts Centre Foundation. The majority of planned gifts are deferred – the most popular and simplest of which are bequests. You can choose to give a specific dollar amount, a portion of the balance of your estate (after loved ones are taken care of), or even a piece of property or art. Your bequest commitment can be directed to support a particular area of interest. Perhaps you are passionate

about ensuring our youth continue to have access to performing arts opportunities in the future. Maybe you're most concerned about sustaining the next crop of playwrights or composers. Whatever you choose, NAC Foundation staff is ready to work with you to help you plan out your specific philanthropic goals. And like any charitable donation, a bequest is tax-deductible, a very important advantage when you consider the somewhat hefty tax implications of passing on your estate to family and loved ones.
