#### INTRODUCTION

The PMRA New Registration Activities report is a summary of registration decisions concerning new active ingredients, their associated end-use products, new uses for currently registered active ingredients, and emergency registrations made by the Pest Management Regulatory (PMRA) of Health Canada during the current fiscal year. This was initiated in 2006 to meet the goals of a more open and transparent pesticide regulatory system, and will be updated on a quarterly basis.

The *PMRA New Registration Activities* is published in a table format that summarizes each registration decision, including, the pesticide product's name and registration number under the *Pest Control Products Act*, registrant, pesticide type (e.g., insecticide), the specific site or host (where and on what the pesticide can be applied), and the date on which the certificate of registration was issued. The tables also identify both the major and minor crop uses registered and include a listing of emergency registrations with the organization that applied for it.
