

# NCB Progress Report, 1999

## Supplementary Statistical Information

### Introduction

All of the material presented here, except for Table 11, was obtained from special tabulations of the Statistics Canada annual Survey of Consumer Finances (SCF). The SCF is a supplement to the April Labour Force Survey (LFS) and covers two-thirds of the full LFS sample, or about 30,000 households. The LFS covers all households living in Canada except those living on Indian Reserves, those in the Yukon and Northwest Territories, the institutionalized population and full-time members of the Canadian Forces. For the SCF, each member of the household aged 15 or older is asked to complete a detailed income questionnaire which lists 25 different sources of income. Each indicates the total income received from each source during the previous calendar year.

To determine low-income status, the total incomes for each member of the economic family are added together. An economic family consists of those members of a household who are related to each other by blood, marriage or adoption. A household member who is not a member of an economic family is considered to be an 'unattached individual'.

Unless otherwise noted, the following tables are based only on those economic families with at least one child under 18 years of age.

After-tax data are not available until the summer of 1999. Consequently 'n/a' appears for the 1997 LIM data.

Thus, changes in income relative to the LIMs describe shifts in the income distribution and not in inflation – adjusted (real) incomes.
