BUSINESS

Routine Matters

- 1. Dr. Naimark welcomed members and outlined two important objectives for the meeting, namely examining CBAC's modus operandi to increase its effectiveness and developing a workplan, with an emphasis on the Biotechnology in Health Innovation (BHI) project.
- 2. He drew the Committee's attention to the resignations of Doug Kilburn, Laura Shanner, and Lorne Babiuk and to the decision by René Simard not to stand for reappointment.
- 3. Dr. Naimark updated the membership on his recent meeting with Nabila Gillett from Treasury Board regarding the cyclical review of the Canadian Biotechnology Strategy.
- 4. The minutes of the April and June 2003 meetings were approved.

Retreat Portion of the Meeting

5. Dr. Naimark identified the overarching goal of the retreat as an exploration of how CBAC can best discharge its mandate. To that effect, he requested that Kim

Elmslie facilitate a session that explored four key points: taking stock; expectations of membership; ways of working; and success factors.

Workplanning Session

6. Kimberly Elmslie presented a summary report of the CBAC budget that shows a free balance of \$145K for the remainder of the fiscal year. Following an overview of projects under consideration, the Committee decided to build on three current projects in the area of privacy and genetic information; the incorporation of social and ethical issues into public policy; and follow-up to the GM food report. In addition, members decided to undertake projects submitted by Industry Canada and Health Canada, including the *Maximizing Value in Health Biotechnology Research* project (Industry Canada); the *Health Canada Biotechnology Framework* project; and the *Federal Government Stewardship Framework* (Health Canada) project. Three proposals submitted by CBAC members were also considered, namely an annual meeting of federal advisory bodies; the biotechnology, sustainable development and the biological economy project; and the advanced technology, brain and behaviour project.

Report on the Biotechnology and Health Innovation Project

7. The Committee's discussion revolved around four points: comments on the Phase I document; a review of the framework; agreement on priorities; and the identification of next steps. It is anticipated that the final report will be available by March 31, 2004.
