INTRODUCTION

The Canadian Centre for Justice Statistics is the focal point of a federal-provincial initiative dedicated to national statistics and information on the justice system in Canada. Established in 1981, the Centre is responsible for producing information on the extent and nature of crime and the administration of justice in Canada. This information is intended to serve governments in the development, operation and evaluation of justice policies and programs, as well as to broaden public understanding of how the justice system operates and of its cost.

This is the seventh National Directory of Courts in Canada. It includes a list of federal and provincial courts across the country. The purpose of this Directory is to identify all courts (permanent and most frequently visited circuit points) in Canada by type, level, and location. The information contained here was obtained from the Departments of Justice and Attorneys' General, the Supreme Court of Canada, the Federal Court of Canada, and the Tax Court of Canada.

A note of caution to users of this Directory: this Directory is updated as of August, 2000; with the passage of time, the structure and location of courts may change, resulting in the information becoming dated. It is accordingly updated every three years.

This Directory has been compiled through efforts and contributions of a large number of justice agencies and people. To them this edition is gratefully dedicated.
