



## Real Time Identification

### Overview

RTID is a National Police Services (NPS) Project under the stewardship of the RCMP designed to improve the efficiency of Canada's national fingerprint and criminal record repository. It will replace outdated paper processes and legacy systems with re-engineered workflows and automation. RTID will use modern technology to meet business demands and support interoperability with all clients. Fingerprint identification and criminal record services are provided by NPS Canadian Criminal Real Time Identification Services (CCRTIS) to the Canadian law enforcement, criminal justice and public security communities, as well as, international partners, such as the Federal Bureau of Investigation and Interpol.

### *RTID will:*

- Supply a new Automated Fingerprint Identification System (AFIS) and associated infrastructure to support rapid fingerprint identification and allow the immediate update of the associated criminal record
- Enable seamless, paperless, electronic submission of fingerprints and criminal record data via the NPS Network (NPSNet) to CCRTIS.
- Provide clients with specifications for a standard for electronic submissions to ensure that they can format data to be compatible with the NPS National Institute of Standards and Technology (NIST) Server.
- The standard selected is the NPS National Institute of Standards and Technology Interface Control Document (NIST-ICD) Version 1.7.7.
- Support the electronic submission of disposition information from law enforcement agencies ensuring an accurate and up-to-date criminal record.
- Replace independent legacy systems with an integrated solution.
- Define and implement a workflow management solution to improve the efficiency of processing criminal record verifications.

### Milestones

Major project milestones include:

- ✓ Fall 2006 NPS-NIST Server Release 0.5 operational
- Winter 2007 New AFIS in production

### Quick Facts

- In 1968, National Police Services installed the first AFIS in the world

### Objectives

Once fully implemented, the service time estimates for RTID are:

Service	RTID Target Processing Time
Criminal ten print searches	2 hours
Criminal record updates	24 hours
Civil ten print searches	72 hours
Latent crime scene searches	24 hours

The improved efficiency of RTID will contribute to the ability of our clients to do their job and enable CCRTIS to process an increased number of service requests including:

- Electronic fingerprint submissions
  - Ten print
  - Latent
- Acceptance of ID flats (ten plain impressions) for civil submissions
- Electronic palm print submissions
- Latent identifications
- Electronic criminal record submissions
  - Charge and disposition
  - Electronic disposition reporting
