- All details of the application will be treated as CONFIDENTIAL.
- All applicable sections must be filled out. Incomplete application forms will not be accepted. Additional information or documents may be requested from the applicant in order to process the application.
- The applicant must sign the application form. For export, applicant must be a resident of Canada or a representative of a company with an office in Canada AND must be knowledgeable of the contents of the shipment.
- There is a six (6) to eight (8) week processing period for all applications.
- If the application is approved, the permit and instructions will be sent by mail to the applicant.
- If you would like your permit sent by courier, provide a pre-paid envelope and your business account number or VISA or MasterCard number to pay courier charges. Permit will be sent to the address provided in Section 3A, unless otherwise specified by the applicant.
- Import and export of animals and their parts and derivatives is also controlled by the Health of Animals Act implemented by the Canadian Food Inspection Agency (CFIA). CFIA can be contacted toll free at: 1 877 493-0468 (Canada East); 1 800 835-4486 (Canada Central); 1 888 732-6222 (Canada West).
