Please note that the Office will take the overall cost of the review into consideration.

The completed form must be submitted with a resume/CV that includes the following information:

- Education (professional qualifications, academic degrees, discipline, institutional name, city and province, year completed).
  - Employment history (employer name, city, province, position, dates held, major job responsibilities and/or accomplishments).
  - Social Security actuarial-related professional participation (presentations, publications, committee service, etc.).
  - Relevant pension, investment and risk management experience.
  - Estimate of the hourly rate that will be charged as well as the anticipated number of hours based on the current Terms of Reference and previous Actuarial Reviews of the 17<sup>th</sup>, 18<sup>th</sup> and 21<sup>st</sup> CPP Actuarial Reports.
