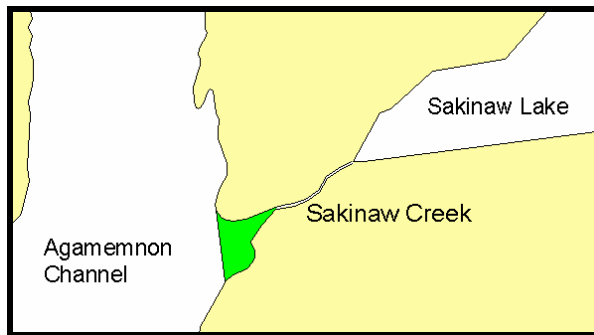
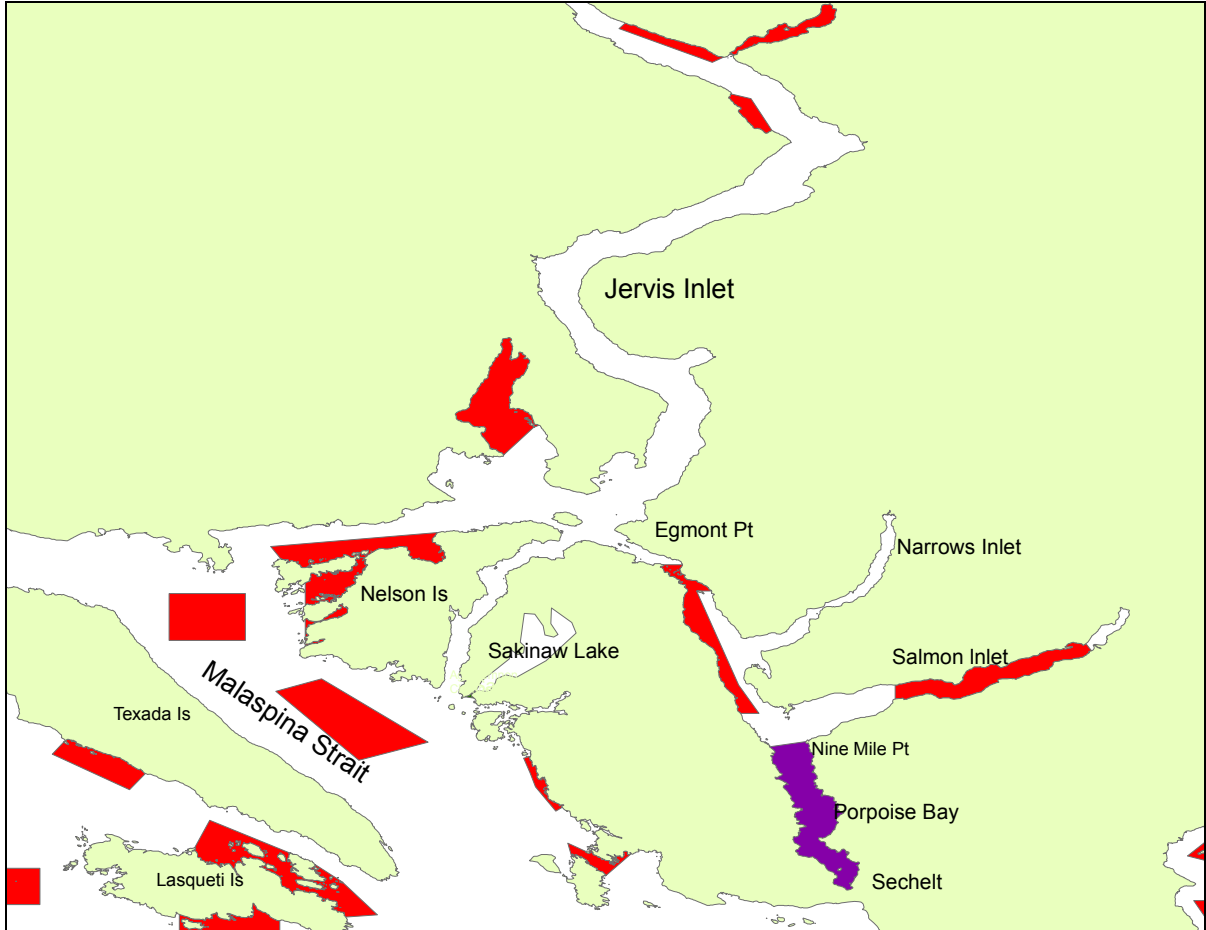

NOTES

The combined aggregate daily limit for Pacific Salmon is four (4) per day.

The possession limit is twice the daily limit.

When fishing for salmon, Fishers are required to use barbless hooks.

Sockeye Closed, opportunities to be announced.

DEFINITIONS

“**Hatchery marked or marked**” means a fish that has a healed scar in place of the adipose, pelvic, or pectoral fin, or in place of a maxillary.

CHINOOK

| January 1 to December 31 | The daily limit for Chinook is two (2) with a minimum size limit of 62 cm: In all areas unless stated otherwise. |
| June 27 to December 31 | The minimum size limit for Chinook in the waters of Sechelt Inlet (Porpoise Bay), south of a line from Nine Mile Point to a boundary sign on the opposite shore is 41 cm. |
| July 1, 2007 to March 31, 2008 | The daily limit of Chapman Creek is four (4) chinook per day, of which two (2) may be greater than 50cm: Chapman Creek upstream of tidal boundary signs located at the Hwy 101 bridge. |

COHO

|--------------------------------|--|
| June 1 through December 31 | The daily limit for coho is two (2) per day, both of which must be hatchery marked: In all areas unless stated otherwise. |
| June 1 through December 31 | The daily limit is four (4) hatchery marked coho per day: In the following area of Sechelt Inlet and Porpoise Bay, southerly of a line from Nine Mile Point to a boundary sign on the opposite shore. |
| July 1, 2007 to March 31, 2008 | The daily limit of Chapman Creek is four (4) hatchery marked coho per day, of which two (2) may be greater than 35cm: Chapman Creek upstream of tidal boundary signs located at the Hwy 101 bridge. |

FINFISH CLOSURES

| June 15 to September 15 | The following waters will be closed to fishing for all finfish: In Area 16, the waters at the mouth of Sakinaw Creek, east of a line between boundary signs on the north and south sides of Sakinaw Bay. |
| November 1 to December 31 | The following waters will be closed to fishing in Sakinaw Lake for all finfish: east of a line from a boundary sign north of the Sakinaw boat launch, southwesterly to a boundary sign at 49 11.50N and 123 58.45W (this encompasses the bay at Haskins Creek and the unnamed bay southwest of the boat launch); and the body of water known as Bear Bay, east of 124 02.13W (marked by boundary signs). Refer to the Freshwater Regulations. |

ROCKFISH CONSERVATION AREAS

Closed to fishing for all finfish: Area 16 has 14 Rockfish Conservation Areas (see the red shaded area of the above map). These areas are closed to all finfishing. For more information regarding Rockfish Conservation Areas in the Pacific Region go to the website:
