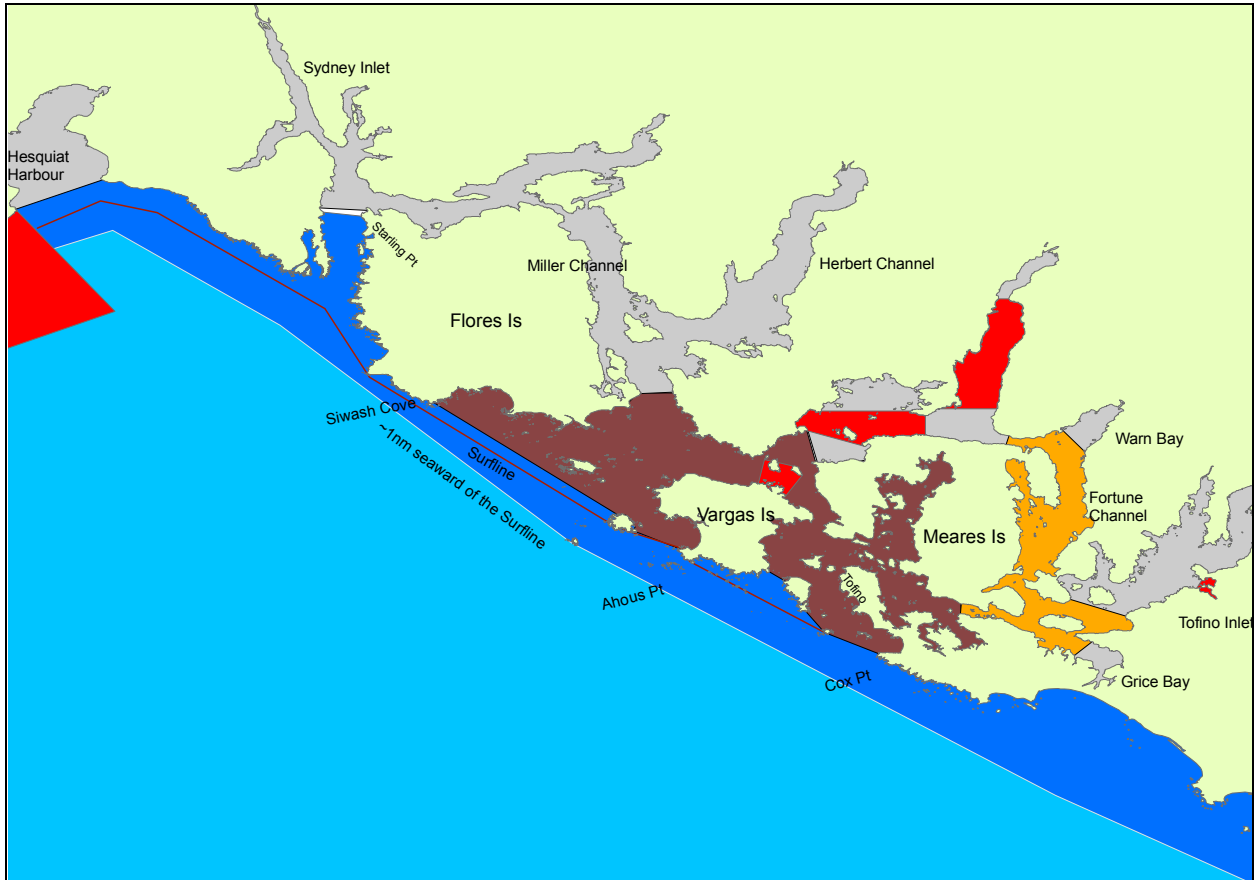

AREA 24/124 CLAYOQUOT AND OFFSHORE AREAS

2007 OPENINGS AND CLOSURES - CHINOOK



	Jan 01 - Dec 31	Rockfish Conservation Closure – Fin Fish Closure Kennedy Cove Fin Fish Closure
	Jan 01 - Dec 31	Two (2) Chinook per day, minimum size 45cm.
	Aug 01 - Oct 15	Two (2) Chinook per day, only one (1) may be larger than 77cm.
	Aug 01 - Oct 31	Two (2) Chinook per day, maximum size limit of 77 cm in those waters.
	Aug01 - Dec 31	Salmon Non-retention Areas
	Aug01 - Dec 31	Chinook Non-retention Areas

NOTES

The combined aggregate daily limit for Pacific Salmon is four (4) per day.

The possession limit is twice the daily limit.

When fishing for salmon, Anglers are required to use barbless hooks.

DEFINITIONS


“**Hatchery marked or marked**” means a fish that has a healed scar in place of the adipose, pelvic, or pectoral fin, or in place of a maxillary.


AREA 124 - OFFSHORE

Effective January 01 through December 31 for that portion of Area 124 that lies seaward of a line approximately one (1) nautical mile seaward of the surfline the daily limit remains at **two (2) chinook**, with a minimum size limit of 45 cm for those waters. *(indicated on the map as the light blue area)* 

Effective August 01 through October 15 in those waters of Area 124 that lie shoreward of a line drawn approximately one (1) nautical mile seaward of the surfline, the daily limit is **two (2) chinook, only one (1) of which may be greater than 77 cm**. *(indicated on the map as the dark blue area outside or seaward of the surfline)* 

AREA 24

Effective August 01 to October 15 the daily limit is two (2) chinook of which only one may be over 77 cm in those waters : that lie seaward of a line from Cox Point to Lennard Island Light, thence to the southeastern tip of Echachis Island, then to the southern tip of Wickaninnish Island, thence from the northwestern tip of Wickaninnish Island to Moser Point on Vargas Island, thence from the northwest tip of Ahous Point on Vargas Island, to the southwest tip of Blunden Island, thence from the northwest tip of Blunden Island, to Siwash Cove on Flores Island. *(indicated on the map as the dark blue area inside or shoreward of the surfline);* 

Effective August 01 until October 31, 2007 the daily limit is two (2) chinook salmon, with a maximum size limit of 77 cm in those waters: that lie shoreward of a line from Cox Point to Lennard Island Light, thence to the southeastern tip of Echachis Island, then to the southern tip of Wickaninnish Island, thence from the northwestern tip of Wickaninnish Island to Moser Point on Vargas Island, thence from the northwest tip of Ahous Point on Vargas Island, to the southwest tip of Blunden Island, thence from the northwest tip of Blunden Island, to Siwash Cove on Flores Island. *(indicated on the map as the brown area).* 

CHINOOK SALMON NON RETENTION AREAS

Effective August 1 until December 31 Chinook salmon non retention will be implemented in the following portion of Area 24:

- those waters inside a line from boundary markers at the western entrance to Matlset Narrows to boundary signs on both shores of Browning Passage approximately 0.7 miles west of Tsapee Narrows the daily limit for chinook salmon is zero (0).

ALL SALMON NON RETENTION AREAS

Effective August 01 until December 31 there will be no retention of any salmon in the following waters:

- **Sydney Inlet, Shelter Inlet, Miller Channel** and **Herbert Inlet** inside or northerly of a line from Starling Point on Flores Island true west to a boundary sign on Vancouver Island; and from Yates Point on Flores Island true east to a boundary sign on Vancouver Island;
- **Hesquiat Harbour** inside a line from Hesquiat Point southerly to Matlahaw Point;
- **Bedwell Sound**, inside a line from Robert Point to Kraan Head and bounded on the east by a line between boundary signs at the western entrance to Matiset Narrows;
- **Warn Bay** inside a line between boundary signs at the entrance to the Warn Bay;
- **Grice Bay** inside a line between boundary signs approximately half way inside Grice Bay to the head of Grice Bay;
- **Tofino Inlet** inside a line between boundary signs near the entrance of Tofino Inlet located just south of Warne Island;

(indicated on the map as the grey area). 


FINFISH CLOSURES

Effective January 01 to December 31 the following waters will be closed to fishing for all finfish:

- Those waters of Kennedy Cove inside or northwesterly of a line between two fishing boundary signs on the outer southwest corner and the outer northeast corner of the cove.

Rock Fish Conservation Areas:

Closed to fishing for all finfish: Area 24 has four (4) Rockfish Conservation Areas. These areas are closed to all finfishing.

(indicated on the map as the red area).
