

# FISHERY NOTICE AREA 26/126 KYUQUOT SOUND 2007 OPENINGS AND CLOSURES



	July 15 - Oct 15	Two (2) Chinook per day, only one (1) may be greater than 77 cm in length.
	June 01 – Aug 31	Two (2) Coho hatchery marked per day
	Sept 01 – Dec 31	Four (4) Coho hatchery marked per day
	Jan 01 - Dec 31	Two (2) Chinook per day, minimum size of 45 cm
	June 01 – Aug 31	Two (2) Coho hatchery marked per day
	Sept 01 – Dec 31	Four (4) Coho hatchery marked per day
	Jan 01 - Dec 31	Fin Fish Closure
	July 15 - Oct 15	Salmon Non-retention Areas

#### **NOTES**

The combined aggregate daily limit for Pacific Salmon is four (4) per day.

The possession limit is twice the daily limit.

When fishing for salmon, fishers are required to use barbless hooks.

# **FISHERY NOTICE** AREA 26/126 KYUQUOT SOUND 2007 OPENINGS AND CLOSURES

### DEFINITIONS

"Hatchery marked or marked" means a fish that has a healed scar in place of the adipose, pelvic, or pectoral fin, or in place of a maxillary.

### CHINOOK

Effective January 1 through December 31 the daily limit remains at two (2) chinook, with a minimum size limit of 45 cm:

• seaward of a line approximately one (1) nautical mile seaward of the surfline. (light blue area on map)

Effective July 15 until October 15 the daily limit is two (2) chinook, only one (1) of which may be greater than 77 cm:

 shoreward of a line drawn approximately one (1) nautical mile seaward of the surfline, (white area on map)

### COHO

Effective June 01 through August 31, the daily bag limit for coho is two (2) per day, hatchery marked fish only:

in Area 126 and a portion of Area 26 seaward of the Area 26 Coho boundary, and,

Effective September 1 to December 31 the daily bag limit for coho is four (4) per day, hatchery marked fish only

• in those same waters as for June 1 to December 31above (white and light blue areas on map)

#### SALMON NON RETENTION

Effective July 15 to October 15, there is non-retention of salmon in the waters of Kyuguot Sound in the following waters:

inside a line from a boundary sign at Gross Point to a point at 49° 56.91'North • Latitude and 127°15.68' West Longitude thence to White Cliff Head on Union Island and from a boundary marker on the most westerly point of Union Island to a boundary marker on the opposite shore of Vancouver Island. (grey area on map)

Effective July 15 to October 15, there is non-retention of salmon in the waters of:

- Ououkinsh Inlet easterly of a line between boundary signs at the entrance to the inlet; and
- Malksope Inlet easterly of a line between boundary signs at the entrance to the • inlet.
