

A. Basic Information

"Do I need an export permit?" This is the first question facing an exporter. Items in some categories, with certain origins, and going to some destinations, require that an exporter first obtain a federal export permit from the Export Controls Division (TIE) of the Department of Foreign Affairs and International Trade (DFAIT) before they can legally be exported. To help understand the decision process involved, please refer to the flow-chart on the previous page.

What is an export permit?

Under the Export and Import Permits Act (EIPA), the Minister of International Trade may issue to any resident of Canada a permit to export items included in an Export Control List (ECL) or items to a country included in an Area Control List (ACL), subject to such terms and conditions as are described in the permit. The permit indicates among other things, the quantity, description and nature of the items to be exported as well as the final destination country and end-user. There are two types of permits: Individual Export Permits (IEP) or General Export Permits (GEP).

Export permits overview

Follow the following steps to determine if an export permit is required. Refer to the diagram on the previous page.

Step 1: Items destined to countries on the Area Control List

Regardless of being listed or not on the ECL, any items going to a country on the Area Control List (ACL) require a permit before they can be exported. At time of publication, the ACL included Myanmar and Belarus.

Step 2: Items destined to countries subject to economic sanctions

For any nation that is subject to a United Nations Security Council embargo, additional approvals may be required. Please consult the following website for more information:

Step 3: The Export Control List

A variety of specific items, controlled by DFAIT require permits for export, regardless of their destination or means of transmission (e.g. facsimile, electronic transfers, consulting services, etc.). These items are found on the ECL, which is contained in this Guide. Most, but not all items are eligible for an exclusion to usual permit requirements if destined for end-use in the US or its territories, dependencies or possessions (refer to Section B). The ECL is quite detailed, covering many items that Canada controls for various reasons. Section K provides some practical information on using the ECL.

Step 4: US Origin Goods

Exporters should note that the export of all goods and technology of US origin as defined in ECL Item 5400, regardless of their nature and destination, require permits (refer to Section C). This is in recognition of the favourable permit/licence treatment accorded bilaterally on most controlled items. (See Section C for details on exports of US origin items contained elsewhere in the ECL.)

Step 5: Items Destined to a Chemical, Biological or Nuclear Weapons, or Missile Application (Goods for Certain Uses)

In 2002, Canada implemented 'catch-all' controls that cover the export of any items not listed elsewhere on the ECL. ECL Item 5505 Goods for Certain Uses imposes a permit requirement on any items if it is determined that the items are destined to an end-use or end-user involved in the development or production of chemical, biological or nuclear weapons or Weapons of Mass Destruction (WMD), or their missile delivery systems. Before exporting any items, exporters must assure themselves that their export is not being transferred, directly or indirectly, to a WMD end-use/end-user. If in doubt, the exporter should contact TIE for assistance.

Step 6: Items Subject to Export Controls by Other Government Departments/Agencies

Other controls may apply, for example: the Canadian Nuclear Safety Commission (CNSC) for nuclear and nuclear related items; Environment Canada for endangered species and hazardous waste; and Heritage Canada for cultural properties. Refer to E for a description of other departments/agencies which may possibly have export authorisation requirements. For more information about exporting requirements, please contact your local Canada Border Services Agency (CBSA) office or the responsible government department or agency. These can be found in the blue pages of your local telephone book under 'Government of Canada'.

In the event none of the above circumstances applies (Steps 1 - 6), then an export permit from DFAIT is not required. None the less, it is the exporter's responsibility to keep abreast of any changes to Canada's export control regime that may affect their export requirements.

Fees

Fees only apply to certain items in Group 5. Under the authority of the Export and Import Permits and Certificate Fees Order, 1995 (amended 1996) a fee is levied for each permit for most Group 5 Items except ECL Items 5400, 5401, 5501, 5502, 5503, 5504 and 5505. All other Items in Group 5 are assessed a \$14 administrative fee for each export permit application submitted. For softwood lumber under Item 5104 and 5105, a \$9 fee is assessed if export permit applications are completed and submitted electronically. For more information about fee charges related to softwood lumber, please contact the Softwood Lumber Division at telephone (613) 944-2167.

Money orders or cheques payable to the Receiver General for Canada are acceptable forms of payment, and must be included with the application for an export permit. Exporters who make frequent shipments may prefer to be placed on a monthly billing system. If the exporter would prefer to be billed monthly, rather than making advance payment for each individual permit, such requests should be submitted to:

B. Export of Controlled Goods or Technology to the United States

Under a bilateral arrangement with the United States, export permits are not required for most ECL items when shipped to a final destination and for end-use in the US, or its territories, dependencies or possessions. However, for all items listed in Groups 3 and 4, as well as ECL Items 2-1, 2-2, 2-3, 2-4.a, 5001., 5011., 5101., 5102., 5103., 5104., 5105., 5201., 5202., 5203., 5204., 5501., 5502.1, 5503., 5504.2.h., 6-1, 6-2, 7-3 and 7-13 require individual export permits when shipped to a final destination or for end-use in the US In addition, if the ECL items are not for consumption in the US but are only transiting the US for export to other destinations, an export permit is required for all items based on the country of final destination. If uncertain as to whether an export permit for the US is required, contact TIE.

C. Controls on the Export of US-Origin Goods or Technology

Export of US Origin Goods and Technology Controlled in the ECL (except ECL Item 5400)

The Government of the United States has traditionally controlled the export from other countries items that had their origins in the United States and as such, imposes re-export controls. Exporters are cautioned that some US origin items, including US origin items incorporated into a finished product, may be subject to US re-export controls. If exporters are uncertain as what re-export controls, if any, might apply to their items, they should contact TIE or the original US supplier for guidance.

Exporters may be required to provide a copy of a validated US export licence, or other export documentation, or verification that the specified goods may be exported to the specified country without the US licence, prior to issuance of an individual export permit. Proof of US re-export authorisation is required for items of US origin which fall within ECL Group 2, ECL Group 6 or ECL Item 5504 before an export permit will be granted (refer to Section D and the Export Permits Regulations). In some cases, the U.S (or other supplier) may impose, as a condition of supplying certain items, a requirement that the Canadian purchaser seek re-export approval before exporting the items from Canada. This may be regardless of whether the items have been incorporated into a finished product in Canada.

Export of Goods and Technology of US Origin Controlled by ECL Item 5400

Items of US origin as defined in ECL Item 5400, and not covered elsewhere in the ECL, are controlled for export from Canada. As this measure is designed to ensure Canada is not used as a diversionary route to circumvent US embargoes, when the items are destined for end-use in countries where no such embargo applies, exporters may invoke General Export Permit No. 12. GEP-12 must be identified in the form prescribed by CBSA. GEPs have several advantages and are administratively easy to use. They are discussed in greater detail in Section E of this Guide.

Export of Goods and Technology of US Origin to Iran, Cuba, Syria, North Korea and Area Control List Countries

As noted above, all items of US origin defined under ECL Item 5400 require an export permit. If these goods are destined for end-use in Iran, Cuba, Syria or North Korea, or to any country on Canada's Area Control List (ACL), the exporter must apply to TIE for an individual export permit. In all other cases, General Export Permit No. 12 is applicable. For more information, contact TIE.

D. Export Permit Application Process

This section describes the application process, including required information. Exporters are encouraged to apply as early in the export process as possible in order to avoid unnecessary delays to shipment schedules.

Export Controls On-Line (EXCOL)

EXCOL is an internet-based system which allows exporters to apply for export control documents electronically. EXCOL is offered through the Government of Canada's Secure Channel and assures client security and privacy for all on-line interactions. Users obtain their own, unique Government of Canada epass, which allows them to access the system through a web browser.

EXCOL exporters are either "Recognized" or "Non Recognized". By default, exporters are Non Recognized and may apply for export permits, International Import Certificates, Delivery Verification Certificates, and Advisory Opinions online, as well as attach to their applications electronic copies of required supporting documents.

Exporters who apply or have applied for more than one export permit annually are advised to become Recognized Users of EXCOL. In addition to the functions available to Non-Recognized Users, Recognized Users may do the following online:

- save partially completed applications and finish them later
- copy previously submitted applications, modify them and submit as new
- request permit amendments
- verify status of all submitted applications
- download and print issued permits and certificates
- submit utilization reports

EXCOL System Requirements

The following are current local system requirements to use EXCOL:

- Internet browsers: Internet Explorer 5.5, 6.0 or 6.1, but not IE 7; or Netscape 8.0 International
- Operating systems: Microsoft Windows NT 4 SP4 and higher; 2000 Professional SP3 Millennium edition; XP Home edition or XP Professional edition; or Macintosh OS 8.6, 9.x or OSX in OS9 emulation.
- In order to support the Epass login via Secure Channel, a small Java applet must be install on the PC, your system will need Sun Java Runtime Environment V. 1.4.2_01 or higher (download free of charge from www.java.com).

EXCOL Registration

Recognized User privileges require registration of the exporting company and of each individual representative of the company who will access EXCOL. There are two forms: the Application for an EXCOL Recognized Business and the Application for an EXCOL Recognized Individual. These forms are also available to print in the EXCOL section of the website www.exportcontrols.gc.ca.

The information provided in the Recognized Business form is used to create a page within EXCOL for the corporate entity. Each business then designates the individual Recognized Users who are able to access this information and use EXCOL on behalf of the corporate entity.

A Recognized User form must be submitted for each and every person who needs access to EXCOL on behalf of the Recognized Business, even if there is only one individual from the business who will use EXCOL. Each individual must sign the Recognized User form and thereby attest that (a) they understand the rules regarding the Access Code and electronic submissions, and (b) they consent to the collection, retention and sharing of the personal information required for the EXCOL account.

Deletions and additions of Recognized Users can be made any time and should be requested in writing to the above address.

Steps for EXCOL registration:

- 1. Fill in Recognized Business and Recognized Individual forms (available in this Guide) and send in by post or courier to: EXCOL Registration, Administration and Technology Services Division (TIA), Foreign Affairs and International Trade Canada, 125 Sussex Drive, Ottawa, Ontario, K1A 0G2.
- 2. Each individual must create a unique epass. To do this, users may access the EXCOL website (www.excol-ceed.gc.ca), choose "Login now", and then follow instructions to "Register for an epass."
- 3. Following receipt in Foreign Affairs and International Trade Canada of the forms described in step 1, each Recognized Individual receives an email from enrolment@excol.com containing an Access Code, the individual's own email address, and a hyperlink for completing enrolment on-line. By following the hyperlink, each user completes the registration process (users need to enter their epass in this step).
- 4. EXCOL then launches and the user's name appears in the upper left corner. For all subsequent logins, users simply go to www.excol-ceed.gc.ca and log in using their epass.

On-line Applications for Export Permits

<u>Instructions for Recognized Users:</u>

- 1. Access the EXCOL website at www.excol-ceed.gc.ca and choose the language of your choice.
- 2. Recognized Users choose "Login now" from the left-hand menu.

Instructions for Non-Recognized Users (anonymous users):

- 1. Access the EXCOL website at www.excol-ceed.gc.ca and choose the language of your choice.
- 2. Choose "Apply for..." from the left-hand menu and select the type of application. Most exporters will select "Export Permit Other Controlled Goods."
- 3. Read and accept the Privacy Disclaimer.
- 4. Complete the form (see below for detailed instructions for export permit applications). Please provide your GST number with your first application.
- 5. Attach all supporting documentation electronically. All paper documents should be scanned and saved as in .pdf or .jpg formats. If it is impossible to attach electronic documents, you must indicate on the application that they will be sent by fax or mail to the Export Controls Division (fax 613-996-9933).
- 6. Once you have submitted your application, the system will automatically generate a reference number (Ref. ID). Please quote the Ref ID in all correspondence on this application.

Paper Applications for Export Permits

Data entry of all paper applications will add up to 5 business days to the processing time for export permit applications. Required forms can be downloaded from the Export Controls Division website at www.exportcontrols.gc.ca by clicking on "Apply for an Individual Permit" under the section "Guidance on Export Controls".

Individual export permit applications require two forms, EXT-1042 Application for Permit to Export Goods (General Information Form) and a second form depending on the type of product. For most applications, this will be EXT-1042-1 Controlled Goods Details Form (others available are Firearms Detail Form, Logs Detail Form, and BC Logs -Transition - Detail Form).

How to Complete the Application to Export

The following section describes the content that is required in each field of the export permit application, either in EXCOL or in the paper forms EXT-1042 (General Information Form) and EXT-1042-1 (Controlled Goods Details Form). This information is similar to that required for EXT-1042-2 (Firearms Application). At the time of printing, a consolidated EXCOL application form for firearm, firearms related components and ammunition is under development.

Applicants should bear in mind that an export permit and all documentation submitted with it are legally binding on all parties once a permit is issued. The EIPA prohibits the "export or attempt to export any goods included in the Export Control List or any goods to any country included in the Area Control List except under the authority of and in accordance with an export permit issued under this Act." (§13) Furthermore, the EIPA states that, "No person shall wilfully furnish any false or misleading information or knowingly make any misrepresentation in any application for a permit ... or for the purpose of procuring its issue or grant or in connection with any subsequent use of the permit ... or the exportation ... of goods to which it relates."

The first and most important step is to have a complete understanding of the export. What is the product? Where is it going? Who are the intermediate and final consignees who will receive the shipment, and what are the exporter's contractual obligations for shipping the goods or technology? What will the exported goods or technology be used for, and by whom? If you cannot answer all of these questions in detail, you are not ready to fill in the application.

Incomplete applications may be returned without action by the Export Controls Division. Information entered on the export permit application must be consistent with the Export Declaration or other export reporting submitted to the Canada Border Services Agency when the goods or technology are presented for export.

Applicant information

- The Client Name is the name of the company acting as Applicant. The Contact identified for the Applicant must be resident at the business address provided.
- Section 7 of the Export and Import Permits Act requires that the Applicant be a resident of Canada (defined as "in the case of a natural person, a person who ordinarily resides in Canada and, in the case

- of a corporation, a corporation having its head office in Canada or operating a branch office in Canada").
- The Applicant and Exporter do not need to be identical.
- If the Applicant is a business, the Applicant must hold a resident Business Number (formerly known as a GST Number) issued by the Canada Revenue Agency. A Business Number is not necessary for an application by an individual. The Applicant must hold an Export and Import Controls Bureau (EICB) Number issued by DFAIT (application forms available at www.exportcontrols.gc.ca) before the application can be processed. However, applications submitted through EXCOL by businesses which do not already have an EICB Number will be assigned one upon receipt of the application in DFAIT.

Exporter information

- The Client Name provided must be the Exporter, the business which exports the goods or technology
 or has the legal right to cause them to be exported. The wording "cause them to be exported" does not
 mean the person involved in the transportation (carriage) of the goods. For more information, please
 consult the publication "Exporting Goods from Canada, A Handy Guide for Exporters", available at
 www.cbsa.gc.ca.
- The Exporter address must be the location from which the goods or technology will be shipped at the time of export. The exporter name and address provided must match the exporter information as stated in the Export Declaration (B13A) or other documentation which is presented to customs authorities when the goods are presented for export.
- The exporter may be a non-resident of Canada but applications for non-resident exporters must be submitted by a Canadian applicant who accepts legal responsibility for the use of the permit if issued.
- If the Exporter is a business, the Exporter must hold a resident or non-resident Business Number (formerly known as a GST Number) issued by the Canada Revenue Agency. The Exporter must hold an Export and Import Controls Bureau (EICB) Number issued by DFAIT (application forms available at www.exportcontrols.gc.ca) before the application can be processed. However, applications submitted through EXCOL by businesses which do not already have an EICB Number will be assigned one upon receipt of the application in DFAIT.

Consignee information

• Exporters may wish to refer to CBSA Memorandum D20-1-1, which provides a definition of consignee for the purpose of export reporting:

"Consignee" means the person, firm or representative named in a freight contract to whom the goods are exported and who, upon presentation of the necessary documents, is recognized as the owner of the goods. The ultimate consignee is the final party who receives and takes ownership of the goods, cargo or containers that are exported from Canada.

- From this definition, all consignees for Canadian exports: are named in a freight contract to which a
 Canadian exporter is a party; receive the goods in a foreign destination; and are recognized as owner
 of the goods outside Canada.
- An intermediate consignee is named as an intermediate party in the Canadian export contract, may
 receive the goods in a foreign destination (not necessarily the country of final destination of the goods),
 and has legal authority to handle, consolidate or otherwise treat the goods as defined by the export
 contract. However they do not take ownership of the goods. Freight forwarders are generally not
 considered to be consignees.
- For the purposes of an export permit the final consignee is also named in the Canadian export contract, receives the goods in the country of final destination, and has legal authority and ownership of the goods.

- The final consignees, as identified on the export permit, the Ultimate consignee on the Export Declaration (B13A) or other export reporting documentation, and shipping documents must be identical.
- Consignee addresses should identify the location of the consignees where they take physical
 possession of the exported goods or technology. Consignee addresses must be complete. Post office
 boxes alone are generally not acceptable.
- Where available, consignee website addresses should be indicated along with contact email addresses.

Overall description of goods and end-use

- The exporter should provide general information about the proposed export in this field, including the following (as applicable):
 - o a description of the goods or technology which is understandable to a layperson;
 - a description of the exporter's understanding of the end-use of the exported goods or technology by the final consignee and, if known, subsequently by other parties;
 - o in the case of temporary exports, an explanation of the reason, such as the name and dates of the applicable trade show, and a statement as to whether the exported goods or technology will remain in the possession of an employee of the Exporter while outside Canada;
 - a declaration of the United States authority under which the goods, their subcomponents or technology were imported into Canada. If U.S. International Traffic in Arms Regulations (ITAR) controlled, under what authority are the goods, subcomponents or technology being re-exported from Canada:
 - O Provision of more precise descriptions where "Spares", "Kits", or "Accessories" are concerned. General terms like these will usually prompt us to ask for a full breakdown of what is actually to be exported as it is unclear exactly what might be encompassed. Recognizing that breakdowns of such lists may be impractical in some cases there is, however, an alternative, that could be considered. Using generic groupings of certain types or categories of items. Terms like "Components of..." or "Tooling for...", are more accurate ways of describing goods than "Spares for" or "Accessories":
 - o date when the export is expected to leave Canada, if known (exporters should allow a minimum of 2-6 weeks for processing export permit applications)
- The Applicant should also provide any other information to support the application and to help the Export Controls Division to fully understand and assess the transaction and the proposed export.
- Such information may alternatively be provided in a separate cover letter on company letterhead, signed by the Registered Individual who is making the application, or a senior officer of the applicant business, which the Applicant should attach to the completed application.

Applicant/Exporter comments

Additional comments which may be pertinent to the application.

Export type

Indicate the type of export, whether permanent or temporary.

Description

 Name of the goods, including, where possible, models, brand names, part numbers, serial numbers, and so on. Where quantity is given as a weight or volume, the unit of measure must be stated. Where units are shipped as separate components, the unit and separate components should be named in a single line item.

- This is how the goods or technology will be identified on the export permit, which will also be verified against the export declaration submitted to Canadian customs authorities.
- Exporters are also required to submit detailed information for the purpose of the technical assessment against the Export Control List (ECL) (see below). The Export Controls Division undertakes a technical assessment of the goods, services, and technology listed in the export permit application to determine under which ECL Item(s) they fall. For this purpose, technical specifications of the export must be detailed and adequately describe the characteristics of the goods and services. They must also provide enough details to establish their true nature. They could be provided in the form of drawings, manuals, component lists, and so on. Marketing brochures may also provide useful additional information.

Item Type

- Select one item type: quantity, lot or no commercial value and provide the corresponding information for the selection.
- Value must be expressed in Canadian dollars and should be the same as the invoice or sale price paid
 by the foreign customer. For permanent exports of new goods or technology, the value should reflect
 the full sale price. For permanent exports of goods repaired in Canada, the value should reflect only
 the cost of repairs in Canada.

US Content

US-origin production as (estimated) percentage of the total value in Canadian dollars.

Country of Manufacture

 Country where the goods or technology were produced or assembled into their final form prior to export from Canada.

Goods are specially designed or modified for

• Specify whether the goods are designed or modified for (select one): military use, space use, nuclear use, other (specify). Appropriate supporting documentation should be attached to the application.

Goods employ cryptography

 For information security products, indicate if the goods employ cryptography (including encryption or decryption).

Supplementary information

- Specify all applicable information, such as:
 - cryptographic executable code;
 - cryptographic source code;
 - o complete system;
 - o part of a system;
 - o raw material;
 - o replacement part;
 - software executable code;

- software source code;
- substance or compound;
- o technical data for design or development;
- technical data for production;
- technical data for repair/overhaul;
- test, inspection or production equipment.

ECL No.

 Using the latest version of the Export Control List as published on the website www.exportcontrols.gc.ca, identify the ECL Item number which controls the goods or technology proposed for export. The non-exhaustive (generic) index of this document names commonly exported items. Users of the electronic version may also perform key-word searches.

Additional information attached

• Specify any additional, supporting documentation that is attached to the application. Important supporting documentation is described at www.exportcontrols.gc.ca. Failure to provide technical specifications of the items and an end-use assurance may delay the processing of your application.

Mandatory Additional Documentation

The following information is required to supplement the completed export permit application. This information helps the Export Controls Division to fully understand the proposed export and to properly advise the exporter. Electronic documents (including scans of paper copies) can be attached to export permit applications made online with the EXCOL system.

1. Technical description of the goods or technology

The Export Controls Division undertakes a technical assessment of the goods, services, and technology listed in the export permit application to determine under which ECL Item(s) they fall. For this purpose, technical specifications of the export must be detailed and adequately describe the characteristics of the goods and services. They must also provide enough details to establish their true nature. They could be provided in the form of drawings, data sheets, manuals, component lists, and so on. Marketing brochures may also provide useful additional information. The information that is submitted should make clear the type and function of the goods and provide key technical parameters.

2. End-Use Assurances

Documents which support the exporter's statements about the end-use and final consignee of the exported items must be provided with the export permit application. In some cases the Export Controls Division may waive the need for end-use assurances (see below).

There are several types of end-use assurance documents which are commonly used, accepted, and understood in Canada and in many other countries:

International Import Certificates (IIC)

An IIC is provided to the exporter by the final consignee and is issued by the government of the final destination. It states the items (including quantities and values) which will be imported, and provides both governments with an additional assurance that the goods will not be diverted to illegitimate end-users. The Canadian exporter must attach the IIC to the export permit application and submit it to the Export Controls Division within the validity period (usually 6 months) of the IIC.

Delivery Verification Certificates (DVC)

A DVC is typically issued by the government of the country to which the item has been exported and provides official confirmation that the goods have been delivered in accordance with the terms of both the

Canadian export permit and/or the foreign-issued IIC. In some cases, Canadian exporters are required to obtain and submit to the Export Controls Division applicable DVCs as a condition of the export permit.

Import Licences (IL)

ILs are issued by the government of the final destination when it controls imports of the items proposed for export from Canada. The Canadian exporter must attach the IL to the export permit application.

End-Use Certificates (EUC)

An EUC is issued by the government of the final destination and provides official acknowledgement of the Canadian export, that the items and end-user described on the export permit application are legitimate, and that the Canadian-origin items will not be diverted to other uses.

End-Use Statements (EUS)

When an official document from the final destination government is not available, an EUS from the final consignee may be acceptable. An EUS must be written on the final consignee's letterhead in either English or French and must:

- Identify the items, including quantities, which are the subject of the export permit application;
- Identify the end-user and the location where the items will be delivered;
- State the purpose and end-use of the products, including a statement of whether the intended end-use of the items is civilian (commercial) or military;
- Declare that the imported items will not be trans-shipped or diverted to uses except as specified in the end-use statement.
- Declare that the imported goods will not be re-exported for any reason or that re-exports and transfers by the end user shall be in accordance with the export controls laws of the country of final destination.
- Declare whether the goods and technology will be used for any purpose associated with the development or production of chemical, biological or nuclear weapons, or their delivery systems (e.g., missiles).
- Identify the name and title of the person signing the EUS, their address, telephone number, fax number, email address and web site.

At the discretion of the Export Controls Division, the end-use assurances described above may be waived if acceptable alternative documents are provided which support the exporters statements about the destination, consignees, and end-use of the goods or technology proposed for export. Exporters who consider that their particular transaction qualifies for a waiver of supporting documentation must state this in the body of the export permit application.

The following are common examples of discretionary waiver:

- Provision of acceptable contract of sale between the Canadian exporter and foreign consignee(s) or end-user(s)
- Temporary exports for exhibition (exporter should provide evidence of a display at the exhibition)
- Exports to certain foreign government ministries or agencies
- Export to relief agencies for use in relief projects
- Maintenance/spare parts (with proof of previous Canadian export of goods, e.g., reference to relevant permit number)
- Export of items for return or repair this could include:

- Canadian-owned items being exported from Canada to a foreign country for repair or replacement (with evidence that the goods were imported into Canada);
- Foreign-owned items which have been repaired or maintained in Canada and are returning to the foreign owner (with evidence of recent import for repair or maintenance); or
- Items to replace previous exports from Canada which have failed and are subject to warranty (with evidence of export permits issued for original export).

End-Use Assurance for Firearms, Components, Ammunition and Explosives

Export permits for firearms, firearm components and ammunition may not be issued unless the exporter provides an import licence or other proof that the items will legally enter the country of destination. To meet the requirements of the Organization of American States' Convention on Firearms, Explosives and Related Material, proof of a transit authorization may be required if the items are transiting a third country.

3. US Re-export Authorization (if applicable)

As mentioned above, the export from Canada of items of US origin or with US-origin components which are controlled in ECL Groups 2 and 6, or in Item 5504 may require an explicit re-export authorization issued by the US Government, which must accompany the export permit application. The authority for such authorizations is the International Traffic in Arms Regulations (ITAR) (see www.pmddtc.state.gov for more information). Re-export authorization may be in the form of:

- an export licence;
- a Warehouse and Distribution Agreement;
- · a Technical Assistance Agreement;
- a Manufacturing Licence Agreement;
- a re-export authorization letter; or
- a US export licence exemption.

Some exporters may declare on their Canadian export permit application an exemption from explicit US reexport authorization under ITAR §123.4(a)(1) if US defence articles are being exported after they were temporarily imported into Canada and "serviced (e.g., inspection, testing, calibration or repair, including overhaul, reconditioning and one-to-one replacement of any defective items, parts or components, but excluding any modifications, enhancement, upgrade or other form of alteration or improvement that changes the basic performance of the item), and subsequently returned to the country from which [they were] imported." Note that this does not apply to any upgrades performed in Canada on US-controlled military goods.

For more information, please see the Specific Controls section of the Export Controls website at www.exportcontrols.gc.ca.

4. Supplementary documents (optional)

In some cases, supplementary documents may help the Export Controls Division to more clearly understand the nature of the proposed export. Such documents could include:

- import bill of lading, airway bill (AWB) or manifest
- validated Carnet
- defect slip / failure report
- repair order form / return material authorization (RMA)

 any official documents originating from other departments and agencies of the Government of Canada or of foreign governments

E. Other Export Control Issues

Export Permit Validity

Export permits for TIE items are subject to different validity periods. The general guidelines are as follows:

Group 1

- All Group 1 ECL Items To non-Open Policy Countries (OPC) 2 years
- All Group 1 ECL Items To OPC destinations when no contract is in place 2 years
- All Group 1 ECL Items To OPC destinations when a contract is being executed Up to 5 years (the export permit would include all the items detailed in the contract to the end-users identified in the contract)

Group 2

- ECL Items 2-1 to 2-4 Single shipment for most items to All Destinations
- ECL Items 2-5 to 2-22 no contract in place or if end user is a commercial enterprise 2 years
- ECL Items 2-5 to 2-22 to an OPC destination where the end-user is a government entity or acting on behalf of a government entity Up to 5 years
- Export permits issued for Group 2 ECL Items are subject to the reporting requirement noted on the export permit. This report must detail actual shipments of items made against each export permit.

Group 3

- All Group 3 ECL Items Up to 5 years
- The exporter must also be in possession of a valid export licence issued by the Canadian Nuclear Safety Commission (CNSC) prior to exporting the items.

Group 4

- ECL items where General Export Permit No. 27 (GEP-27) applies Export in accordance with GEP-27
- All other Group 4 ECL Items Up to 5 years
- The exporter must also be in possession of a valid export licence issued by the Canadian Nuclear Safety Commission (CNSC) prior to exporting the items.

Group 5

- ECL Item 5400 when General Export Permit No. 12 (GEP-12) applies Export in accordance with GEP-12
- ECL Item 5400 when GEP-12 does not apply 2 years
- ECL Items 5504 To non OPC destinations 2 years some items require export permits to All Destinations
- ECL Items 5504 To OPC destinations when no contract is in place 2 years
- ECL Items 5504 To OPC destinations when a contract is being executed Up to 5 years (the export permit would include all the items detailed in the contract to the end-users identified in the contract)

Group 6

- ECL Items 6-1 and 6-2 Single shipment for most items to All Destinations
- ECL Items 6-3 to 6-20 2 years

Group 7

All Group 7 ECL Items – 2 years

Permits for Temporary Exports

Permits for temporary exports are common for items exported for trade shows, exhibitions, demonstrations, geological surveying, and other events where the items will return to Canada. Exporters must apply for a permit in the normal manner and must note in the body of the application that they are asking for a permit for a temporary export. In granting a permit for a temporary export, TIE may place certain conditions on the export. These conditions may include:

- adhering to the expiry date of the permit (normally 12 months);
- ensuring the items are properly supervised while abroad; and
- providing proof that the items are returned to Canada unchanged.

Multiple Shipments/Multiple Consignee/Distribution Permits (Strategic/Other Goods)

In some cases, an exporter may use an export permit for more than one shipment to the consignee(s) specified on the export permit up to the value and quantity noted on the permit. This procedure applies to all items in Groups 1, 4, 5 (except ECL Items 5501, 5502, 5503, 5504 and 5505), 6 and 7. In certain cases, exporters may be allowed to apply for a Distribution Permit valid for a number of different destinations. Such permits may be subject to reporting requirements.

Single Shipment Permits (Offensive Military Equipment)

As a general rule, export permits for military items falling under ECL Items 2-1 through 2-4, will be issued for a single shipment/single consignee only. The export permit becomes invalid after the first shipment is made even if the shipment is only a partial one. Exporters must re-apply for a new export permit to cover any shortfall.

Multiple Shipments/Single Consignee Permits (Non-offensive Military/Nuclear Equipment)

Other ECL Items in Group 2 not identified above in the section "Export Permit Validity", and all items in ECL Group 3, may be exported to a single consignee on a multiple shipment basis.

Project Development Permits

Permits are required in all cases (except the US) where technology, as defined in the ECL, is transferred abroad, regardless of the means of transmission. As a technology transfer is often required for issuing or responding to RFPs (Requests for Proposal), developing new products or other circumstances where no physical goods are exported, export permits should be sought to cover these contingencies. Should this development work lead to a contract to supply other ECL Items, a separate permit valid for up to five years covering the deliverables of the contract may be issued in certain circumstances (refer to Section E).

Automatic Firearms Country Control List (AFCCL)

In addition to the ECL and the ACL, certain additional export controls exist specifically for automatic firearms. These firearms may be exported only to countries with which Canada has intergovernmental defence, research, development and production arrangements. While new countries are added periodically and exporters should contact TIE to determine whether countries have been added, the current list of AFCCL countries are:

Australia New Zealand
Belgium Norway
Botswana Poland
Denmark Portugal
Finland Saudi Arabia
France Spain
Germany Sweden

Greece United Kingdom United States

Netherlands

General Export Permits (GEP)

General Export Permits (GEP) issued by the Minister of International Trade enable an exporter to export certain items which are subject to control to eligible destinations without the necessity of submitting individual export permit applications. Exporters do not apply to TIE for authorisation to use a GEP. A GEP is a valid export permit which is used to minimize the administrative burden for exporters and to streamline licensing procedures. When exporting items listed on the ECL where a GEP applies, the exporter must cite the appropriate GEP number in the relevant box in the appropriate form prescribed by CBSA. (refer to Section G). However, some GEPs contain conditions which must be adhered to in order to use them. In some cases, the use of a GEP is conditional on an exporter undertaking to report on actual volumes of exports or on specific final consignees made against the GEP.

GEPs have been issued for specific items, and specific destinations. The current list of GEPs is available on the TIE website or by contacting TIE. For details on how to use a GEP, please contact TIE.

<u>Dual-controls for Nuclear and Nuclear Related Items</u>

In addition to controls imposed by DFAIT under the EIPA, the export of nuclear and nuclear-related items is also controlled by the Canadian Nuclear Safety Commission (CNSC) under the Nuclear Safety and Control Act (NSCA) and Regulations. Therefore, the export of Groups 3 and 4 Items also requires a licence from the CNSC. As well, there are nuclear and nuclear-related items not listed in this Guide that are controlled under the NSCA and Regulations and require a license from the CNSC prior to export. Information on CNSC's export licensing requirements may be obtained by contacting:

It should be noted that Group 3 and 4 related exports can only occur when export authorizations are obtained from both DFAIT and the CNSC. In order to obtain such authorizations, an exporter shall submit an export permit application along with the appropriate supporting documents to TIE, which will forward all pertinent information to the CNSC.

Narcotics, Controlled Drugs and Precursors

Controls on the export, import and internal trade in illicit drug precursors are administered by Health Canada under the Controlled Drugs and Substances Act.

Canadian National Authority for the Chemical Weapons Convention (CWC)

The Canadian National Authority (CNA) for the CWC is responsible for the collection and monitoring of Canadian data dealing with the importation of Import Control List Item number 74 chemicals and precursors, and the exportation of ECL Item 7-3. These items correspond to Schedules 1, 2 and 3 of the Chemical Weapons Convention (CWC). For further information contact the Canadian National Authority at 1-800-655-6229.

Other Government Departments

It is possible that export authorisations may be required for other goods from other government departments. These include, but are not limited to:

Exporters can obtain information relating to such controls by contacting the appropriate department.

Controlled Goods Programme (CGP)

The Controlled Goods Programme (CGP) was established in 2001 under the Defence Production Act (DPA) and the Controlled Goods Regulations (CGR). Generally speaking, companies or persons having access to 'controlled goods' as defined in the Schedule to the DPA, or who may possess, examine or transfer 'controlled goods', including related technology within Canada, must be registered under the CGP. The CGP is administered by the Controlled Goods Directorate (CGD) of the Department of Public Works and Government Services Canada (PWGSC). Those items contained in ECL Groups 2 (with certain exceptions, see below) and 6, and ECL Item 5504 are 'controlled goods'. Exporters wishing to export

'controlled goods' must be registered under the CGP. If an exporter is not registered, an export permit application cannot be issued and the application will be held in abeyance until there is evidence that the exporter has registered. For information on the CGP, please refer to the address and web site noted below.

For the purposes of the CGP, Group 2 covers Items 2-2 and 2-4 through 2-22 in their entirety. As well, under Item 2-1, firearms with a calibre of 12.7mm or less are CGP-controlled to the extent that they are 'prohibited firearms' as defined in paragraph 84(1)(c) of the Criminal Code. Ammunition in Item 2-3 is CGP-controlled if the calibre is greater than 12.7mm.

F. Administrative Procedures

Processing Time

Every effort will be made to process permit applications quickly. TIE takes several factors into consideration when processing export permit applications. In many instances, the processing time can be as short as 10 business days from receipt of the application in TIE. However, for some items, including military and strategic items being exported to destinations other than Open Policy Countries (OPCs), allow 6-8 weeks for processing, or longer for some destinations. In most cases TIE consults with other government departments and, in some cases seeks ministerial approval.

Open Policy Countries are like-minded countries that belong to the same export control regimes as Canada and which have effective export controls.

Export Permit Status Enquiries

Exporters may obtain information regarding the processing of their permit application by contacting TIE at (613) 996-2387 and citing the Ref I.D. number located in the upper right-hand corner of the export permit application. Please allow at least seven working days from time of mailing of the application before enquiring as to the status of the application.

Advisory Opinions

Exporters may request an Advisory Opinion to determine the control status of items or whether an export permit is required. This advice is provided wherever possible, but is not binding on the Minister. Therefore, exporters who want a binding decision are encouraged to apply for an export permit rather than requesting a technical assessment.

Policy Assessments

After a technical assessment is completed to determine the control status of the proposed export, further consideration is given to the country of final destination and the intended use and end-user of the product. In many cases, a thorough consideration of the relevant foreign policy and security concerns is undertaken.

This may include policy considerations from other branches of government through a consultation process. Where concerns exist about a proposed export, ministerial guidance will be sought.

Consultations

The purpose of intra/interdepartmental consultations is to fully assess the risks and implications related to proposed exports. Various Canadian government departments (most commonly DFAIT, agencies or boards may be involved in the export control consultation process. Consultations may be carried out at the national, bilateral or multilateral levels.

Strategic Goods and Technology

Groups 1, 3, 4, 6 and 7 of the ECL cover strategic as well as dual-use goods and technology. Dual-use items, though mainly civil/commercial in nature, could contribute to chemical, biological and nuclear weapons proliferation, and their missile delivery systems, as well as the development of conventional weapons. Generally, exports of strategic and dual-use civilian items are considered favourably with some exceptions. For example, an export permit application may be denied where there is a risk of diversion of the items to an unacceptable use or destination or, where secondary military uses might be foreseen. An export permit may be denied where there is a risk of proliferation of nuclear explosive activity or unsafeguarded nuclear fuel cycle activity (Groups 3 and 4), missile systems (Group 6) or chemical/biological weapons (Group 7) to any country. The onus is on the exporter to indicate the final destination of the items.

Military Goods and Technology

With respect to military goods and technology, Canadian export control policy has, for many years, been restrictive. Under present policy guidelines set out by Cabinet in 1986, Canada closely controls the export of military items to:

- countries which pose a threat to Canada and its allies;
- countries involved in or under imminent threat of hostilities:
- countries under United Nations Security Council sanctions; or
- countries whose governments have a persistent record of serious violations of the human rights of their citizens, unless it can be demonstrated that there is no reasonable risk that the goods might be used against the civilian population.

Permit Issuance and Distribution

Once issued, export permits are sent to the applicant depending on the selected method of distribution. Recognized Users of EXCOL can download and print valid export permits directly from EXCOL. Other exporters may choose to receive permits by courier or surface mail.

Paper copies of valid export permits must be presented with other export reporting documents to the Canada Border Services Agency when the goods or technology are presented for export. If a permit has been issued for multiple shipments, a copy of the permit must be presented with every shipment. See Section G below for more information.

The exporter must retain original copies of all documents in respect of each export made under an export permit, including both General Export Permits and Individual Export Permits, for a period of seven years.

Amendments and Extensions of Export Permits

Minor amendments to permits may be allowed in limited circumstances. All requests should be received in the Division at least four weeks prior to the expiry date of the export permit.

Items not listed on the export permit, or destined to a consignee not listed on the export permit, may be subject to CBSA detention or seizure. Therefore, exporters must ensure they are in possession of a legally amended export permit before any export takes place.

Access to Information

As a general rule, under the Privacy Act, personal information in the possession of the Federal government cannot be disclosed without the consent of the individual concerned, notwithstanding the source of that information. Under the Access to Information Act, disclosure is the operative principle. However, before any information provided on an application is released to the public the applicant will be contacted. It is up to the applicant to demonstrate that its release would damage the applicant's commercial interests. Please refer to these Acts for more information or consult with the Access to Information and Privacy Protection Division (DCP) at the Department of Foreign Affairs and International Trade (DFAIT [FA]) ((613) 992-1425) to discuss any concerns.

Tendering Items for Export

A unique permit number is assigned when your application is approved. This unique number is recorded in the "Permit Number" field in the top left-hand corner of the permit. It is the responsibility of the exporter to cite the permit number on the appropriate export documentation at time of export. This and other requirements under the Customs Act administered by CBSA are further described in Section G.

Some export permits are issued on the condition that certain terms and/or conditions are met. Exporters must examine their export permit and any terms and conditions attached to the export permit to determine whether or not specific conditions apply. Many export permits are issued with the condition that a Utilization Report must be submitted to TIE at predefined intervals.

G. Customs Procedures

Before allowing the export of ECL items, it is the duty of Customs Officers, under the Export and Import Permits Act (EIPA), and the Customs Act (CA), to satisfy themselves that the export does not contravene the EIPA.

At the time the items are presented for export, it is necessary to properly declare the export to CBSA and provide a copy of an export permit. Where a permit is required, it is the responsibility of the exporter to cite the Individual Export Permit number or the General Export Permit number in the appropriate field of the Export Declaration (Form B-13A). If no permit is required, this must be stated on the export documentation. If a B-13A is not required for an export, permit numbers, whether individual or general, must be clearly cited on any other documentation (such as shipping, invoice, waybill, etc) accompanying the export.

For permits valid for multiple shipments, it is the responsibility of the exporter to present a copy of the export permit to Customs at the time of each shipment. Each shipment will be recorded by Customs until the export permit expires or the quantity/value of the export permit has been reached, whichever comes first. However, it should be noted that it is the responsibility of the exporter to keep records and not to ship beyond the quantity or value limits of the export permit (refer to Section F).

For more information on presentation and processing of Customs' export documents, please contact your local CBSA office.

Exporters believed to be in violation of the Export and Import Permits Act (EIPA) may have their items detained or seized by CBSA. If seized, the exporter may be liable for severe penalties under the Customs Act or the EIPA. Following seizure, CBSA assumes the sole responsibility for all seized items and their final disposition will be determined through an adjudication process. TIE will not enter into any correspondence over items that have been seized.

If the basis for the seizure is upheld, forfeiture of the items or an ascertained forfeiture (equivalent to a fine) may occur, or a fine itself may be levied.

Permits are not valid for items under seizure until such time as the items may be released to the exporter.

Reminder: CBSA compares the items described on the export permit and the Customs Export Declaration form B-13A or equivalent export documentation with the contents of the shipment. Discrepancies in documentation, exports without a permit, or shipped to a consignee not listed on the permit, the use of an expired permit, among others, may result in a detention. Pending clarification, or if a violation has occurred, the items may be seized. Such items are not exempt from controls and require a permit, either individual or general (GEP). Where items may be exported under a GEP, there is an obligation on the part of the exporter to cite the appropriate GEP number. Where the items are tendered for export without citing the appropriate permit number, they may be detained or seized. Furthermore, failure to present a permit or to cite the permit number or GEP number in the form prescribed by CBSA may lead to the levying of a fine under the CBSA Administration Penalties System (AMPS).

Items that have been detained by CBSA are referred to TIE for a determination as to whether an export permit is required for the specific export. TIE evaluates the export documentation submitted by the exporter at time of export and in many instances will contact the exporter for supporting technical documentation. During the export permit control status determination process, exporters may contact TIE at (613) 996-2387. Upon finalizing the control status of the items tendered for the specific export, TIE will advise CBSA of the findings. The exporter must contact CBSA regarding any further information/actions to the specific detention.

H. Export Permit Requirements for Forest Products

A variety of export controls apply to Canadian forest products listed in Group 5 of the ECL. Remember that each export permit application for ECL Items 5101, 5102, 5103 and 5104 entails a \$14 processing fee. The following explains how exporters may obtain a permit to export a controlled forest product.

Logs and Pulpwood: All Provinces and Territories except British Columbia and the Yukon

Exporters are required to apply for an export permit for logs and pulpwood identified in ECL Group 5. The export permit application is to be sent directly to TIE for processing.

Logs and Pulpwood: Originating from British Columbia

Details governing the export of logs from British Columbia are contained in Notice to Exporters No. 102, dated April 1, 1998. In summary, exporters who harvest logs from non-provincial Crown land or private lands must apply to TIE on the form 'Application to Advertise Logs on the B.C. Federal Bi-Weekly List' (EXT 1718). The application to advertise is the first step in the surplus testing process. Applications are

reviewed by the Federal Timber Export Advisory Committee (FTEAC). If it is determined that the logs are surplus to domestic requirements, the exporter will be informed to submit the form 'Information on Logs in Support of Federal Application EXT 1042' (EXT 1719) together with the federal form EXT 1042 to TIE. In those instances where logs are determined not to be surplus to domestic requirements, the exporter will be so informed.

Applications to export pulpwood must include a copy of the relevant Order of the Lieutenant Governor in Council issued by the Province of British Columbia. The approval or rejection of an application will be issued by DFAIT on behalf of the Minister of International Trade.

Logs and Pulpwood: Originating from Indian Reserves in British Columbia

For logs harvested from Indian Reserves and surrendered lands as defined in the Indian Act and Indian Timber Regulations, an applicant must submit the following documentation to the B.C. Ministry of Forests Provincial Regional Office:

- 1. The federal form, 'Information on Logs in Support of Federal Application EXT-1042' (EXT 1719);
- 2. Written Letter of Consent from the Indian and Northern Affairs Canada (INAC); and
- 3. A summary of scale (FS-72) in approved format.

The exporter must obtain a Written Letter of Consent by applying to INAC in Vancouver. Once the Letter of Consent is issued by INAC, it is sent to DFAIT with copies to the B.C. Ministry of Forests and the applicable Indian Band. For information contact:

Upon receipt of the documentation noted in paragraph 5 above, the Provincial Regional Office will return copies of the documents to the applicant. The applicant then applies to TIE for a federal export permit on form EXT 1042, 'Application for Permit to Export Goods', and includes copies of all documents identified in paragraph 5 above.

Upon receipt of the documents noted in paragraph 7 above, TIE will process the federal export permit application.

All logs are subject to, and must be available for, inspection by the B.C. Ministry of Forests. As well, all logs must be marked to identify their origin.

Logs and Pulpwood: Originating from the Yukon Territory

Exporters must first apply to the Yukon provincial government to obtain a provincial timber permit. A summary of scale will be required to obtain this permit. Once the provincial timber permit has been issued, the exporter will then be required to complete form EXT 1042 "Application for Permit to Export Goods". This application should be sent to DFAIT. Softwood Lumber

Exports of softwood lumber require export permits if destined to the United States. I. Why Do Export Controls Exist?

For some items, such as certain US origin items, controls exist to fulfill Canada's bilateral obligations. However, most of Canada's export controls exist because Canada is a partner in multilateral or international agreements (e.g., Wassenaar Arrangement) designed to control and monitor the movement of strategic goods and technology. These international obligations are non-discretionary. These obligations include the control of military goods and technology, or goods and technology that could be used for developing or producing nuclear, chemical or biological weapons or their missile delivery systems. Canada's export controls are not intended to hamper legitimate trade. Rather, the regulations are designed to ensure that exports and transfers of certain items are in keeping with the strategic interests of Canada or its allies and are consistent with Canada's bilateral or multilateral commitments. Considering the volatility of the international political environment - and the speed with which new technology is being developed - it is clear that these controls are necessary to safeguard Canadian security, political and international interests.

While strategic concerns are important in overall export controls, what many people fail to realize is that Canadian export controls are also designed to protect trade interests. For example, by ensuring that controlled items are covered by appropriate end-use assurances from the recipient country, export controls provide a measure of assurance that the items are not diverted to unacceptable uses or destinations resulting in embarrassment to Canada or the exporting company.

J. Canada's Multilateral Commitments on Export Controls

The four major export-control regimes in which Canada participates are described below. Each regime maintains a list or lists of controlled goods and technology, depending on its mandate. The participants in

each regime typically agree to updates and changes to these lists annually, and changes are subsequently incorporated into Canada's ECL through the regulatory amendment process. The most recent versions of each regime's control lists which are currently included in the ECL are as follows:

Wassenaar Arrangement (ECL Groups 1 and 2)

(www.wassenaar.org)

The Wassenaar Arrangement (WA) on Export Controls for Conventional Arms and Dual-use Goods and Technology was established in order to contribute to regional and international security and stability, by promoting transparency and greater responsibility in transfers of conventional arms and dual-use goods and technology, thus preventing destabilising accumulations. The participating states of the WA seek to ensure that transfers of these items do not contribute to the development or enhancement of military capabilities which undermine these goals, and are not diverted to support such capabilities.

The WA complements and reinforces, with minimal duplication, the existing control regimes for weapons of mass destruction and their delivery systems. This arrangement is also intended to enhance co-operation to prevent the acquisition of armaments and sensitive dual-use items for military end-uses, if the situation in a region or the behaviour of a state is, or becomes, a cause for serious concern to the participating states. Finally, it will not be directed against any state or group of states and will not impede bona fide civil transactions. ECL Group 1 (Wassenaar Arrangement Dual-Use List) comprises dual-purpose items that have both civilian and military application. ECL Group 2 (Wassenaar Arrangement Munitions List) comprises items that are specially designed or modified for military purposes and those that present a strategic military concern.

Nuclear Suppliers Group (ECL Groups 3 and 4)

(www.nuclearsuppliersgroup.org)

Canada has a long-standing nuclear non-proliferation policy that is designed, inter alia, to ensure that Canada's nuclear exports are not used for any nuclear explosive purpose. As a party to the Treaty on the Non-proliferation of Nuclear Weapons (NPT) that came into force in 1970, Canada is obliged not to provide source or special fissionable material, or equipment or material especially designed or prepared for the processing, use or production of special fissionable material to any Non-nuclear Weapon State (NNWS) for peaceful purposes unless the source or special fissionable material is subject to International Atomic Energy Agency (IAEA) safeguards. In the early 1970's, Canada, as a member of a group of states that became known as the Zangger Committee, adopted a common understanding with respect to the implementation of this commitment.

In the late 1970's, a group of nuclear suppliers, including Canada, agreed on a further set of guidelines for nuclear transfers to any NNWS for peaceful purposes. These became known as the Nuclear Suppliers' Group (NSG) guidelines. In 1992, the NSG established a list of nuclear-related dual-use goods and technology that could make a major contribution to a nuclear explosive activity or a non-safeguarded nuclear fuel cycle activity.

Group 3 includes items that are nuclear-specific. Group 4 includes nuclear related, dual-use, items; that is, items that are used in non-nuclear applications and that could also be used in a nuclear explosive activity or a non-safeguarded nuclear fuel cycle activity.

Miscellaneous Goods and Technology (ECL Group 5)

Canada is a participant in a number of bilateral and multilateral arrangements designed to control the export from Canada of various other strategic and non-strategic items. Included in Group 5 are forest products, medical products, agricultural and food products, US origin goods (refer to Section C), antipersonnel land mines, blinding laser weapons, nuclear fusion reactors, certain items for which controls were deemed necessary under a bilateral arrangement with the US, as well as 'Goods for Certain Uses'.

Item 5504 covers 'strategic goods and technology' which include certain global navigation satellite systems, propulsion and space-related equipment, payloads, ground control stations, chemiluminescent compounds, radiation-hardened microelectronic circuits, nuclear weapons test design and equipment, as well as related software and technology.

Group 5 also includes Item 5505 (Goods for Certain Uses). This item covers non-listed, commercial/civilian items, which could make a serious or major contribution to the proliferation of chemical, biological or nuclear weapons, or their missile delivery systems, if those items were to fall into the hands of questionable end-users or destined to dubious end-uses.

Missile Technology Control Regime (ECL Group 6)

(www.mtcr.info)

The MTCR was established in 1987 to address concerns about the proliferation of systems capable of delivering weapons of mass destruction, namely chemical, biological or nuclear weapons. Group 6 (Missile Technology Control Regime Annex) includes items agreed upon by the MTCR that are used or could be used in the proliferation of systems capable of delivering chemical, biological or nuclear weapons.

Australia Group (ECL Group 7)

(www.australiagroup.net)

In 1985, Canada, together with a number of other countries, agreed that the proliferation of chemical and biological weapons required immediate attention and formed the Australia Group (AG). The Australia Group controls chemical substances and biological agents and related items that could be used in the production of chemical and biological weapons. Chemical weapon precursors and biological agents and related dual-use items are identified in Group 7 of this Guide.

<u>Chemical Weapons Convention/Biological and Toxin Weapons Convention (ECL Group 7)</u>

Also contained in ECL Group 7 (and to a lesser degree in Group 2) are chemicals and precursors controlled under the Chemical Weapons Convention (CWC). Some of the CWC chemicals and precursors are also controlled by the Australia Group.

K. How to Use the ECL

This Guide contains the ECL, a lengthy and very technical list of items that require permits from DFAIT if they are exported. Understanding how to read the ECL and how to find information in it is vital. This section will help explain how the ECL is organised, and how to find specific information in it.

The ECL is divided into seven different chapters, known as Groups. These Groups each consist of items that in many ways appear similar to each other. The following is a list of all of the Groups, and the items that they control:

Group 1: Dual-use List

Group 2: Munitions List

Group 3: Nuclear Non-Proliferation List

Group 4: Nuclear-Related Dual-use List

Group 5: Miscellaneous Goods and Technology

Group 6: Missile Technology Control Regime List

Group 7: Chemical and Biological Weapons Non - Proliferation List

"Dual-Use" items are industrial products with a civilian/military or nuclear/non-nuclear use.

The text of each Group reflects the international agreement(s) that Canada has entered into concerning the items controlled in that Group. For example, the text of Group 7, which deals with chemical and biological weapons, is very similar to the texts of the Australia Group arrangement on chemical and biological weapons and the Chemical Weapons Convention Treaty.

Each portion of distinct information in the ECL is known as an Item. Items are the bits of information that make up the ECL, and are collected into the Groups. Items are numbered to make it easier to find the information.

Numbering of Items reflects the Group that contains that Item. For example, in Group 2 (Munitions), all of the Items begin with the number 2. For example, Item 2-4 includes bombs, torpedoes and rockets. Item 2-5 includes fire control systems, such as bomb sights. Group 4 Items (Nuclear-Related Dual-Use) begin with the number 4, Group 6 Items (Missile Technology Control Regime) begin with the number 6, and so on. This is important to remember, and makes it easier to find a listed item.

Sub-Items are also given unique numbers. Numbers for sub-items are based upon the main Item number to which the sub-item refers: for example, Item 2-4.a. is a sub-item of Item 2-4. When there are many sub-items, the numbering can become complicated. Consider, for example, Item 1-6.A. has dozens of sub-items, of which one is 1-6.A.5.c.2.b.1., which addresses Q-switched lasers.

As evidenced by the example above, the number of sub-items alternates between number and letter. Thus, in 1-6.A.5.c.2.b.1.:

1-6.A. is the main Item
5. is the first level of sub-item
c. is the second level of sub-item
2. is the third level
...etc.

In addition to numbering, sub-items are identified by indentations in the text.

Many of the terms in the ECL are in quotations. For example, 'aircraft' appears several times. These quotes signify that the word or phrase contained in the quotes has a specific definition in the Guide. The definitions for terms are found at the end of each Group, and apply to that specific Group. The definitions originate from the various international agreements and arrangements to which Canada subscribes.

Below is an example that illustrates the text of the ECL. It may help demonstrate how the numbering system is structured, and how Items/sub-items relate to one another.

Example of ECL Text:

1-8.A. Systems, Equipment and Components

1. a. Manned, tethered submersible vehicles designed to operate at depths exceeding 1,000 m:

- b. Manned, untethered submersible vehicles having any of the following:
 - 1. Designed to operate autonomously and having a lifting capacity of all the following:
 - a. 10% or more of their weight in air; and
 - b. 15 kN or more;

This large number is the main Item number: Item 1-8.A. It is part of Group 1 (Dual-Use Goods).

This would be sub-item '1-8.A.1.' The first level of sub-division is flush with the left margin.

Additional levels of sub-division are indented directly below the previous level.

This item is the fourth level of subdivision and would be identified as subitem '1-8.A.1.b.1.b.'

Exporters should know specifically what products they deal with, and if those items are controlled. There are two main ways to try to locate specific items on the ECL:

- Use the Index to specifically find the Item; or
- Search through Groups that contain like products to find any Items that might apply to your items.

The first step is obvious. At the back of this Guide is a detailed, but not exhaustive, index to items found in the ECL. By using this index, readers can quickly find all of the important references the ECL may have concerning a specific good. Exporters are cautioned that the index is not all-inclusive and that generic names or other terms may be used in place of common or trade terminology.

If specific items are not mentioned in the Index, exporters are advised to review the pertinent sections of the Guide to find out if controls nonetheless apply. This is because some ECL Items apply to a large number of items but do not list them by name; hence the items do not appear in the index. Exporters are encouraged to contact the responsible government department or agency if there is any doubt about the applicability of a particular product or commodity. Item 5400, in Group 5 of the ECL, is a good example of this. No specific items are mentioned in Item 5400, but all US origin items as defined therein require an export permit, regardless of the nature of the item, when exported to any destination other than the US

Items Identified Under More Than One Group /ECL Item of this Guide

Each Group of this Guide must be considered independently, but goods or technology identified in one Group/ECL Item may also be identified in other Groups/ECL Items. Exporters should ensure that they have reviewed this Guide in sufficient detail to assure themselves that all relevant Groups/ECL Items have been considered.

Export Control List Numbering System

In the following pages readers will notice that the numbering has changed for most Groups and most Items in the ECL. This new numbering represents changes to numbering in the international lists as agreed in the various regimes. This will permit greater compatibility when identifying like or similar goods.

While the numbering of Items in Group 5 remains unchanged, Groups 1, 2, 3, 4, 6 and 7 have been changed. The following highlight these changes:

In Group 1 the first 2 digits have been replaced by a "1-". The third digit represents the Category (there are 9 Categories in Group 1) and the fourth digit has been replaced by a letter: "systems, equipment and components" (A), "test, inspection and production equipment" (B), "materials" (C), "software" (D) or "technology" (E). The numbers and letters that follow this 'letter' define the appropriate Sub-Item.

In Groups 3, 4, 6 and 7, the first 2 digits have been replaced by a "3-", "4-", "6-" or "7-". The third digit represents the general description of the Item and the fourth digit has been replaced by a letter: "systems, equipment and components" (A), "test, inspection and production equipment" (B), "materials" (C), "software" (D) or "technology" (E). The numbers and letters that follow this 'letter' define the appropriate Sub-Item.

L. Goods Subject to Import Controls

Canada has a range of goods over which it imposes import controls. These goods are listed in the Import Control List (ICL) of the Export and Import Permits Act. Military goods and firearms are controlled by paragraphs 70-73 and 91, and Chemical Weapons Convention items are controlled by paragraph 74 of the ICL.

Applications for import permits for these items must be submitted to TIE. Application forms may be requested from TIE.

Current policy allows for the waiver of an import permit for goods set out in Para 70, (1), a) and b), firearms and their parts, when destined to sporting or recreational use.

International Import Certificates

A Canadian-issued International Import Certificate (IIC) may be required by an exporting country prior to that country authorising an export permit/licence. An IIC does not replace an import permit where a permit is required. Application forms may be requested from TIE.

M. Notices to Exporters and Notices to Importers

TIE issues various Notices to Exporters and Notices to Importers to assist the exporting community in understanding current policies and procedures. The current list of Notices to Exporters and Notices to Importers are available on the TIE website or by contacting TIE.

Group 1 - Dual-Use List

Note:

Terms in "quotation" are defined terms. Refer to 'Definitions of Terms used in these Lists' annexed to this List at the end of Group 2. References to the "Dual-Use List" and "Munitions List" within Groups 1 and 2 refer to the "Group 1 - Dual-Use List" and the "Group 2 - Munitions List" respectively.

General "Technology" Note

The export of "technology" which is "required" for the "development", "production" or "use" of items controlled in the Dual-Use List is controlled according to the provisions in each Category. This "technology" remains under control even when applicable to any uncontrolled item.

Controls do not apply to that "technology" which is the minimum necessary for the installation, operation, maintenance (checking) and repair of those items which are not controlled or whose export has been authorised.

Note:

This does not release such "technology" controlled in entries 1-1.E.2.e. & 1-1.E.2.f. and 1-8.E.2.a. & 1-8.E.2.b.

Controls do not apply to "technology" "in the public domain", to "basic scientific research" or to the minimum necessary information for patent applications.

General "Software" Note

The Lists do not control "software" which is either:

- 1. Generally available to the public by being:
 - a. Sold from stock at retail selling points, without restriction, by means of:
 - Over-the-counter transactions;
 - 2. Mail order transactions;
 - 3. Electronic Transactions; or
 - 4. Telephone call transactions; and
 - Designed for installation by the user without further substantial support by the supplier; or

Note:

Entry 1 of the General Software Note does not release "software" controlled by Category 5-Part 2 ("Information Security").

2. "In the public domain".

Category 1: Advanced Materials

1-1.A. Systems, Equipment and Components

- 1. Components made from fluorinated compounds, as follows:
 - a. Seals, gaskets, sealants or fuel bladders specially designed for "aircraft" or aerospace use made from more than 50% by weight of any of the materials controlled by 1-1.C.9.b. or 1-1.C.9.c.:
 - b. Piezoelectric polymers and copolymers made from vinylidene fluoride materials controlled by 1-1.C.9.a.:
 - 1. In sheet or film form; and
 - 2. With a thickness exceeding 200 µm;
 - c. Seals, gaskets, valve seats, bladders or diaphragms made from fluoroelastomers containing at least one vinylether group as a constitutional unit, specially designed for "aircraft", aerospace or missile use.
- 2. "Composite" structures or laminates, having any of the following:
 - a. An organic "matrix" and made from materials controlled by 1-1.C.10.c., 1-1.C.10.d. or 1-1.C.10.e.; **or**

Note:

1-1.A.2.a. does not control finished or semi-finished items specially designed for purely civilian applications as follows:

- a. Sporting goods;
- b. Automotive industry:
- c. Machine tool industry;
- d. Medical applications.

- b. A metal or carbon "matrix" and made from:
 - 1. Carbon "fibrous or filamentary materials" with:
 - a. A specific modulus exceeding 10.15 x 10⁶ m; and
 - b. A specific tensile strength exceeding $17.7 \times 10^4 \text{ m}$; or
 - 2. Materials controlled by 1-1.C.10.c.

Note:

1-1.A.2.b. does not control finished or semi-finished items specially designed for purely civilian applications as follows:

- 1. Sporting goods;
- 2. Automotive industry;
- 3. Machine tool industry;
- 4. Medical applications.

Technical Notes:

- Specific modulus: Young's modulus in pascals, equivalent to N/m² divided by specific weight in N/m³, measured at a temperature of (296 ± 2) K ((23 ± 2)°C) and a relative humidity of (50 ± 5)%.
- Specific tensile strength: ultimate tensile strength in pascals, equivalent to N/m² divided by specific weight in N/m³, measured at a temperature of (296 ± 2) K((23 ± 2)°C) and a relative humidity of (50 ± 5)%.

Note:

1-1.A.2. does not control composite structures or laminates made from epoxy resin impregnated carbon "fibrous or filamentary materials" for the repair of aircraft structures or laminates, provided the size does not exceed 1 m².

- 3. Manufactures of non-fluorinated polymeric substances controlled by 1-1.C.8.a.3., in film, sheet, tape or ribbon form:
 - a. With a thickness exceeding 0.254 mm; or
 - Coated or laminated with carbon, graphite, metals or magnetic substances.

Note:

1-1.A.3. does not control manufactures when coated or laminated with copper and designed for the production of electronic printed circuit boards.

- 4. Protective and detection equipment and components not specially designed for military use, as follows:
 - a. Gas masks, filter canisters and decontamination equipment therefor designed or modified for defence against biological agents or radioactive materials "adapted for use in war" or chemical warfare (CW) agents and specially designed components therefor;
 - Protective suits, gloves and shoes specially designed or modified for defence against biological agents or radioactive materials "adapted for use in war" or chemical warfare (CW) agents;
 - c. Nuclear, biological and chemical (NBC) detection systems specially designed or modified for detection or identification of biological agents or radioactive materials "adapted for use in war" or chemical warfare (CW) agents and specially designed components therefor.

Note:

Item 1-1.A.4. does not control:

- a. Personal radiation monitoring dosimeters;
- b. Equipment limited by design or function to protect against hazards specific to civil industries, such as mining, quarrying, agriculture, pharmaceuticals, medical, veterinary, environmental, waste management, or to the food industry.
- Body armour, and specially designed components therefor, not manufactured to military standards or specifications, nor to their equivalents in performance.

N.B.:

For "fibrous or filamentary materials" used in the manufacture of body armour, see entry 1-1.C.10.

Note 1:

1-1.A.5. does not control individual suits of body armour and accessories therefor, when accompanying their users for his/her own personal protection.

Note 2:

1-1.A.5 does not control body armour designed to provide frontal protection only from both fragment and blast from non-military explosive devices.

1-1.B. Test, Inspection and Production Equipment

- 1. Equipment for the production of fibres, prepregs, preforms or "composites" controlled by 1-1.A.2. or 1-1.C.10., as follows, and specially designed components and accessories therefor:
 - a. Filament winding machines of which the motions for positioning, wrapping and winding fibres are coordinated and programmed in three or more axes, specially designed for the manufacture of "composite" structures or laminates from "fibrous or filamentary materials";
 - Tape-laying or tow-placement machines of which the motions for positioning and laying tape, tows or sheets are coordinated and programmed in two or more axes, specially designed for the manufacture of "composite" airframe or missile structures;
 - Multidirectional, multidimensional weaving machines or interlacing machines, including adapters and modification kits, for weaving, interlacing or braiding fibres to manufacture "composite" structures;

Technical Note:

For the purposes of 1-1.B.1.c. the technique of interlacing includes knitting.

Note:

1-1.B.1.c. does not control textile machinery not modified for the above end-uses.

- d. Equipment specially designed or adapted for the production of reinforcement fibres, as follows:
 - Equipment for converting polymeric fibres (such as polyacrylonitrile, rayon, pitch or polycarbosilane) into carbon fibres or silicon carbide fibres, including special equipment to strain the fibre during heating;
 - Equipment for the chemical vapour deposition of elements or compounds on heated filamentary substrates to manufacture silicon carbide fibres;
 - 3. Equipment for the wet-spinning of refractory ceramics (such as aluminium oxide);
 - 4. Equipment for converting aluminium containing precursor fibres into alumina fibres by heat treatment;
- e. Equipment for producing prepregs controlled by 1-1.C.10.e. by the hot melt method;
- f. Non-destructive inspection equipment capable of inspecting defects three dimensionally, using ultrasonic or X-ray tomography and specially designed for "composite" materials.
- 2. Equipment for producing metal alloys, metal alloy powder or alloyed materials, specially designed to avoid contamination and specially designed for use in one of the processes in 1-1.C.2.c.2.
- 3. Tools, dies, moulds or fixtures, for "superplastic forming" or "diffusion bonding" titanium or aluminium or their alloys, specially designed for the manufacture of:
 - a. Airframe or aerospace structures;
 - b. "Aircraft" or aerospace engines; or

 Specially designed components for those structures or engines.

1-1.C. Materials

Technical Note:

Metals and alloys

Unless provision to the contrary is made, the words 'metals' and 'alloys' cover crude and semi-fabricated forms, as follows:

Crude forms

Anodes, balls, bars (including notched bars and wire bars), billets, blocks, blooms, brickets, cakes, cathodes, crystals, cubes, dice, grains, granules, ingots, lumps, pellets, pigs, powder, rondelles, shot, slabs, slugs, sponge, sticks;

Semi-fabricated forms (whether or not coated, plated, drilled or punched):

- a. Wrought or worked materials fabricated by rolling, drawing, extruding, forging, impact extruding, pressing, graining, atomizing, and grinding, i.e.: angles, channels, circles, discs, dust, flakes, foils and leaf, forging, plate, powder, pressings and stampings, ribbons, rings, rods (including bare welding rods, wire rods, and rolled wire), sections, shapes, sheets, strip, pipe and tubes (including tube rounds, squares, and hollows), drawn or extruded wire;
- b. Cast material produced by casting in sand, die, metal, plaster or other types of moulds, including high pressure castings, sintered forms, and forms made by powder metallurgy.

The object of the control should not be defeated by the export of non-listed forms alleged to be finished products but representing in reality crude forms or semi-fabricated forms.

- 1. Materials specially designed for use as absorbers of electromagnetic waves, or intrinsically conductive polymers, as follows:
 - a. Materials for absorbing frequencies exceeding 2 x 10^8 Hz but less than 3 x 10^{12} Hz;

Note 1:

1-1.C.1.a. does not control:

- Hair type absorbers, constructed of natural or synthetic fibres, with non-magnetic loading to provide absorption;
- Absorbers having no magnetic loss and whose incident surface is non-planar in shape, including pyramids, cones, wedges and convoluted surfaces;
- c. Planar absorbers, having all of the following characteristics:
 - 1. Made from any of the following:
 - a. Plastic foam materials (flexible or non-flexible) with carbon-loading, or organic materials, including binders, providing more than 5% echo compared with metal over a bandwidth exceeding ±15% of the centre frequency of the incident energy, and not capable of withstanding temperatures exceeding 450 K (177°C); or
 - b. Ceramic materials providing more than 20% echo compared with metal over a bandwidth exceeding ±15% of the centre frequency of the incident energy, and not capable of withstanding temperatures exceeding 800 K (527°C);

Technical Note:

Absorption test samples for 1-1.C.1.a Note 1-1.C.1. should be a square at least 5 wavelengths of the centre frequency on a side and positioned in the far field of the radiating element.

- 2. Tensile strength less than 7 x 10⁶ N/m²; and
- 3. Compressive strength less than 14 x 10⁶ N/m²;
- d. Planar absorbers made of sintered ferrite, having:
 - 1. A specific gravity exceeding 4.4; and
- 2. A maximum operating temperature of 548 K (275°C).

Note 2:

Nothing in this Note 1 releases magnetic materials to provide absorption when contained in paint.

- b. Materials for absorbing frequencies exceeding $1.5 \times 10^{14} \, \text{Hz}$ but less than $3.7 \times 10^{14} \, \text{Hz}$ and not transparent to visible light;
- c. Intrinsically conductive polymeric materials with a bulk electrical conductivity exceeding 10,000 S/m (Siemens per metre) or a sheet (surface) resistivity of less than 100 ohms/ square, based on any of the following polymers:
 - 1. Polyaniline;
 - 2. Polypyrrole;
 - 3. Polythiophene;
 - 4. Poly phenylene-vinylene; or
 - 5. Poly thienylene-vinylene.

Technical Note:

Bulk electrical conductivity and sheet (surface) resistivity should be determined using ASTM D-257 or national equivalents.

Metal alloys, metal alloy powder and alloyed materials, as follows: Note:

1-1.C.2. does not control metal alloys, metal alloy powder and alloyed materials for coating substrates.

Technical Note:

- The metal alloys in 1-1.C.2. are those containing a higher percentage by weight of the stated metal than of any other element.
- Stress-rupture life should be measured in accordance with ASTM Standard E-139 or national equivalents.
- 3. Low cycle fatigue life should be measured in accordance with ASTM Standard E-606 'Recommended Practice for Constant-Amplitude Low-Cycle Fatigue Testing' or national equivalents. Testing should be axial with an average stress ratio equal to 1 and a stress-concentration factor (K_t) equal to 1. The average stress is defined as maximum stress minus minimum stress divided by maximum stress.
- a. Aluminides, as follows:
 - Nickel aluminides containing a minimum of 15 weight percent aluminium, a maximum of 38 weight percent aluminium and at least one additional alloying element;
 - 2. Titanium aluminides containing 10 weight percent or more aluminium and at least one additional alloying element;
- Metal alloys, as follows, made from material controlled by 1-1.C.2.c.:
 - 1. Nickel alloys with:
 - a. A stress-rupture life of 10,000 hours or longer at 923 K (650°C) at a stress of 676 MPa; **or**
 - A low cycle fatigue life of 10,000 cycles or more at 823 K (550°C) at a maximum stress of 1,095 MPa;
 - 2. Niobium alloys with:
 - a. A stress-rupture life of 10,000 hours or longer at 1,073 K (800°C) at a stress of 400 MPa; or
 - b. A low cycle fatigue life of 10,000 cycles or more at 973 K (700°C) at a maximum stress of 700 MPa;
 - 3. Titanium alloys with:
 - a. A stress-rupture life of 10,000 hours or longer at 723 K (450°C) at a stress of 200 MPa; **or**
 - b. A low cycle fatigue life of 10,000 cycles or more at 723 K (450°C) at a maximum stress of 400 MPa;
 - 4. Aluminium alloys with a tensile strength of:
 - a. 240 MPa or more at 473 K (200°C); or
 - b. 415 MPa or more at 298 K (25°C);
 - 5. Magnesium alloys with:
 - a. a tensile strength of 345 MPa or more; and
 - a corrosion rate of less than 1 mm/year in 3% sodium chloride aqueous solution measured in accordance with ASTM standard G-31 or national equivalents;

- c. Metal alloy powder or particulate material having all of the following characteristics:
 - Made from any of the following composition systems: Technical Note:

X in the following equals one or more alloying elements.

- Nickel alloys (Ni-Al-X, Ni-X-Al) qualified for turbine engine parts or components, i.e. with less than 3 nonmetallic particles (introduced during the manufacturing process) larger than 100 μm in 10⁹ alloy particles;
- Niobium alloys (Nb-Al-X or Nb-X-Al, Nb-Si-X or Nb-X-Si, Nb-Ti-X or Nb-X-Ti);
- c. Titanium alloys (Ti-Al-X or Ti-X-Al);
- d. Aluminium alloys (Al-Mg-X or Al-X-Mg, Al-Zn-X or Al-X-Zn, Al-Fe-X or Al-X-Fe); **or**
- e. Magnesium alloys (Mg-Al-X or Mg-X-Al); and
- Made in a controlled environment by any of the following processes:
 - a. "Vacuum atomisation";
 - b. "Gas atomisation";
 - c. "Rotary atomisation";
 - d. "Splat quenching";
 - e. "Melt spinning" and "comminution";
 - f. "Melt extraction" and "comminution"; or
 - g. "Mechanical alloying";
- 3. Capable of forming material controlled by 1-1.C.2.a. or 1-1.C.2.b.
- d. Alloyed materials, having all of the following characteristics:
 - 1. Made from any of the composition systems specified in 1-1.C.2.c.1.;
 - 2. In the form of uncomminuted flakes, ribbons or thin rods; and
 - 3. Produced in a controlled environment by any of the following:
 - a. "Splat quenching";
 - b. "Melt spinning"; or
 - c. "Melt extraction";
- 3. Magnetic metals, of all types and of whatever form, having any of the following characteristics:
 - Initial relative permeability of 120,000 or more and a thickness of 0.05 mm or less;

Technical Note:

Measurement of initial permeability must be performed on fully annealed materials.

- Magnetostrictive alloys, having any of the following characteristics:
 - 1. A saturation magnetostriction of more than 5 x 10⁻⁴; or
 - 2. A magnetomechanical coupling factor (k) of more than 0.8;
- Amorphous or nanocrystalline alloy strips having all of the following characteristics:
 - A composition having a minimum of 75 weight percent of iron, cobalt or nickel;
 - 2. A saturation magnetic induction (B_S) of 1.6 T or more; and
 - 3. Any of the following:
 - a. A strip thickness of 0.02 mm or less; or
 - b. An electrical resistivity of 2 x 10⁻⁴ ohm cm or more.

Technical Note

'Nanocrystalline' materials in 1-1.C.3.c. are those materials having a crystal grain size of 50 nm or less, as determined by X-ray diffraction.

- 4. Uranium titanium alloys or tungsten alloys with a "matrix" based on iron, nickel or copper, having all of the following:
 - a. A density exceeding 17.5 g/cm³;
 - b. An elastic limit exceeding 880 MPa;
 - c. An ultimate tensile strength exceeding 1270 Mpa; and
 - d. An elongation exceeding 8%.
- 5. "Superconductive" "composite" conductors in lengths exceeding 100 m or with a mass exceeding 100 g, as follows:
 - a. Multifilamentary "superconductive" "composite" conductors containing one or more niobium-titanium filaments:
 - 1. Embedded in a "matrix" other than a copper or copper-based mixed "matrix"; **or**
 - 2. Having a cross-section area less than 0.28 x 10⁻⁴ mm² (6 µm in diameter for circular filaments);
 - b. "Superconductive" "composite" conductors consisting of one or more "superconductive" filaments other than niobium-titanium, having all of the following:
 - 1. A "critical temperature" at zero magnetic induction exceeding 9.85 K (-263.31 $^{\circ}$ C) but less than 24 K (-249.16 $^{\circ}$ C);
 - 2. With a cross-section area less than 0.28 x 10⁻⁴ mm²; and
 - 3. Remaining in the "superconductive" state at a temperature of 4.2 K (-268.96°C) when exposed to a magnetic field corresponding to a magnetic induction of 12 T.
- 6. Fluids and lubricating materials, as follows:
 - a. Hydraulic fluids containing, as their principal ingredients, any of the following compounds or materials:
 - 1. Synthetic silahydrocarbon oils, having all of the following:

Technical Note:

For the purpose of 1-1.C.6.a.1., silahydrocarbon oils contain exclusively silicon, hydrogen and carbon.

- a. A flash point exceeding 477 K (204°C);
- b. A pour point at 239 K (-34°C) or less;
- c. A viscosity index of 75 or more; and
- d. A thermal stability at 616 K (343°C); or
- 2. Chlorofluorocarbons, having all of the following: *Technical Note:*

For the purpose of 1-1.C.6.a.2., chlorofluorocarbons contain exclusively carbon, fluorine and chlorine.

- a. No flash point;
- An autogenous ignition temperature exceeding 977 K (704°C);
- c. A pour point at 219 K (-54°C) or less;
- d. A viscosity index of 80 or more; and
- e. A boiling point at 473 K (200°C) or higher;
- b. Lubricating materials containing, as their principal ingredients, any of the following compounds or materials:
 - Phenylene or alkylphenylene ethers or thio-ethers, or their mixtures, containing more than two ether or thio-ether functions or mixtures thereof; or
 - Fluorinated silicone fluids with a kinematic viscosity of less than 5,000 mm²/s (5,000 centistokes) measured at 298 K (25°C);
- c. Damping or flotation fluids with a purity exceeding 99.8%, containing less than 25 particles of 200 µm or larger in size per 100 ml and made from at least 85% of any of the following compounds or materials:
 - 1. Dibromotetrafluoroethane;

- Polychlorotrifluoroethylene (oily and waxy modifications only); or
- 3. Polybromotrifluoroethylene;
- d. Fluorocarbon electronic cooling fluids, having all of the following characteristics:
 - 1. Containing 85% by weight or more of any of the following, or mixtures thereof:
 - a. Monomeric forms of perfluoropolyalkylether-triazines or perfluoroaliphatic-ethers;
 - b. Perfluoroalkylamines;
 - c. Perfluorocycloalkanes; or
 - d. Perfluoroalkanes;
 - 2. Density at 298 K (25°C) of 1.5 g/ml or more;
 - 3. In a liquid state at 273 K (0°C); and
 - 4. Containing 60% or more by weight of fluorine.

Technical Note:

For the purpose of 1-1.C.6.:

- Flash point is determined using the Cleveland Open Cup Method described in ASTM D-92 or national equivalents;
- Pour point is determined using the method described in ASTM D-97 or national equivalents;
- Viscosity index is determined using the method described in ASTM D-2270 or national equivalents;
- d. Thermal stability is determined by the following test procedure or national equivalents:

Twenty ml of the fluid under test is placed in a 46 ml type 317 stainless steel chamber containing one each of 12.5 mm (nominal) diameter balls of M-10 tool steel, 52100 steel and naval bronze (60% Cu, 39% Zn, 0.75% Sn);

The chamber is purged with nitrogen, sealed at atmospheric pressure and the temperature raised to and maintained at $644 \pm 6 \text{ K}$ (371 $\pm 6^{\circ}\text{C}$) for six hours:

The specimen will be considered thermally stable if, on completion of the above procedure, all of the following conditions are met:

- The loss in weight of each ball is less than 10 mg/mm² of ball surface:
- 2. The change in original viscosity as determined at 311 K (38°C) is less than 25%: and
- 3. The total acid or base number is less than 0.40;
- e. Autogenous ignition temperature is determined using the method described in ASTM E-659 or national equivalents.
- 7. Ceramic base materials, non-"composite" ceramic materials, ceramic-"matrix" "composite" materials and precursor materials, as follows:
 - a. Base materials of single or complex borides of titanium having total metallic impurities, excluding intentional additions, of less than 5,000 ppm, an average particle size equal to or less than 5 μ m and no more than 10% of the particles larger than 10 μ m;
 - Non-"composite" ceramic materials in crude or semifabricated form, composed of borides of titanium with a density of 98% or more of the theoretical density;

1-1.C.7.b. does not control abrasives.

- c. Ceramic-ceramic "composite" materials with a glass or oxide-"matrix" and reinforced with fibres having all of the following:
 - 1. Made from any of the following materials:
 - a. Si-N;
 - b. Si-C;
 - c. Si-Al-O-N; or
 - d. Si-O-N; and
 - 2. Having a specific tensile strength exceeding $12.7 \times 10^3 \text{ m}$;

- d. Ceramic-ceramic "composite" materials, with or without a continuous metallic phase, incorporating particles, whiskers or fibres, where carbides or nitrides of silicon, zirconium or boron form the "matrix";
- e. Precursor materials (i.e., special purpose polymeric or metallo-organic materials) for producing any phase or phases of the materials controlled by 1-1.C.7.c., as follows:
 - 1. Polydiorganosilanes (for producing silicon carbide);
 - 2. Polysilazanes (for producing silicon nitride);
 - Polycarbosilazanes (for producing ceramics with silicon, carbon and nitrogen components);
- f. Ceramic-ceramic "composite" materials with an oxide or glass "matrix" reinforced with continuous fibres from any of the following systems:
 - 1. Al₂O₃; or
 - 2. Si-C-N.

1-1.C.7.f. does not control "composites" containing fibres from these systems with a fibre tensile strength of less than 700 MPa at 1,273 K (1,000° C) or fibre tensile creep resistance of more than 1% creep strain at 100 MPa load and 1,273 K (1,000° C) for 100 hours.

- 8. Non-fluorinated polymeric substances, as follows:
 - a. 1. Bismaleimides;
 - 2. Aromatic polyamide-imides;
 - 3. Aromatic polyimides;
 - 4. Aromatic polyetherimides having a glass transition temperature (T_g) exceeding 513 K (240°C).

Note:

1-1.C.8.a. does not control non-fusible compression moulding powders or moulded forms.

- b. Thermoplastic liquid crystal copolymers having a heat distortion temperature exceeding 523 K (250°C) measured according to ISO 75-3 (2004), or national equivalents, with a load of 1.82 N/mm² and composed of:
 - 1. Any of the following:
 - a. Phenylene, biphenylene or naphthalene; or
 - Methyl, tertiary-butyl or phenyl substituted phenylene, biphenylene or naphthalene; and
 - 2. Any of the following acids:
 - a. Terephthalic acid;
 - b. 6-hydroxy-2 naphthoic acid; or
 - c. 4-hydroxybenzoic acid;
- c. Polyarylene ether ketones, as follows:
 - 1. Deleted:
 - 2. Polyether ketone ketone (PEKK);
 - 3. Polyether ketone (PEK);
 - 4. Polyether ketone ether ketone ketone (PEKEKK);
- d. Polyarylene ketones;
- e. Polyarylene sulphides, where the arylene group is biphenylene, triphenylene or combinations thereof;
- f. Polybiphenylenethersulphone having a glass transition temperature (Tg) exceeding 513 K (240°C).

Technical Note:

The glass transition temperature (Tg) for 1-1.C.8. materials is determined using the method described in ISO 11357-2 (1999) or national equivalents.

- 9. Unprocessed fluorinated compounds, as follows:
 - a. Copolymers of vinylidene fluoride having 75% or more beta crystalline structure without stretching;

- Fluorinated polyimides containing 10% by weight or more of combined fluorine;
- Fluorinated phosphazene elastomers containing 30% by weight or more of combined fluorine.
- 10. "Fibrous and filamentary materials" which may be used in organic "matrix", metallic "matrix" or carbon "matrix" "composite" structures or laminates, as follows:
 - a. Organic "fibrous or filamentary materials" having all of the following:
 - 1. A specific modulus exceeding 12.7 x 10⁶ m; and
 - 2. A specific tensile strength exceeding 23.5 x 10^4 m; Note:

1-1.C.10.a. does not control polyethylene.

- b. Carbon "fibrous or filamentary materials", having all of the following:
 - 1. A specific modulus exceeding 12.7 x 10⁶ m; and
 - 2. A specific tensile strength exceeding 23.5 x 10⁴ m; *Technical Note:*

Properties for materials described in 1-1.C.10.b. should be determined using SACMA recommended methods SRM 12 to 17, or national equivalent tow tests, such as Japanese Industrial Standard JIS-R-7601, Paragraph 6.6.2., and based on lot average.

Note:

1-1.C.10.b. does not control fabric made from "fibrous or filamentary materials" for the repair of aircraft structures or laminates, in which the size of individual sheets does not exceed 50 cm x 90 cm.

- Inorganic "fibrous or filamentary materials", having all of the following:
 - 1. A specific modulus exceeding 2.54 x 106 m; and
 - A melting, softening, decomposition or sublimation point exceeding 1,922 K (1,649°C) in an inert environment;

Note:

1-1.C.10.c. does not control:

- Discontinuous, multiphase, polycrystalline alumina fibres in chopped fibre or random mat form, containing 3 weight percent or more silica, with a specific modulus of less than 10 x 10⁶ m;
- 2. Molybdenum and molybdenum alloy fibres;
- 3. Boron fibres;
- Discontinuous ceramic fibres with a melting, softening, decomposition or sublimation point lower than 2,043 K (1,770°C) in an inert environment.
- d. "Fibrous or filamentary materials":
 - 1. Composed of any of the following:
 - a. Polyetherimides controlled by 1-1.C.8.a.; or
 - b. Materials controlled by 1-1.C.8.b. to 1-1.C.8.f.; or
 - 2. Composed of materials controlled by 1-1.C.10.d.1.a. or 1-1.C.10.d.1.b. and "commingled" with other fibres controlled by 1-1.C.10.a., 1-1.C.10.b. or 1-1.C.10.c.;
- e. Resin-impregnated or pitch-impregnated fibres (prepregs), metal or carbon-coated fibres (preforms) or "carbon fibre preforms", as follows:
 - 1. Made from "fibrous or filamentary materials" controlled by 1-1.C.10.a., 1-1.C.10.b. or 1-1.C.10.c.;
 - Made from organic or carbon "fibrous or filamentary materials":
 - a. With a specific tensile strength exceeding $17.7 \times 10^4 \,\mathrm{m}$;
 - b. With a specific modulus exceeding $10.15 \times 10^6 \text{ m}$;
 - c. Not controlled by 1-1.C.10.a. or 1-1.C.10.b.; and
 - d. When impregnated with materials controlled by 1-1.C.8. or 1-1.C.9.b., having a glass transition temperature (T_g) exceeding 383 K (110°C) or with phenolic or epoxy resins, having a glass transition temperature (T_g) equal to or exceeding 418 K (145°C).

1-1.C.10.e. does not control:

- Epoxy resin "matrix" impregnated carbon "fibrous or filamentary materials" (prepregs) for the repair of aircraft structures or laminates, in which the size of individual sheets of prepreg does not exceed 50 cm x 90 cm;
- Prepregs when impregnated with phenolic or epoxy resins having a glass transition temperature (Tg) less than 433 K (160°C) and a cure temperature lower than the glass transition temperature.

Technical Note:

The glass transition temperature (Tg) for 1-1.C.10.e. materials is determined using the method described in ASTM D 3418 using the dry method. The glass transition temperature for phenolic and epoxy resins is determined using the method described in ASTM D 4065 at a frequency of 1 Hz and a heating rate of 2 K (2°C) per minute using the dry method.

Technical Notes:

- Specific modulus: Young's modulus in pascals, equivalent to N/m² divided by specific weight in N/m³, measured at a temperature of (296 ± 2) K ((23 ± 2)°C) and a relative humidity of (50 ± 5)%.
- 2. Specific tensile strength: ultimate tensile strength in pascals, equivalent to N/m^2 divided by specific weight in N/m^3 , measured at a temperature of (296 ± 2) $K((23 \pm 2)^{\circ}C)$ and a relative humidity of (50 ± 5)%.

11. Metals and compounds, as follows:

 a. Metals in particle sizes of less than 60 μm whether spherical, atomised, spheroidal, flaked or ground, manufactured from material consisting of 99% or more of zirconium, magnesium and alloys of these;

Technical Note:

The natural content of hafnium in the zirconium (typically 2% to 7%) is counted with the zirconium.

Note:

The metals or alloys listed in 1-1.C.11.a. are controlled whether or not the metals or alloys are encapsulated in aluminium, magnesium, zirconium or beryllium.

 Boron or boron carbide of 85% purity or higher and a particle size of 60 µm or less;

Note:

The metals or alloys listed in 1-1.C.11.b. are controlled whether or not the metals or alloys are encapsulated in aluminium, magnesium, zirconium or beryllium.

- c. Guanidine nitrate.
- d. Nitroguanidine (NQ) (CAS 556-88-7)
- 12. Materials as follows:

Technical Note:

These materials are typically used for nuclear heat sources.

 a. Plutonium in any form with a plutonium isotopic assay of plutonium-238 of more than 50 % by weight;

Note:

1-1.C.12.a. does not control:

- 1. Shipments with a plutonium content of 1 g or less;
- 2. Shipments of 3 "effective grams" or less when contained in a sensing component in instruments.
- b. "Previously separated" neptunium-237 in any form.

1-1.C.12.b. does not control shipments with a neptunium-237 content of 1 g or less.

1-1.D. Software

1. "Software" specially designed or modified for the "development", "production" or "use" of equipment controlled by 1-1.B.

2. "Software" for the "development" of organic "matrix", metal "matrix" or carbon "matrix" laminates or "composites".

1-1.E. Technology

- 1. "Technology" according to the General Technology Note for the "development" or "production" of equipment or materials controlled by 1-1.A.1.b., 1-1.A.1.c., 1-1.A.2. to 1-1.A.5., 1-1.B. or 1-1.C.
- 2. Other "technology", as follows:
 - a. "Technology" for the "development" or "production" of polybenzothiazoles or polybenzoxazoles;
 - b. "Technology" for the "development" or "production" of fluoroelastomer compounds containing at least one vinylether monomer;
 - c. "Technology" for the design or "production" of the following base materials or non-"composite" ceramic materials:
 - 1. Base materials having all of the following characteristics:
 - a. Any of the following compositions:
 - 1. Single or complex oxides of zirconium and complex oxides of silicon or aluminium;

 - 3. Single or complex carbides of silicon or boron; or

Note

1-1.E.2.f. does not control "technology" for the repair of "civil aircraft" structures using carbon "fibrous or filamentary materials" and epoxy resins, contained in aircraft manufacturers' manuals.

N.B.:

For quiet running bearings, see Item 2-9. on the Munitions List.

 Anti-friction bearings and bearing systems, as follows, and components therefor:

Note:

1-2.A.1. does not control balls with tolerances specified by the manufacturer in accordance with ISO 3290 as grade 5 or worse.

 a. Ball bearings and solid roller bearings having all tolerances specified by the manufacturer in accordance with ISO 492 Tolerance Class 4 (or ANSI/ABMA Std 20 Tolerance Class ABEC-7 or RBEC-7, or other national equivalents), or better, and having both rings and rolling elements (ISO 5593) made from monel or beryllium;

Note:

1-2.A.1.a. does not control tapered roller bearings.

 b. Other ball bearings and solid roller bearings having all tolerances specified by the manufacturer in accordance with ISO 492 Tolerance Class 2 (or ANSI/ABMA Std 20 Tolerance Class ABEC-9 or RBEC-9, or other national equivalents), or better;

Note:

1-2.A.1.b. does not control tapered roller bearings.

- c. Active magnetic bearing systems using any of the following:
 - Materials with flux densities of 2.0 T or greater and yield strengths greater than 414 MPa;
 - All-electromagnetic 3D homopolar bias designs for actuators; or
 - 3. High temperature (450 K (177°C) and above) position sensors.

1-2.B. Test, Inspection and Production Equipment

Technical Notes:

- Secondary parallel contouring axes, (e.g., the w-axis on horizontal boring mills or a secondary rotary axis the centre line of which is parallel to the primary rotary axis) are not counted in the total number of contouring axes. Rotary axes need not rotate over 360°. A rotary axis can be driven by a linear device (e.g., a screw or a rack-and-pinion).
- 2. For the purposes of 1-2.B., the number of axes which can be co-ordinated simultaneously for "contouring control" is the number of axes along or around which, during processing of the workpiece, simultaneous and interrelated motions are performed between the workpiece and a tool. This does not include any additional axes along or around which other relative motions within the machine are performed, such as:
 - a. Wheel-dressing systems in grinding machines;
 - b. Parallel rotary axes designed for mounting of separate workpieces;
 - Co-linear rotary axes designed for manipulating the same workpiece by holding it in a chuck from different ends.
- Axis nomenclature shall be in accordance with International Standard ISO 841, 'Numerical Control Machines - Axis and Motion Nomenclature'.
- 4. For the purposes of this Category a "tilting spindle" is counted as a rotary axis.
- 5. Stated positioning accuracy levels derived from measurements made according to ISO 230/2 (1997) or national equivalents may be used for each machine tool model instead of individual machine tests. Stated positioning accuracy means the accuracy value provided to national licensing authorities as representative of the accuracy of a machine model.

Determination of Stated Values:

- a. Select five machines of a model to be evaluated;
- b. Measure the linear axis accuracies according to ISO 230/2 (1997);
- Determine the A-values for each axis of each machine. The method of calculating the A-value is described in the ISO standard;
- Determine the mean value of the A-value of each axis. This mean value becomes the stated value of each axis for the model (Âx, Ây...);
- Since the Category 2 list refers to each linear axis there will be as many stated values as there are linear axes;
- f. If any axis of a machine model not controlled by 1-2.B.1.a. to c. has a stated accuracy of 5 microns for grinding machines and 6.5 microns for milling and turning machines or better, the builder should be required to reaffirm the accuracy level once every eighteen months.
- Machine tools, as follows, and any combination thereof, for removing (or cutting) metals, ceramics or "composites", which, according to the manufacturer's technical specification, can be equipped with electronic devices for "numerical control", and specially designed components as follows:

Note 1:

1-2.B.1. does not control special purpose machine tools limited to the manufacture of gears. For such machines, see Item 1-2.B.3.

Note 2:

1-2.B.1. does not control special purpose machine tools limited to the manufacture of any of the following parts:

- a. Crank shafts or cam shafts;
- b. Tools or cutters;
- c. Extruder worms;
- d. Engraved or facetted jewellery parts.

Note 3

A machine tool having at least two of the three turning, milling or grinding capabilities (e.g., a turning machine with milling capability), must be evaluated against each applicable entry 1-2.B.1.a., b. or c.

- Machine tools for turning, having all of the following characteristics:
 - Positioning accuracy with "all compensations available" equal to or less (better) than 4.5 µm according to ISO 230/2 (1997) or national equivalents along any linear axis; and
 - Two or more axes which can be coordinated simultaneously for "contouring control";

Note:

1-2.B.1.a. does not control turning machines specially designed for the production of contact lenses.

- b. Machine tools for milling, having any of the following characteristics:
 - 1. Having all of the following:
 - a. Positioning accuracy with "all compensations available" equal to or less (better) than 4.5 μ m according to ISO 230/2 (1997) or national equivalents along any linear axis; **and**
 - b. Three linear axes plus one rotary axis which can be coordinated simultaneously for "contouring control";
 - 2. Five or more axes which can be coordinated simultaneously for "contouring control";
 - A positioning accuracy for jig boring machines, with "all compensations available", equal to or less (better) than 3.0 μm according to ISO 230/2 (1997) or national equivalents along any linear axis; or
 - 4. Fly cutting machines, having all of the following characteristics:
 - a. Spindle "run-out" and "camming" less (better) than 0.0004 mm TIR; and

- Angular deviation of slide movement (yaw, pitch and roll) less (better) than 2 seconds of arc, TIR, over 300 mm of travel.
- Machine tools for grinding, having any of the following characteristics:
 - 1. Having all of the following:
 - a. Positioning accuracy with "all compensations available" equal to or less (better) than 3.0 μ m according to ISO 230/2 (1997) or national equivalents along any linear axis; **and**
 - b. Three or more axes which can be coordinated simultaneously for "contouring control"; or
 - 2. Five or more axes which can be coordinated simultaneously for "contouring control";

1-2.B.1.c. does not control grinding machines, as follows:

- Cylindrical external, internal, and external-internal grinding machines having all the following characteristics:
 - a. Limited to cylindrical grinding; and
 - Limited to a maximum workpiece capacity of 150 mm outside diameter or length;
- Machines designed specifically as jig grinders that do not have a z-axis or a w-axis, with a positioning accuracy with "all compensations available" less (better) than 3 μm according to ISO 230/2 (1997) or national equivalents.
- 3. Surface grinders.
- d. Electrical discharge machines (EDM) of the non-wire type which have two or more rotary axes which can be coordinated simultaneously for "contouring control";
- e. Machine tools for removing metals, ceramics or "composites" having all of the following characteristics:
 - 1. Removing material by means of any of the following:
 - Water or other liquid jets, including those employing abrasive additives;
 - b. Electron beam; or
 - c. "Laser" beam; and
 - 2. Having two or more rotary axes which:
 - a. Can be coordinated simultaneously for "contouring control"; and
 - b. Have a positioning accuracy of less (better) than 0.003°;
- f. Deep-hole-drilling machines and turning machines modified for deep-hole-drilling having a maximum depth-of-bore capability exceeding 5,000 mm and specially designed components therefor.
- 2. Numerically controlled machine tools using a magnetorheological finishing (MRF) process equipped to produce nonspherical surfaces and having any of the following characteristics:
 - a. Finishing the form to less (better) than 1.0 µm; or
 - b. Finishing to a roughness less (better) than 100 nm rms.

Technical Note:

For the purposes of 1-2.B.2., 'MRF' is a material removal process using an abrasive magnetic fluid whose viscosity is controlled by a magnetic field.

- 3. "Numerically controlled" or manual machine tools, and specially designed components, controls and accessories therefor, specially designed for the shaving, finishing, grinding or honing of hardened ($R_c = 40$ or more) spur, helical and double-helical gears with a pitch diameter exceeding 1,250 mm and a face width of 15% of pitch diameter or larger finished to a quality of AGMA 14 or better (equivalent to ISO 1328 class 3).
- 4. Hot "isostatic presses", having all of the following, and specially designed components and accessories therefor:

- A controlled thermal environment within the closed cavity and a chamber cavity with an inside diameter of 406 mm or more; and
- b. Any of the following:
 - 1. A maximum working pressure exceeding 207 MPa;
 - A controlled thermal environment exceeding 1,773 K (1,500°C); or
 - A facility for hydrocarbon impregnation and removal of resultant gaseous degradation products.

Technical Note:

The inside chamber dimension is that of the chamber in which both the working temperature and the working pressure are achieved and does not include fixtures. That dimension will be the smaller of either the inside diameter of the pressure chamber or the inside diameter of the insulated furnace chamber, depending on which of the two chambers is located inside the other.

N.B.:

For specially designed dies, moulds and tooling see Items 1-1.B.3., 1-9.B.9. and 2-18. of the Munitions List.

- 5.  - 1. Process modified for one of the following:
 - a. Pulsating CVD;
 - b. Controlled nucleation thermal deposition (CNTD); or
 - c. Plasma enhanced or plasma assisted CVD; and
 - 2. Any of the following:
 - a. Incorporating high vacuum (equal to or less than 0.01 Pa) rotating seals; or
 - b. Incorporating in situ coating thickness control;
 - Ion implantation production equipment having beam currents of 5 mA or more;
 - c. Electron beam physical vapour deposition (EB-PVD) production equipment incorporating power systems rated for over 80 kW, having any of the following:
 - 1. A liquid pool level "laser" control system which regulates precisely the ingots feed rate; **or**
 - A computer controlled rate monitor operating on the principle of photo-luminescence of the ionised atoms in the evaporant stream to control the deposition rate of a coating containing two or more elements;
 - d. Plasma spraying production equipment having any of the following characteristics:
 - Operating at reduced pressure controlled atmosphere (equal to or less than 10 kPa measured above and within 300 mm of the gun nozzle exit) in a vacuum chamber capable of evacuation down to 0.01 Pa prior to the spraying process; or
 - 2. Incorporating in situ coating thickness control;
 - e. Sputter deposition production equipment capable of current densities of 0.1 mA/mm² or higher at a deposition rate of 15 μ m/hr or more;
 - f. Cathodic arc deposition production equipment incorporating a grid of electromagnets for steering control of the arc spot on the cathode;

- g. Ion plating production equipment allowing for the *in situ* measurement of any of the following:
 - 1. Coating thickness on the substrate and rate control; or
 - 2. Optical characteristics.

1-2.B.5.a., 1-2.B.5.b., 1-2.B.5.e., 1-2.B.5.f. and 1-2.B.5.g. do not control chemical vapour deposition, cathodic arc, sputter deposition, ion plating or ion implantation equipment specially designed for cutting or machining tools.

- Dimensional inspection or measuring systems, equipment and "electronic assemblies", as follows:
 - a. Computer controlled, "numerically controlled" co-ordinate measuring machines (CMM), having a three dimensional (volumetric) maximum permissible error of indication (MPEE) at any point within the operating range of the machine (ie., within the length of axes) equal to or less (better) than 1.7 + L/1,000 μm (L is the measured length in mm) tested according to ISO 10360-2 (2001);
 - Linear and angular displacement measuring instruments, as follows:
 - Linear displacement measuring instruments having any of the following:

Technical Note:

For the purpose of 1-2.B.6.b.1., 'linear displacement' means the change of distance between the measuring probe and the measured object.

- a. Non-contact type measuring systems with a "resolution" equal to or less (better) than $0.2~\mu m$ within a measuring range up to 0.2~mm;
- b. Linear voltage differential transformer systems having all of the following characteristics:
 - 1. "Linearity" equal to or less (better) than 0.1% within a measuring range up to 5 mm; **and**
 - 2. Drift equal to or less (better) than 0.1% per day at a standard ambient test room temperature ±1 K; or
- c. Measuring systems having all of the following:
 - 1. Containing a "laser"; and
 - 2. Maintaining, for at least 12 hours, over a temperature range of ± 1 K around a standard temperature and at a standard pressure, all of the following:
 - a. A "resolution" over their full scale of 0.1 μm or less (better); and
 - b. A "measurement uncertainty" equal to or less (better) than (0.2 + L/2,000) μm (L is the measured length in mm);
- d. "Electronic assemblies" specially designed to provide feedback capability in systems controlled by 1-2.B.6.b.1.c.

Note:

1-2.B.6.b.1. does not control measuring interferometer systems, with an automatic control system that is designed to use no feedback techniques, containing a "laser" to measure slide movement errors of machine-tools, dimensional inspection machines or similar equipment.

 Angular displacement measuring instruments having an "angular position deviation" equal to or less (better) than 0.00025°:

Note:

1-2.B.6.b.2. does not control optical instruments, such as autocollimators, using collimated light (e.g., laser light) to detect angular displacement of a mirror.

 Equipment for measuring surface irregularities, by measuring optical scatter as a function of angle, with a sensitivity of 0.5 nm or less (better).

Note:

Machine tools which can be used as measuring machines are controlled if they meet or exceed the criteria specified for the machine tool function or the measuring machine function.

- 7. "Robots", having any of the following characteristics, and specially designed controllers and "end-effectors" therefor:
 - a. Capable in real time of full three-dimensional image processing or full three-dimensional scene analysis to generate or modify "programmes" or to generate or modify numerical programme data;

Technical Note:

The scene analysis limitation does not include approximation of the third dimension by viewing at a given angle, or limited grey scale interpretation for the perception of depth or texture for the approved tasks (2 1/2 D).

- Specially designed to comply with national safety standards applicable to explosive munitions environments;
- c. Specially designed or rated as radiation-hardened to withstand greater than 5 x 10^3 Gy (Si) without operational degradation; or
- d. Specially designed to operate at altitudes exceeding 30,000 m.
- 8. Assemblies or units, specially designed for machine tools, or dimensional inspection or measuring systems and equipment, as follows:
 - a. Linear position feedback units (e.g., inductive type devices, graduated scales, infrared systems or "laser" systems) having an overall "accuracy" less (better) than (800 + (600 x L x 10-3)) nm (L equals the effective length in mm);
 N.B.

For "laser" systems see also Note to 1-2.B.6.b.1.

 Rotary position feedback units (e.g., inductive type devices, graduated scales, infrared systems or "laser" systems) having an "accuracy" less (better) than 0.00025°;

N.B.

For "laser" systems see also Note to 1-2.B.6.b.1.

- c. "Compound rotary tables" and "tilting spindles", capable of upgrading, according to the manufacturer's specifications, machine tools to or above the levels specified in 1-2.B.
- 9. Spin-forming machines and flow-forming machines, which, according to the manufacturer's technical specification, can be equipped with "numerical control" units or a computer control and having all of the following:
 - a. Two or more controlled axes of which at least two can be coordinated simultaneously for "contouring control"; and
 - b. A roller force more than 60 kN.

Technical Note:

Machines combining the function of spin-forming and flow-forming are for the purpose of 1-2.B.9. regarded as flow-forming machines.

1-2.C. Materials

None.

1-2.D.1. for control of "software" for items controlled by 1-2.B.2.

1-2.E. Technology

Table - Deposition Techniques - Notes:

- The term 'coating process' includes coating repair and refurbishing as well as original coating.
- 2. The term 'alloyed aluminide coating' includes single or multiple-step coatings in which an element or elements are deposited prior to or during application of the aluminide coating, even if these elements are deposited by another coating process. It does not, however, include the multiple use of single-step pack cementation processes to achieve alloyed aluminides.
- The term 'noble metal modified aluminide' coating includes multiple-step coatings in which the noble metal or noble metals are laid down by some other coating process prior to application of the aluminide coating.
- The term 'mixtures thereof' includes infiltrated material, graded compositions, co-deposits and multilayer deposits and are obtained by one or more of the coating processes specified in the Table.
- 5. 'MCrAIX' refers to a coating alloy where M equals cobalt, iron, nickel or combinations thereof and X equals hafnium, yttrium, silicon, tantalum in any amount or other intentional additions over 0.01 weight percent in various proportions and combinations, except:
 - a. CoCrAIY coatings which contain less than 22 weight percent of chromium, less than 7 weight percent of aluminium and less than 2 weight percent of yttrium;

- The term 'aluminium alloys' refers to alloys having an ultimate tensile strength of 190 MPa or more measured at 293 K (20°C).
- The term 'corrosion resistant steel' refers to AISI (American Iron and Steel Institute) 300 series or equivalent national standard steels.
- Institute) 300 series or equivalent national standard steels.

 3. 'Refractory metals and alloys' include the following metals and their alloys:

niobium (columbium), molybdenum, tungsten and tantalum.

- 'Sensor window materials', as follows: alumina, silicon, germanium, zinc sulphide, zinc selenide, gallium arsenide, diamond, gallium phosphide, sapphire and the following metal halides: sensor window materials of more than 40 mm diameter zirconium fluoride and hafnium fluoride.
- "Technology" for single-step pack cementation of solid airfoils is not controlled by Category 2.
- 'Polymers', as follows: polyimide, polyester, polysulphide, polycarbonates and polyurethanes.
- 12. 'Modified zirconia' refers to additions of other metal oxides, (e.g., calcia, magnesia, yttria, hafnia, rare earth oxides) to zirconia in order to stabilise certain crystallographic phases and phase compositions. Thermal barrier coatings made of zirconia, modified with calcia or magnesia by mixing or fusion, are not controlled.
- 'Titanium alloys' refers only to aerospace alloys having an ultimate tensile strength of 900 MPa or more measured at 293 K (20°C).
- 'Low-expansion glasses' refers to glasses which have a coefficient of thermal expansion of 1 x 10⁻⁷ K⁻¹ or less measured at 293 K (20°C).
- 15. 'Dielectric layers' are coatings constructed of multi-layers of insulator materials in which the interference properties of a design composed of materials of various refractive indices are used to reflect, transmit or absorb various wavelength bands. Dielectric layers refers to more than four dielectric layers or dielectric/metal "composite" layers.
- 16. 'Cemented tungsten carbide' does not include cutting and forming tool materials consisting of tungsten carbide/(cobalt, nickel), titanium carbide/(cobalt, nickel), chromium carbide/nickel-chromium and chromium carbide/nickel.
- 17. "Technology" specially designed to deposit diamond-like carbon on any of the following is not controlled: magnetic disk drives and heads, equipment for the manufacture of disposables, valves for faucets, acoustic diaphragms for speakers, engine parts for automobiles, cutting tools, punching-pressing dies, office automation equipment, microphones, medical devices or moulds, for casting or moulding of plastics, manufactured from alloys containing less than 5% beryllium.
- 18. 'Silicon carbide' does not include cutting and forming tool materials.

Table - Deposition Techniques - Technical Notes:

Processes specified in Column 1 of the Table are defined as follows:

a. Chemical Vapour Deposition (CVD) is an overlay coating or surface modification coating process wherein a metal, alloy, "composite", dielectric or ceramic is deposited upon a heated substrate. Gaseous reactants are decomposed or combined in the vicinity of a substrate resulting in the

deposition of the desired elemental, alloy or compound material on the substrate. Energy for this decomposition or chemical reaction process may be provided by the heat of the substrate, a glow discharge plasma, or "laser" irradiation.

N.B.1.:

CVD includes the following processes: directed gas flow out-of-pack deposition, pulsating CVD, controlled nucleation thermal deposition (CNTD), plasma enhanced or plasma assisted CVD processes.

N.B.2.:

Pack denotes a substrate immersed in a powder mixture.

NR3

The gaseous reactants used in the out-of-pack process are produced using the same basic reactions and parameters as the pack cementation process, except that the substrate to be coated is not in contact with the powder mixture.

b. Thermal Evaporation-Physical Vapour Deposition (TE-PVD) is an overlay coating process conducted in a vacuum with a pressure less than 0.1 Pa wherein a source of thermal energy is used to vaporize the coating material. This process results in the condensation, or deposition, of the evaporated species onto appropriately positioned substrates.

The addition of gases to the vacuum chamber during the coating process to synthesize compound coatings is an ordinary modification of the process.

The use of ion or electron beams, or plasma, to activate or assist the coating's deposition is also a common modification in this technique. The use of monitors to provide in-process measurement of optical characteristics and thickness of coatings can be a feature of these processes.

Specific TE-PVD processes are as follows:

- Electron Beam PVD uses an electron beam to heat and evaporate the material which forms the coating;
- Ion Assisted Resistive Heating PVD employs electrically resistive heating sources in combination with impinging ion beam(s) to produce a controlled and uniform flux of evaporated coating species;
- "Laser" Vaporization uses either pulsed or continuous wave "laser" beams to vaporize the material which forms the coating;
- 4. Cathodic Arc Deposition employs a consumable cathode of the material which forms the coating and has an arc discharge established on the surface by a momentary contact of a ground trigger. Controlled motion of arcing erodes the cathode surface creating a highly ionized plasma. The anode can be either a cone attached to the periphery of the cathode, through an insulator, or the chamber. Substrate biasing is used for non line-of-sight deposition.

N.B.:

This definition does not include random cathodic arc deposition with non-biased substrates.

- 5. Ion Plating is a special modification of a general TE-PVD process in which a plasma or an ion source is used to ionize the species to be deposited, and a negative bias is applied to the substrate in order to facilitate the extraction of the species from the plasma. The introduction of reactive species, evaporation of solids within the process chamber, and the use of monitors to provide in-process measurement of optical characteristics and thicknesses of coatings are ordinary modifications of the process.
- c. Pack Cementation is a surface modification coating or overlay coating process wherein a substrate is immersed in a powder mixture (a pack), that consists of:
 - The metallic powders that are to be deposited (usually aluminium, chromium, silicon or combinations thereof);
 - 2. An activator (normally a halide salt); and
 - 3. An inert powder, most frequently alumina.

The substrate and powder mixture is contained within a retort which is heated to between 1,030 K (757°C) and 1,375 K (1,102°C) for sufficient time to deposit the coating.

d. Plasma Spraying is an overlay coating process wherein a gun (spray torch) which produces and controls a plasma accepts powder or wire coating materials, melts them and propels them towards a substrate, whereon an integrally bonded coating is formed. Plasma spraying constitutes either low pressure plasma spraying or high velocity plasma spraying.

N.B.1.:

Low pressure means less than ambient atmospheric pressure.

N.B.2.:

High velocity refers to nozzle-exit gas velocity exceeding 750 m/s calculated at 293 K (20°C) at 0.1 MPa.

e. Slurry Deposition is a surface modification coating or overlay coating process wherein a metallic or ceramic powder with an organic binder is suspended in a liquid and is applied to a substrate by either spraying, dipping or painting, subsequent air or oven drying, and heat treatment to obtain the desired coating.

Table - Deposition Techniques - Technical Note:

f. Sputter Deposition is an overlay coating process based on a momentum transfer phenomenon, wherein positive ions are accelerated by an electric field towards the surface of a target (coating material). The kinetic energy of the impacting ions is sufficient to cause target surface atoms to be released and deposited on an appropriately positioned substrate.

N.B.1.:

The Table refers only to triode, magnetron or reactive sputter deposition which is used to increase adhesion of the coating and rate of deposition and to radio frequency (RF) augmented sputter deposition used to permit vapourisation of non-metallic coating materials.

N.B.2.:

Low-energy ion beams (less than 5 keV) can be used to activate the deposition.

g. Ion Implantation is a surface modification coating process in which the element to be alloyed is ionised, accelerated through a potential gradient and implanted into the surface region of the substrate. This includes processes in which ion implantation is performed simultaneously with electron beam physical vapour deposition or sputter deposition.

 - 1. Exceeds 31.8 GHz but does not exceed 43.5 GHz; and
 - Is "allocated by the ITU" for radio-communications services, but not for radio-determination;
- Travelling wave tubes, pulsed or continuous wave, as follows:
 - 1. Operating at frequencies exceeding 31.8 GHz;
 - 2. Having a cathode heater element with a turn on time to rated RF power of less than 3 seconds;
 - 3. Coupled cavity tubes, or derivatives thereof, with a "fractional bandwidth" of more than 7% or a peak power exceeding 2.5 kW;
 - 4. Helix tubes, or derivatives thereof, with any of the following characteristics:
 - a. An "instantaneous bandwidth" of more than one octave, and average power (expressed in kW) times frequency (expressed in GHz) of more than 0.5;

- b. An "instantaneous bandwidth" of one octave or less, and average power (expressed in kW) times frequency (expressed in GHz) of more than 1; or
- c. Being "space qualified";
- b. Crossed-field amplifier tubes with a gain of more than 17 dB;
- c. Impregnated cathodes designed for electronic tubes producing a continuous emission current density at rated operating conditions exceeding 5 A/cm²;
- 2. Microwave monolithic integrated circuits (MMIC) power amplifiers having any of the following:
 - Rated for operation at frequencies exceeding 3.2 GHz up to and including 6 GHz and with an average output power greater than 4W (36 dBm) with a "fractional bandwidth" greater than 15%;
 - b. Rated for operation at frequencies exceeding 6 GHz up to and including 16 GHz and with an average output power greater than 1W (30 dBm) with a "fractional bandwith" greater than 10%;
 - c. Rated for operation at frequencies exceeding 16 GHz up to and including 31.8 GHz and with an average output power greater than 0.8W (29 dBm) with a "fractional bandwidth" greater than 10%;
 - d. Rated for operation at frequencies exceeding 31.8 GHz up to and including 37.5 GHz;
 - e. Rated for operation at frequencies exceeding 37.5 GHz up to and including 43.5 GHz and with an average output power greater than 0.25W (24 dBm) with a "fractional bandwidth" greater than 10%; **or**
 - f. Rated for operation at frequencies exceeding $43.5\,\mathrm{GHz}.$

Note 1

1-3.A.1.b.2. does not control broadcast satellite equipment designed or rated to operate in the frequency range of 40.5 to 42.5 GHz:

Note 2:

The control status of the MMIC whose rated operating frequency includes frequencies listed in more than one frequency range, as defined by 1-3.A.1.b.2.a. through 1-3.A.1.b.2.f., is determined by the lowest average output power control threshold.

Note 3

Notes 1 and 2 in the chapeau to Category 3 mean that 1-3.A.1.b.2. does not control MMICs if they are specially designed for other applications, e.g., telecommunications, radar, automobiles.

- 3. Discrete microwave transistors having any of the following:
 - Rated for operation at frequencies exceeding 3.2 GHz up to and including 6 GHz and having an average output power greater than 60W (47.8 dBm);
 - b. Rated for operation at frequencies exceeding 6 GHz up to and including 31.8 GHz and having an average output power greater than 20W (43 dBm);
 - Rated for operation at frequencies exceeding 31.8 GHz up to and including 37.5 GHz and having an average output power greater than 0.5W (27 dBm);
 - Rated for operation at frequencies exceeding 37.5 GHz up to and including 43.5 GHz and having an average output power greater than 1W (30 dBm); or
 - e. Rated for operation at frequencies exceeding 43.5 GHz. *Note:*

The control status of a transistor whose rated operating frequency includes frequencies listed in more than one frequency range, as defined by 1-3.A.1.b.3.a. through 1-3.A.1.b.3.e., is determined by the lowest average output power control threshold.

- 4. Microwave solid state amplifiers and microwave assemblies/modules containing microwave amplifiers having any of the following:
 - a. Rated for operation at frequencies exceeding 3.2 GHz up to and including 6 GHz and with an average output power greater than 60W (47.8 dBm) with a "fractional bandwidth" greater than 15%;
 - Rated for operation at frequencies exceeding 6 GHz up to and including 31.8 GHz and with an average output power greater than 15W (42 dBm) with a "fractional bandwidth" greater than 10%;
 - c. Rated for operation at frequencies exceeding 31.8 GHz up to and including 37.5 GHz;
 - d. Rated for operation at frequencies exceeding 37.5 GHz up to and including 43.5 GHz and with an average output power greater than 1W (30 dBm) with a "fractional bandwidth" greater than 10%;
 - e. Rated for operation at frequencies exceeding 43.5 GHz; or
 - f. Rated for operation at frequencies above 3.2 GHz and having all of the following;
 - An average output power (in watts), P, greater than 150 divided by the maximum operating frequency (in GHz) squared [P>150 W*GHz²/f_{GHz}²];
 - 2. A fractional bandwidth of 5% or greater; and
 - 3. Any two sides perpendicular to one another with length d (in cm) equal to or less than 15 divided by the lowest operating frequency in GHz [d \leq 15cm*GHz/f_{GHz}].

Technical Note:

3.2 GHz should be used as the lowest operating frequency (f_{GHz}) in the formula in 1-3.A.1.b.4.f.3., for amplifiers that have a rated operation range extending downward to 3.2 GHz and below [d \leq 15cm*GHz/3.2 GHz].

N.B.:

MMIC power amplifiers should be evaluated against the criteria in 1-3.A.1.b.2.

Note 1:

1-3.A.1.b.4. does not control broadcast satellite equipment designed or rated to operate in the frequency range of 40.5 to 42.5 GHz.

Note 2:

The control status of an item whose rated operating frequency includes frequencies listed in more than one frequency range, as defined by 1-3.A.1.b.4.a. through 1-3.A.1.b.4.e., is determined by the lowest average output power control threshold.

- 5. Electronically or magnetically tunable band-pass or bandstop filters having more than 5 tunable resonators capable of tuning across a 1.5:1 frequency band (f_{max} / f_{min}) in less than 10 µs having any of the following:
 - a. A band-pass bandwidth of more than 0.5% of centre frequency; ${\bf or}$
 - A band-stop bandwidth of less than 0.5% of centre frequency;
- 6. Deleted;
- Mixers and converters designed to extend the frequency range of equipment described in 1-3.A.2.c., 1-3.A.2.e. or 1-3.A.2.f. beyond the limits stated therein;
- 8. Microwave power amplifiers containing tubes controlled by 1-3.A.1.b. and having all of the following:
 - a. Operating frequencies above 3 GHz;

- b. An average output power density exceeding 80 W/kg;
 and
- c. A volume of less than 400 cm³;

Note:

1-3.A.1.b.8. does not control equipment designed or rated for operation in any frequency band which is "allocated by the ITU" for radio-communications services, but not for radio-determination.

- Acoustic wave devices, as follows, and specially designed components therefor:
 - Surface acoustic wave and surface skimming (shallow bulk) acoustic wave devices (i.e., "signal processing" devices employing elastic waves in materials), having any of the following:
 - a. A carrier frequency exceeding 2.5 GHz;
 - b. A carrier frequency exceeding 1 GHz but not exceeding 2.5 GHz, and having any of the following:
 - 1. A frequency side-lobe rejection exceeding 55 dB;
 - A product of the maximum delay time and the bandwidth (time in µs and bandwidth in MHz) of more than 100;
 - 3. A bandwidth greater than 250 MHz; or
 - 4. A dispersive delay of more than 10 μs; or
 - c. A carrier frequency 1 GHz or less, having any of the following:
 - A product of the maximum delay time and the bandwidth (time in µs and bandwidth in MHz) of more than 100;
 - 2. A dispersive delay of more than 10 µs; or
 - A frequency side-lobe rejection exceeding 55 dB and a bandwidth greater than 50 MHz;
 - Bulk (volume) acoustic wave devices (i.e., "signal processing" devices employing elastic waves) which permit the direct processing of signals at frequencies exceeding 1 GHz;
 - Acoustic-optic "signal processing" devices employing interaction between acoustic waves (bulk wave or surface wave) and light waves which permit the direct processing of signals or images, including spectral analysis, correlation or convolution;
- d. Electronic devices and circuits containing components, manufactured from "superconductive" materials specially designed for operation at temperatures below the "critical temperature" of at least one of the "superconductive" constituents, with any of the following:
 - Current switching for digital circuits using "superconductive" gates with a product of delay time per gate (in seconds) and power dissipation per gate (in watts) of less than 10-14 J; or
 - Frequency selection at all frequencies using resonant circuits with Q-values exceeding 10,000;
- e. High energy devices, as follows:
 - Batteries and photovoltaic arrays, as follows: Note:

1-3.A.1.e.1. does not control batteries with volumes equal to or less than 27 $\rm cm^3$ (e.g., standard C-cells or R14 batteries).

 a. Primary cells and batteries having an energy density exceeding 480 Wh/kg and rated for operation in the temperature range from below 243 K (-30°C) to above 343 K (70°C); b. Rechargeable cells and batteries having an energy density exceeding 150 Wh/kg after 75 charge/ discharge cycles at a discharge current equal to C/5 hours (C being the nominal capacity in ampere hours) when operating in the temperature range from below 253 K (-20°C) to above 333 K (60°C);

Technical Note:

Energy density is obtained by multiplying the average power in watts (average voltage in volts times average current in amperes) by the duration of the discharge in hours to 75% of the open circuit voltage divided by the total mass of the cell (or battery) in kg.

- c. "Space qualified" and radiation hardened photovoltaic arrays with a specific power exceeding 160 W/m² at an operating temperature of 301 K (28°C) under a tungsten illumination of 1 kW/m² at 2,800 K (2,527°C);
- 2. High energy storage capacitors, as follows:
 - a. Capacitors with a repetition rate of less than 10 Hz (single shot capacitors) having all of the following:
 - 1. A voltage rating equal to or more than 5 kV;
 - An energy density equal to or more than 250 J/kg; and
 - 3. A total energy equal to or more than 25 kJ;
 - b. Capacitors with a repetition rate of 10 Hz or more (repetition rated capacitors) having all of the following:
 - 1. A voltage rating equal to or more than 5 kV;
 - 2. An energy density equal to or more than 50 J/kg;
 - 3. A total energy equal to or more than 100 J; and
 - 4. A charge/discharge cycle life equal to or more than 10,000;
- 3. "Superconductive" electromagnets and solenoids specially designed to be fully charged or discharged in less than one second, having all of the following:

Note:

1-3.A.1.e.3. does not control "superconductive" electromagnets or solenoids specially designed for Magnetic Resonance Imaging (MRI) medical equipment.

- Energy delivered during the discharge exceeding 10 kJ in the first second;
- b. Inner diameter of the current carrying windings of more than 250 mm; **and**
- c. Rated for a magnetic induction of more than $8\ T$ or "overall current density" in the winding of more than $300\ A/mm^2$;
- f. Rotary input type shaft absolute position encoders having any of the following:
 - 1. A resolution of better than 1 part in 265,000 (18 bit resolution) of full scale; **or**
 - 2. An accuracy better than \pm 2.5 seconds of arc.
- 2. General purpose electronic equipment, as follows:
 - a. Recording equipment, as follows, and specially designed test tape therefor:
 - 1. Analogue instrumentation magnetic tape recorders, including those permitting the recording of digital signals (e.g., using a high density digital recording (HDDR) module), having any of the following:
 - a. A bandwidth exceeding 4 MHz per electronic channel or track;
 - b. A bandwidth exceeding 2 MHz per electronic channel or track and having more than 42 tracks; **or**

c. A time displacement (base) error, measured in accordance with applicable IRIG or EIA documents, of less than \pm 0.1 μ s;

Note:

Analogue magnetic tape recorders specially designed for civilian video purposes are not considered to be instrumentation tape recorders.

 Digital video magnetic tape recorders having a maximum digital interface transfer rate exceeding 360 Mbit/s; Note:

1-3.A.2.a.2. does not control digital video magnetic tape recorders specially designed for television recording using a signal format, which may include a compressed signal format, standardised or recommended by the ITU, the IEC, the SMPTE, the EBU, the ETSI or the IEEE for civil television applications.

- 3. Digital instrumentation magnetic tape data recorders employing helical scan techniques or fixed head techniques, having any of the following:
 - a. A maximum digital interface transfer rate exceeding 175 Mbit/s; or
 - b. Being "space qualified";

Note:

1-3.A.2.a.3. does not control analogue magnetic tape recorders equipped with HDDR conversion electronics and configured to record only digital data.

- Equipment, having a maximum digital interface transfer rate exceeding 175 Mbit/s, designed to convert digital video magnetic tape recorders for use as digital instrumentation data recorders;
- Waveform digitisers and transient recorders having all of the following:
 - Digitising rates equal to or more than 200 million samples per second and a resolution of 10 bit or more;
 and
 - b. A continuous throughput of 2 Gbit/s or more;

Technical Note:

For those instruments with a parallel bus architecture, the continuous throughput rate is the highest word rate multiplied by the number of bits in a word.

Continuous throughput is the fastest data rate the instrument can output to mass storage without the loss of any information whilst sustaining the sampling rate and analogue-to-digital conversion.

- 6. Digital instrumentation data recorders, using magnetic disk storage technique, having all of the following:
 - Digitising rates equal to or more than 100 million samples per second and a resolution of 8 bit or more;
 and
 - b. A continuous throughput of 1 Gbit/s or more;
- b. "Frequency synthesiser" "electronic assemblies" having a "frequency switching time" from one selected frequency to another of less than 1 ms;
- c. Radio frequency "signal analysers", as follows:
 - 1. "Signal analysers" capable of analyzing any frequencies exceeding 31.8 GHz but not exceeding 37.5 GHz and having a 3 dB resolution bandwidth (RBW) exceeding 10 MHz;
 - "Signal analysers" capable of analyzing frequencies exceeding 43.5 GHz;
 - "Dynamic signal analysers" having a "real-time bandwidth" exceeding 500 kHz;

1-3.A.2.c.3. does not control those "dynamic signal analysers" using only constant percentage bandwidth filters (also known as octave or fractional octave filters).

- d. Frequency synthesised signal generators producing output frequencies, the accuracy and short term and long term stability of which are controlled, derived from or disciplined by the internal master frequency, and having any of the following:
 - A maximum synthesised frequency exceeding 31.8 GHz but not exceeding 43.5 GHz and rated to generate a pulse duration of less than 100ns;
 - 2. A maximum synthesised frequency exceeding 43.5 GHz
 - 3. A "frequency switching time" from one selected frequency to another of less than 1 ms; or
 - A single sideband (SSB) phase noise better than -(126 + 20 log₁₀F - 20 log₁₀f) in dBc/Hz, where F is the off-set from the operating frequency in Hz and f is the operating frequency in MHz;

Technical Note:

For the purposes of 1-3.A.2.d.1. 'pulse duration' is defined as the time interval between the leading edge of the pulse achieving 90% of the peak and the trailing edge of the pulse achieving 10% of the peak.

Note:

1-3.A.2.d. does not control equipment in which the output frequency is either produced by the addition or subtraction of two or more crystal oscillator frequencies, or by an addition or subtraction followed by a multiplication of the result.

- Network analysers with a maximum operating frequency exceeding 43.5 GHz;
- f. Microwave test receivers having all of the following:
 - A maximum operating frequency exceeding 43.5 GHz; and
 - 2. Being capable of measuring amplitude and phase simultaneously;
- g. Atomic frequency standards having any of the following:
 - Long term stability (aging) less (better) than 1 x 10⁻¹¹/month; or
 - 2. Being "space qualified".

Note:

1-3.A.2.g.1. does not control non-"space qualified" rubidium standards.

3. Spray cooling thermal management systems employing closed loop fluid handling and reconditioning equipment in a sealed enclosure where a dielectric fluid is sprayed onto electronic components using specially designed spray nozzles that are designed to maintain electronic components within their operating temperature range, and specially designed components therefor.

1-3.B. Test, Inspection and Production Equipment

- 1. Equipment for the manufacturing of semiconductor devices or materials, as follows, and specially designed components and accessories therefor:
 - a. Equipment designed for epitaxial growth, as follows:
 - Equipment capable of producing a layer of any material other than silicon with a thickness uniform to less than ±2.5% across a distance of 75 mm or more;
 - Metal organic chemical vapour deposition (MOCVD) reactors specially designed for compound semiconductor crystal growth by the chemical reaction between materials controlled by 1-3.C.3. or 1-3.C.4.;

- Molecular beam epitaxial growth equipment using gas or solid sources;
- Equipment designed for ion implantation, having any of the following:
 - 1. A beam energy (accelerating voltage) exceeding 1 MeV;
 - 2. Being specially designed and optimised to operate at a beam energy (accelerating voltage) of less than 2 keV;
 - 3. Direct write capability; or
 - 4. A beam energy of 65 keV or more and a beam current of 45 mA or more for high energy oxygen implant into a heated semiconductor material "substrate";
- c. Anisotropic plasma dry etching equipment, as follows:
 - 1. Equipment with cassette-to-cassette operation and load-locks, and having any of the following:
 - a. Designed or optimised to produce critical dimensions of 180 nm or less with ±5% 3 sigma precision; or
 - b. Designed for generating less than 0.04 particles/cm² with a measurable particle size greater than 0.1 μm in diameter;
 - 2. Equipment specially designed for equipment controlled by 1-3.B.1.e. and having any of the following:
 - a. Designed or optimised to produce critical dimensions of 180 nm or less with ±5% 3 sigma precision; or
 - b. Designed for generating less than 0.04 particles/cm² with a measurable particle size greater than 0.1 μm in diameter;
- d. Plasma enhanced CVD equipment, as follows:
 - Equipment with cassette-to-cassette operation and loadlocks, and designed according to the manufacturer's specifications or optimised for use in the production of semiconductor devices with critical dimensions of 180 nm or less:
 - Equipment specially designed for equipment controlled by 1-3.B.1.e. and designed according to the manufacturer's specifications or optimised for use in the production of semiconductor devices with critical dimensions of 180 nm or less:
- e. Automatic loading multi-chamber central wafer handling systems, having all of the following:
 - Interfaces for wafer input and output, to which more than two pieces of semiconductor processing equipment are to be connected; and
 - Designed to form an integrated system in a vacuum environment for sequential multiple wafer processing;

Note:

1-3.B.1.e. does not control automatic robotic wafer handling systems not designed to operate in a vacuum environment.

- f. Lithography equipment, as follows:
 - Align and expose step and repeat (direct step on wafer) or step and scan (scanner) equipment for wafer processing using photo-optical or X-ray methods, having any of the following:
 - a. A light source wavelength shorter than 245 nm; or
 - b. Capable of producing a pattern with a minimum resolvable feature size of 180 nm or less;

Technical Note:

The minimum resolvable feature size is calculated by the following formula:

MRF = (an exposure light source wavelength in nm) x (K factor)
numerical aperture

where the K factor = 0.45 MRF = minimum resolvable feature size.

- Equipment specially designed for mask making or semiconductor device processing using deflected focussed electron beam, ion beam or "laser" beam, having any of the following:
 - a. A spot size smaller than 0.2 µm;
 - b. Being capable of producing a pattern with a feature size of less than 1 μm ; or
 - c. An overlay accuracy of better than $\pm 0.20~\mu m$ (3 sigma);
- g. Masks and reticles designed for integrated circuits controlled by 1-3.A.1.;
- h. Multi-layer masks with a phase shift layer.

1-3.B.1.h. does not control multi-layer masks with a phase shift layer designed for the fabrication of memory devices not controlled by 1-3.A.1.

- 2. Test equipment, specially designed for testing finished or unfinished semiconductor devices, as follows, and specially designed components and accessories therefor:
 - For testing S-parameters of transistor devices at frequencies exceeding 31.8 GHz;
 - b. Deleted.
 - c. For testing microwave integrated circuits controlled by 1-3.A.1.b.2.

1-3.C. Materials

- 1. Hetero-epitaxial materials consisting of a "substrate" having stacked epitaxially grown multiple layers of any of the following:
 - a. Silicon;
 - b. Germanium;
 - c. Silicon Carbide; or
 - d. III/V compounds of gallium or indium.

Technical Note:

III/V compounds are polycrystalline or binary or complex monocrystalline products consisting of elements of groups IIIA and VA of Mendeleyev's periodic classification table (e.g., gallium arsenide, gallium-aluminium arsenide, indium phosphide).

- Resist materials, as follows, and "substrates" coated with controlled resists:
 - a. Positive resists designed for semiconductor lithography specially adjusted (optimised) for use at wavelengths below 350 nm;
 - b. All resists, designed for use with electron beams or ion beams, with a sensitivity of 0.01 μcoulomb/mm² or better;
 - All resists, designed for use with X-rays, with a sensitivity of 2.5 mJ/mm² or better;
 - d. All resists optimised for surface imaging technologies, including silvlated resists.

Technical Note:

Silylation techniques are defined as processes incorporating oxidation of the resist surface to enhance performance for both wet and dry developing.

- 3. Organo-inorganic compounds as follows:
 - a. Organo-metallic compounds of aluminium, gallium or indium having a purity (metal basis) better than 99.999%;
 - Organo-arsenic, organo-antimony and organo-phosphorus compounds having a purity (inorganic element basis) better than 99.999%.

Note:

1-3.C.3. only controls compounds whose metallic, partly metallic or non-metallic element is directly linked to carbon in the organic part of the molecule.

4. Hydrides of phosphorus, arsenic or antimony, having a purity better than 99.999%, even diluted in inert gases or hydrogen.

1-3.C.4. does not control hydrides containing 20% molar or more of inert gases or hydrogen.

1-3.D. Software

- 1. "Software" specially designed for the "development" or "production" of equipment controlled by 1-3.A.1.b. to 1-3.A.2.g. or 1-3.B.
- 2. "Software" specially designed for the "use" of any of the following:
 - a. Equipment controlled by 1-3.B.1.a. to f.; or
 - b. Equipment controlled by 1-3.B.2.
- Physics-based simulation "software" specially designed for the "development" of lithographic, etching or deposition processes for translating masking patterns into specific topographical patterns in conductors, dielectrics or semiconductor materials. Technical Note:

'Physics-based' in 1-3.D.3. means using computations to determine a sequence of physical cause and effect events based on physical properties (e.g., temperature, pressure, diffusion constants and semiconductor materials properties).

Note:

Libraries, design attributes or associated data for the design of semiconductor devices or integrated circuits are considered as "technology".

4. "Software" specially designed for the "development" of the equipment controlled by 1-3.A.3.

1-3.E. Technology

1. "Technology" according to the General Technology Note for the "development" or "production" of equipment or materials controlled by 1-3.A., 1-3.B. or 1-3.C.

Note:

1-3.E.1. does not control "technology" for the "production" of equipment or components controlled by 1-3.A.3.

2. "Technology" according to the General Technology Note other than that controlled in 1-3.E.1. for the "development" or "production" of "microprocessor microcircuits", "micro-computer microcircuits" and microcontroller microcircuits having a "composite theoretical performance" ("CTP") of 530 million theoretical operations per second (Mtops) or more and an arithmetic logic unit with an access width of 32 bit or more. Note:

1-3.E.1. and 1-3.E.2. do not control "technology" for the "development" or "production" of integrated circuits controlled by 1-3.A.1.a.3. to 1-3.A.1.a.12., having all of the following:

- 1. Using "technology" of 0.5 μm or more; and
- 2. Not incorporating multi-layer structures.

Technical Note:

The term multi-layer structures in Note 2 above does not include devices incorporating a maximum of three metal layers and three polysilicon layers.

- 3. Other "technology" for the "development" or "production" of:
 - a. Vacuum microelectronic devices;
 - Hetero-structure semiconductor devices such as high electron mobility transistors (HEMT), hetero-bipolar transistors (HBT), quantum well and super lattice devices;

1-3.E.3.b. does not control technology for high electron mobility transistors (HEMT) operating at frequencies lower than 31.8 GHz and hetero-junction bipolar transistors (HBT) operating at frequencies lower than 31.8 GHz.

- c. "Superconductive" electronic devices;
- d. Substrates of films of diamond for electronic components;
- Substrates of silicon-on-insulator (SOI) for integrated circuits in which the insulator is silicon dioxide;
- f. Substrates of silicon carbide for electronic components;
- g. Electronic vacuum tubes operating at frequencies of 31.8 GHz or higher.

Category 4: Computers

Note 1:

Computers, related equipment and "software" performing telecommunications or "local area network" functions must also be evaluated against the performance characteristics of Category 5, Part 1 (Telecommunications).

Control units which directly interconnect the buses or channels of central processing units, "main storage" or disk controllers are not regarded as telecommunications equipment described in Category 5, Part 1 (Telecommunications).

N.B.

For the control status of "software" specially designed for packet switching, see Category 1-5.D.1. (Telecommunications).

Note 3:

Note:

1-4.A.1.a.1. does not apply to computers specially designed for civil automobile or railway train applications.

2. Radiation hardened to exceed any of the following specifications:

a. Total Dose
 b. Dose Rate Upset
 c. Single Event Upset
 5 x 10³ Gy (Si);
 5 x 10⁶ Gy (Si)/s; or
 1 x 10⁻⁷ Error/bit/day;

b. Having characteristics or performing functions exceeding the limits in Category 5, Part 2 ("Information Security").

Note:

1-4.A.1.b. does not control electronic computers and related equipment when accompanying their user for the user's personal use.

- 2. Deleted.
- "Digital computers", "electronic assemblies", and related equipment therefor, as follows, and specially designed components therefor:

Note 1:

1-4.A.3. includes the following:

Vector processors;

- b. Array processors:
- c. Digital signal processors;
- d. Logic processors;
- e. Equipment designed for "image enhancement";
- f. Equipment designed for "signal processing".

Note 2:

The control status of the "digital computers" and related equipment described in 1-4.A.3. is determined by the control status of other equipment or systems provided:

- The "digital computers" or related equipment are essential for the operation of the other equipment or systems;
- The "digital computers" or related equipment are not a "principal element" of the other equipment or systems; and

NR1.

The control status of "signal processing" or "image enhancement" equipment specially designed for other equipment with functions limited to those required for the other equipment is determined by the control status of the other equipment even if it exceeds the "principal element" criterion.

N.B.2.

For the control status of "digital computers" or related equipment for telecommunications equipment, see Category 5, Part 1 (Telecommunications).

- c. The technology for the "digital computers" and related equipment is determined by 1-4.E.
- a. Designed or modified for "fault tolerance";

For the purposes of 1-4.A.3.a., "digital computers" and related equipment are not considered to be designed or modified for "fault tolerance" if they utilise any of the following:

- 1. Error detection or correction algorithms in "main storage";
- The interconnection of two "digital computers" so that, if the active central processing unit fails, an idling but mirroring central processing unit can continue the system's functioning;
- 3. The interconnection of two central processing units by data channels or by using shared storage to permit one central processing unit to perform other work until the second central processing unit fails, at which time the first central processing unit takes over in order to continue the system's functioning; or
- 4. The synchronisation of two central processing units by "software" so that one central processing unit recognises when the other central processing unit fails and recovers tasks from the failing unit.

Note:

The control status of "software" for the "development", "production", or "use" of equipment described in other Categories is dealt with in the appropriate Category. The control status of "software" for equipment described in this Category is dealt with herein.

 - b. "Technology", other than that controlled by 1-4.E.1.a., specially designed or modified for the "development" or "production" of:
 - "Digital computers" having an "Adjusted Peak Performance" ("APP") exceeding 0.04 Weighted TeraFLOPS (WT); or

Technical Note on "Composite Theoretical Performance" ("CTP"):

Abbreviations used in this Technical Note:

"CE" = "computing element" (typically an arithmetic logical unit)

FP = floating point

XP = fixed point

t = execution time

XOR = exclusive OR CPU = central processing unit

TP = theoretical performance (of a single "CE")

"CTP" = "composite theoretical performance" (multiple "CEs")

R = effective calculating rate

WL = word length

L = word length adjustment

' = multiply

Execution time 't' is expressed in microseconds, TP and "CTP" are expressed in millions of theoretical operations per second (Mtops) and WL is expressed in bit.

Outline of "CTP" Calculation Method

"CTP" is a measure of computational performance given in Mtops. In calculating the "CTP" of an aggregation of "CEs" the following three steps are required:

- 1. Calculate the effective calculating rate R for each "CE";
- Apply the word length adjustment (L) to the effective calculating rate (R), resulting in a Theoretical Performance (TP) for each "CE";
- If there is more than one "CE", combine the TPs, resulting in a "CTP" for the aggregation.

Details for these steps are given in the following sections.

Note 1:

For aggregations of multiple "CEs" which have both shared and unshared memory subsystems, the calculation of "CTP" is completed hierarchically, in two steps: first, aggregate the groups of "CEs" sharing memory; second, calculate the "CTP" of the groups using the calculation method for multiple "CEs" not sharing memory.

Note 2:

"CEs" that are limited to input/output and peripheral functions (e.g., disk drive, communication and video display controllers) are not aggregated into the "CTP" calculation.

Note W

For a pipelined "CE" capable of executing up to one arithmetic or logic operation every clock cycle after the pipeline is full, a pipelined rate can be established. The effective calculating rate (R) for such a "CE" is the faster of the pipelined rate or non-pipelined execution rate.

Note X:

For a "CE" which performs multiple operations of a specific type in a single cycle (e.g., two additions per cycle or two identical logic operations per cycle), the execution time t is given by:

"CEs" which perform different types of arithmetic or logic operations in a single machine cycle are to be treated as multiple separate "CEs" performing simultaneously (e.g., a "CE" performing an addition and a multiplication in one cycle is to be treated as two "CEs", the first performing an addition in one cycle and the second performing a multiplication in one cycle).

If a single "CE" has both scalar function and vector function, use the shorter execution time value.

Note \

For the "CE" that does not implement FP add or FP multiply, but that performs FP divide:

$$R_f = \frac{1}{t_{fp \ divide}}$$

If the "CE" implements FP reciprocal but not FP add, FP multiply or FP divide, then:

$$R_{fp} = \frac{1}{t_{fp, reciprocal}}$$

If none of the specified instructions is implemented, the effective FP rate is 0.

Note Z:

In simple logic operations, a single instruction performs a single logic manipulation of no more than two operands of given lengths.

In complex logic operations, a single instruction performs multiple logic manipulations to produce one or more results from two or more operands. Rates should be calculated for all supported operand lengths considering both pipelined operations (if supported), and non-pipelined operations using the fastest executing instruction for each operand length based on:

- Pipelined or register-to-register operations. Exclude extraordinarily short execution times generated for operations on a predetermined operand or operands (for example, multiplication by 0 or 1). If no register-to-register operations are implemented, continue with (2);
- 2. The faster of register-to-memory or memory-to-register operations; if these also do not exist, then continue with (3);
- 3. Memory-to-memory.

In each case above, use the shortest execution time certified by the manufacturer.

Step 2: TP for each supported operand length WL:

Adjust the effective rate R (or R') by the word length adjustment L as follows:

 where $L = (1/3 + WL/96)$

Note:

The word length WL used in these calculations is the operand length in bits. (If an operation uses operands of different lengths, select the largest word length.) The combination of a mantissa ALU and an exponent ALU of a floating point processor or unit is considered to be one "CE" with a Word Length (WL) equal to the number of bits in the data representation (typically 32 or 64) for purposes of the "CTP" calculation.

This adjustment is not applied to specialized logic processors which do not use XOR instructions. In this case TP = R.

Select the maximum resulting value of TP for:

Each XP-only "CE" (R_{xp});

Each FP-only "CE" (R_{fp}^{γ}) ;

Each combined FP and XP "CE" (R);

Each simple logic processor not implementing any of the specified arithmetic operations; **and**

Each special logic processor not using any of the specified arithmetic or logic operations.

"CTP" for aggregations of multiple "CEs" operating simultaneously is calculated as follows:

Note 1:

For aggregations that do not allow all of the "CEs" to run simultaneously, the possible combination of "CEs" that provides the largest "CTP" should be used. The TP of each contributing "CE" is to be calculated at its maximum value theoretically possible before the "CTP" of the combination is derived.

N.B.:

To determine the possible combinations of simultaneously operating "CEs", generate an instruction sequence that initiates operations in multiple "CEs", beginning with the slowest "CE" (the one needing the largest number of cycles to complete its operation) and ending with the fastest "CE". At each cycle of the sequence, the combination of "CEs" that are in operation during that cycle is a possible combination. The instruction sequence must take into account all hardware and/or architectural constraints on overlapping operations.

Note 2:

A single integrated circuit chip or board assembly may contain multiple "CEs".

Note 3:

Simultaneous operations are assumed to exist when the computer manufacturer claims concurrent, parallel or simultaneous operation or execution in a manual or brochure for the computer.

Note 4:

"CTP" values are not to be aggregated for "CE" combinations (inter)connected by "Local Area Networks", Wide Area Networks, I/O shared connections/devices, I/O controllers and any communication interconnection implemented by software.

Note 5:

"CTP" values must be aggregated for multiple "CEs" specially designed to enhance performance by aggregation, operating simultaneously and sharing memory,- or multiple memory/"CE"- combinations operating simultaneously utilising specially designed hardware.

This aggregation does not apply to "electronic assemblies" described in 1-4.A.3.c.

"CTP" =

,

where the TPs are ordered by value, with TP_1 being the highest, TP_2 being the second highest, ..., and TP_n being the lowest. C_i is a coefficient determined by the strength of the interconnection between "CEs", as follows:

For multiple "CEs" operating simultaneously and sharing memory:

$$C_2 = C_3 = C_4 = \dots = C_n = 0.75$$

Note 1:

When the "CTP" calculated by the above method does not exceed 194 Mtops, the following formula may be used to calculate C_i :

where m = the number of "CEs" or groups of "CEs" sharing access, provided:

- 1. The TP_i of each "CE" or group of "CEs" does not exceed 30 Mtops;

When calculating a C_i for a group of "CEs", the number of the first "CE" in a group determines the proper limit for C_i . For example, in an aggregation of groups consisting of 3 "CEs" each, the 22nd group will contain "CE" $_{64}$, "CE" $_{65}$ and "CE" $_{66}$ The proper limit for C_i for this group is 0.60.

Aggregation (of "CEs" or groups of "CEs") should be from the fastest-to-slowest; i.e.: $TP_1 \ge TP_2 \ge \ge TPn$, **and**

in the case of $TP_i = TP_i + 1$, from the largest to smallest; i.e., $C_i \ge C_i + 1$

Note

The k_i factor is not to be applied to "CEs" 2 to 12 if the TP_i of the "CE" or group of "CEs" is more than 50 Mtops; i.e., C_i for "CEs" 2 to 12 is 0.75.

Technical Note on "Adjusted Peak Performance" ("APP")

"APP" is an adjusted peak rate at which "digital computers" perform 64-bit or larger floating point additions and multiplications.

"APP" is expressed in Weighted TeraFLOPS (WT), in units of 10¹² adjusted floating point operations per second.

Outline of "APP" calculation method

 For each processor i, determine the peak number of 64-bit or larger floating point operations, FPO_i, performed per cycle for each processor in the "digital computer".

Note:

In determining FPO, include only 64-bit or larger floating point additions and/or multiplications. All floating point operations must be expressed in operations per processor cycle; operations requiring multiple cycles may be expressed in fractional results per cycle. For processors not capable of performing calculations on floating point operands of 64-bits or more, the effective calculating rate R is zero.

- 2. Calculate the floating point rate R for each processor $R_i = FPO/t_i$
- 3. Calculate "APP" as "APP" = $W_1 \times R_1 + W_2 \times R_2 + ... + W_n \times R_n$.

Note 1

For processors that perform compound operations in a cycle, such as addition and multiplication, each operation is counted.

Note 2:

For a pipelined processor the effective calculating rate R is the faster of the pipelined rate, once the pipeline is full, or the non-pipelined rate.

Note 3

The calculating rate R of each contributing processor is to be calculated at its maximum value theoretically possible before the "APP" of the combination is derived. Simultaneous operations are assumed to exist when the computer manufacturer claims concurrent, parallel, or simultaneous operation or execution in a manual or brochure for the computer.

Note 4:

Do not include processors that are limited to input/output and peripheral functions (e.g., disk drive, communication and video display) when calculating "APP".

"APP" values are not to be calculated for processor combinations (inter)connected by "Local Area Networks", Wide Area Networks, I/O shared connections/devices, I/O controllers and any communication interconnection implemented by "software".

Note 6:

"APP" values must be calculated for 1) processor combinations containing processors specially designed to enhance performance by aggregation, operating simultaneously and sharing memory; or 2) multiple memory/processor combinations operating simultaneously utilizing specially designed hardware.

Note 7:

A "vector processor" is defined as a processor with built-in instructions that perform multiple calculations on floating-point vectors (one-dimensional arrays of 64-bit or larger numbers) simultaneously, having at least 2 vector functional units and at least 8 vector registers of at least 64 elements each.

Category 5 - Part 1: Telecommunications

Note 1:

The control status of components, "lasers", test and "production" equipment and "software" therefor which are specially designed for telecommunications equipment or systems is determined in Category 5, Part 1.

Note 2:

"Digital computers", related equipment or "software", when essential for the operation and support of telecommunications equipment described in this Category, are regarded as specially designed components, provided they are the standard models customarily supplied by the manufacturer. This includes operation, administration, maintenance, engineering or billing computer systems.

1-5.A.1. Systems, Equipment and Components

- Any type of telecommunications equipment having any of the following characteristics, functions or features:
 - Specially designed to withstand transitory electronic effects or electromagnetic pulse effects, both arising from a nuclear explosion;
 - 2. Specially hardened to withstand gamma, neutron or ion radiation; **or**
 - 3. Specially designed to operate outside the temperature range from 218 K (-55 $^{\circ}$ C) to 397 K (124 $^{\circ}$ C).

Note:

1-5.A.1.a.3. applies only to electronic equipment.

Note

1-5.A.1.a.2. and 1-5.A.1.a.3. do not control equipment designed or modified for use on board satellites.

- b. Telecommunication transmission equipment and systems, and specially designed components and accessories therefor, having any of the following characteristics, functions or features:
 - Being underwater communications systems having any of the following characteristics:
 - a. An acoustic carrier frequency outside the range from 20 kHz to 60 kHz;
 - Using an electromagnetic carrier frequency below 30 kHz; or
 - c. Using electronic beam steering techniques;
 - 2. Being radio equipment operating in the 1.5 to 87.5 MHz band and having any of the following characteristics:
 - a. Incorporating adaptive techniques providing more than 15 dB suppression of an interfering signal; **or**
 - b. Having all of the following:
 - Automatically predicting and selecting frequencies and "total digital transfer rates" per channel to optimise the transmission; and
 - 2. Incorporating a linear power amplifier configuration having a capability to support multiple signals simultaneously at an output power of 1 kW or more in the frequency range of 1.5 MHz or more but less than 30 MHz, or 250 W or more in the frequency range of 30 MHz or more but not exceeding 87.5 MHz, over an "instantaneous bandwidth" of one octave or more and with an output harmonic and distortion content of better than -80 dB;
 - 3. Being radio equipment employing "spread spectrum" techniques, including "frequency hopping" techniques, not controlled in 1-5.A.1.b.4., having any of the following characteristics:

- a. User programmable spreading codes; or
- A total transmitted bandwidth which is 100 or more times the bandwidth of any one information channel and in excess of 50 kHz.

Note:

1-5.A.1.b.3.b. does not control radio equipment specially designed for use with civil cellular radio-communications systems.

Note:

1-5.A.1.b.3. does not control equipment designed to operate at an output power of 1.0 Watt or less.

- Being radio equipment employing ultra-wideband modulation techniques having user programmable channelizing codes, scrambling codes or network identification codes, having any of the following characterics;
 - a. A bandwidth exceeding 500 MHz; or
 - b. A "fractional bandwidth" of 20% or more.
- Being digitally controlled radio receivers having all of the following:
 - a. More than 1,000 channels;
 - b. A "frequency switching time" of less than 1 ms;
 - Automatic searching or scanning of a part of the electromagnetic spectrum; and
 - d. Identification of the received signals or the type of transmitter; or

Note:

1-5.A.1.b.5. does not control radio equipment specially designed for use with civil cellular radio-communications systems.

- Employing functions of digital "signal processing" to provide voice coding output at rates of less than 2,400 bit/s Technical Notes:
 - For variable rate voice coding, 1-5.A.1.b.6. applies to the voice coding output of continuous speech.
 - For the purpose of 1-5.A.1.b.6., 'voice coding' is defined as the technique to take samples of human voice and then convert these samples into a digital signal, taking into account specific characteristics of human speech.
- Optical fibre communication cables, optical fibres and accessories, as follows:
 - 1. Optical fibres of more than 500 m in length, specified by the manufacturer as being capable of withstanding a proof test tensile stress of 2 x 10^9 N/m² or more;

Technical Note:

Proof Test: on-line or off-line production screen testing that dynamically applies a prescribed tensile stress over a 0.5 to 3 m length of fibre at a running rate of 2 to 5 m/s while passing between capstans approximately 150 mm in diameter. The ambient temperature is a nominal 293 K and relative humidity 40%. Equivalent national standards may be used for executing the proof test.

Optical fibre cables and accessories designed for underwater use.

Note:

1-5.A.1.c.2. does not control standard civil telecommunication cables and accessories.

N.B.1:

For underwater umbilical cables, and connectors therefor, see 1-8.A.2.a.3.

N.B.2:

For fibre-optic hull penetrators or connectors, see 1-8.A.2.c.

d. "Electronically steerable phased array antennae" operating above 31.8 GHz.

Note:

1-5.A.1.d. does not control "electronically steerable phased array antennae" for landing systems with instruments meeting ICAO standards covering microwave landing systems (MLS).

- e. Radio direction finding equipment operating at frequencies above 30 MHz and having all of the following characteristics, and specially designed components therefor:
 - 1. "Instantaneous bandwidth" of 10 MHz or more; and
 - 2. Capable of finding a line of bearing (LOB) to non-cooperating radio transmitters with a signal duration of less than 1 ms.
- f. Jamming equipment specially designed or modified to intentionally and selectively interfere with, deny, inhibit, degrade or seduce cellular mobile telecommunication services, having any of the following characterictics, and specially designed components therefor:
 - 1. Simulating the functions of Radio Access Network (RAN) equipment; **or**
 - 2. Detecting and exploiting specific characteristics of the mobile telecommunications protocol employed (eg., GSM).

N.B.:

For GNSS jamming equipment see the Munitions List.

1-5.B.1. Test, Inspection and Production Equipment

 Equipment and specially designed components or accessories therefor, specially designed for the "development", "production" or "use" of equipment, functions or features controlled by Category 5 - Part 1.

Note:

1-5.B.1.a. does not control optical fibre characterization equipment.

- Equipment and specially designed components or accessories therefor, specially designed for the "development" of any of the following telecommunication transmission or switching equipment:
 - 1. Equipment employing digital techniques designed to operate at a "total digital transfer rate" exceeding 15 Gbit/s;

Technical Note:

For switching equipment the "total digital transfer rate" is measured at the highest speed port or line.

- 2. Equipment employing a "laser" and having any of the following:

- An instantaneous radiated acoustic power density exceeding 0.01 mW/mm²/Hz for devices operating at frequencies below 10 kHz;

Technical Note:

Acoustic power density is obtained by dividing the output acoustic power by the product of the area of the radiating surface and the frequency of operation.

- c. Non-"space-qualified" non-linear (2-dimensional) "focal plane arrays", having individual elements with a peak response in the wavelength range exceeding 1,200 nm but not exceeding 30,000 nm.

Silicon and other material based microbolometer non "space-qualified" "focal plane arrays" are only specified in 1-6.A.2.a.3.f.

- d. Non-"space-qualified" linear (1-dimensional) "focal plane arrays", having all of the following:
 - 1. Individual elements with a peak response in the wavelength range exceeding 1,200 nm but not exceeding 2,500 nm; and
 - 2. Any of the following:

- a. A ration of scan direction dimension of the detector element to the cross-scan direction dimension of the detector element of less than 3.8: or
- b. Signal processing in the element (SPRITE);

- Direct view imaging equipment operating in the visible or infrared spectrum, incorporating any of the following:

Technical Note:

'Direct view' refers to imaging equipment, operating in the visible or infrared spectrum, that presents a visual image to a human observer without converting the image into an electronic signal for television display, and that cannot record or store the image photographically, electronically or by any other means.

1-6.A.2.c. does not control the following equipment incorporating other than GaAs or GalnAs photocathodes:

- Industrial equipment used for inspection, sorting or analysis of the properties of materials:
- d. Flame detectors for industrial furnaces;
- e. Equipment specially designed for laboratory use.
- d. Special support components for optical sensors, as follows:
 - 1. "Space-qualified" cryocoolers;
 - 2. Non-"space-qualified" cryocoolers, having a cooling source temperature below 218 K (-55°C), as follows:
 - a. Closed cycle type with a specified Mean-Time-To-Failure (MTTF), or Mean-Time-Between-Failures (MTBF), exceeding 2,500 hours;
 - b. Joule-Thomson (JT) self-regulating minicoolers having bore (outside) diameters of less than 8 mm;

- Optical sensing fibres specially fabricated either compositionally or structurally, or modified by coating, to be acoustically, thermally, inertially, electromagnetically or nuclear radiation sensitive.
- e. "Space qualified" "focal plane arrays" having more than 2,048
 elements per array and having a peak response in the
 wavelength range exceeding 300 nm but not exceeding 900 nm.

3. Cameras

N.B.:

For cameras specially designed or modified for underwater use, see 1-8.A.2.d. and 1-8.A.2.e.

a. Instrumentation cameras and specially designed components therefor, as follows:

Note:

Instrumentation cameras, controlled by 1-6.A.3.a.3. to 1-6.A.3.a.5., with modular structures should be evaluated by their maximum capability, using plug-ins available according to the camera manufacturer's specifications.

 High-speed cinema recording cameras using any film format from 8 mm to 16 mm inclusive, in which the film is continuously advanced throughout the recording period, and that are capable of recording at framing rates exceeding 13,150 frames/s;

Note:

1-6.A.3.a.1. does not control cinema recording cameras designed for civil purposes.

- Mechanical high speed cameras, in which the film does not move, capable of recording at rates exceeding 1,000,000 frames/s for the full framing height of 35 mm film, or at proportionately higher rates for lesser frame heights, or at proportionately lower rates for greater frame heights;
- Mechanical or electronic streak cameras having writing speeds exceeding 10 mm/µs;
- 4. Electronic framing cameras having a speed exceeding 1,000,000 frames/s;
- 5. Electronic cameras having all of the following:
 - a. An electronic shutter speed (gating capability) of less than 1 µs per full frame; **and**
 - A read out time allowing a framing rate of more than 125 full frames per second.
- 6. Plug-ins, having all of the following characteristics:
 - a. Specially designed for instrumentation cameras which have modular structures and which are controlled by 1-6.A.3.a.; and
 - Enabling these cameras to meet the characteristics specified in 1-6.A.3.a.3., 1-6.A.3.a.4. or 1-6.A.3.a.5., according to the manufacturer's specifications.
- b. Imaging cameras, as follows:

Note

1-6.A.3.b. does not control television or video cameras specially designed for television broadcasting.

- Video cameras incorporating solid state sensors, having a peak response in the wavelength range exceeding 10 nm, but not exceeding 30,000 nm and having all of the following:
 - a. Having any of the following:
 - 1. More than 4 x 10⁶ "active pixels" per solid state array for monochrome (black and white) cameras;

- More than 4 x 106 "active pixels" per solid state array for colour cameras incorporating three solid state arrays; or
- 3. More than 12 x 106 "active pixels" for solid state array colour cameras incorporating one solid state array; and
- b. Having any of the following:
 - 1. Optical mirrors controlled by 1-6.A.4.a.;
 - Optical control equipment controlled by 1-6.A.4.d.;
 or
 - The capability for annotating internally generated camera tracking data.

Technical Notes:

- For the purpose of this entry, digital video cameras should be evaluated by the maximum number of "active pixels" used for capturing moving images.
- 2. For the purpose of this entry, camera tracking data is the information necessary to define camera line of sight orientation with respect to the earth. This includes: 1) the horizontal angle the camera line of sight makes with respect to the earth's magnetic field direction and; 2) the vertical angle between the camera line of sight and the earth's horizon.
- 2. Scanning cameras and scanning camera systems, having all of the following:
 - a. A peak response in the wavelength range exceeding 10 nm, but not exceeding 30,000 nm;
 - b. Linear detector arrays with more than 8,192 elements per array; **and**
 - c. Mechanical scanning in one direction;
- 3. Imaging cameras incorporating image intensifier tubes having the characteristics listed in 1-6.A.2.a.2.a.;
- 4. Imaging cameras incorporating "focal plane arrays" having any of the following:
 - a. Incorporating "focal plane arrays" controlled by 1-6.A.2.a.3.a. to 1-6.A.2.a.3.e.; **or**
 - b. Incorporating "focal plane arrays" controlled by 1-6.A.2.a.3.f.

Note 1:

'Imaging cameras' described in 1-6.A.3.b.4. include "focal plane arrays" combined with sufficient signal processing electronics, beyond the read out integrated circuit, to enable as a minimum the output of an analogue or digital signal once power is supplied.

Note 2:

1-6.A.3.b.4. does not control imaging cameras incorporating linear "focal plane arrays" with twelve elements or fewer, not employing time-delay-and-integration within the element, designed for any of the following:

- a. Industrial or civilian intrusion alarm, traffic or industrial movement control or counting systems;
- Industrial equipment used for inspection or monitoring of heat flows in buildings, equipment or industrial processes;
- Industrial equipment used for inspection, sorting or analysis of the properties of materials;
- d. Equipment specially designed for laboratory use; or
- e. Medical equipment.

Note 3:

1-6.A.3.b.4.b. does not control imaging cameras having any of the following characteristics:

- a. A maximum frame rate equal to or less than 9 Hz;
- b. Having all of the following:
 - Having a minimum horizontal or vertical Instantaneous-Field-of-View (IFOV) of at least 10 mrad/pixel (milliradians/pixel);
 - Incorporating a fixed focal-length lens that is not designed to be removed;
 - 3. Not incorporating a direct view display; and

Technical Note:

'Direct view' refers to an imaging camera operating in the infrared spectrum that presents a visual image to a human observer using a near-to-eye micro display incorporating any light-security mechanism.

- 4. Having any of the following:
 - a. No facility to obtain a viewable image of the detected field-of-view; **or**
 - The camera is designed for a single kind of application and designed not to be user modified; or

Technical Note

Instantaneous Field of View (IFOV) specified in Note 3.b. is the lesser figure of the Horizontal IFOV or the Vertical IFOV. Horizontal IFOV = horizontal Field of View

(FOV)/number of horizontal detector elements

Vertical IFOV= vertical Field of View (FOV)/number of vertical detector elements.

- c. Where the camera is specially designed for installation into a civilian passenger land vehicle of less than three tonnes (gross vehicle weight) and having all of the following:
 - 1. Is only operable when installed in any of the following:
 - a. The civilian passenger land vehicle for which it was intended: **or**
 - b. A specially designed, authorized maintenance test facility: and
 - Incorporates an active mechanism that forces the camera not to function when it is removed from the vehicle for which it was intended.

Note:

When necessary, details of the item will be provided, upon request, to the appropriate authority in the exporter's country in order to ascertain compliance with the conditions described in Note 3.b.4. and Note 3.c. above.

4. Optics

- a. Optical mirrors (reflectors), as follows:
 - "Deformable mirrors" having either continuous or multielement surfaces, and specially designed components therefor, capable of dynamically repositioning portions of the surface of the mirror at rates exceeding 100 Hz;
 - Lightweight monolithic mirrors having an average "equivalent density" of less than 30 kg/m² and a total mass exceeding 10 kg;
 - Lightweight "composite" or foam mirror structures having an average "equivalent density" of less than 30 kg/m² and a total mass exceeding 2 kg;
 - 4. Beam steering mirrors more than 100 mm in diameter or length of major axis, which maintain a flatness of lambda/2 or better (lambda is equal to 633 nm) having a control bandwidth exceeding 100 Hz.
- b. Optical components made from zinc selenide (ZnSe) or zinc sulphide (ZnS) with transmission in the wavelength range exceeding 3,000 nm but not exceeding 25,000 nm and having any of the following:
 - 1. Exceeding 100 cm³ in volume; **or**
 - 2. Exceeding 80 mm in diameter or length of major axis and 20 mm in thickness (depth).
- c. "Space-qualified" components for optical systems, as follows:
 - Lightweighted to less than 20% "equivalent density" compared with a solid blank of the same aperture and thickness;
 - Raw substrates, processed substrates having surface coatings (single-layer or multi-layer, metallic or dielectric, conducting, semiconducting or insulating) or having protective films;

- Segments or assemblies of mirrors designed to be assembled in space into an optical system with a collecting aperture equivalent to or larger than a single optic 1 m in diameter:
- 4. Manufactured from "composite" materials having a coefficient of linear thermal expansion equal to or less than 5×10^{-6} in any coordinate direction.
- d. Optical control equipment, as follows:
 - Specially designed to maintain the surface figure or orientation of the "space-qualified" components controlled by 1-6.A.4.c.1. or 1-6.A.4.c.3.;
 - 2. Having steering, tracking, stabilisation or resonator alignment bandwidths equal to or more than 100 Hz and an accuracy of 10 µrad (microradians) or less;
 - 3. Gimbals having all of the following:
 - a. a maximum slew exceeding 5°;
 - b. a bandwidth of 100 Hz or more;
 - c. Angular pointing errors of 200 μ rad (microradians) or less; and
 - d. Having any of the following:
 - Exceeding 0.15 m but not exceeding 1 m in diameter or major axis length and capable of angular accelerations exceeding 2 rad (radians)/s²; or
 - 2. Exceeding 1 m in diameter or major axis length and capable of angular accelerations exceeding 0.5 rad (radians)/s²;
 - Specially designed to maintain the alignment of phased array or phased segment mirror systems consisting of mirrors with a segment diameter or major axis length of 1 m or more;
- e. Aspheric optical elements having all of the following characteristics:
 - 1. The largest dimension of the optical-aperture is greater than 400 mm;
 - 2. The surface roughness is less than 1 nm (rms) for sampling lengths equal to or greater than 1 mm; **and**
 - 3. The coefficient of linear thermal expansion's absolute magnitude is less than 3×10^{-6} /K at $25 \,^{\circ}$ C;

Technical Notes:

- An 'aspheric optical element' is any element used in an optical system whose imaging surface or surfaces are designed to depart from the shape of an ideal sphere.
- Manufacturers are not required to measure the surface roughness listed in 1-6.A.4.e.2. unless the optical element was designed or manufactured with the intent to meet, or exceed, the control parameter.

Note:

1-6.A.4.e. does not control aspheric optical elements having any of the following:

- A largest optical-aperture dimension less than 1 m and a focal length to aperture ratio equal to or greater than 4.5:1;
- A largest optical-aperture dimension equal to or greater than 1 m and a focal length to aperture ratio equal to or greater than 7:1;
- c. Being designed as Fresnel, flyeye, stripe, prism or diffractive optical elements:
- d. Being fabricated from borosilicate glass having a coefficient of linear thermal expansion greater than 2.5 x 10⁻⁶ / K at 25° C; or
- e. Being an x-ray optical element having inner mirror capabilities (e.g. tube-type mirrors).

N.B.

For aspheric optical elements specially designed for lithography equipment, see Item 1-3.B.1.

5. Lasers

"Lasers", components and optical equipment, as follows:

Note 1:

Pulsed "lasers" include those that run in a continuous wave (CW) mode with pulses superimposed.

Note 2:

Pulse-excited "lasers" include those that run in a continuously excited mode with pulse excitation superimposed.

Note 3:

The control status of Raman "lasers" is determined by the parameters of the pumping source "lasers". The pumping source "lasers" can be any of the "lasers" described below.

- a. Gas "lasers", as follows:
 - 1. Excimer "lasers" having any of the following:
 - a. An output wavelength not exceeding 150 nm and having any of the following:
 - 1. An output energy exceeding 50 mJ per pulse; or
 - 2. An average output power exceeding 1 W;
 - b. An output wavelength exceeding 150 nm but not exceeding 190 nm and having any of the following:
 - 1. An output energy exceeding 1.5 J per pulse; or
 - 2. An average output power exceeding 120 W;
 - c. An output wavelength exceeding 190 nm but not exceeding 360 nm and having any of the following:
 - 1. An output energy exceeding 10 J per pulse; or
 - 2. An average output power exceeding 500 W; or
 - d. An output wavelength exceeding 360 nm and having any of the following:
 - 1. An output energy exceeding 1.5 J per pulse; or
 - 2. An average output power exceeding 30 W;

N.B.:

For excimer "lasers" specially designed for lithography equipment, see 1-3.B.1.

- 2. Metal vapour "lasers", as follows:
 - a. Copper (Cu) "lasers" having an average output power exceeding 20 W;
 - Gold (Au) "lasers" having an average output power exceeding 5 W;
 - Sodium (Na) "lasers" having an output power exceeding 5 W;
 - d. Barium (Ba) "lasers" having an average output power exceeding 2 W;
- 3. Carbon monoxide (CO) "lasers" having any of the following:
 - a. An output energy exceeding 2 J per pulse and a pulsed "peak power" exceeding 5 kW; ${f or}$
 - b. An average or CW output power exceeding 5 kW;
- Carbon dioxide (CO₂) "lasers" having any of the following:
 - a. A CW output power exceeding 15 kW;
 - b. A pulsed output having a "pulse duration" exceeding 10 µs and having any of the following:
 - 1. An average output power exceeding 10 kW; \boldsymbol{or}
 - 2. A pulsed "peak power" exceeding 100 kW; or
 - c. A pulsed output having a "pulse duration" equal to or less than 10 μs and having any of the following:
 - 1. A pulse energy exceeding 5 J per pulse; or
 - 2. An average output power exceeding 2.5 kW;
- 5. "Chemical lasers", as follows:
 - a. Hydrogen Fluoride (HF) "lasers";
 - b. Deuterium Fluoride (DF) "lasers";
 - c. "Transfer lasers", as follows:
 - 1. Oxygen Iodine (O₂-I) "lasers";

- 2. Deuterium Fluoride-Carbon dioxide (DF-CO₂) "lasers":
- 6. Krypton ion or argon ion "lasers", having any of the following:
 - An output energy exceeding 1.5 J per pulse and a pulsed "peak power" exceeding 50 W; or
 - b. An average or CW output power exceeding 50 W;
- 7. Other gas "lasers", having any of the following: **Note:**

1-6.A.5.a.7. does not control nitrogen "lasers".

- a. An output wavelength not exceeding 150 nm and having any of the following:
 - An output energy exceeding 50 mJ per pulse and a pulsed "peak power" exceeding 1 W; or
 - 2. An average or CW output power exceeding 1 W;
- b. An output wavelength exceeding 150 nm but not exceeding 800 nm and having any of the following:
 - An output energy exceeding 1.5 J per pulse and a pulsed "peak power" exceeding 30 W; or
 - 2. An average or CW output power exceeding 30 W;
- c. An output wavelength exceeding 800 nm but not exceeding 1,400 nm and having any of the following:
 - 1. An output energy exceeding 0.25 J per pulse and a pulsed "peak power" exceeding 10 W; **or**
 - 2. An average or CW output power exceeding 10 W; or
- d. An output wavelength exceeding 1,400 nm and an average or CW output power exceeding 1 W.
- b. Semiconductor "lasers", as follows:

Note 1:

1-6.A.5.b. includes semiconductor "lasers" having optical output connectors (e.g. fibre optic pigtails).

Note 2:

The control status of semiconductor "lasers" specially designed for other equipment is determined by the control status of the other equipment.

- 1. Individual single-transverse mode semiconductor "lasers", having any of the following:
 - a. A wavelength equal to or less than 1510 nm, and having an average or CW output power exceeding 1.5 W; or
 - A wavelength greater than 1510 nm, and having an average or CW output power exceeding 500 mW;
- 2. Individual, multiple-transverse mode semiconductor "lasers", having any of the following:
 - a. A wavelength of less than 1400 nm, and having an average or CW output exceeding 10W;
 - b. A wavelength equal to or greater than 1400 nm and less than 1900 nm, and having an average or CW output power exceeding 2.5W; **or**
 - A wavelength equal to or greater than 1900 nm, and having an average or CW output power exceeding 1W.
- 3. Individual semiconductor "laser" arrays, having any of the following:
 - a. A wavelength of less than 1400 nm, and having an average or CW output power exceeding 80 W;
 - b. A wavelength equal to or greater than 1400 nm and less than 1900 nm, and having an average or CW output power exceeding 25 W; or
 - c. A wavelength equal to or greater than 1900 nm, and having an average or CW output power exceeding 10 W.
- 4. Array stacks of semiconductor "lasers" containing at least one array that is controlled under 1-6.A.5.b.3.

Technical Notes:

- 1. Semiconductor "lasers" are commonly called "laser" diodes.
- An 'array' consists of multiple semiconductor "laser" emitters fabricated as a single chip so that the centres of the emitted light beams are on parallel paths.
- An 'array stack' is fabricated by stacking, or otherwise assembling, 'arrays' so that the centres of the emitted light beams are on parallel paths.
- c. Solid state "lasers", as follows:
 - 1. "Tunable" "lasers" having any of the following: **Note:**

1-6.A.5.c.1. includes titanium - sapphire(Ti: Al₂O₃), thulium - YAG (Tm: YAG), thulium - YSGG (Tm: YSGG), alexandrite (Cr: BeAl₂O₄) and colour centre "lasers".

- a. An output wavelength less than 600 nm and having any of the following:
 - An output energy exceeding 50 mJ per pulse and a pulsed "peak power" exceeding 1 W; or
 - 2. An average or CW output power exceeding 1 W;
- b. An output wavelength of 600 nm or more but not exceeding 1,400 nm and having any of the following:
 - 1. An output energy exceeding 1 J per pulse and a pulsed "peak power" exceeding 20 W; or
 - 2. An average or CW output power exceeding 20 W; or
- c. An output wavelength exceeding 1,400 nm and having any of the following:
 - An output energy exceeding 50 mJ per pulse and a pulsed "peak power" exceeding 1 W; or
 - 2. An average or CW output power exceeding 1 W.
- 2. Non-"tunable" "lasers", as follows:

Note:

1-6.A.5.c.2. includes atomic transition solid state "lasers".

- a. Neodymium glass "lasers", as follows:
 - 1. "Q-switched lasers" having any of the following:
 - a. An output energy exceeding 20 J but not exceeding 50 J per pulse and an average output power exceeding 10 W; or
 - b. An output energy exceeding 50 J per pulse.
 - 2. Non-"Q-switched lasers" having any of the following:
 - a. An output energy exceeding 50 J but not exceeding 100 J per pulse and an average output power exceeding 20 W; or
 - b. An output energy exceeding 100 J per pulse.
- Neodymium-doped (other than glass) "lasers", having an output wavelength exceeding 1,000 nm but not exceeding 1,100 nm, as follows:

For neodymium-doped (other than glass) "lasers" having an output wavelength not exceeding 1,000 nm or exceeding 1,100 nm, see 1-6.A.5.c.2.c.

- 1. Pulse-excited, mode-locked, "Q-switched lasers" having a "pulse duration" of less than 1 ns and having any of the following:
 - a. A "peak power" exceeding 5 GW;
 - b. An average output power exceeding 10 W; or
 - c. A pulsed energy exceeding 0.1 J.
- Pulse-excited, "Q-switched lasers" having a pulse duration equal to or more than 1 ns, and having any of the following:
 - a. A single-transverse mode output having:

- 1. A "peak power" exceeding 100 MW;
- 2. An average output power exceeding 20 W; or
- 3. A pulsed energy exceeding 2 J; or
- b. A multiple-transverse mode output having:
 - 1. A "peak power" exceeding 400 MW;
 - An average output power exceeding 2 kW;or
 - 3. A pulsed energy exceeding 2 J;
- 3. Pulse-excited, non-"Q-switched lasers", having:
 - a. A single-transverse mode output having:
 - 1. A "peak power" exceeding 500 kW; or
 - An average output power exceeding 150 W;
 - b. A multiple-transverse mode output having:
 - 1. A "peak power" exceeding 1 MW; or
 - 2. An average power exceeding 2 kW;
- 4. Continuously excited "lasers" having:
 - a. A single-transverse mode output having:
 - 1. A "peak power" exceeding 500 kW; or
 - 2. An average or CW output power exceeding 150 W; or
 - b. A multiple-transverse mode output having:
 - 1. A "peak power" exceeding 1 MW; or
 - 2. An average or CW output power exceeding 2 kW;
- c. Other non-"tunable" "lasers", having any of the following:
 - 1. A wavelength less than 150 nm and having any of the following:
 - a. An output energy exceeding 50 mJ per pulse and a pulsed "peak power" exceeding 1 W; or
 - b. An average or CW output power exceeding 1 W;
 - 2. A wavelength of 150 nm or more but not exceeding 800 nm and having any of the following:
 - a. An output energy exceeding 1.5 J per pulse and a pulsed "peak power" exceeding 30 W; or
 - b. An average or CW output power exceeding 30 W;
 - 3. A wavelength exceeding 800 nm but not exceeding 1,400 nm, as follows:
 - a. "Q-switched lasers" having:
 - An output energy exceeding 0.5 J per pulse and a pulsed "peak power" exceeding 50 W;
 - 2. An average output power exceeding:
 - a. 10 W for single-tranverse mode "lasers";
 - b. 30 W for multiple-transverse mode "lasers";
 - b. Non-"Q-switched lasers" having:
 - An output energy exceeding 2 J per pulse and a pulsed "peak power" exceeding 50 W; or
 - 2. An average or CW output power exceeding 50 W; or
 - 4. A wavelength exceeding 1,400 nm and having any of the following:
 - a. An output energy exceeding 100 mJ per pulse and a pulsed "peak power" exceeding 1 W; or
 - b. An average or CW output power exceeding 1 W;
- d. Dye and other liquid "lasers", having any of the following:
 - 1. A wavelength less than 150 nm and:

- a. An output energy exceeding 50 mJ per pulse and a pulsed "peak power" exceeding 1 W; or
- b. An average or CW output power exceeding 1 W;
- 2. A wavelength of 150 nm or more but not exceeding 800 nm and having any of the following:
 - An output energy exceeding 1.5 J per pulse and a pulsed "peak power" exceeding 20 W;
 - b. An average or CW output power exceeding 20 W; or
 - c. A pulsed single longitudinal mode oscillator having an average output power exceeding 1 W and a repetition rate exceeding 1 kHz if the "pulse duration" is less than 100 ns;
- 3. A wavelength exceeding 800 nm but not exceeding 1,400 nm and having any of the following:
 - An output energy exceeding 0.5 J per pulse and a pulsed "peak power" exceeding 10 W; or
 - b. An average or CW output power exceeding 10 W; or
- 4. A wavelength exceeding 1,400 nm and having any of the following;
 - a. An output energy exceeding 100 mJ per pulse and a pulsed "peak power" exceeding 1 W; or
 - b. An average or CW output power exceeding 1 W;
- e. Components, as follows:
 - Mirrors cooled either by active cooling or by heat pipe cooling;

Technical Note:

Active cooling is a cooling technique for optical components using flowing fluids within the subsurface (nominally less than 1 mm below the optical surface) of the optical component to remove heat from the optic.

- Optical mirrors or transmissive or partially transmissive optical or electro-optical components specially designed for use with controlled "lasers";
- f. Optical equipment, as follows:

N.B.:

For shared aperture optical elements, capable of operating in "Super-High Power Laser" ("SHPL") applications, see Item 2-19., Note 2.d. on the Munitions List.

- 1. Dynamic wavefront (phase) measuring equipment capable of mapping at least 50 positions on a beam wavefront having any of the following:
 - a. Frame rates equal to or more than 100 Hz and phase discrimination of at least 5% of the beam's wavelength; **or**
 - b. Frame rates equal to or more than 1,000 Hz and phase discrimination of at least 20% of the beam's wavelength;
- 2. "Laser" diagnostic equipment capable of measuring "SHPL" system angular beam steering errors of equal to or less than 10 µrad (microradians);
- 3. Optical equipment and components specially designed for a phased-array "SHPL" system for coherent beam combination to an accuracy of lambda/10 at the designed wavelength, or 0.1 µm, whichever is the smaller;
- 4. Projection telescopes specially designed for use with "SHPL" systems.

6. Magnetic and Electric Field Sensors

"Magnetometers", "magnetic gradiometers", "intrinsic magnetic gradiometers", underwater electric field sensors, and compensation systems, and specially designed components therefor, as follows:

1-6.A.6. does not control instruments specially designed for fishery applications or biomagnetic measurements for medical diagnostics.

- a. "Magnetometers" and subsystems, as follows:
 - 1. Using "superconductive" (SQUID) "technology" and having any of the following characteristics:
 - a. SQUID systems designed for stationary operation, without specially designed subsystems designed to reduce in-motion noise, and having a "noise level" (sensitivity) equal to or lower (better) than 50 fT (rms) per square root Hz at a frequency of 1 Hz; or
 - SQUID systems having an in-motion-magnetometer "noise level" (sensitivity) lower (better) than 20 pT (rms) per square root Hz at a frequency of 1 Hz and specially designed to reduce in-motion noise;
 - Using optically pumped or nuclear precession (proton/Overhauser) "technology" having a "noise level" (sensitivity) lower (better) than 20 pT (rms) per square root Hz.
 - 3. Using fluxgate "technology" having a "noise level" (sensitivity) equal to or lower (better) than 10 pT (rms) per square root Hz at a frequency of 1 Hz;
 - 4. Induction coil "magnetometers" having a "noise level" (sensitivity) lower (better) than any of the following:

- d. Unmanned, untethered submersible vehicles, having any of the following:
 - 1. Designed for deciding a course relative to any geographical reference without real-time human assistance;
 - 2. Having an acoustic data or command link; or
 - Having a fibre optic data or command link exceeding 1,000 m;
- e. Ocean salvage systems with a lifting capacity exceeding 5 MN for salvaging objects from depths exceeding 250 m and having any of the following:
 - 1. Dynamic positioning systems capable of position keeping within 20 m of a given point provided by the navigation system; **or**
 - Seafloor navigation and navigation integration systems for depths exceeding 1,000 m with positioning accuracies to within 10 m of a predetermined point;
- f. Surface-effect vehicles (fully skirted variety) having all of the following characteristics:
 - A maximum design speed, fully loaded, exceeding 30 knots in a significant wave height of 1.25 m (Sea State 3) or more;
 - 2. A cushion pressure exceeding 3,830 Pa; and
 - 3. A light-ship-to-full-load displacement ratio of less than 0.70;
- g. Surface-effect vehicles (rigid sidewalls) with a maximum design speed, fully loaded, exceeding 40 knots in a significant wave height of 3.25 m (Sea State 5) or more;

 - A full load displacement exceeding 500 tonnes with a maximum design speed, fully loaded, exceeding 35 knots in a significant wave height of 3.25 m (Sea State 5) or more; or
 - 2. A full load displacement exceeding 1,500 tonnes with a maximum design speed, fully loaded, exceeding 25 knots in a significant wave height of 4 m (Sea State 6) or more.

Technical Note:

A small waterplane area vessel is defined by the following formula: waterplane area at an operational design draft less than $2 \times (displaced volume at the operational design draft)^{2/3}$.

2. Systems and equipment, as follows:

N.B.:

For underwater communications systems, see Category 5, Part 1 Telecommunications.

- a. Systems and equipment, specially designed or modified for submersible vehicles, designed to operate at depths exceeding 1,000 m, as follows:
 - 1. Pressure housings or pressure hulls with a maximum inside chamber diameter exceeding 1.5 m;
 - 2. Direct current propulsion motors or thrusters;
 - 3. Umbilical cables, and connectors therefor, using optical fibre and having synthetic strength members;
- b. Systems specially designed or modified for the automated control of the motion of submersible vehicles controlled by 1-8.A.1. using navigation data and having closed loop servo-controls:
 - 1. Enabling a vehicle to move within 10 m of a predetermined point in the water column;
 - 2. Maintaining the position of the vehicle within 10 m of a predetermined point in the water column; **or**

 - More than 150,000 "active pixels" per solid state area array;

Technical Note:

Limiting resolution in television is a measure of horizontal resolution usually expressed in terms of the maximum number of lines per picture height discriminated on a test chart, using IEEE Standard 208/1960 or any equivalent standard.

- Systems, specially designed or modified for remote operation with an underwater vehicle, employing techniques to minimise the effects of back scatter, including range-gated illuminators or "laser" systems;
- e. Photographic still cameras specially designed or modified for underwater use below 150 m having a film format of 35 mm or larger, and having any of the following:
 - Annotation of the film with data provided by a source external to the camera;
 - 2. Automatic back focal distance correction; or
 - Automatic compensation control specially designed to permit an underwater camera housing to be usable at depths exceeding 1,000 m;

 f. Electronic imaging systems, specially designed or modified for underwater use, capable of storing digitally more than 50 exposed images;

Note:

1-8.A.2.f. does not control digital cameras specially designed for consumer purposes, other than those employing electronic image multiplication techniques.

- g. Light systems, as follows, specially designed or modified for underwater use:
 - Stroboscopic light systems capable of a light output energy of more than 300 J per flash and a flash rate of more than 5 flashes per second;
 - 2. Argon arc light systems specially designed for use below 1.000 m:
- h. "Robots" specially designed for underwater use, controlled by using a dedicated computer, having any of the following:
 - 1. Systems that control the "robot" using information from sensors which measure force or torque applied to an external object, distance to an external object, or tactile sense between the "robot" and an external object; or
 - 2. The ability to exert a force of 250 N or more or a torque of 250 Nm or more and using titanium based alloys or "fibrous or filamentary" "composite" materials in their structural members;
- i. Remotely controlled articulated manipulators specially designed or modified for use with submersible vehicles, having any of the following:
 - 1. Systems which control the manipulator using the information from sensors which measure the torque or force applied to an external object, or tactile sense between the manipulator and an external object; or
 - Controlled by proportional master-slave techniques or by using a dedicated computer, and having 5 degrees of freedom of movement or more;

Note:

Only functions having proportional control using positional feedback or by using a dedicated computer are counted when determining the number of degrees of freedom of movement.

- j. Air independent power systems, specially designed for underwater use, as follows:
 - 1. Brayton or Rankine cycle engine air independent power systems having any of the following:
 - a. Chemical scrubber or absorber systems specially designed to remove carbon dioxide, carbon monoxide and particulates from recirculated engine exhaust;
 - b. Systems specially designed to use a monoatomic gas;
 - c. Devices or enclosures specially designed for underwater noise reduction in frequencies below 10 kHz, or special mounting devices for shock mitigation; **or**
 - d. Systems specially designed:
 - 1. To pressurise the products of reaction or for fuel reformation:
 - 2. To store the products of the reaction; and
 - 3. To discharge the products of the reaction against a pressure of 100 kPa or more;
 - 2. Diesel cycle engine air independent systems, having all of the following:
 - a. Chemical scrubber or absorber systems specially designed to remove carbon dioxide, carbon monoxide and particulates from recirculated engine exhaust;
 - b. Systems specially designed to use a monoatomic gas;

- Devices or enclosures specially designed for underwater noise reduction in frequencies below 10 kHz or special mounting devices for shock mitigation; and
- d. Specially designed exhaust systems that do not exhaust continuously the products of combustion;
- 3. Fuel cell air independent power systems with an output exceeding 2 kW having either of the following:
 - Devices or enclosures specially designed for underwater noise reduction in frequencies below 10 kHz or special mounting devices for shock mitigation; or
 - b. Systems specially designed:
 - 1. To pressurise the products of reaction or for fuel reformation;
 - 2. To store the products of the reaction; and
 - 3. To discharge the products of the reaction against a pressure of 100 kPa or more;
- 4. Stirling cycle engine air independent power systems, having all of the following:
 - a. Devices or enclosures specially designed for underwater noise reduction in frequencies below 10 kHz or special mounting devices for shock mitigation; and
 - Specially designed exhaust systems which discharge the products of combustion against a pressure of 100 kPa or more;
- k. Skirts, seals and fingers, having any of the following:
 - 1. Designed for cushion pressures of 3,830 Pa or more, operating in a significant wave height of 1.25 m (Sea State 3) or more and specially designed for surface effect vehicles (fully skirted variety) controlled by 1-8.A.1.f.; **or**
 - 2. Designed for cushion pressures of 6,224 Pa or more, operating in a significant wave height of 3.25 m (Sea State 5) or more and specially designed for surface effect vehicles (rigid sidewalls) controlled by 1-8.A.1.g.;
- Lift fans rated at more than 400 kW specially designed for surface effect vehicles controlled by 1-8.A.1.f. or 1-8.A.1.g.;
- m. Fully submerged subcavitating or supercavitating hydrofoils specially designed for vessels controlled by 1-8.A.1.h.;
- Active systems specially designed or modified to control automatically the sea-induced motion of vehicles or vessels controlled by 1-8.A.1.f., 1-8.A.1.g., 1-8.A.1.h. or 1-8.A.1.i.;
- o. Propellers, power transmission systems, power generation systems and noise reduction systems, as follows:
 - 1. Water-screw propeller or power transmission systems, as follows, specially designed for surface effect vehicles (fully skirted or rigid sidewall variety), hydrofoils or small waterplane area vessels controlled by 1-8.A.1.f., 1-8.A.1.g., 1-8.A.1.h. or 1-8.A.1.i.:
 - Supercavitating, super-ventilated, partially-submerged or surface piercing propellers rated at more than 7.5 MW;
 - b. Contrarotating propeller systems rated at more than 15 MW;
 - c. Systems employing pre-swirl or post-swirl techniques for smoothing the flow into a propeller;
 - d. Light-weight, high capacity (K factor exceeding 300) reduction gearing;
 - e. Power transmission shaft systems, incorporating "composite" material components, capable of transmitting more than 1 MW;

- Water-screw propeller, power generation systems or transmission systems designed for use on vessels, as follows:
 - a. Controllable-pitch propellers and hub assemblies rated at more than 30 MW;
 - b. Internally liquid-cooled electric propulsion engines with a power output exceeding 2.5 MW;
 - c. "Superconductive" propulsion engines, or permanent magnet electric propulsion engines, with a power output exceeding 0.1 MW;

1-8.B. Test, Inspection and Production Equipment

 Water tunnels, having a background noise of less than 100 dB (reference 1 µPa, 1 Hz) in the frequency range from 0 to 500 Hz, designed for measuring acoustic fields generated by a hydro-flow around propulsion system models.

1-8.C. Materials

- 1. Syntactic foam designed for underwater use, having all of the following:
 - a. Designed for marine depths exceeding 1,000 m; and
 - b. A density less than 561 kg/m³.

Technical Note:

Syntactic foam consists of hollow spheres of plastic or glass embedded in a resin matrix.

1-8.D. Software

1. "Software" specially designed or modified for the "development", "production" or "use" of equipment or materials controlled by 1-8.A., 1-8.B. or 1-8.C.

 Specific "software" specially designed or modified for the "development", "production", repair, overhaul or refurbishing (re-machining) of propellers specially designed for underwater noise reduction.

1-8.E. Technology

- 1. "Technology" according to the General Technology Note for the "development" or "production" of equipment or materials controlled by 1-8.A., 1-8.B. or 1-8.C.
- 2. Other "technology", as follows:
 - a. "Technology" for the "development", "production", repair, overhaul or refurbishing (re-machining) of propellers specially designed for underwater noise reduction;
 - b. "Technology" for the overhaul or refurbishing of equipment controlled by 1-8.A.1., 1-8.A.2.b., 1-8.A.2.j., 1-8.A.2.o. or 1-8.A.2.p.

1-9.A. Systems, Equipment and Components

NR.

For propulsion systems designed or rated against neutron or transient ionizing radiation, see Group 2, Munitions List.

- 1. Aero gas turbine engines having any of the following:
 - a. Incorporating any of the technologies controlled by 1-9.E.3.a.;

Note:

1-9.A.1.a. does not control aero gas turbine engines which meet all of the following:

- 1. Certified by the civil aviation authority in a Participating State; and
- Intended to power non-military manned aircraft for which one of the following has been issued by a Participating State for the aircraft with this specific engine type:
 - a. A civil Type Certificate; or
 - An equivalent document recognised by the International Civil Aviation Organisation (ICAO).
- b. Designed to power an aircraft designed to cruise at Mach 1 or higher for more than 30 minutes.
- Marine gas turbine engines with an ISO standard continuous power rating of 24,245 kW or more and a specific fuel consumption not exceeding 0.219 kg/kWh in the power range from 35 to 100%, and specially designed assemblies and components therefor.

Note:

The term 'marine gas turbine engines' includes those industrial, or aero-derivative, gas turbine engines adapted for a ship's electric power generation or propulsion.

- 3. Specially designed assemblies and components, incorporating any of the "technologies" controlled by 1-9.E.3.a., for the following gas turbine engine propulsion systems:
 - a. Controlled by 1-9.A.1.; or
 - b. Whose design or production origins are either non-participating states or unknown to the manufacturer.
- 4. Space launch vehicles and "spacecraft".

Note:

1-9.A.4. does not control payloads.

N.B.

For the control status of products contained in "spacecraft" payloads, see the appropriate Categories.

- 5. Liquid rocket propulsion systems containing any of the systems or components controlled by 1-9.A.6.
- 6. Systems and components specially designed for liquid rocket propulsion systems, as follows:
 - a. Cryogenic refrigerators, flightweight dewars, cryogenic heat pipes or cryogenic systems specially designed for use in space vehicles and capable of restricting cryogenic fluid losses to less than 30% per year;
 - b. Cryogenic containers or closed-cycle refrigeration systems capable of providing temperatures of 100 K (-173°C) or less for "aircraft" capable of sustained flight at speeds exceeding Mach 3, launch vehicles or "spacecraft";
 - c. Slush hydrogen storage or transfer systems;
 - d. High pressure (exceeding 17.5 MPa) turbo pumps, pump components or their associated gas generator or expander cycle turbine drive systems;

 - Insulation and propellant bonding systems using liners to provide a strong mechanical bond or a barrier to chemical migration between the solid propellant and case insulation material;

Technical Note:

For the purposes of 1-9.A.8.a., a strong mechanical bond means bond strength equal to or more than propellant strength.

 Filament-wound "composite" motor cases exceeding 0.61 m in diameter or having structural efficiency ratios (PV/W) exceeding 25 km;

Technical Note:

The structural efficiency ratio (PV/W) is the burst pressure (P) multiplied by the vessel volume (V) divided by the total pressure vessel weight (W).

 Nozzles with thrust levels exceeding 45 kN or nozzle throat erosion rates of less than 0.075 mm/s;

- d. Movable nozzle or secondary fluid injection thrust vector control systems capable of any of the following:
 - 1. Omni-axial movement exceeding $\pm 5^{\circ}$
 - 2. Angular vector rotations of 20°/s or more; or
 - 3. Angular vector accelerations of $40^{\circ}/s^2$ or more.
- 9. Hybrid rocket propulsion systems with:
 - a. Total impulse capacity exceeding 1.1 MNs; or

- 3. "Software" specially designed or modified for the "use" of full authority digital electronic engine controls (FADEC) for propulsion systems controlled by 1-9.A. or equipment controlled by 1-9.B., as follows:

- "Technology" according to the General Technology Note for the "production" of equipment controlled by 1-9.A.1.c, 1-9.A.4. to 1-9.A.11. or 1-9.B.

N.B.:

For "technology" for the repair of controlled structures, laminates or materials, see 1-1.E.2.f.

Note

"Development" or "production" "technology" controlled by 1-9.E. for gas turbine engines remains controlled when used as "use" "technology" for repair, rebuild and overhaul. - 5. Cooled turbine blades, vanes or tip-shrouds, other than those described in 1-9.E.3.a.1., exposed to gas path temperatures of 1,643 K (1,370°C) or more;
- 6. Airfoil-to-disk blade combinations using solid state joining;
- Gas turbine engine components using "diffusion bonding" "technology" controlled by 1-2.E.3.b.;
- 8. Damage tolerant gas turbine engine rotating components using powder metallurgy materials controlled by 1-1.C.2.b.;
- "FADEC' for gas turbine and combined cycle engines and their related diagnostic components, sensors and specially designed components;
- 10. Adjustable flow path geometry and associated control systems for:
 - a. Gas generator turbines;
 - b. Fan or power turbines; or
 - c. Propelling nozzles;

Note 1:

Adjustable flow path geometry and associated control systems in 1-9.E.3.a.10. do not include inlet guide vanes, variable pitch fans, variable stators or bleed valves for compressors.

Note 2:

1-9.E.3.a.10. does not control "development" or "production" "technology" for adjustable flow path geometry for reverse thrust.

11. Hollow fan blades;

- b. "Technology" "required" for the "development" or "production" of any of the following:
 - 1. Wind tunnel aero-models equipped with non-intrusive sensors capable of transmitting data from the sensors to the data acquisition system; **or**
 - "Composite" propeller blades or propfans capable of absorbing more than 2,000 kW at flight speeds exceeding Mach 0.55;
- c. "Technology" "required" for the "development" or "production" of gas turbine engine components using "laser", water jet, ECM or EDM hole drilling processes to produce holes having any of the following sets of characteristics:
 - 1. All of the following:
 - a. Depths more than four times their diameter;
 - b. Diameters less than 0.76 mm; and
 - c. Incidence angles equal to or less than 25°; or
 - 2. All of the following:
 - a. Depths more than five times their diameter;
 - b. Diameters less than 0.4 mm; and

Technical Note:

For the purposes of 1-9.E.3.c., incidence angle is measured from a plane tangential to the airfoil surface at the point where the hole axis enters the airfoil surface.

- c. The diameter of the flywheel housing;

 - a. Injection amount in excess of 230 mm³ per injection per cylinder; **and**
 - Specially designed electronic control features for switching governor characteristics automatically depending on fuel property to provide the same torque characteristics by using the appropriate sensors;
- g. "Technology" "required" for the "development" or "production" of high output diesel engines for solid, gas phase or liquid film (or combinations thereof) cylinder wall lubrication, permitting operation to temperatures exceeding 723 K (450°C), measured on the cylinder wall at the top limit of travel of the top ring of the piston.

Technical Note:

High output diesel engines: diesel engines with a specified brake mean effective pressure of 1.8 MPa or more at a speed of 2,300 r.p.m., provided the rated speed is 2,300 r.p.m. or more.

- **2-2.** Smooth-bore weapons with a calibre of 20 mm or more, other weapons or armament with a calibre greater than 12.7 mm (calibre 0.50 inches), projectors and accessories, as follows, and specially designed components therefor:
- Guns, howitzers, cannon, mortars, anti-tank weapons, projectile launchers, military flame throwers, recoilless rifles and signature reduction devices therefor;

(All destinations)

Note

2-2.a. includes injectors, metering devices, storage tanks and other specially designed components for use with liquid propelling charges for any of the equipment controlled by 2-2.a.

b. Military smoke, gas and pyrotechnic projectors or generators; (All destinations)

Note:

2-2.b. does not control signal pistols.

c. Weapons sights.

2-3. Ammunition and fuze setting devices, as follows, and specially designed components therefor: (All destinations)

- a. Ammunition for the weapons controlled by 2-1., 2-2. or 2-12.;
- Fuze setting devices specially designed for ammunition controlled by 2-3.a.

Note 1:

Specially designed components include:

- Metal or plastic fabrications such as primer anvils, bullet cups, cartridge links, rotating bands and munitions metal parts;

Note:

2-4.a. includes:

2-15. Imaging or countermeasure equipment, as follows, specially designed for military use, and specially designed components and accessories therefor:

- a. Recorders and image processing equipment;
- b. Cameras, photographic equipment and film processing equipment;
- c. Image intensifier equipment;
- d. Infrared or thermal imaging equipment;

- e. Imaging radar sensor equipment;
- f. Countermeasure or counter-countermeasure equipment for the equipment controlled by sub-items 2-15.a. to 2-15.e.
 Note:
- 2-15.f. includes equipment designed to degrade the operation or effectiveness of military imaging systems or to minimize such degrading effects.

Note 1:

The term 'specially designed components' includes the following when specially designed for military use:

- a. Infrared image converter tubes;
- b. Image intensifier tubes (other than first generation);
- c. Microchannel plates;
- d. Low-light-level television camera tubes;
- e. Detector arrays (including electronic interconnection or read out systems);
- f. Pyroelectric television camera tubes;
- g. Cooling systems for imaging systems;
- h. Electrically triggered shutters of the photochromic or electro-optical type having a shutter speed of less than 100 µs, except in the case of shutters which are an essential part of a high speed camera;
- i. Fibre optic image inverters;
- i. Compound semiconductor photocathodes.

Note 2:

2-15. does not control "first generation image intensifier tubes" or equipment specially designed to incorporate "first generation image intensifier tubes".

N.B.

For the status of weapons sights incorporating "first generation image intensifier tubes" see entries 2-1., 2-2. and 2-5.a.

N.B.:

See also Items 1-6.A.2.a.2. and 1-6.A.2.b. on the Dual-Use List.

2-16. Forgings, castings and other unfinished products the use of which in a controlled product is identifiable by material composition, geometry or function, and which are specially designed for any products controlled by 2-1. to 2-4., 2-6., 2-9., 2-10., 2-12. or 2-19.

2-17. Miscellaneous equipment, materials and libraries, as follows, and specially designed components therefor:

- Self-contained diving and underwater swimming apparatus, as follows:
 - Closed or semi-closed circuit (rebreathing) apparatus specially designed for military use (i.e., specially designed to be non magnetic);
 - Specially designed components for use in the conversion of open-circuit apparatus to military use;
 - Articles designed exclusively for military use with selfcontained diving and underwater swimming apparatus;
- b. Construction equipment specially designed for military use;
- Fittings, coatings and treatments for signature suppression, specially designed for military use;
- d. Field engineer equipment specially designed for use in a combat zone;
- e. "Robots", "robot" controllers and "robot" "end-effectors", having any of the following characteristics:
 - 1. Specially designed for military use;
 - 2. Incorporating means of protecting hydraulic lines against externally induced punctures caused by ballistic fragments (e.g., incorporating self-sealing lines) and designed to use hydraulic fluids with flash points higher than 839 K (566°C); or

- Specially designed or rated for operating in an electromagnetic pulse (EMP) environment;
- f. Libraries (parametric technical databases) specially designed for military use with equipment controlled by the Munitions List;
- g. Nuclear power generating equipment or propulsion equipment, including "nuclear reactors", specially designed for military use and components therefor specially designed or modified for military use;
- Equipment and material, coated or treated for signature suppression, specially designed for military use, other than those controlled elsewhere in the Munitions List;
- i. Simulators specially designed for military "nuclear reactors";
- Mobile repair shops specially designed or modified to service military equipment;
- k. Field generators specially designed or modified for military use;
- 1. Containers specially designed or modified for military use;
- m. Ferries, other than those controlled elsewhere in the Munitions List, bridges and pontoons, specially designed for military use;
- n. Test models specially designed for the "development" of items controlled by 2-4., 2-6., 2-9. or 2-10;
- Laser protection equipment (e.g., eye and sensor protection) specially designed for military use.

Technical Notes:

- For the purpose of 2-17., the term 'library' (parametric technical database) means a collection of technical information of a military nature, reference to which may enhance the performance of military equipment or systems.
- For the purpose of 2-17., 'modified' means any structural, electrical, mechanical, or other change that provides a non-military item with military capabilities equivalent to an item which is specially designed for military use.

2-18. Equipment for the production of products referred to in the Munitions List, as follows:

- a. Specially designed or modified production equipment for the production of products controlled by the Munitions List, and specially designed components therefor;
- Specially designed environmental test facilities and specially designed equipment therefor, for the certification, qualification or testing of products controlled by the Munitions List.

Technical Note:

For the purposes of 2-18., the term 'production' includes design, examination, manufacture, testing and checking.

Note 1:

2-18.a. and 2-18.b. include the following equipment:

- a. Continuous nitrators;
- Centrifugal testing apparatus or equipment having any of the following characteristics:
 - Driven by a motor or motors having a total rated horsepower of more than 298 kW (400 hp);
 - 2. Capable of carrying a payload of 113 kg or more; or
 - Capable of exerting a centrifugal acceleration of 8 g or more on a payload of 91 kg or more;
- c. Dehydration presses;
- d. Screw extruders specially designed or modified for military explosive extrusion;
- e. Cutting machines for the sizing of extruded propellants;
- f. Sweetie barrels (tumblers) 1.85 m or more in diameter and having over 227 kg product capacity;
- g. Continuous mixers for solid propellants;
- Fluid energy mills for grinding or milling the ingredients of military explosives:
- Equipment to achieve both sphericity and uniform particle size in metal powder listed in 2-8.c.8.:
- j. Convection current converters for the conversion of materials listed in 2-8.c.3.

Note 2:

- a. The term 'products referred to in the Munitions List' includes:
 - Products not controlled if inferior to specified concentrations as follows:
 - a. Hydrazine (see 2-8.c.4.);
 - b. "Explosives" (see 2-8.);
 - Products not controlled if inferior to technical limits, (i.e. "superconductive" materials not controlled by 1-1.C.5. on the Dual-Use List; "superconductive" electromagnets not controlled by 1-3.A.1.e.3. on the Dual-Use List; "superconductive" electrical equipment excluded from control under 2-20.b.);
 - Metal fuels and oxidants deposited in laminar form from the vapour phase (see 2-8.c.5.);
- b. The term 'products referred to in the Munitions List' does not include:
 - 1 Signal pistols (see 2-2.b.);
 - 2. The substances excluded from control under Note 3 to 2-7.;
 - Personal radiation monitoring dosimeters (see 2-7.g.) and masks for protection against specific industrial hazards, see also Dual-Use List;
 - 4. Difluoroamine and potassium nitrate powder (see Note 6 to 2-8.);
 - 5. Aero-engines excluded from control under 2-10.;
 - Conventional steel helmets not equipped with, or modified or designed to accept, any type of accessory device (see Note 2 to Item 2-13.);
 - Equipment fitted with industrial machinery, which is not controlled such as coating machinery not elsewhere specified and equipment for the casting of plastics;
 - Muskets, rifles and carbines dated earlier than 1938, reproductions of muskets, rifles and carbines dated earlier than 1890, revolvers, pistols and machine guns dated earlier than 1890, and their reproductions;

Note 3:

Note 2.b.8. of 2-18. does not release from controls production equipment for non-antique small arms, even if used to produce reproductions of antique small arms.

2-19. Directed energy weapon systems (DEW), related or countermeasure equipment and test models, as follows, and specially designed components therefor:

- a. "Laser" systems specially designed for destruction or effecting mission-abort of a target;
- Particle beam systems capable of destruction or effecting mission-abort of a target;
- c. High power radio-frequency (RF) systems capable of destruction or effecting mission-abort of a target;
- d. Equipment specially designed for the detection or identification of, or defence against, systems controlled by 2-19.a. to 2-19.c.;
- Physical test models and related test results for the systems, equipment and components controlled by this Item.
- f. Continuous wave or pulsed "laser" systems specially designed to cause permanent blindness to unenhanced vision, i.e., to the naked eye or to the eye with corrective eyesight devices.

Note 1:

Directed energy weapon systems controlled by 2-19. include systems whose capability is derived from the controlled application of:

- "Lasers" of sufficient continuous wave or pulsed power to effect destruction similar to the manner of conventional ammunition;
- Particle accelerators which project a charged or neutral particle beam with destructive power;
- c. High pulsed power or high average power radio frequency beam transmitters which produce fields sufficiently intense to disable electronic circuitry at a distant target.

Note 2:

2-19. includes the following when specially designed for directed energy weapon systems:

 a. Prime power generation, energy storage, switching, power conditioning or fuel-handling equipment;

- b. Target acquisition or tracking systems;
- Systems capable of assessing target damage, destruction or mission-abort;
- d. Beam-handling, propagation or pointing equipment;
- Equipment with rapid beam slew capability for rapid multiple target operations;
- f. Adaptive optics and phase conjugators;
- g. Current injectors for negative hydrogen ion beams;
- h. "Space qualified" accelerator components;
- i. Negative ion beam funnelling equipment;
- Equipment for controlling and slewing a high energy ion beam;
- k. "Space qualified" foils for neutralising negative hydrogen isotope beams.

2-20. Cryogenic and "superconductive" equipment, as follows, and specially designed components and accessories therefor:

 Equipment specially designed or configured to be installed in a vehicle for military ground, marine, airborne or space applications, capable of operating while in motion and of producing or maintaining temperatures below 103 K (-170°C);
 Note:

2-20.a. includes mobile systems incorporating or employing accessories or components manufactured from non-metallic or non-electrical conductive materials, such as plastics or epoxy-impregnated materials.

 "Superconductive" electrical equipment (rotating machinery and transformers) specially designed or configured to be installed in a vehicle for military ground, marine, airborne or space applications, capable of operating while in motion.

Note:

2-20.b. does not control direct-current hybrid homopolar generators that have single-pole normal metal armatures which rotate in a magnetic field produced by superconducting windings, provided those windings are the only superconducting component in the generator.

2-21. "Software", as follows:

- a. "Software" specially designed or modified for the "development", "production" or "use" of equipment or materials controlled by the Munitions List;
- b. Specific "software", as follows:
 - 1. "Software" specially designed for:
 - a. Modelling, simulation or evaluation of military weapon systems;
 - b. "Development", monitoring, maintenance or up-dating of "software" embedded in military weapon systems;
 - Modelling or simulating military operation scenarios, not controlled by 2-14.;
 - d. Command, Communications, Control and Intelligence (C³I) or Command, Communications, Control, Computer and Intelligence (C⁴I) applications;
 - "Software" for determining the effects of conventional, nuclear, chemical or biological warfare weapons.
 - 3. "Software", not controlled by 2-21.a., 2-21.b.1. or 2-21.b.2., specially designed or modified to enable equipment not controlled by the Munitions List to perform the military functions of equipment controlled by 2-5., 2-7.g., 2-9.c., 2-9.e., 2-10.e., 2-11., 2-14., 2-15., 2-17.i. or 2-18.

2-22. "Technology" as follows:

- a. "Technology", other than specified in 2-22.b., which is "required" for the "development", "production" or "use" of items controlled in the Munitions List.
- b. "Technology" as follows:
 - "Technology" "required" for the design of, the assembly of components into, and the operation, maintenance and repair of complete production installations for items controlled in the Munitions List, even if the components of such production installations are not controlled;
 - 2. "Technology" "required" for the "development" and "production" of small arms even if used to produce reproductions of antique small arms;
 - 3. "Technology" "required" for the "development", "production" or "use" of toxicological agents, related equipment or components controlled by 2-7.a. to 2-7.g.;
 - "Technology" "required" for the "development", "production" or "use" of "biopolymers" or cultures of specific cells controlled by 2-7.h.;
 - "Technology" "required" exclusively for the incorporation of "biocatalysts", controlled by 2-7.i.1., into military carrier substances or military material.

Note 1:

"Technology" "required" for the "development", "production" or "use" of items controlled in the Munitions List remains under control even when applicable to any uncontrolled item.

Note 2:

2-22. does not control "technology" as follows:

- a. Which is the minimum necessary for the installation, operation, maintenance (checking) and repair of those items which are not controlled or whose export has been authorised;
- Which is "in the public domain", "basic scientific research" or the minimum necessary information for patent applications;
- c. For magnetic induction for continuous propulsion of civil transport devices.

Definitions of Terms used in Groups 1 and 2

This document contains the definitions of the terms used in Groups 1 and 2 in alphabetical order.

Note 1:

Definitions apply throughout Groups 1 and 2. The references are purely advisory and have no effect on the universal application of defined terms throughout Groups 1 and 2.

Note 2:

Words and terms contained in the List of Definitions only take the defined meaning where this is indicated by their being enclosed in quotations marks (""). Elsewhere, words and terms take their commonly accepted (dictionary) meanings, unless a local definition for a particular control is given.

Cat 2/Cat 6 - "Accuracy"

(Usually measured in terms of inaccuracy) is the maximum deviation, positive or negative, of an indicated value from an accepted standard or true value.

Cat 7 - "Active flight control systems"

Function to prevent undesirable "aircraft" and missile motions or structural loads by autonomously processing outputs from multiple sensors and then providing necessary preventive commands to effect automatic control.

Cat 6/Cat 8 - "Active pixel"

A minimum (single) element of the solid state array which has a photoelectric transfer function when exposed to light (electromagnetic) radiation.

Cat 1/2-7 - "Adapted for use in war"

Any modification or selection (such as altering purity, shelf life, virulence, dissemination characteristics, or resistance to UV radiation) designed to increase the effectiveness in producing casualties in humans or animals, degrading equipment or damaging crops or the environment.

2-8 - "Additives"

Substances used in explosive formulations to improve their properties.

Cat 1/Cat 7/Cat 9/2-10/2-14 - "Aircraft"

A fixed wing, swivel wing, rotary wing (helicopter), tilt rotor or tilt-wing airborne vehicle.

Cat 2 - "All compensations available"

"All compensations available" means after all feasible measures available to the manufacturer to minimise all systematic positioning errors for the particular machine-tool model are considered.

Cat 3/Cat 5 P1 - "Allocated by the ITU"

The allocation of frequency bands according to the current edition of the ITU Radio Regulations for primary, permitted and secondary services.

N.B. Additional and alternative allocations are not included.

Cat 2 - "Angular position deviation"

The maximum difference between angular position and the actual, very accurately measured angular position after the workpiece mount of the table has been turned out of its initial position. (Reference: VDI/VDE 2617, Draft: 'Rotary tables on coordinate measuring machines').

Cat 5 - "Asymmetric algorithm"

A cryptographic algorithm using different, mathematically-related keys for encryption and decryption.

Technical Note:

A common use of "asymmetric algorithms" is key management.

Cat 6 - "Automatic target tracking"

A processing technique that automatically determines and provides as output an extrapolated value of the most probable position of the target in real time.

Cat 3 - "Basic gate propagation delay time"

The propagation delay time value corresponding to the basic gate used in a "monolithic integrated circuit". For a 'family' of "monolithic integrated circuits", this may be specified, either as the propagation delay time per typical gate within the given 'family' or as the typical propagation delay time per gate within the given 'family'.

Technical Notes:

- "Basic gate propagation delay time" is not to be confused with the input/output delay time of a complex "monolithic integrated circuit".
- 'Family' consists of all integrated circuits to which all of the following are applied as their manufacturing methodology and specifications except their respective functions:
 - a. The common hardware and software architecture;
 - b. The common design and process technology; and
 - c. The common basic characteristics.

GTN - "Basic scientific research"

Experimental or theoretical work undertaken principally to acquire new knowledge of the fundamental principles of phenomena or observable facts, not primarily directed towards a specific practical aim or objective.

Cat 7 - "Bias" (accelerometer)

An accelerometer output when no acceleration is applied.

2-7/2-22 - "Biocatalysts"

Enzymes for specific chemical or biochemical reactions or other biological compounds which bind to and accelerate the degradation of CW agents.

N.B.:

'Enzymes' means "biocatalysts" for specific chemical or biochemical reactions.

2-7/2-22 - "Biopolymers"

Biological macromolecules as follows:

- a. Enzymes for specific chemical or biochemical reactions;
- b. Antibodies, monoclonal, polyclonal or anti-idiotypic;
- c. Specially designed or specially processed receptors;

Technical Notes:

- 'Anti-idiotypic antibodies' means antibodies which bind to the specific antigen binding sites of other antibodies;
- 'Monoclonal antibodies' means proteins which bind to one antigenic site and are produced by a single clone of cells;
- 'Polyclonal antibodies' means a mixture of proteins which bind to the specific antigen and are produced by more than one clone of cells;
- 'Receptors' means biological macromolecular structures capable of binding ligands, the binding of which affects physiological functions.

Cat 2 - "Camming" (axial displacement)

Axial displacement in one revolution of the main spindle measured in a plane perpendicular to the spindle faceplate, at a point next to the circumference of the spindle faceplate (Reference: ISO 230/1 1986, paragraph 5.63).

Cat 1 - "Carbon fibre preforms"

An ordered arrangement of uncoated or coated fibres intended to constitute a framework of a part before the "matrix" is introduced to form a "composite".

Cat 4 - "CE"

"CE" is equivalent to "computing element".

Cat 6 - "Chemical Laser"

A "laser" in which the excited species is produced by the output energy from a chemical reaction.

"Circuit element"

A single active or passive functional part of an electronic circuit, such as one diode, one transistor, one resistor, one capacitor, etc.

Cat 7 - "Circulation-controlled anti-torque or circulation-controlled direction control systems"

Control systems using air blown over aerodynamic surfaces to increase or control the forces generated by the surfaces.

Cat 1/Cat 7/Cat 9/2-10 - "Civil aircraft"

Those "aircraft" listed by designation in published airworthiness certification lists by the civil aviation authorities to fly commercial civil internal and external routes or for legitimate civil, private or business use.

Cat 1 - "Commingled"

Filament to filament blending of thermoplastic fibres and reinforcement fibres in order to produce a fibre reinforcement "matrix" mix in total fibre form.

Cat 1 - "Comminution"

A process to reduce a material to particles by crushing or grinding. Cat 5 - "Common channel signalling"

A signalling method in which a single channel between exchanges conveys, by means of labelled messages, signalling information relating to a multiplicity of circuits or calls and other information such as that used for network management.

Cat 4 - "Communications channel controller"

The physical interface which controls the flow of synchronous or asynchronous digital information. It is an assembly that can be integrated into computer or telecommunications equipment to provide communications access.

Cat 1/Cat 2/Cat6/Cat 8/Cat 9 - "Composite"

A "matrix" and an additional phase or additional phases consisting of particles, whiskers, fibres or any combination thereof, present for a specific purpose or purposes.

Cat 3/Cat 4 - "Composite theoretical performance" ("CTP")

A measure of computational performance given in millions of theoretical operations per second (Mtops), calculated using the aggregation of "computing elements"

N.B.: See Category 4, Technical Note.

Cat 2 - "Compound rotary table"

A table allowing the workpiece to rotate and tilt about two non-parallel axes, which can be coordinated simultaneously for "contouring control".

Cat 4 - "Computing element" ("CE")

The smallest computational unit that produces an arithmetic or logic result.

Cat 2 - "Contouring control"

Two or more "numerically controlled" motions operating in accordance with instructions that specify the next required position and the required feed rates to that position. These feed rates are varied in relation to each other so that a desired contour is generated (Ref. ISO/DIS 2806 - 1980).

Cat 1/Cat 3/Cat 6 - "Critical temperature"

(sometimes referred to as the transition temperature) of a specific "superconductive" material is the temperature at which the material loses all resistance to the flow of direct electrical current.

Cat 5 - "Cryptography"

The discipline which embodies principles, means and methods for the transformation of data in order to hide its information content, prevent its undetected modification or prevent its unauthorized use. "Cryptography" is limited to the transformation of information using one or more secret parameters (e.g., crypto variables) or associated key management.

Technical Note:

'Secret parameter': a constant or key kept from the knowledge of others or shared only within a group.

Cat 3/Cat 4 - "CTP"

"CTP" is equivalent to "Composite theoretical performance".

Cat 7 - "Data-Based Referenced Navigation" ("DBRN") Systems Systems which use various sources of previously measured geomapping data integrated to provide accurate navigation information under dynamic conditions. Data sources include bathymetric maps, stellar maps, gravity maps, magnetic maps or 3-D digital terrain maps.

Cat 5 - "Data signalling rate"

The rate, as defined in ITU Recommendation 53-36, taking into account that, for non-binary modulation, baud and bit per second are not equal. Bits for coding, checking and synchronisation functions are to be included.

Note:

When determining the "data signalling rate", servicing and administrative channels shall be excluded.

Technical Note:

It is the maximum one-way rate, i.e., the maximum rate in either transmission or reception.

Cat 6 - "Deformable Mirrors"

Mirrors:

- a. Having a single continuous optical reflecting surface which is dynamically deformed by the application of individual torques or forces to compensate for distortions in the optical waveform incident upon the mirror; or
- b. Having multiple optical reflecting elements that can be individually and dynamically repositioned by the application of torques or forces to compensate for distortions in the optical waveform incident upon the mirror.

"Deformable mirrors" are also known as adaptive optic mirrors. GTN-Both Lists - "Development"

Is related to all stages prior to serial production, such as: design, design research, design analyses, design concepts, assembly and testing of prototypes, pilot production schemes, design data, process of transforming design data into a product, configuration design, integration design, layouts.

Cat 1/Cat 2/Cat 9 - "Diffusion bonding"

A solid state molecular joining of at least two separate metals into a single piece with a joint strength equivalent to that of the weakest material.

Cat 4/Cat 5 - "Digital computer"

Equipment which can, in the form of one or more discrete variables, perform all of the following:

- a. Accept data;
- Store data or instructions in fixed or alterable (writable) storage devices;
- Process data by means of a stored sequence of instructions which is modifiable; and

d. Provide output of data.

Technical Note:

Modifications of a stored sequence of instructions include replacement of fixed storage devices, but not a physical change in wiring or interconnections.

Cat 5 - "Digital transfer rate"

The total bit rate of the information that is directly transferred on any type of medium. (See also "total digital transfer rate").

Cat 2 - "Direct-acting hydraulic pressing"

A deformation process which uses a fluid-filled flexible bladder in direct contact with the workpiece.

"Discrete component"

A separately packaged "circuit element" with its own external connections.

Cat 7 - "Drift rate" (gyro)

The time rate of output deviation from the desired output. It consists of random and systematic components and is expressed as an equivalent input angular displacement per unit time with respect to inertial space.

Cat 5 - "Dynamic adaptive routing"

Automatic rerouting of traffic based on sensing and analysis of current actual network conditions.

Note:

This does not include cases of routing decisions taken on predefined information.

Cat 3 - "Dynamic signal analysers"

"Signal analysers" which use digital sampling and transformation techniques to form a Fourier spectrum display of the given waveform including amplitude and phase information.

Cat 1 - "Effective gram"

"Effective gram" for plutonium isotope is defined as the isotope weight in grams.

Cat 5/Cat 6 - "Electronically steerable phased array antenna"

An antenna which forms a beam by means of phase coupling, (i.e., the beam direction is controlled by the complex excitation coefficients of the radiating elements) and the direction of that beam can be varied (both in transmission and reception) in azimuth or in elevation, or both, by application of an electrical signal.

Cat 2/Cat 3/Cat 4/Cat5 - "Electronic assembly"

A number of electronic components (i.e., "circuit elements", "discrete components", integrated circuits, etc.) connected together to perform (a) specific function(s), replaceable as an entity and normally capable of being disassembled.

Cat 2/2-17 - "End-effectors"

Grippers, active tooling units and any other tooling that is attached to the baseplate on the end of a "robot" manipulator arm. *Technical Note:*

'Active tooling units' are devices for applying motive power, process energy or sensing to a workpiece.

2-4/2-8 - "Energetic materials"

Substances or mixtures that react chemically to release energy required for their intended application. "Explosives", "pyrotechnics" and "propellants" are subclasses of energetic materials.

Cat 6 - "Equivalent Density"

The mass of an optic per unit optical area projected onto the optical surface.

Cat 4/Cat 7 - "Expert systems"

Systems providing results by application of rules to data which are stored independently of the "programme" and capable of any of the following:

- a. Modifying automatically the "source code" introduced by the user;
- Providing knowledge linked to a class of problems in quasinatural language; or
- Acquiring the knowledge required for their development (symbolic training).

2-8/2-18 - "Explosives"

Solid, liquid or gaseous substances or mixtures of substances which, in their application as primary, booster, or main charges in warheads, demolition and other applications, are required to detonate.

2-7 - "Expression Vectors"

Carriers (e.g., plasmid or virus) used to introduce genetic material into host cells.

Cat 7/Cat 9 - "FADEC"

Full Authority Digital Engine Control (FADEC) - an electronic control system for gas turbine or combined cycle engines utilising a digital computer to control the variables required to regulate engine thrust or shaft power output throughout the engine operating range from the beginning of fuel metering to fuel shutoff.

Cat 4 - "Fault tolerance"

The capability of a computer system, after any malfunction of any of its hardware or "software" components, to continue to operate without human intervention, at a given level of service that provides continuity of operation, data integrity and recovery of service within a given time.

Cat 1/Cat 8 - "Fibrous or filamentary materials"

Include:

- a. Continuous monofilaments;
- b. Continuous yarns and rovings;
- c. Tapes, fabrics, random mats and braids;
- d. Chopped fibres, staple fibres and coherent fibre blankets;
- e. Whiskers, either monocrystalline or polycrystalline, of any length;
- f. Aromatic polyamide pulp.

Cat 3 - "Film type integrated circuit"

An array of "circuit elements" and metallic interconnections formed by deposition of a thick or thin film on an insulating "substrate".

2-15 - "First generation image intensifier tubes"

Electrostatically focused tubes, employing input and output fibre optic or glass face plates, multi-alkali photocathodes (S-20 or S-25), but not microchannel plate amplifiers.

Cat 5 - "Fixed"

The coding or compression algorithm cannot accept externally supplied parameters (e.g., cryptographic or key variables) and cannot be modified by the user.

Cat 7 - "Flight control optical sensor array"

A network of distributed optical sensors, using "laser" beams, to provide real-time flight control data for on-board processing.

Cat 7 - "Flight path optimization"

A procedure that minimizes deviations from a four-dimensional (space and time) desired trajectory based on maximizing performance or effectiveness for mission tasks.

Cat 7 - "Focal plane array"

A linear or two-dimensional planar layer, or combination of planar layers, of individual detector elements, with or without readout electronics, which work in the focal plane.

Note:

This definition does not include a stack of single detector elements or any two, three or four element detectors provided time delay and integration is not performed within the element.

Cat 3 - "Fractional bandwidth"

The "instantaneous bandwidth" divided by the centre frequency, expressed as a percentage.

Cat 5 - "Frequency hopping"

A form of "spread spectrum" in which the transmission frequency of a single communication channel is made to change by a random or pseudo-random sequence of discrete steps.

Cat 3/Cat 5 - "Frequency switching time"

The maximum time (i.e., delay) taken by a signal, when switched from one selected output frequency to another selected output frequency, to reach any of the following:

- a. A frequency within 100 Hz of the final frequency; or
- b. An output level within 1 dB of the final output level.

Cat 3 - "Frequency synthesiser"

Any kind of frequency source or signal generator, regardless of the actual technique used, providing a multiplicity of simultaneous or alternative output frequencies, from one or more outputs, controlled by, derived from or disciplined by a lesser number of standard (or master) frequencies.

Cat 1 - "Gas Atomisation"

A process to reduce a molten stream of metal alloy to droplets of 500 µm diameter or less by a high pressure gas stream.

Cat 6 - "Geographically dispersed"

Sensors are considered "geographically dispersed" when each location is distant from any other more than 1,500 m in any direction. Mobile sensors are always considered "geographically dispersed".

Cat 2 - "Hot isostatic densification"

A process of pressurising a casting at temperatures exceeding 375 K (102°C) in a closed cavity through various media (gas, liquid, solid particles, etc.) to create equal force in all directions to reduce or eliminate internal voids in the casting.

Cat 4 - "Hybrid computer"

Equipment which can perform all of the following:

- a. Accept data;
- Process data, in both analogue and digital representations;
 and
- c. Provide output of data.

Cat 3 - "Hybrid integrated circuit"

Any combination of integrated circuit(s), or integrated circuit with "circuit elements" or "discrete components" connected together to perform (a) specific function(s), and having all of the following characteristics:

- a. Containing at least one unencapsulated device;
- b. Connected together using typical IC production methods;
- c. Replaceable as an entity; and
- d. Not normally capable of being disassembled.

Cat 4 - "Image enhancement"

The processing of externally derived information-bearing images by algorithms such as time compression, filtering, extraction, selection, correlation, convolution or transformations between domains (e.g., fast Fourier transform or Walsh transform). This does not include algorithms using only linear or rotational transformation of a single image, such as translation, feature extraction, registration or false coloration.

Cat 5 - "Information security"

All the means and functions ensuring the accessibility, confidentiality or integrity of information or communications, excluding the means and functions intended to safeguard against malfunctions. This includes "cryptography", cryptanalysis, protection against compromising emanations and computer security. *Technical Nate:*

'Cryptanalysis': the analysis of a cryptographic system or its inputs and outputs to derive confidential variables or sensitive data, including clear text. (ISO 7498-2-1988 (E), paragraph 3.3.18).

Cat 3/Cat 5 P1 - "Instantaneous bandwidth"

The bandwidth over which output power remains constant within 3 dB without adjustment of other operating parameters.

Cat 6 - "Instrumented range"

The specified unambiguous display range of a radar.

Cat 6 - "Interconnected radar sensors"

Two or more radar sensors are interconnected when they mutually exchange data in real time.

GTN/GSN/2-22 - "In the public domain"

This means "technology" or "software" which has been made available without restrictions upon its further dissemination.

Copyright restrictions do not remove "technology" or "software" from being "in the public domain".

Cat 6 - "Intrinsic magnetic gradiometer"

A single magnetic field gradient sensing element and associated electronics the output of which is a measure of magnetic field gradient.

Cat 2 - "Isostatic presses"

Equipment capable of pressurising a closed cavity through various media (gas, liquid, solid particles, etc.) to create equal pressure in all directions within the cavity upon a workpiece or material.

Cat 2/Cat 3/Cat 5/Cat 6/Cat 9/2-5/2-19 - "Laser"

An assembly of components which produce both spatially and temporally coherent light that is amplified by stimulated emission of radiation.

2-10 - "Lighter-than-air vehicles"

Balloons and airships that rely on hot air or on lighter-than-air gases such as helium or hydrogen for their lift.

Cat 2 - "Linearity"

(Usually measured in terms of non-linearity) is the maximum deviation of the actual characteristic (average of upscale and downscale readings), positive or negative, from a straight line so positioned as to equalise and minimise the maximum deviations.

Cat 4 - "Local area network"

A data communication system having all of the following characteristics:

- Allows an arbitrary number of independent data devices to communicate directly with each other; and
- b. Is confined to a geographical area of moderate size (e.g., office building, plant, campus, warehouse).

Technical Note:

'Data device' means equipment capable of transmitting or receiving sequences of digital information.

Cat 6 - "Magnetic gradiometers"

Are designed to detect the spatial variation of magnetic fields from sources external to the instrument. They consist of multiple "magnetometers" and associated electronics the output of which is a measure of magnetic field gradient. (See also "Intrinsic Magnetic Gradiometer").

Cat 6 - "Magnetometers"

Are designed to detect magnetic fields from sources external to the instrument. They consist of a single magnetic field sensing element and associated electronics the output of which is a measure of the magnetic field.

Cat 4 - "Main storage"

The primary storage for data or instructions for rapid access by a central processing unit. It consists of the internal storage of a "digital computer" and any hierarchical extension thereto, such as cache storage or non-sequentially accessed extended storage.

Cat 1/Cat 2/Cat 8/Cat 9 - "Matrix"

A substantially continuous phase that fills the space between particles, whiskers or fibres.

Cat 2 - "Measurement uncertainty"

The characteristic parameter which specifies in what range around the output value the correct value of the measurable variable lies with a confidence level of 95%. It includes the uncorrected systematic deviations, the uncorrected backlash and the random deviations (Reference: ISO 10360-2, or VDI/VDE2617).

Cat 1 - "Mechanical alloying"

An alloying process resulting from the bonding, fracturing and rebonding of elemental and master alloy powders by mechanical impact. Non-metallic particles may be incorporated in the alloy by addition of the appropriate powders.

Cat 1 - "Melt extraction"

A process to "solidify rapidly" and extract a ribbon-like alloy product by the insertion of a short segment of a rotating chilled block into a bath of a molten metal alloy.

Cat 1 - "Melt spinning"

A process to "solidify rapidly" a molten metal stream impinging upon a rotating chilled block, forming a flake, ribbon or rod-like product.

Cat 3 - "Microcomputer microcircuit"

A "monolithic integrated circuit" or "multichip integrated circuit" containing an arithmetic logic unit (ALU) capable of executing general purpose instructions from an internal storage, on data contained in the internal storage.

Technical Note:

The internal storage may be augmented by an external storage.

Cat 3 - "Microprocessor microcircuit"

A "monolithic integrated circuit" or "multichip integrated circuit" containing an arithmetic logic unit (ALU) capable of executing a series of general purpose instructions from an external storage.

Technical Note:

The "microprocessor microcircuit" normally does not contain integral useraccessible storage, although storage present on-the-chip may be used in performing its logic function.

Note:

This definition includes chip sets which are designed to operate together to provide the function of a "microprocessor microcircuit".

"Microprogramme"

A sequence of elementary instructions maintained in a special storage, the execution of which is initiated by the introduction of its reference instruction register.

Cat 3 - "Monolithic integrated circuit"

A combination of passive or active "circuit elements" or both which:

- a. Are formed by means of diffusion processes, implantation processes or deposition processes in or on a single semiconducting piece of material, a so-called 'chip';
- b. Can be considered as indivisibly associated; and
- c. Perform the function(s) of a circuit.

Cat 6 - "Monospectral imaging sensors"

Are capable of acquisition of imaging data from one discrete spectral band.

Cat 3 - "Multichip integrated circuit"

Two or more "monolithic integrated circuits" bonded to a common "substrate".

Cat 4 - "Multi-data-stream processing"

The "microprogramme" or equipment architecture technique which permits simultaneous processing of two or more data sequences under the control of one or more instruction sequences by means such as:

- a. Single Instruction Multiple Data (SIMD) architectures such as vector or array processors;
- b. Multiple Single Instruction Multiple Data (MSIMD) architectures;
- Multiple Instruction Multiple Data (MIMD) architectures, including those which are tightly coupled, closely coupled or loosely coupled; or
- d. Structured arrays of processing elements, including systolic arrays.

Cat 5 - "Multilevel security"

A class of system containing information with different sensitivities that simultaneously permits access by users with different security clearances and needs-to-know, but prevents users from obtaining access to information for which they lack authorization.

Technical Note:

"Multilevel security" is computer security and not computer reliability which deals with equipment fault prevention or human error prevention in general.

Cat 6 - "Multispectral imaging sensors"

Are capable of simultaneous or serial acquisition of imaging data from two or more discrete spectral bands. Sensors having more than twenty discrete spectral bands are sometimes referred to as hyperspectral imaging sensors.

Cat 4 - "Network access controller"

A physical interface to a distributed switching network. It uses a common medium which operates throughout at the same "digital transfer rate" using arbitration (e.g., token or carrier sense) for transmission. Independently from any other, it selects data packets or data groups (e.g., IEEE 802) addressed to it. It is an assembly that can be integrated into computer or telecommunications equipment to provide communications access.

Cat 4 - "Neural computer"

A computational device designed or modified to mimic the behaviour of a neuron or a collection of neurons, i.e., a computational device which is distinguished by its hardware capability to modulate the weights and numbers of the interconnections of a multiplicity of computational components based on previous data.

Cat 6 - "Noise level"

An electrical signal given in terms of power spectral density. The relation between "noise level" expressed in peak-to-peak is given by $S^2\ pp=8N_o(f_2\text{-}f_1)$, where S_{pp} is the peak-to-peak value of the signal (e.g., nanoteslas), N_o is the power spectral density (e.g., (nanotesla)^2/Hz) and $(f_2\text{-}f_1)$ defines the bandwidth of interest.

2-17 - "Nuclear reactor"

Includes the items within or attached directly to the reactor vessel, the equipment which controls the level of power in the core, and the components which normally contain or come into direct contact with or control the primary coolant of the reactor core.

Cat 2 - "Numerical control"

The automatic control of a process performed by a device that makes use of numeric data usually introduced as the operation is in progress (Ref. ISO 2382).

Cat 4/Cat 9 - "Object code"

"Object code": An equipment executable form of a convenient expression of one or more processes ("source code" (or source language)) which has been converted by a programming system.

Cat 5 - "Optical amplification"

In optical communications, an amplification technique that introduces a gain of optical signals that have been generated by a separate optical source, without conversion to electrical signals, i.e., using semiconductor optical amplifiers, optical fibre luminescent amplifiers.

Cat 4 - "Optical computer"

A computer designed or modified to use light to represent data and whose computational logic elements are based on directly coupled optical devices.

Cat 3 - "Optical integrated circuit"

A "monolithic integrated circuit" or a "hybrid integrated circuit", containing one or more parts designed to function as a photosensor or photoemitter or to perform (an) optical or (an) electro-optical function(s).

Cat 5 - "Optical switching"

The routing of or switching of signals in optical form without conversion to electrical signals.

Cat 3 - "Overall current density"

The total number of ampere-turns in the coil (i.e., the sum of the number of turns multiplied by the maximum current carried by each turn) divided by the total cross-section of the coil (comprising the superconducting filaments, the metallic matrix in which the superconducting filaments are embedded, the encapsulating material, any cooling channels, etc.).

Cat 6 - "Peak power"

Energy per pulse in joules divided by the pulse duration in seconds.

Cat 5 - "Personalised smart card"

A smart card containing a microcircuit which has been programmed for a specific application and cannot be reprogrammed for any other application by the user.

Cat 7 - "Power management"

Changing the transmitted power of the altimeter signal so that received power at the "aircraft" altitude is always at the minimum necessary to determine the altitude.

2-8 - "Precursors"

Speciality chemicals used in the manufacture of explosives.

Cat 1 - "Previously separated"

The application of any process intended to increase the concentration of the controlled isotope.

Cat 7 - "Primary flight control"

"Aircraft" stability or manoeuvering control using force/moment generators, i.e., aerodynamic control surfaces or propulsive thrust vectoring.

Cat 4 - "Principal element"

An element is a "principal element" when its replacement value is more than 35% of the total value of the system of which it is an element. Element value is the price paid for the element by the manufacturer of the system, or by the system integrator. Total value is the normal international selling price to unrelated parties at the point of manufacture or consolidation of shipment.

GTN & Both Lists - "Production"

Means all production stages, such as: product engineering, manufacture, integration, assembly (mounting), inspection, testing, quality assurance.

Cat 2/Cat 4/Cat 5/Cat 6 - "Programme"

A sequence of instructions to carry out a process in, or convertible into, a form executable by an electronic computer.

2-8 - "Propellants"

Substances or mixtures that react chemically to produce large volumes of hot gases at controlled rates to perform mechanical work.

Cat 6 - "Pulse compression"

The coding and processing of a radar signal pulse of long time duration to one of short time duration, while maintaining the benefits of high pulse energy.

Cat 6 - "Pulse duration"

Duration of a "laser" pulse measured at Full Width Half Intensity (FWHI) levels.

2-4/2-8 - "Pyrotechnic(s)"

Mixtures of solid or liquid fuels and oxidizers which, when ignited, undergo an energetic chemical reaction at a controlled rate intended to produce specific time delays, or quantities of heat, noise, smoke, visible light or infrared radiation. Pyrophorics are a subclass of pyrotechnics, which contain no oxidizers but ignite spontaneously on contact with air.

Cat 5P2 - "Quantum cryptography"

A family of techniques for the establishment of a shared key for "cryptography" by measuring the quantum-mechanical properties of a physical system (including those physical properties explicitly governed by quantum optics, quantum field theory, or quantum electrodynamics).

Cat 6 - "Q-switched laser"

A "laser" in which the energy is stored in the population inversion or in the optical resonator and subsequently emitted in a pulse.

Cat 6 - "Radar frequency agility"

Any technique which changes, in a pseudo-random sequence, the carrier frequency of a pulsed radar transmitter between pulses or between groups of pulses by an amount equal to or larger than the pulse bandwidth.

Cat 6 - "Radar spread spectrum"

Any modulation technique for spreading energy originating from a signal with a relatively narrow frequency band, over a much wider band of frequencies, by using random or pseudorandom coding.

Cat 3 - "Real-time bandwidth"

For "dynamic signal analysers", the widest frequency range which the analyser can output to display or mass storage without causing any discontinuity in the analysis of the input data. For analysers with more than one channel, the channel configuration yielding the widest "real-time bandwidth" shall be used to make the calculation.

Cat 2/Cat 6/Cat 7 - "Real time processing"

The processing of data by a computer system providing a required level of service, as a function of available resources, within a guaranteed response time, regardless of the load of the system, when stimulated by an external event.

Cat 5/Cat 6/Cat 9/GTN/2-22 - "Required"

As applied to "technology", refers to only that portion of "technology" which is peculiarly responsible for achieving or exceeding the controlled performance levels, characteristics or functions. Such "required" "technology" may be shared by different products.

Cat 2 - "Resolution"

The least increment of a measuring device; on digital instruments, the least significant bit. (Reference: ANSI B-89.1.12)

2-7 - "Riot control agents"

Substances which, under the expected conditions of use for riot control purposes, produce rapidly in humans sensory irritation or disabling physical effects which disappear within a short time following termination of exposure. (Tear gases are a subset of "riot control agents".)

Cat 2/Cat 8/2-17 - "Robot"

A manipulation mechanism, which may be of the continuous path or of the point-to-point variety, may use sensors, and has all the following characteristics:

- a. Is multifunctional;
- Is capable of positioning or orienting material, parts, tools or special devices through variable movements in three dimensional space;
- Incorporates three or more closed or open loop servo-devices which may include stepping motors; and
- d. Has "user-accessible programmability" by means of the teach/playback method or by means of an electronic computer which may be a programmable logic controller, i.e., without mechanical intervention.

Note:

The above definition does not include the following devices:

- Manipulation mechanisms which are only manually/teleoperator controllable;
- 2. Fixed sequence manipulation mechanisms which are automated moving devices, operating according to mechanically fixed programmed motions. The programme is mechanically limited by fixed stops, such as pins or cams. The sequence of motions and the selection of paths or angles are not variable or changeable by mechanical, electronic or electrical means;
- 3. Mechanically controlled variable sequence manipulation mechanisms which are automated moving devices, operating according to mechanically fixed programmed motions. The programme is mechanically limited by fixed, but adjustable stops, such as pins or cams. The sequence of motions and the selection of paths or angles are variable within the fixed programme pattern. Variations or modifications of the programme pattern (e.g., changes of pins or exchanges of cams) in one or more motion axes are accomplished only through mechanical operations;
- 4. Non-servo-controlled variable sequence manipulation mechanisms which are automated moving devices, operating according to mechanically fixed programmed motions. The programme is variable but the sequence proceeds only by the binary signal from mechanically fixed electrical binary devices or adjustable stops;
- Stacker cranes defined as Cartesian coordinate manipulator systems manufactured as an integral part of a vertical array of storage bins and designed to access the contents of those bins for storage or retrieval.

Cat 1 - "Rotary atomisation"

A process to reduce a stream or pool of molten metal to droplets to a diameter of 500 μm or less by centrifugal force.

Cat 2 - "Run out" (out-of-true running)

Radial displacement in one revolution of the main spindle measured in a plane perpendicular to the spindle axis at a point on the external or internal revolving surface to be tested (Reference: ISO 230/1-1986, paragraph 5.61).

Cat 7 - "Scale factor" (gyro or accelerometer)

The ratio of change in output to a change in the input intended to be measured. Scale factor is generally evaluated as the slope of the straight line that can be fitted by the method of least squares to input-output data obtained by varying the input cyclically over the input range.

Cat 3 - "Settling time"

The time required for the output to come within one-half bit of the final value when switching between any two levels of the converter.

Cat 6 - "SHPL"

"SHPL" is equivalent to "Super High Power Laser".

Cat 3 - "Signal analysers"

Apparatus capable of measuring and displaying basic properties of the single-frequency components of multi-frequency signals.

Cat3/Cat 4/Cat 5/Cat 6 - "Signal processing"

The processing of externally derived information-bearing signals by algorithms such as time compression, filtering, extraction, selection, correlation, convolution or transformations between domains (e.g., fast Fourier transform or Walsh transform).

Both Lists - "Software"

A collection of one or more "programmes" or "microprogrammes" fixed in any tangible medium of expression.

"Solidify rapidly"

A process involving the solidification of molten material at cooling rates exceeding $1{,}000~{\rm K/s}.$

Cat 4/Cat 5/Cat 6/Cat 7/Cat 9 - "Source code"

A convenient expression of one or more processes which may be turned by a programming system into equipment executable form ("object code" (or object language)).

Cat 7/Cat 9 - "Spacecraft"

Active and passive satellites and space probes.

Cat 3/Cat 6/2-23 - "Space qualified"

Products designed, manufactured and tested to meet the special electrical, mechanical or environmental requirements for use in the launch and deployment of satellites or high altitude flight systems operating at altitudes of 100 km or higher.

Cat 1 - "Splat quenching"

A process to "solidify rapidly" a molten metal stream impinging upon a chilled block, forming a flake-like product.

Cat 5 - "Spread spectrum"

The technique whereby energy in a relatively narrow-band communication channel is spread over a much wider energy spectrum.

Cat 6 - "Spread spectrum" radar - see "Radar spread spectrum"

Cat 7 - "Stability"

Standard deviation (1 sigma) of the variation of a particular parameter from its calibrated value measured under stable temperature conditions. This can be expressed as a function of time.

Cat 3 - "Substrate"

A sheet of base material with or without an interconnection pattern and on which or within which "discrete components" or integrated circuits or both can be located.

Cat 6 - "Substrate blanks"

Monolithic compounds with dimensions suitable for the production of optical elements such as mirrors or optical windows.

Cat 2/Cat 9 - "Superalloy"

Nickel-, cobalt- or iron-base alloys having strengths superior to any alloys in the AISI 300 series at temperatures over 922 K (649°C) under severe environmental and operating conditions.

Cat 1/Cat 3/Cat 6/Cat 8/2-18/2-20 - "Superconductive"

Refers to materials, (i.e., metals, alloys or compounds) which can lose all electrical resistance (i.e., which can attain infinite electrical conductivity and carry very large electrical currents without Joule heating).

Technical Note:

The "superconductive" state of a material is individually characterised by a "critical temperature", a critical magnetic field, which is a function of temperature, and a critical current density which is, however, a function of both magnetic field and temperature.

Cat 6 - "Super High Power Laser" ("SHPL")

A "laser" capable of delivering (the total or any portion of) the output energy exceeding 1 kJ within 50 ms or having an average or CW power exceeding 20 kW.

Cat 1/Cat 2 - "Superplastic forming"

A deformation process using heat for metals that are normally characterised by low values of elongation (less than 20%) at the breaking point as determined at room temperature by conventional tensile strength testing, in order to achieve elongations during processing which are at least 2 times those values.

Cat 5 - "Symmetric algorithm"

A cryptographic algorithm using an identical key for both encryption and decryption.

Technical Note:

A common use of "symmetric algorithms" is confidentiality of data.

Cat 6 - "System tracks"

Processed, correlated (fusion of radar target data to flight plan position) and updated aircraft flight position report available to the Air Traffic Control centre controllers.

Cat 4 - "Systolic array computer"

A computer where the flow and modification of the data is dynamically controllable at the logic gate level by the user.

GTN & Both Lists - "Technology"

Specific information necessary for the "development", "production" or "use" of a product. The information takes the form of technical data or technical assistance. Controlled "technology" for the Dual-Use List is defined in the General Technology Note and in the Dual-Use List. Controlled "technology" for the Munitions List is specified in 2-22.

Technical Note:

- 'Technical data' may take forms such as blueprints, plans, diagrams, models, formulae, tables, engineering designs and specifications, manuals and instructions written or recorded on other media or devices such as disk, tape, read-only memories.
- 'Technical assistance' may take forms such as instruction, skills, training, working knowledge, consulting services. 'Technical assistance' may involve transfer of 'technical data'.

Cat 4 - "Terminal interface equipment"

Equipment at which information enters or leaves the telecommunication system, e.g., telephone, data device, computer, facsimile device.

Cat 4 - "Three dimensional Vector Rate"

The number of vectors generated per second which have 10 pixel poly line vectors, clip tested, randomly oriented, with either integer or floating point X-Y-Z coordinate values (whichever produces the maximum rate).

Cat 2 - "Tilting spindle"

A tool-holding spindle which alters, during the machining process, the angular position of its centre line with respect to any other axis.

Cat 6 - "Time constant"

The time taken from the application of a light stimulus for the current increment to reach a value of 1-1/e times the final value (i.e., 63% of the final value).

Cat 7 - "Total control of flight"

Automated control of "aircraft" state variables and flight path to meet mission objectives responding to real time changes in data regarding objectives, hazards or other "aircraft".

Cat 5 - "Total digital transfer rate"

The number of bits, including line coding, overhead and so forth per unit time passing between corresponding equipment in a digital transmission system. (See also "digital transfer rate")

Cat 6 - "Transfer laser"

A "laser" in which the lasing species is excited through the transfer of energy by collision of a non-lasing atom or molecule with a lasing atom or molecule species.

Cat 6 - "Tunable"

The ability of a "laser" to produce a continuous output at all wavelengths over a range of several "laser" transitions. A line selectable "laser" produces discrete wavelengths within one "laser" transition and is not considered "tunable".

Cat 9 - "Unmanned aerial vehicle" ("UAV")

Any "aircraft" capable of initiating flight and sustaining controlled flight and navigation without any human presence on board.

GTN/Cat 1/Cat 2/Cat 4/Cat 5/Cat 6/Cat 7/Cat 8/Cat 9/2-21/2-22 - "Use" Operation, installation (including on-site installation), maintenance (checking), repair, overhaul and refurbishing.

Cat 4/Cat 5/Cat 6 - "User-accessible programmability"

The facility allowing a user to insert, modify or replace "programmes" by means other than:

- a. A physical change in wiring or interconnections; or
- b. The setting of function controls including entry of parameters.

Cat 1 - "Vacuum atomisation"

A process to reduce a molten stream of metal to droplets of a diameter of $500~\mu m$ or less by the rapid evolution of a dissolved gas upon exposure to a vacuum.

Cat 7 - "Variable geometry airfoils"

Use trailing edge flaps or tabs, or leading edge slats or pivoted nose droop, the position of which can be controlled in flight.

Group 3 - Nuclear Non-Proliferation List

Note:

Terms in 'single quotations' are usually defined within each entry of the list. Terms in "double quotations" are defined at the end of Group 4.

Canadian Nuclear Safety Commission (CNSC) Note:

The export of nuclear and nuclear-related items is also controlled by the CNSC under the Nuclear Safety and Control Act (NSCA) and Regulations. Therefore, the export of nuclear and nuclear-related items, not listed in Group 3 or which meet the specific Group 3 decontrol notes may still require a license from the CNSC. Information on export licensing requirements under the NSCA may be obtained by contacting the CNSC.

Nuclear Technology Note:

The "technology" directly associated with any items controlled in Group 3 is controlled according to the provisions of Group 3.

"Technology" for the "development", "production" or "use" of items under control remains under control even when applicable to non-controlled items.

The approval of items for export also authorizes the export to the same enduser of the minimum "technology" required for the installation, operation, maintenance and repair of the items.

Controls on "technology" transfer, do not apply to information "in the public domain" or to "basic scientific research".

General Software Note:

Group 3 does not control "software" which is either:

- Generally available to the public by being.
 - a. Sold from stock at retail selling points, without restriction, by means of:
 - 1. Over-the-counter transactions;
 - 2. Mail order transactions;
 - 3. Electronic transactions: or
 - 4. Telephone call transactions; and
 - Designed for installation by the user without further substantial support by the supplier; or
- 2. "In the public domain".

3-1. Source and special fissionable materials

3-1.1 Source materials

Source materials in the form of metal, alloy, chemical compound, concentrate, or that are incorporated in any material or substance and in which the concentration of source material is greater than 0.05 weight %, as follows:

- 1. Natural uranium (i.e. containing the mixture of isotopes occurring in nature);
- Depleted uranium (i.e. depleted in the isotope 235 below that occurring in nature); and
- 3. Thorium.

Note:

- 3-1.1 does not control the following:
- Four grams or less of natural uranium or depleted uranium when contained in a sensing component in instruments;
- b. Alloys containing less than 5% thorium;
- Ceramic products containing thorium, which have been manufactured for non-nuclear use;
- d. Medicinal substances;
- Trace amounts found on contaminated items such as clothing, shielding or packaging; and
- f. Source material which the Government is satisfied is to be used only in civil non-nuclear applications, such as shielding, packaging, ballasts, counterweights or the production of alloys and ceramics (For the purpose of export control, the Export Controls Division at International Trade Canada, will determine whether or not the exports of source material meeting the above specifications are for non-nuclear applications).

3-1.2 Special fissionable materials

- Plutonium of all isotopes and any alloy, compound or material containing plutonium;
- Uranium-233; uranium enriched in the isotopes 233 or 235; or any alloy, compound or material containing one or more of the foregoing;

Note:

3-1.2 does not control the following:

- Four 'effective grams' or less of special fissionable material when contained in a sensing component in instruments;
- Trace amounts found on contaminated items such as clothing, shielding or packaging; and
- c. Plutonium 238 that is contained in heart pacemakers.

Technical Note:

'Effective gram' means:

- a. For plutonium isotopes and uranium-233, the isotope weight in grams;
- b. For uranium enriched 1 percent or greater in the isotope uranium-235, the element weight in grams multiplied by the square of its enrichment expressed as a decimal weight fraction; and
- c. For uranium enriched below 1 percent in the isotope uranium-235, the element weight in grams multiplied by 0.0001.

3-2. Equipment and Non-nuclear Materials

3-2.1 Nuclear reactors and especially designed or prepared equipment and components therefor, including:

1. Complete nuclear reactors

Nuclear reactors capable of operation so as to maintain a controlled self-sustaining fission chain reaction, excluding zero energy reactors, the latter being defined as reactors with a designed maximum rate of production of plutonium not exceeding 100 grams per year.

Explanatory Note:

A nuclear reactor basically includes the items within or attached directly to the reactor vessel, the equipment which controls the level of power in the core, and the components which normally contain or come in direct contact with or control the primary coolant of the reactor core.

It is not intended to exclude reactors which could reasonably be capable of modification to produce significantly more than 100 grams of plutonium per year. Reactors designed for sustained operation at significant power levels, regardless of their capacity for plutonium production, are not considered as zero energy reactors.

2. Nuclear reactor vessels

Metal vessels, or major shop-fabricated parts therefor, especially designed or prepared to contain the core of a nuclear reactor as defined in item 3-2.1.1. above, as well as relevant reactor internals as defined in item 3-2.1.8. below.

Explanatory Note:

The reactor vessel head is covered by item 3-2.1.2. as a major shop-fabricated part of a reactor vessel.

3. Nuclear reactor fuel charging and discharging machines

Manipulative equipment especially designed or prepared for inserting or removing fuel in a nuclear reactor as defined in item 3-2.1.1. above.

Explanatory Note:

The items noted above are capable of on-load operation or at employing technically sophisticated positioning or alignment features to allow complex off-load fueling operations such as those in which direct viewing of or access to the fuel is not normally available.

4. Nuclear reactor control rods and equipment

Especially designed or prepared rods, support or suspension structures therefor, rod drive mechanisms or rod guide tubes to control the fission process in a nuclear reactor as defined in item 3-2.1.1. above.

5. Nuclear reactor pressure tubes

Tubes which are especially designed or prepared to contain fuel elements and the primary coolant in a reactor as defined in item 3-2.1.1. above at an operating pressure in excess of 50 atmospheres.

6. Zirconium tubes

Zirconium metal and alloys in the form of tubes or assemblies of tubes, especially designed or prepared for use in a reactor as defined in item 3-2.1.1. above, and in which the relation of hafnium to zirconium is less than 1:500 parts by weight.

7. Primary coolant pumps

Pumps especially designed or prepared for circulating the primary coolant for nuclear reactors as defined in item 3-2.1.1. above. **Explanatory Note:**

Especially designed or prepared pumps may include elaborate sealed or multi-sealed systems to prevent leakage of primary coolant, canned-driven pumps, and pumps with inertial mass systems. This definition encompasses pumps certified to Section III, Division I, Subsection NB (Class 1 components) of the American Society of Mechanical Engineers (ASME) Code, or equivalent standards.

8. Nuclear reactor internals

'Nuclear reactor internals' especially designed or prepared for use in a nuclear reactor as defined in item 3-2.1.1. above, including support columns for the core, fuel channels, thermal shields, baffles, core grid plates, and diffuser plates.

Explanatory Note:

'Nuclear reactor internals' are major structures within a reactor vessel which have one or more functions such as supporting the core, maintaining fuel alignment, directing primary coolant flow, providing radiation shields for the reactor vessel, and guiding in-core instrumentation.

9. Heat exchangers

Heat exchangers (steam generators) especially designed or prepared for use in the primary coolant circuit of a nuclear reactor as defined in item 3-2.1.1. above.

Explanatory Note:

Steam generators are especially designed or prepared to transfer the heat generated in the reactor (primary side) to the feed water (secondary side) for steam generation. In the case of a liquid metal fast breeder reactor for which an intermediate liquid metal coolant loop is also present, the heat exchangers for transferring heat from the primary side to the intermediate coolant circuit are understood to be within the scope of control in addition to the steam generator. The scope of control for this entry does not include heat exchangers for the emergency cooling system or the decay heat cooling system.

10. Neutron detection and measuring instruments

Especially designed or prepared neutron detection and measuring instruments for determining neutron flux levels within the core of a reactor as defined in item 3-2.1.1. above.

Explanatory Note:

The scope of this entry encompasses in-core and ex-core instrumentation which measure flux levels in a large range, typically from 10⁴ neutrons per

cm² per second to 10¹⁰ neutrons per cm² per second or more. Ex-core refers to those instruments outside the core of a reactor as defined in item 3-2.1.1. above, but located within the biological shielding.

3-2.2 Non-nuclear materials for reactors;

1. Deuterium and heavy water

Deuterium, heavy water (deuterium oxide) and any other deuterium compound in which the ratio of deuterium to hydrogen atoms exceeds 1:5000 for use in a nuclear reactor as defined in item 3-2.1.1. above.

Explanatory Note:

For the purpose of export control, the Export Controls Division at International Trade Canada, will determine whether or not the exports of deuterium and deuterium compounds meeting the above specifications are for nuclear reactor use.

2. Nuclear grade graphite

Graphite having a purity level better (less) than 5 parts per million 'boron equivalent' and with a density greater than 1.50 g/cm³ for use in a nuclear reactor as defined in item 3-2.1.1. above.

Explanatory Note:

For the purpose of export control, the Export Controls Division at International Trade Canada will determine whether or not the exports of graphite meeting the above specifications are for nuclear reactor use.

'Boron equivalent' (BE) may be determined experimentally or is calculated as the sum of BE_z for impurities (excluding BE_{carbon} since carbon is not considered an impurity) including boron, where:

 BE_Z (ppm) = CF x concentration of element Z (in ppm);

CF is the conversion factor: $(\sigma_z \times A_B)$ divided by $(\sigma_B \times A_z)$;

 σ_B and σ_Z are the thermal neutron capture cross sections (in barns) for naturally occurring boron and element Z respectively; and

 A_B and A_Z are the atomic masses of naturally occurring boron and element Z respectively.

3-2.3 Plants for the reprocessing of irradiated fuel elements, equipment and components especially designed or prepared therefor, including:

Introductory Note:

Reprocessing irradiated nuclear fuel separates plutonium and uranium from intensely radioactive fission products and other transuranic elements. Different technical processes can accomplish this separation. However, over the years Purex has become the most commonly used and accepted process. Purex involves the dissolution of irradiated nuclear fuel in nitric acid, followed by separation of the uranium, plutonium, and fission products by solvent extraction using a mixture of tributyl phosphate in an organic diluent.

Purex facilities have process functions similar to each other, including: irradiated fuel element chopping, fuel dissolution, solvent extraction, and process liquor storage. There may also be equipment for thermal denitration of uranium nitrate, conversion of plutonium nitrate to oxide or metal, and treatment of fission product waste liquor to a form suitable for long term storage or disposal. However, the specific type and configuration of the equipment performing these functions may differ between Purex facilities for several reasons, including the type and quantity of irradiated nuclear fuel to be reprocessed and the intended disposition of the recovered materials, and the safety and maintenance philosophy incorporated into the design of the facility.

A plant for the reprocessing of irradiated fuel elements, includes the equipment and components which normally come in direct contact with and directly control the irradiated fuel and the major nuclear material and fission product processing streams.

These processes, including the complete systems for plutonium conversion and plutonium metal production, may be identified by the measures taken to avoid criticality (e.g. by geometry), radiation exposure (e.g. by shielding), and toxicity hazards (e.g. by containment).

Items of equipment that are considered to fall within the meaning of the phrase 'and equipment especially designed or prepared' for the reprocessing of irradiated fuel elements include:

1. Irradiated fuel element chopping machines Introductory Note:

This equipment breaches the cladding of the fuel to expose the irradiated nuclear material to dissolution. Especially designed metal cutting shears are the most commonly employed, although advanced equipment, such as lasers, may be used.

Remotely operated equipment especially designed or prepared for use in a reprocessing plant as identified above and intended to cut, chop or shear irradiated nuclear fuel assemblies, bundles or rods.

2. Dissolvers

Introductory Note:

Dissolvers normally receive the chopped-up spent fuel. In these critically safe vessels, the irradiated nuclear material is dissolved in nitric acid and the remaining hulls removed from the process stream.

Critically safe tanks (e.g. small diameter, annular or slab tanks) especially designed or prepared for use in a reprocessing plant as identified above, intended for dissolution of irradiated nuclear fuel and which are capable of withstanding hot, highly corrosive liquid, and which can be remotely loaded and maintained.

3. Solvent extractors and solvent extraction equipment Introductory Note:

Solvent extractors both receive the solution of irradiated fuel from the dissolvers and the organic solution which separates the uranium, plutonium, and fission products. Solvent extraction equipment is normally designed to meet strict operating parameters, such as long operating the with no maintenance requirements or adaptability to easy replacement, simplicity of operation and control, and flexibility for variations in process conditions.

Especially designed or prepared solvent extractors such as packed or pulse columns, mixer settlers or centrifugal contactors for use in a plant for the reprocessing of irradiated fuel. Solvent extractors must be resistant to the corrosive effect of nitric acid. Solvent extractors are normally fabricated to extremely high standards (including special welding and inspection and quality assurance and quality control techniques) out of low carbon stainless steels, titanium, zirconium, or other high quality materials.

4. Chemical Holding or Storage Vessels *Introductory Note:*

Three main process liquor streams result from the solvent extraction step. Holding or storage vessels are used in the further processing of all three streams, as follows:

- a. The pure uranium nitrate solution is concentrated by evaporation and passed to a denitration process where it is converted to uranium oxide. This oxide is re-used in the nuclear fuel cycle.
- b. The intensely radioactive fission products solution is normally concentrated by evaporation and stored as a liquor concentrate. This concentrate may be subsequently evaporated and converted to a form suitable for storage or disposal.
- c. The pure plutonium nitrate solution is concentrated and stored pending its transfer to further process steps. In particular, holding or storage vessels for plutonium solutions are designed to avoid criticality problems resulting from changes in concentration and form of this stream.

Especially designed or prepared holding or storage vessels for use in a plant for the reprocessing of irradiated fuel. The holding or storage vessels must be resistant to the corrosive effect of nitric acid. The holding or storage vessels are normally fabricated of materials such as low carbon stainless steels, titanium or zirconium, or other high quality materials. Holding or storage vessels may be designed for remote operation and maintenance and may have the following features for control of nuclear criticality:

- walls or internal structures with a boron equivalent of at least two per cent, or
- 2. a maximum diameter of 175 mm (7 in) for cylindrical vessels, or
- 3. a maximum width of 75 mm (3 in) for either a slab or annular vessel.

3-2.4 Plants for the fabrication of nuclear reactor fuel elements, equipment and components especially designed or prepared therefor:

Introductory Note:

Nuclear fuel elements are manufactured from one or more of the source or special fissionable materials mentioned in Item 3-1. For oxide fuels, the most common type of fuel, equipment for pressing pellets, sintering, grinding and grading will be present. Mixed oxide fuels are handled in glove boxes (or equivalent containment) until they are sealed in the cladding. In all cases, the fuel is hermetically sealed inside a suitable cladding which is designed to be the primary envelope encasing the fuel so as to provide suitable performance and safety during reactor operation. Also, in all cases, precise control of processes, procedures and equipment to extremely high standards is necessary in order to ensure predictable and safe fuel performance.

Explanatory Note:

Items of equipment that are considered to fall within the meaning of the phrase 'and equipment especially designed or prepared' for the fabrication of fuel elements include equipment which:

- a. normally comes in direct contact with, or directly processes, or controls, the production flow of nuclear material;
- b. seals the nuclear material within the cladding;
- c. checks the integrity of the cladding or the seal; or
- d. checks the finish treatment of the sealed fuel.

Such equipment or systems of equipment may include, for example:

- fully automatic pellet inspection stations especially designed or prepared for checking final dimensions and surface defects of the fuel pellets;
- automatic welding machines especially designed or prepared for welding end caps onto the fuel pins (or rods):
- automatic test and inspection stations especially designed or prepared for checking the integrity of completed fuel pins (or rods).
 Item 3 typically includes equipment for: a) x-ray examination of pin (or rod) end cap welds, b) helium leak detection from pressurized pins (or rods), and c) gamma-ray scanning of the pins (or rods) to check for correct loading of the fuel pellets inside.

3-2.5 Plants for the separation of isotopes of uranium and equipment and components, other than analytical instruments, especially designed or prepared therefor, including:

Items of equipment that are considered to fall within the meaning of the phrase 'equipment, other than analytical instruments, especially designed or prepared' for the separation of isotopes of uranium include:

Gas centrifuges and assemblies and components especially designed or prepared for use in gas centrifuges Introductory Note:

The gas centrifuge normally consists of a thin-walled cylinder(s) of between 75 mm (3 in) and 400 mm (16 in) diameter contained in a vacuum environment and spun at high peripheral speed of the order of 300 m/s or more with its central axis vertical. In order to achieve high speed the materials of construction for the rotating components have to be of a high strength to density ratio and the rotor assembly, and hence its individual components, have to be manufactured to very close tolerances in order to minimize the unbalance. In contrast to other centrifuges, the gas centrifuge for uranium enrichment is characterized by having within the rotor chamber a rotating disc-shaped baffle(s) and a stationary tube arrangement for feeding and extracting the UF₆ gas and featuring at least 3 separate channels, of which 2 are connected to scoops extending from the rotor axis towards the periphery of the rotor chamber. Also contained within the vacuum environment are a number of critical items which do not rotate and which although they are especially designed are not difficult to fabricate nor are they fabricated out of unique materials. A centrifuge facility however requires a large number of these components, so that quantities can provide an important indication of end use.

1. Rotating components

a. Complete rotor assemblies:

Thin-walled cylinders, or a number of interconnected thin-walled cylinders, manufactured from one or more of the high strength to density ratio materials described in the Explanatory Note to this Section. If interconnected, the cylinders are joined together by flexible bellows or rings as described in section 3-2.5.1.1.c. following. The rotor is fitted with an internal baffle(s) and end caps, as described in section 3-2.5.1.1.d. and e. following, if in final form. However the complete assembly may be delivered only partly assembled.

b. Rotor tubes:

Especially designed or prepared thin-walled cylinders with thickness of 12 mm (0.5 in) or less, a diameter of between 75 mm (3 in) and 400 mm (16 in), and manufactured from one or more of the high strength to density ratio materials described in the Explanatory Note to this Section.

c. Rings or Bellows:

Components especially designed or prepared to give localized support to the rotor tube or to join together a number of rotor tubes. The bellows is a short cylinder of wall thickness 3 mm (0.12 in) or less, a diameter of between 75 mm (3 in) and 400 mm (16 in), having a convolute, and manufactured from one of the high strength to density ratio materials described in the Explanatory Note to this Section.

d. Baffles:

Disc-shaped components of between 75 mm (3 in) and 400 mm (16 in) diameter especially designed or prepared to be mounted inside the centrifuge rotor tube, in order to isolate the take-off chamber from the main separation chamber and, in some cases, to assist the UF $_6$ gas circulation within the main separation chamber of the rotor tube, and manufactured from one of the high strength to density ratio materials described in the Explanatory Note to this Section.

e. Top caps/Bottom caps:

Disc-shaped components of between 75 mm (3 in) and 400 mm (16 in) diameter especially designed or prepared to fit to the ends of the rotor tube, and so contain the UF_6 within the rotor tube, and in some cases to support, retain or contain as an integrated part an element of the upper bearing (top cap) or to carry the rotating elements of the motor and lower bearing (bottom cap), and manufactured from one of the high strength to density ratio materials described in the Explanatory Note to this Section.

Explanatory Note:

The materials used for centrifuge rotating components are:

- a. Maraging steel capable of an ultimate tensile strength of 2.05 X 10⁹ N/m² (300,000 psi) or more;
- b. Aluminium alloys capable of an ultimate tensile strength of 0.46 X 10⁹ N/m² (67,000 psi) or more;
- c. "Fibrous or Filamentary materials" suitable for use in composite structures and having a 'specific modulus' of 3.18 X 10⁶ m or greater and a 'specific ultimate tensile strength' of 7.62 x 10⁴ m or greater ('Specific Modulus' is the Young's Modulus in N/m² divided by the specific weight in N/m³; 'Specific Ultimate Tensile Strength' is the ultimate tensile strength in N/m² divided by the specific weight in N/m³).

2. Static components

a. Magnetic suspension bearings:

Especially designed or prepared bearing assemblies consisting of an annular magnet suspended within a housing containing a damping medium. The housing will be manufactured from a UF₆-resistant material (see Explanatory Note to Section 3-2.5.2.). The magnet couples with a pole piece or a second magnet fitted to the top cap described in Section 3-2.5.1.1.e. The magnet may be ringshaped with a relation between outer and inner diameter smaller or equal to 1.6:1. The magnet may be in a form having an initial permeability of 0.15 H/m (120,000 in CGS units) or more, or a remanence of 98.5% or more, or an energy product of greater than 80 kJ/m³ (10⁷ gaussoersteds). In addition to the usual material properties, it is a prerequisite that the deviation of the magnetic axes from the geometrical axes is limited to very small tolerances (lower than 0.1 mm or 0.004 in) or that homogeneity of the material of the magnet is specially called for.

b. Bearings/Dampers:

Especially designed or prepared bearings comprising a pivot/cup assembly mounted on a damper. The pivot is normally a hardened steel shaft with a hemisphere at one end with a means of attachment to the bottom cap described in section 3-2.5.1.1.e. at the other. The shaft may however have a hydrodynamic bearing attached. The cup is pellet-shaped with a hemispherical indentation in one surface. These components are often supplied separately to the damper.

c. Molecular pumps:

Especially designed or prepared cylinders having internally machined or extruded helical grooves and internally machined bores. Typical dimensions are as follows: 75 mm (3 in) to 400 mm (16 in) internal diameter, 10 mm (0.4 in) or more wall thickness, with the length equal to or greater than the diameter. The grooves are typically rectangular in cross section and 2 mm (0.08 in) or more in depth.

d. Motor stators:

Especially designed or prepared ring-shaped stators for high speed multiphase AC hysteresis (or reluctance) motors for synchronous operation within a vacuum in the frequency range of 600 - 2000 Hz and a power range of 50 - 1000 VA. The stators consist of multi-phase windings on a laminated low loss iron core comprised of thin layers typically 2.0 mm (0.08 in) thick or less.

e. Centrifuge housing/recipients:

Components especially designed or prepared to contain the rotor tube assembly of a gas centrifuge. The housing consists of a rigid cylinder of wall thickness up to 30 mm (1.2 in) with precision machined ends to locate the bearings and with one or more flanges for mounting. The machined ends are parallel to each other and perpendicular to the cylinder's longitudinal axis to within 0.05 degrees or less. The housing may also be a honeycomb type structure to accommodate several rotor tubes. The housings are made of or protected by materials resistant to corrosion by UF₆.

f. Scoops:

Especially designed or prepared tubes of up to 12 mm (0.5 in) internal diameter for the extraction of UF₆ gas from within the rotor tube by a Pitot tube action (that is, with an aperture facing into the circumferential gas flow within the rotor tube, for example by bending the end of a radially disposed tube) and capable of being fixed to the central gas extraction system. The tubes are made of or protected by materials resistant to corrosion by UF₆.

2. Especially designed or prepared auxiliary systems, equipment and components for gas centrifuge enrichment plants *Introductory Note:*

The auxiliary systems, equipment and components for a gas centrifuge enrichment plant are the systems of plant needed to feed UF $_6$ to the centrifuges, to link the individual centrifuges to each other to form cascades (or stages) to allow for progressively higher enrichments and to extract the product and tails UF $_6$ from the centrifuges, together with the equipment required to drive the centrifuges or to control the plant.

Normally UF $_6$ is evaporated from the solid using heated autoclaves and is distributed in gaseous form to the centrifuges by way of cascade header pipework. The product and tails UF $_6$ gaseous streams flowing from the centrifuges are also passed by way of cascade header pipework to cold traps (operating at about 203 K (-70°C)) where they are condensed prior to onward transfer into suitable containers for transportation or storage. Because an enrichment plant consists of many thousands of centrifuges arranged in cascades there are many kilometers of cascade header pipework, incorporating thousands of welds with a substantial amount of repetition of layout. The equipment, components and piping systems are fabricated to very high vacuum and cleanliness standards.

1. Feed systems/product and tails withdrawal systems

Especially designed or prepared process systems including:

- a. Feed autoclaves (or stations), used for passing UF₆ to the centrifuge cascades at up to 100 kPa (15 psi) and at a rate of 1 kg/h or more;
- b. Desublimers (or cold traps) used to remove UF $_6$ from the cascades at up to 3 kPa (0.5 psi) pressure. The desublimers are capable of being chilled to 203 K (-70 °C) and heated to 343 K (70 °C);
- Product and Tails stations used for trapping UF₆ into containers.

This plant, equipment and pipework is wholly made of or lined with UF_6 resistant materials (see Explanatory Note to this section) and is fabricated to very high vacuum and cleanliness standards.

2. Machine header piping systems

Especially designed or prepared piping systems and header systems for handling UF_6 within the centrifuge cascades. The piping network is normally of the triple header system with each centrifuge connected to each of the headers. There is thus a substantial amount of repetition in its form. It is wholly made of UF_6 -resistant materials (see Explanatory Note to this section) and is fabricated to very high vacuum and cleanliness standards.

3. UF₆ mass spectrometers/ion sources

Especially designed or prepared magnetic or quadrupole mass spectrometers capable of taking on-line samples of feed, product or tails, from ${\rm UF}_6$ gas streams and having all of the following characteristics:

- 1. Unit resolution for atomic mass unit greater than 320;
- Ion sources constructed of or lined with nichrome or monel or nickel plated;
- 3. Electron bombardment ionization sources;
- 4. Having a collector system suitable for isotopic analysis.

4. Frequency changers

Frequency changers (also known as converters or invertors) especially designed or prepared to supply motor stators as defined under 3-2.5.1.2.d., or parts, components and sub-assemblies of such frequency changers having all of the following characteristics:

- 1. A multiphase output of 600 to 2000 Hz;
- 2. High stability (with frequency control better than 0.1%);
- 3. Low harmonic distortion (less than 2%); and
- 4. An efficiency of greater than 80%.

Explanatory Note:

The items listed above either come into direct contact with the UF_6 process gas or directly control the centrifuges and the passage of the gas from centrifuge to centrifuge and cascade to cascade.

Materials resistant to corrosion by UF₆ include stainless steel, aluminum, aluminum alloys, nickel or alloys containing 60% or more nickel.

Especially designed or prepared assemblies and components for use in gaseous diffusion enrichment Introductory Note:

In the gaseous diffusion method of uranium isotope separation, the main technological assembly is a special porous gaseous diffusion barrier, heat exchanger for cooling the gas (which is heated by the process of compression), seal valves and control valves, and pipelines. In as much as gaseous diffusion technology uses uranium hexafluoride (UF $_6$), all equipment, pipeline and instrumentation surfaces (that come in contact with the gas) must be made of materials that remain stable in contact with UF $_6$. A gaseous diffusion facility requires a number of these assemblies, so that quantities can provide an important indication of end use.

1. Gaseous diffusion barriers

a. Especially designed or prepared thin, porous filters, with a pore size of 100 - 1,000 Å (angstroms), a thickness of 5 mm (0.2 in) or less, and for tubular forms, a diameter of 25 mm (1 in) or less, made of metallic, polymer or ceramic materials resistant to corrosion by UF₆; and

b. Especially prepared compounds or powders for the manufacture of such filters. Such compounds and powders include nickel or alloys containing 60 per cent or more nickel, aluminium oxide, or UF₆-resistant fully fluorinated hydrocarbon polymers having a purity of 99.9 per cent or more, a particle size less than 10 microns, and a high degree of particle size uniformity, which are especially prepared for the manufacture of gaseous diffusion barriers.

2. Diffuser housings

Especially designed or prepared hermetically sealed cylindrical vessels greater than 300 mm (12 in) in diameter and greater than 900 mm (35 in) in length, or rectangular vessels of comparable dimensions, which have an inlet connection and two outlet connections all of which are greater than 50 mm (2 in) in diameter, for containing the gaseous diffusion barrier, made of or lined with UF $_6$ -resistant materials and designed for horizontal or vertical installation.

3. Compressors and gas blowers

Especially designed or prepared axial, centrifugal, or positive displacement compressors, or gas blowers with a suction volume capacity of 1 m 3 /min or more of UF $_6$, and with a discharge pressure of up to several hundred kPa (100 psi), designed for long-term operation in the UF $_6$ environment with or without an electrical motor of appropriate power, as well as separate assemblies of such compressors and gas blowers. These compressors and gas blowers have a pressure ratio between 2:1 and 6:1 and are made of, or lined with, materials resistant to UF $_6$.

4. Rotary shaft seals

Especially designed or prepared vacuum seals, with seal feed and seal exhaust connections, for sealing the shaft connecting the compressor or the gas blower rotor with the driver motor so as to ensure a reliable seal against in-leaking of air into the inner chamber of the compressor or gas blower which is filled with UF₆. Such seals are normally designed for a buffer gas in-leakage rate of less than 1000 cm³/min (60 in³/min).

5. Heat exchangers for cooling UF_6

Especially designed or prepared heat exchangers made of or lined with UF_6 -resistant materials (except stainless steel) or with copper or any combination of those metals, and intended for a leakage pressure change rate of less than 10 Pa (0.0015 psi) per hour under a pressure difference of 100 kPa (15 psi).

4. Especially designed or prepared auxiliary systems, equipment and components for use in gaseous diffusion enrichment Introductory Note:

The auxiliary systems, equipment and components for gaseous diffusion enrichment plants are the systems of plant needed to feed UF_6 to the gaseous diffusion assembly, to link the individual assemblies to each other to form cascades (or stages) to allow for progressively higher enrichments and to extract the product and tails UF_6 from the diffusion cascades. Because of the high inertial properties of diffusion cascades, any interruption in their operation, and especially their shut-down, leads to serious consequences. Therefore, a strict and constant maintenance of vacuum in all technological systems, automatic protection from accidents, and precise automated regulation of the gas flow is of importance in a gaseous diffusion plant. All this leads to a need to equip the plant with a large number of special measuring, regulating and controlling systems.

Normally UF $_6$ is evaporated from cylinders placed within autoclaves and is distributed in gaseous form to the entry point by way of cascade header pipework. The product and tails UF $_6$ gaseous streams flowing from exit points are passed by way of cascade header pipework to either cold traps or to compression stations where the UF $_6$ gas is liquefied prior to onward transfer into suitable containers for transportation or storage. Because a gaseous diffusion enrichment plant consists of a large number of gaseous diffusion assemblies arranged in cascades, there are many kilometers of cascade header pipework, incorporating thousands of welds with substantial amounts of repetition of layout. The equipment, components and piping systems are fabricated to very high vacuum and cleanliness standards.

1. Feed systems/product and tails withdrawal systems

Especially designed or prepared process systems, capable of operating at pressures of 300 kPa (45 psi) or less, including:

- a. Feed autoclaves (or systems), used for passing UF_6 to the gaseous diffusion cascades;
- Desublimers (or cold traps) used to remove UF₆ from diffusion cascades;
- Liquefaction stations where UF₆ gas from the cascade is compressed and cooled to form liquid UF₆;
- d. Product or tails stations used for transferring UF_6 into containers.

2. Header piping systems

Especially designed or prepared piping systems and header systems for handling UF_6 within the gaseous diffusion cascades. This piping network is normally of the double header system with each cell connected to each of the headers.

3. Vacuum systems

- Especially designed or prepared large vacuum manifolds, vacuum headers and vacuum pumps having a suction capacity of 5 m³/min (175 ft³/min) or more.
- b. Vacuum pumps especially designed for service in UF₆-bearing atmospheres made of, or lined with, aluminium, nickel, or alloys bearing more than 60% nickel. These pumps may be either rotary or positive, may have displacement and fluorocarbon seals, and may have special working fluids present.

4. Special shut-off and control valves

Especially designed or prepared manual or automated shut-off and control bellows valves made of UF $_6$ -resistant materials with a diameter of 40 to 1500 mm (1.5 to 59 in) for installation in main and auxiliary systems of gaseous diffusion enrichment plants.

5. UF₆ mass spectrometers/ion sources

Especially designed or prepared magnetic or quadrupole mass spectrometers capable of taking on-line samples of feed, product or tails, from UF₆ gas streams and having all of the following characteristics:

- 1. Unit resolution for atomic mass unit greater than 320;
- Ion sources constructed of or lined with nichrome or monel or nickel plated;
- 3. Electron bombardment ionization sources;
- 4. Collector system suitable for isotopic analysis.

Explanatory Note:

The items listed above either come into direct contact with the UF_6 process gas or directly control the flow within the cascade. All surfaces which come into contact with the process gas are wholly made of, or lined with, UF_6 -resistant materials. For the purposes of the sections relating to gaseous diffusion items the materials resistant to corrosion by UF_6 include stainless steel, aluminium, aluminium alloys, aluminium oxide, nickel or alloys containing 60% or more nickel and UF_6 -resistant fully fluorinated hydrocarbon polymers.

Especially designed or prepared systems, equipment and components for use in aerodynamic enrichment plants Introductory Note:

In aerodynamic enrichment processes, a mixture of gaseous UF_6 and light gas (hydrogen or helium) is compressed and then passed through separating elements wherein isotopic separation is accomplished by the generation of high centrifugal forces over a curved-wall geometry. Two processes of this type have been successfully developed: the separation nozzle process and the vortex tube process. For both processes the main components of a separation stage include cylindrical vessels housing the special separation elements (nozzles or vortex tubes), gas compressors and heat exchangers to remove the heat of compression. An aerodynamic plant requires a number of these stages, so that quantities can provide an important indication of end use. Since aerodynamic processes use UF_6 , all equipment, pipeline and instrumentation surfaces (that come in contact with the gas) must be made of materials that remain stable in contact with UF_6 . **Explanatory Note:**

The items listed in this section either come into direct contact with the UF $_6$ process gas or directly control the flow within the cascade. All surfaces which come into contact with the process gas are wholly made of or protected by UF $_6$ -resistant materials. For the purposes of the section relating to aerodynamic enrichment items, the materials resistant to corrosion by UF $_6$ include copper, stainless steel, aluminum, aluminum alloys, nickel or alloys containing 60% or more nickel and UF $_6$ -resistant fully fluorinated hydrocarbon polymers.

1. Separation nozzles

Especially designed or prepared separation nozzles and assemblies thereof. The separation nozzles consist of slit-shaped, curved channels having a radius of curvature less than 1 mm (typically 0.1 to 0.05 mm), resistant to corrosion by UF $_6$ and having a knife-edge within the nozzle that separates the gas flowing through the nozzle into two fractions.

2. Vortex tubes

Especially designed or prepared vortex tubes and assemblies thereof. The vortex tubes are cylindrical or tapered, made of or protected by materials resistant to corrosion by UF_6 , having a diameter of between 0.5 cm and 4 cm, a length to diameter ratio of 20:1 or less and with one or more tangential inlets. The tubes may be equipped with nozzle-type appendages at either or both ends.

Explanatory Note:

The feed gas enters the vortex tube tangentially at one end or through swirl vanes or at numerous tangential positions along the periphery of the tube.

3. Compressors and gas blowers

Especially designed or prepared axial, centrifugal or positive displacement compressors or gas blowers made of or protected by materials resistant to corrosion by UF $_6$ and with a suction volume capacity of 2 m 3 /min or more of UF $_6$ /carrier gas (hydrogen or helium) mixture.

Explanatory Note:

These compressors and gas blowers typically have a pressure ratio between 1.2:1 and 6:1.

4. Rotary Shaft Seals

Especially designed or prepared rotary shaft seals, with seal feed and seal exhaust connections, for sealing the shaft connecting the compressor rotor or the gas blower rotor with the driver motor so as to ensure a reliable seal against outleakage of process gas or in leakage of air or seal gas into the inner chamber of the compressor or gas blower which is filled with a UF₆/carrier gas mixture.

5. Heat exchangers for gas cooling

Especially designed or prepared heat exchangers made of or protected by materials resistant to corrosion by UF₆.

6. Separation element housings

Especially designed or prepared separation element housings, made of or protected by materials resistant to corrosion by UF₆, for containing vortex tubes or separation nozzles. *Explanatory Note:*

These housings may be cylindrical vessels greater than 300 mm in diameter and greater than 900 mm in length, or may be rectangular vessels of comparable dimensions, and may be designed for horizontal or vertical installation.

7. Feed systems/product and tails withdrawal systems

Especially designed or prepared process systems or equipment for enrichment plants made of or protected by materials resistant to corrosion by UF_6 , including:

- a. Feed autoclaves, ovens, or systems used for passing ${\rm UF}_6$ to the enrichment process;
- Desublimers (or cold traps) used to remove UF₆ from the enrichment process for subsequent transfer upon heating;
- c. Solidification or liquefaction stations used to remove UF₆ from the enrichment process by compressing and converting UF₆ to a liquid or solid form;
- d. Product or tails stations used for transferring UF_6 into containers.

8. Header piping systems

Especially designed or prepared header piping systems, made of or protected by materials resistant to corrosion by UF_6 , for handling UF_6 within the aerodynamic cascades. This piping network is normally of the double header design with each stage or group of stages connected to each of the headers.

9. Vacuum systems and pumps

- a. Especially designed or prepared vacuum systems having a suction capacity of 5 m³/min or more, consisting of vacuum manifolds, vacuum headers and vacuum pumps, and designed for service in UF₆-bearing atmospheres;
- b. Vacuum pumps especially designed or prepared for service in UF₆-bearing atmospheres and made of or protected by materials resistant to corrosion by UF₆. These pumps may use fluorocarbon seals and special working fluids.

10. Special shut-off and control valves

Especially designed or prepared manual or automated shut-off and control bellows valves made of or protected by materials resistant to corrosion by ${\rm UF}_6$ with a diameter of 40 to 1500 mm for installation in main and auxiliary systems of aerodynamic enrichment plants.

11. UF₆ mass spectrometers/Ion sources

Especially designed or prepared magnetic or quadrupole mass spectrometers capable of taking on-line samples of feed, product or tails, from UF $_6$ gas streams and having all of the following characteristics:

- 1. Unit resolution for mass greater than 320;
- Ion sources constructed of or lined with nichrome or monel or nickel plated;
- 3. Electron bombardment ionization sources;
- 4. Collector system suitable for isotopic analysis.

12.UF₆/carrier gas separation systems

Especially designed or prepared process systems for separating UF_6 from carrier gas (hydrogen or helium).

Explanatory Note:

These systems are designed to reduce the UF₆ content in the carrier gas to 1 ppm or less and may incorporate equipment such as:

- a. Cryogenic heat exchangers and cryoseparators capable of temperatures of -120 °C or less; **or**
- b. Cryogenic refrigeration units capable of temperatures of -120 °C or less or
- Separation nozzle or vortex tube units for the separation of UF₆ from carrier gas; or
- d. UF₆ cold traps capable of temperatures of -20 °C or less.

Especially designed or prepared systems, equipment and components for use in chemical exchange or ion exchange enrichment plants.

Introductory Note:

The slight difference in mass between the isotopes of uranium causes small changes in chemical reaction Equilibria that can be used as a basis for separation of the isotopes. Two processes have been successfully developed: liquid-liquid chemical exchange and solid-liquid ion exchange.

In the liquid-liquid chemical exchange process, immiscible liquid phases (aqueous and organic) are counter currently contacted to give the cascading effect of thousands of separation stages. The aqueous phase consists of uranium chloride in hydrochloric acid solution; the organic phase consists of an extractant containing uranium chloride in an organic solvent. The contactors employed in the separation cascade can be liquid-liquid exchange columns (such as pulsed columns with sieve plates) or liquid centrifugal contactors. Chemical conversions (oxidation and reduction) are required at both ends of the separation cascade in order to provide for the reflux requirements at each end. A major design concern is to avoid contamination of the process streams with certain metal ions. Plastic, plastic-lined (including use of fluorocarbon polymers) and/or glass-lined columns and piping are therefore used.

In the solid-liquid ion-exchange process, enrichment is accomplished by uranium adsorption/desorption on a special, very fast-acting, ion-exchange resin or adsorbent. A solution of uranium in hydrochloric acid and other chemical agents is passed through cylindrical enrichment columns containing packed beds of the adsorbent. For a continuous process, a reflux system is necessary to release the uranium from the adsorbent back into the liquid flow so that product and tails can be collected. This is accomplished with the use of suitable reduction/oxidation chemical agents that are fully regenerated in separate external circuits and that may be partially regenerated within the isotopic separation columns themselves. The presence of hot concentrated hydrochloric acid solutions in the process requires that the equipment be made of or protected by special corrosion-resistant materials.

1. Liquid-liquid exchange columns (Chemical exchange)

Countercurrent liquid-liquid exchange columns having mechanical power input (i.e., pulsed columns with sieve plates, reciprocating plate columns, and columns with internal turbine mixers), especially designed or prepared for uranium enrichment using the chemical exchange process. For corrosion resistance to concentrated hydrochloric acid solutions, these columns, and their internals are made of or protected by suitable plastic materials (such as fluorocarbon polymers) or glass. The stage residence time of the columns is designed to be short (30 seconds or less).

2. Liquid-liquid centrifugal contactors (Chemical exchange)

Liquid-liquid centrifugal contactors especially designed or prepared for uranium enrichment using the chemical exchange process. Such contactors use rotation to achieve dispersion of the organic and aqueous streams and then centrifugal force to separate the phases. For corrosion resistance to concentrated hydrochloric acid solutions, the contactors are made of or are lined with suitable plastic materials (such as fluorocarbon polymers) or are lined with glass. The stage residence time of the centrifugal contactors is designed to be short (30 seconds or less).

3. Uranium reduction systems and equipment (Chemical exchange)

a. Especially designed or prepared electrochemical reduction cells to reduce uranium from one valence state to another for uranium enrichment using the chemical exchange process. The cell materials in contact with process solutions must be corrosion resistant to concentrated hydrochloric acid solutions.

Explanatory Note:

The cell cathodic compartment must be designed to prevent reoxidation of uranium to its higher valence state. To keep the uranium in the cathodic compartment, the cell may have an impervious diaphragm membrane constructed of special cation exchange material. The cathode consists of a suitable solid conductor such as graphite.

b. Especially designed or prepared systems at the product end of the cascade for taking the U⁺⁴ out of the organic stream, adjusting the acid concentration and feeding to the electrochemical reduction cells.

Explanatory Note:

These systems consist of solvent extraction equipment for stripping the U+4 from the organic stream into an aqueous solution, evaporation and/or other equipment to accomplish solution pH adjustment and control, and pumps or other transfer devices for feeding to the electrochemical reduction cells. A major design concern is to avoid contamination of the aqueous stream with certain metal ions. Consequently, for those parts in contact with the process stream, the system is constructed of equipment made of or protected by suitable materials (such as glass, fluorocarbon polymers, polyphenyl sulfate, polyether sulfone, and resinimpregnated graphite).

4. Feed preparation systems (Chemical exchange)

Especially designed or prepared systems for producing highpurity uranium chloride feed solutions for chemical exchange uranium isotope separation plants.

Explanatory Note:

These systems consist of dissolution, solvent extraction and/or ion exchange equipment for purification and electrolytic cells for reducing the uranium U+6 or U+4 to U+3. These systems produce uranium chloride solutions having only a few parts per million of metallic impurities such as chromium, iron, vanadium, molybdenum and other bivalent or higher multi-valent cations. Materials of construction for portions of the system processing high purity U+3 include glass, fluorocarbon polymers, polyphenyl sulfate or polyether sulfone plastic-lined and resin impregnated graphite.

5. Uranium oxidation systems (Chemical exchange)

Especially designed or prepared systems for oxidation of U^{+3} to U^{+4} for return to the uranium isotope separation cascade in the chemical exchange enrichment process.

Explanatory Note:

These systems may incorporate equipment such as:

- a. Equipment for contacting chlorine and oxygen with the aqueous effluent from the isotope separation equipment and extracting the resultant U⁺⁴ into the stripped organic stream returning from the product end of the cascade.
- b. Equipment that separates water from hydrochloric acid so that the water and the concentrated hydrochloric acid may be reintroduced to the process at the proper locations.

6. Fast-reacting ion exchange resins/adsorbents (Ion exchange)

Fast-reacting ion-exchange resins or adsorbents especially designed or prepared for uranium enrichment using the ion exchange process, including porous macroreticular resins, and/or pellicular structures in which the active chemical exchange groups are limited to a coating on the surface of an inactive porous support structure, and other composite structures in any suitable form including particles or fibers. These ion exchange resins/adsorbents have diameters of 0.2 mm or less and must be chemically resistant to concentrated hydrochloric acid solutions as well as physically strong enough so as not to degrade in the exchange columns. The resins/adsorbents are especially designed to achieve very fast uranium isotope exchange kinetics (exchange rate half-time of less than 10 seconds) and are capable of operating at a temperature in the range of 100°C to 200°C.

7. Ion exchange columns (Ion exchange)

Cylindrical columns greater than 1000 mm in diameter for containing and supporting packed beds of ion exchange resin/adsorbent, especially designed or prepared for uranium enrichment using the ion exchange process. These columns are made of or protected by materials (such as titanium or fluorocarbon plastics) resistant to corrosion by concentrated hydrochloric acid solutions and are capable of operating at a temperature in the range of 100 °C to 200 °C and pressures above 0.7 MPa (102 psi).

8. Ion exchange reflux systems (Ion exchange)

- Especially designed or prepared chemical or electrochemical reduction systems for regeneration of the chemical reducing agent(s) used in ion exchange uranium enrichment cascades.
- Especially designed or prepared chemical or electrochemical oxidation systems for regeneration of the chemical oxidizing agent(s) used in ion exchange uranium enrichment cascades.

Explanatory Note:

The ion exchange enrichment process may use, for example, trivalent titanium (Ti+3) as a reducing cation in which case the reduction system would regenerate Ti+3 by reducing Ti+4.

The process may use, for example, trivalent iron (Fe^{+3}) as an oxidant in which case the oxidation system would regenerate Fe^{+3} by oxidizing Fe^{+2} .

Especially designed or prepared systems, equipment and components for use in laser-based enrichment plants. Introductory Note:

Present systems for enrichment processes using lasers fall into two categories: those in which the process medium is atomic uranium vapor and those in which the process medium is the vapor of a uranium compound. Common nomenclature for such processes include: first category - atomic vapor laser isotope separation (AVLIS or SILVA); second category - molecular laser isotope separation (MLIS or MOLIS) and chemical reaction by isotope selective laser activation (CRISLA). The systems, equipment and components for laser enrichment plants embrace:

- a. devices to feed uranium-metal vapor (for selective photo-ionization) or devices to feed the vapor of a uranium compound (for photodissociation or chemical activation);
- devices to collect enriched and depleted uranium metal as product and tails in the first category, and devices to collect dissociated or reacted compounds as product and unaffected material as tails in the second category;
- c. process laser systems to selectively excite the uranium-235 species; and
- d. feed preparation and product conversion equipment.

The complexity of the spectroscopy of uranium atoms and compounds may require incorporation of any of a number of available laser technologies.

Explanatory Note:

Many of the items listed in this section come into direct contact with uranium metal vapor or liquid or with process gas consisting of UF $_6$ or a mixture of UF $_6$ and other gases. All surfaces that come into contact with the uranium or UF $_6$ are wholly made of or protected by corrosion-resistant materials. For the purposes of the section relating to laser-based enrichment items, the materials resistant to corrosion by the vapor or liquid of uranium metal or uranium alloys include yttria-coated graphite and tantalum; and the materials resistant to corrosion by UF $_6$ include copper, stainless steel, aluminum, aluminum alloys, nickel or alloys containing 60% or more nickel and UF $_6$ -resistant fully fluorinated hydrocarbon polymers.

1. Uranium vaporization systems (AVLIS)

Especially designed or prepared uranium vaporization systems which contain high-power strip or scanning electron beam guns with a delivered power on the target of more than 2.5 kW/cm.

2. Liquid uranium metal handling systems (AVLIS)

Especially designed or prepared liquid metal handling systems for molten uranium or uranium alloys, consisting of crucibles and cooling equipment for the crucibles.

Explanatory Note:

The crucibles and other parts of this system that come into contact with molten uranium or uranium alloys are made of or protected by materials of suitable corrosion and heat resistance. Suitable materials include tantalum, yttria-coated graphite, graphite coated with other rare earth oxides (see Group 4) or mixtures thereof.

3. Uranium metal product and tails collector assemblies (AVLIS)

Especially designed or prepared product and tails collector assemblies for uranium metal in liquid or solid form.

Explanatory Note:

Components for these assemblies are made of or protected by materials resistant to the heat and corrosion of uranium metal vapor or liquid (such as yttria-coated graphite or tantalum) and may include pipes, valves, fittings, gutters, feed-throughs, heat exchangers and collector plates for magnetic, electrostatic or other separation methods.

4. Separator module housings (AVLIS)

Especially designed or prepared cylindrical or rectangular vessels for containing the uranium metal vapor source, the electron beam gun, and the product and tails collectors.

Explanatory Note:

These housings have multiplicity of ports for electrical and water feedthroughs, laser beam windows, vacuum pump connections and instrumentation diagnostics and monitoring. They have provisions for opening and closure to allow refurbishment of internal components.

5. Supersonic expansion nozzles (MLIS)

Especially designed or prepared supersonic expansion nozzles for cooling mixtures of UF_6 and carrier gas to 150 K or less and which are corrosion resistant to UF_6 .

6. Uranium pentafluoride product collectors (MLIS)

Especially designed or prepared uranium pentafluoride (UF $_5$) solid product collectors consisting of filter, impact, or cyclone-type collectors, or combinations thereof, and which are corrosion resistant to the UF $_5$ /UF $_6$ environment.

7. UF₆/carrier gas compressors (MLIS)

Especially designed or prepared compressors for UF_6 /carrier gas mixtures, designed for long term operation in a UF_6 environment. The components of these compressors that come into contact with process gas are made of or protected by materials resistant to corrosion by UF_6 .

8. Rotary shaft seals (MLIS)

Especially designed or prepared rotary shaft seals, with seal feed and seal exhaust connections, for sealing the shaft connecting the compressor rotor with the driver motor so as to ensure a reliable seal against out-leakage of process gas or in-leakage of air or seal gas into the inner chamber of the compressor which is filled with a UF₆/carrier gas mixture.

9. Fluorination systems (MLIS)

Especially designed or prepared systems for fluorinating UF_5 (solid) to UF_6 (gas).

Explanatory Note:

These systems are designed to fluorinate the collected UF_5 powder to UF_6 for subsequent collection in product containers or for transfer as feed to MLIS units for additional enrichment. In one approach, the fluorination reaction may be accomplished within the isotope separation system to react and recover directly off the product collectors. In another approach, the UF_5 powder may be removed/transferred from the product collectors into a suitable reaction vessel (e.g., fluidized-bed reactor, screw reactor or flame tower) for fluorination. In both approaches, equipment for storage and transfer of fluorine (or other suitable fluorinating agents) and for collection and transfer of UF_6 are used.

10. UF₆ mass spectrometers/ion sources (MLIS)

Especially designed or prepared magnetic or quadrupole mass spectrometers capable of taking on-line samples of feed, product or tails, from UF $_6$ gas streams and having all of the following characteristics:

- 1. Unit resolution for mass greater than 320;
- Ion sources constructed of or lined with nichrome or monel or nickel plated;
- 3. Electron bombardment ionization sources;
- 4. Collector system suitable for isotopic analysis.

11. Feed systems/product and tails withdrawal systems (MLIS)

Especially designed or prepared process systems or equipment for enrichment plants made of or protected by materials resistant to corrosion by UF₆, including:

- Feed autoclaves, ovens, or systems used for passing UF₆ to the enrichment process;
- Desublimers (or cold traps) used to remove UF₆ from the enrichment process for subsequent transfer upon heating;
- c. Solidification or liquefaction stations used to remove UF_6 from the enrichment process by compressing and converting UF_6 to a liquid or solid form;
- d. Product or tails stations used for transferring UF_6 into containers.

12. UF₆/carrier gas separation systems (MLIS)

Especially designed or prepared process systems for separating UF₆ from carrier gas. The carrier gas may be nitrogen, argon, or other gas.

Explanatory Note:

These systems may incorporate equipment such as:

- a. Cryogenic heat exchangers or cryoseparators capable of temperatures of -120°C or less; or
- Cryogenic refrigeration units capable of temperatures of -120°C or less; or
- c. UF₆ cold traps capable of temperatures of -20°C or less.

13. Laser systems (AVLIS, MLIS and CRISLA)

Lasers or laser systems especially designed or prepared for the separation of uranium isotopes.

Explanatory Note:

The lasers and laser components of importance in laser-based enrichment processes include those identified in Group 4. The laser system for the AVLIS process usually consists of two lasers: a copper vapor laser and a dye laser. The laser system for MLIS usually consists of a $\rm CO_2$ or excimer laser and a multi-pass optical cell with revolving mirrors at both ends. Lasers or laser systems for both processes require a spectrum frequency stabilizer for operation over extended periods of time.

Especially designed or prepared systems, equipment and components for use in plasma separation enrichment plants. Introductory Note:

In the plasma separation process, a plasma of uranium ions passes through an electric field tuned to the U-235 ion resonance frequency so that they preferentially absorb energy and increase the diameter of their corkscrew-like orbit. Ions with a large-diameter path are trapped to produce a product enriched in U-235. The plasma, which is made by ionizing uranium vapor, is contained in a vacuum chamber with a high-strength magnetic field produced by a superconducting magnet. The main technological systems of the process include the uranium plasma generation system, the separator module with superconducting magnet (see Group 4), and metal removal systems for the collection of product and tails.

1. Microwave power sources and antennae

Especially designed or prepared microwave power sources and antennae for producing or accelerating ions and having the following characteristics: greater than 30 GHz frequency and greater than 50 kW mean power output for ion production.

2. Ion excitation coils

Especially designed or prepared radio frequency ion excitation coils for frequencies of more than 100 kHz and capable of handling more than 40 kW mean power.

3. Uranium plasma generation systems

Especially designed or prepared systems for the generation of uranium plasma, which may contain high-power strip or scanning electron beam guns with a delivered power on the target of more than 2.5 kW/cm.

4. Liquid uranium metal handling systems

Especially designed or prepared liquid metal handling systems for molten uranium or uranium alloys, consisting of crucibles and cooling equipment for the crucibles.

Explanatory Note:

The crucibles and other parts of this system that come into contact with molten uranium or uranium alloys are made of or protected by materials of suitable corrosion and heat resistance. Suitable materials include tantalum, yttria-coated graphite, graphite coated with other rare earth oxides (see Group 4) or mixtures thereof.

5. Uranium metal product and tails collector assemblies

Especially designed or prepared product and tails collector assemblies for uranium metal in solid form. These collector assemblies are made of or protected by materials resistant to the heat and corrosion of uranium metal vapor, such as yttriacoated graphite or tantalum.

6. Separator module housings

Cylindrical vessels especially designed or prepared for use in plasma separation enrichment plants for containing the uranium plasma source, radio-frequency drive coil and the product and tails collectors.

Explanatory Note:

These housings have a multiplicity of ports for electrical feed-throughs, diffusion pump connections and instrumentation diagnostics and monitoring. They have provisions for opening and closure to allow for refurbishment of internal components and are constructed of a suitable non-magnetic material such as stainless steel.

Especially designed or prepared systems, equipment and components for use in electromagnetic enrichment plants. Introductory Note:

In the electromagnetic process, uranium metal ions produced by ionization of a salt feed material (typically UCl $_4$) are accelerated and passed through a magnetic field that has the effect of causing the ions of different isotopes to follow different paths. The major components of an electromagnetic isotope separator include: a magnetic field for ion-beam diversion/separation of the isotopes, an ion source with its acceleration system, and a collection system for the separated ions. Auxiliary systems for the process include the magnet power supply system, the ion source high-voltage power supply system, the vacuum system, and extensive chemical handling systems for recovery of product and cleaning/recycling of components.

1. Electromagnetic isotope separators

Electromagnetic isotope separators especially designed or prepared for the separation of uranium isotopes, and equipment and components therefor, including:

a. Ion sources

Especially designed or prepared single or multiple uranium ion sources consisting of a vapor source, ionizer, and beam accelerator, constructed of suitable materials such as graphite, stainless steel, or copper, and capable of providing a total ion beam current of 50 mA or greater.

b. Ion collectors

Collector plates consisting of two or more slits and pockets especially designed or prepared for collection of enriched and depleted uranium ion beams and constructed of suitable materials such as graphite or stainless steel.

c. Vacuum housings

Especially designed or prepared vacuum housings for uranium electromagnetic separators, constructed of suitable non-magnetic materials such as stainless steel and designed for operation at pressures of 0.1 Pa or lower.

Explanatory Note:

The housings are specially designed to contain the ion sources, collector plates and water-cooled liners and have provision for diffusion pump connections and opening and closure for removal and reinstallation of these components.

d. Magnet pole pieces

Especially designed or prepared magnet pole pieces having a diameter greater than 2 m used to maintain a constant magnetic field within an electromagnetic isotope separator and to transfer the magnetic field between adjoining separators.

2. High voltage power supplies

Especially designed or prepared high-voltage power supplies for ion sources, having all of the following characteristics: capable of continuous operation, output voltage of 20,000 V or greater, output current of 1 A or greater, and voltage regulation of better than 0.01% over a time period of 8 hours.

3. Magnet power supplies

Especially designed or prepared high-power, direct current magnet power supplies having all of the following characteristics: capable of continuously producing a current output of 500 A or greater at a voltage of 100 V or greater and with a current or voltage regulation better than 0.01% over a period of 8 hours.

3-2.6 Plants for the production or concentration of heavy water, deuterium and deuterium compounds and equipment and components especially designed or prepared therefor, including:

Introductory Note:

Heavy water can be produced by a variety of processes. However, the two processes that have proven to be commercially viable are the water-hydrogen sulphide exchange process (GS process) and the ammonia-hydrogen exchange process.

The GS process is based upon the exchange of hydrogen and deuterium between water and hydrogen sulphide within a series of towers which are operated with the top section cold and the bottom section hot. Water flows down the towers while the hydrogen sulphide gas circulates from the bottom to the top of the towers. A series of perforated trays are used to promote mixing between the gas and the water. Deuterium migrates to the water at low temperatures and to the hydrogen sulphide at high temperatures. Gas or water, enriched in deuterium, is removed from the first stage towers at the junction of the hot and cold sections and the process is repeated in subsequent, stage towers. The product of the last stage, water enriched up to 30% in deuterium, is sent to a distillation unit to, produce reactor grade heavy water; i.e., 99.75% deuterium oxide.

The ammonia-hydrogen exchange process can extract deuterium from synthesis gas through contact with liquid ammonia in the presence of a catalyst. The synthesis gas is fed into exchange towers and to an ammonia converter. Inside the towers the gas flows from the bottom to the top while the liquid ammonia flows from the top to the bottom. The deuterium is stripped from the hydrogen in the synthesis gas and concentrated in the ammonia. The ammonia then flows into an ammonia cracker at the bottom of the tower while the gas flows into an ammonia converter at the top. Further enrichment takes place in subsequent stages and reactor grade heavy water is produced through final distillation. The synthesis gas feed can be provided by an ammonia plant that, in turn, can be constructed in association with a heavy water ammonia-hydrogen exchange plant. The ammonia-hydrogen exchange process can also use ordinary water as a feed source of deuterium.

Many of the key equipment items for heavy water production plants using GS or the ammonia-hydrogen exchange processes are common to several segments of the chemical and petroleum industries. This is particularly so for small plants using the GS process. However, few of the items are available off-the-shelf. The GS and ammonia hydrogen processes require the handling of large quantities of flammable, corrosive and toxic fluids at elevated pressures. Accordingly, in establishing the design and operating standards for plants and equipment using these processes, careful attention to the materials selection and specifications is required to ensure long service life with high safety and reliability factors. The choice of scale is primarily a function of economics and need. Thus, most of the equipment items would be prepared according to the requirements of the customer.

Finally, it should be noted that, in both the GS and the ammonia-hydrogen exchange processes, items of equipment which individually are not especially designed or prepared for heavy water production can be assembled into systems which are especially designed or prepared for producing heavy water. The catalyst production system used in the ammonia-hydrogen exchange process and water distillation systems used for the final concentration of heavy water to reactor-grade in either process are examples of such systems.

The items of equipment which are especially designed or prepared for the production of heavy water utilizing either the water-hydrogen sulphide exchange process or the ammonia-hydrogen exchange process include the following:

1. Water - Hydrogen Sulphide Exchange Towers

Exchange towers fabricated from fine carbon steel (such as ASTM A516) with diameters of 6 m (20 ft) to 9 m (30 ft), capable of operating at pressures greater than or equal to 2 MPa (300 psi) and with a corrosion allowance of 6 mm or greater, especially designed or prepared for heavy water production utilizing the water-hydrogen sulphide exchange process.

2. Blowers and Compressors

Single stage, low head (i.e., 0.2 MPa or 30 psi) centrifugal blowers or compressors for hydrogen-sulphide gas circulation (i.e., gas containing more than 70% $\rm H_2S$) especially designed or prepared for heavy water production utilizing the water-hydrogen sulphide exchange process. These blowers or compressors have a throughput capacity greater than or equal to 56 m³/second (120,000 SCFM) while operating at pressures greater than or equal to 1.8 MPa (260 psi) suction and have seals designed for wet $\rm H_2S$ service.

3. Ammonia-Hydrogen Exchange Towers

Ammonia-hydrogen exchange towers greater than or equal to 35 m (114.3 ft) in height with diameters of 1.5 m (4.9 ft) to 2.5 m (8.2 ft) capable of operating at pressures greater than 15 MPa (2225 psi) especially designed or prepared for heavy water production utilizing the ammonia-hydrogen exchange process. These towers also have at least one flanged, axial opening of the same diameter as the cylindrical part through which the tower internals can be inserted or withdrawn.

4. Tower Internals and Stage Pumps

Tower internals and stage pumps especially designed or prepared for towers for heavy water production utilizing the ammonia-hydrogen exchange process. Tower internals include especially designed stage contactors which promote intimate gas/liquid contact. Stage pumps include especially designed submersible pumps for circulation of liquid ammonia within a contacting stage internal to the stage towers.

5. Ammonia Crackers

Ammonia crackers with operating pressures greater than or equal to 3 MPa (450 psi) especially designed or prepared for heavy water production utilizing the ammonia-hydrogen exchange process.

6. Infrared Absorption Analyzers

Infrared absorption analyzers capable of on-line hydrogen/deuterium ratio analysis where deuterium concentrations are equal to or greater than 90%.

7. Catalytic Burners

Catalytic burners for the conversion of enriched deuterium gas into heavy water especially designed or prepared for heavy water production utilizing the ammonia-hydrogen exchange process.

8. Complete heavy water upgrade systems or columns therefor

Complete heavy water upgrade systems, or columns therefor, especially designed or prepared for the upgrade of heavy water to reactor-grade deuterium concentration.

Explanatory Note:

These systems, which usually employ water distillation to separate heavy water from light water, are especially designed or prepared to produce reactor-grade heavy water (i.e., typically 99.75% deuterium oxide) from heavy water feedstock of lesser concentration.

3-2.7 Plants for the conversion of uranium and plutonium for use in the fabrication of fuel elements and the separation of uranium isotopes as defined in Items 3-2.4. and 3-2.5. respectively, and equipment and components especially designed or prepared therefor, including:

Plants for the conversion of uranium and equipment especially designed or prepared therefor Introductory Note:

Uranium conversion plants and systems may perform one or more transformations from one uranium chemical species to another, including: conversion of uranium ore concentrates to UO₃, conversion of UO₃ to UO₂, conversion of uranium oxides to UF₄, UF₆, or UCI₄, conversion of UF₄ to UF₆, conversion of UF₆ to UF₄, conversion of UF₄ to uranium metal, and conversion of uranium fluorides to UO2. Many of the key equipment items for uranium conversion plants are common to several segments of the chemical process industry. For example, the types of equipment employed in these processes may include: furnaces, rotary kilns, fluidized bed reactors, flame tower reactors, liquid centrifuges, distillation columns and liquid-liquid extraction columns. However, few of the items are available offthe-shelf, most would be prepared according to the requirements and specifications of the customer. In some instances, special design and construction considerations are required to address the corrosive properties of some of the chemicals handled (HF, F2, CIF3, and uranium fluorides) as well as nuclear criticality concerns. Finally, it should be noted that, in all of the uranium conversion processes, items of equipment which individually are not especially designed or prepared for uranium conversion can be assembled into systems which are especially designed or prepared for use in uranium conversion.

1. Especially designed or prepared systems for the conversion of uranium ore concentrates to UO₃ Explanatory Note:

Conversion of uranium ore concentrates to UO₃ can be performed by first dissolving the ore in nitric acid and extracting purified uranyl nitrate using a solvent such as tributyl phosphate. Next, the uranyl nitrate is converted to UO₃ either by concentration and denitration or by neutralization with gaseous ammonia to produce ammonium diuranate with subsequent filtering, drying, and calcining.

Especially designed or prepared systems for the conversion of UO₃ to UF₆ Explanatory Note:

Conversion of ${\rm UO}_3$ to ${\rm UF}_6$ can be performed directly by fluorination. The process requires a source of fluorine gas or chlorine trifluoride.

3. Especially designed or prepared systems for the conversion of UO₃ to UO₂ Explanatory Note:

Conversion of UO₃ to UO₂ can be performed through reduction of UO₃ with cracked ammonia gas or hydrogen.

4. Especially designed or prepared systems for the conversion of UO_2 to UF_4

Explanatory Note:

Conversion of UO_2 to UF_4 can be performed by reacting UO_2 with hydrogen fluoride gas (HF) at 300-500 $^{\circ}$ C.

5. Especially designed or prepared systems for the conversion of UF $_4$ to UF $_6$

Explanatory Note:

Conversion of UF_4 to UF_6 is performed by exothermic reaction with fluorine in a tower reactor. UF_6 is condensed from the hot effluent gases by passing the effluent stream through a cold trap cooled to -10°C. The process requires a source of fluorine gas.

6. Especially designed or prepared systems for the conversion of UF₄ to U metal

Explanatory Note:

Conversion of UF_4 to U metal is performed by reduction with magnesium (large batches) or calcium (small batches). The reaction is carried out at temperatures above the melting point of uranium (1130°C).

7. Especially designed or prepared systems for the conversion of ${\rm UF}_6$ to ${\rm UO}_2$ Explanatory Note:

Conversion of UF $_6$ to UO $_2$ can be performed by one of three processes. In the first, UF $_6$ is reduced and hydrolyzed to UO $_2$ using hydrogen and steam. In the second, UF $_6$ is hydrolyzed by solution in water, ammonia is added to precipitate ammonium diuranate, and the diuranate is reduced to UO $_2$ with hydrogen at 820°C. In the third process, gaseous UF $_6$, CO $_2$, and NH $_3$ are combined in water, precipitating ammonium uranyl carbonate. The ammonium uranyl carbonate is combined with steam and hydrogen at 500-600°C to yield UO $_2$.

 UF_6 to UO_2 conversion is often performed as the first stage of a fuel fabrication plant.

8. Especially designed or prepared systems for the conversion of UF_6 to UF_4

Explanatory Note:

Conversion of UF₆ to UF₄ is performed by reduction with hydrogen.

9. Especially designed or prepared systems for the conversion of UO_2 to UCl_4

Explanatory Note:

Conversion of $\rm UO_2$ to $\rm UCl_4$ can be performed by one of two processes. In the first, $\rm UO_2$ is reacted with carbon tetrachloride ($\rm CCl_4$) at approximately 400°C. In the second, $\rm UO_2$ is reacted at approximately 700°C in the presence of carbon black (CAS 1333-86-4), carbon monoxide, and chlorine to yield $\rm UCl_4$.

2. Plants for the conversion of plutonium and equipment especially designed or prepared therefor *Introductory Note:*

Plutonium conversion plants and systems perform one or more transformations from one plutonium chemical species to another, including: conversion of plutonium nitrate to PuO2, conversion of PuO2 to PuF4, and conversion of PuF₄ to plutonium metal. Plutonium conversion plants are usually associated with reprocessing facilities, but may also be associated with plutonium fuel fabrication facilities. Many of the key equipment items for plutonium conversion plants are common to several segments of the chemical process industry. For example, the types of equipment employed in these processes may include: furnaces, rotary kilns, fluidized bed reactors, flame tower reactors, liquid centrifuges, distillation columns and liquid-liquid extraction columns. Hot cells, glove boxes and remote manipulators may also be required. However, few of the items are available off-the-shelf; most would be prepared according to the requirements and specifications of the customer. Particular care in designing for the special radiological, toxicity and criticality hazards associated with plutonium is essential. In some instances, special design and construction considerations are required to address the corrosive properties of some of the chemicals handled (e.g. HF). Finally, it should be noted that, for all plutonium conversion processes, items of equipment which individually are

not especially designed or prepared for plutonium conversion can be assembled into systems which are especially designed or prepared for use in plutonium conversion.

1. Especially designed or prepared systems for the conversion of plutonium nitrate to oxide Explanatory Note:

The main functions involved in this process are: process feed storage and adjustment, precipitation and solid/liquor separation, calcination, product handling, ventilation, waste management, and process control. The process systems are particularly adapted so as to avoid criticality and radiation effects and to minimize toxicity hazards. In most reprocessing facilities, this process involves the conversion of plutonium nitrate to plutonium dioxide. Other processes can involve the precipitation of plutonium oxalate or plutonium peroxide.

2. Especially designed or prepared systems for plutonium metal production

Explanatory Note:

This process usually involves the fluorination of plutonium dioxide, normally with highly corrosive hydrogen fluoride, to produce plutonium fluoride which is subsequently reduced using high purity calcium metal to produce metallic plutonium and a calcium fluoride slag. The main functions involved in this process are fluorination (e.g. involving equipment fabricated or lined with a precious metal), metal reduction (e.g. employing ceramic crucibles), slag recovery, product handling, ventilation, waste management and process control. The process systems are, particularly adapted so as to avoid criticality and radiation effects and to minimize toxicity hazards. Other, processes include the fluorination of plutonium oxalate or plutonium peroxide followed by a reduction to metal.

3-3. Software

"Software" especially designed or modified for the "development", "production", or "use" of items specified in Group 3.

3-4. Technology

"Technology" according to the Nuclear Technology Note for the "development", "production", or "use" of items specified in Group 3.

Group 4 - Nuclear-Related Dual-Use List

Note:

Terms in 'single quotations' are usually defined within each entry of the list. Terms in "double quotations" are defined at the end of Group 4.

Canadian Nuclear Safety Commission (CNSC) Note:

The export of nuclear and nuclear-related items is also controlled by the CNSC under the Nuclear Safety and Control Act (NSCA) and Regulations. Therefore, the export of nuclear and nuclear-related items, not listed in Group 4 or which meet the specific Group 4 decontrol notes may still require a license from the CNSC. Information on export licensing requirements under the NSCA may be obtained by contacting the CNSC.

General Technology Note:

The export of "technology" required for the "development", "production" or "use" of items controlled in Group 4, is controlled according to the provisions of Group 4. This "technology" remains under control even when applicable to non-controlled items.

The approval of items for export also authorizes the export to the same enduser of the minimum "technology" required for the installation, operation, maintenance and repair of the items.

Controls on "technology" transfer, do not apply to information "in the public domain" or to "basic scientific research".

General Software Note:

The export of "software" is controlled according to the provisions of Group 4. Group 4 does not control "software" which is either:

- 1. Generally available to the public by being:
 - a. Sold from stock at retail selling points, without restriction, by means of:
 - 1. Over-the-counter transactions;
 - 2. Mail order transactions:
 - 3. Electronic Transactions; or
 - 4. Telephone call transactions; and
 - Designed for installation by the user without further substantial support by the supplier; or
- 2. "In the public domain".

4-1. Industrial Equipment

4-1.A Equipment, Assemblies and Components

- High-density (lead glass or other) radiation shielding windows, having all of the following characteristics, and specially designed frames therefor:
 - a. A 'cold area' greater than 0.09 m²;
 - b. A density greater than 3 g/cm³; and
 - c. A thickness of 100 mm or greater.

Technical Note:

In Item 4-1.A.1.a. the term 'cold area' means the viewing area of the window exposed to the lowest level of radiation in the design application.

2. Radiation-hardened TV cameras, or lenses therefor, specially designed or rated as radiation hardened to withstand a total radiation dose greater than 5 x 10^4 Gy (silicon) without operational degradation.

Technical Note:

The term Gy (silicon) refers to the energy in Joules per kilogram absorbed by an unshielded silicon sample when exposed to ionizing radiation.

- 3. "Robots", "end-effectors" and control units as follows:
 - a. "Robots" or "end-effectors" having either of the following characteristics:
 - Specially designed to comply with national safety standards applicable to handling high explosives (for example, meeting electrical code ratings for high explosives); or

2. Specially designed or rated as radiation hardened to withstand a total radiation dose greater than 5 x 10⁴ Gy (silicon) without operational degradation;

Technical Note:

The term Gy (silicon) refers to the energy in Joules per kilogram absorbed by an unshielded silicon sample when exposed to ionizing radiation.

b. Control units specially designed for any of the "robots" or "end-effectors" specified in Item 4-1.A.3.a.

Note:

Item 4-1.A.3. does not control "robots" specially designed for non-nuclear industrial applications such as automobile paint-spraying booths.

- 4. Remote manipulators that can be used to provide remote actions in radiochemical separation operations or hot cells, having either of the following characteristics:
 - a. A capability of penetrating 0.6 m or more of hot cell wall (through-the-wall operation); **or**
 - b. A capability of bridging over the top of a hot cell wall with a thickness of 0.6 m or more (over-the-wall operation).

Technical Note:

Remote manipulators provide translation of human operator actions to a remote operating arm and terminal fixture. They may be of a master/slave type or operated by joystick or keypad.

4-1.B. Test and Production Equipment

- Flow-forming machines, spin-forming machines capable of flow-forming functions, and mandrels, as follows:
 - a. Machines having both of the following characteristics:
 - 1. Three or more rollers (active or guiding); and
 - Which, according to the manufacturer's technical specification, can be equipped with "numerical control" units or a computer control;
 - Rotor-forming mandrels designed to form cylindrical rotors of inside diameter between 75 and 400 mm.

Note

Item 4-1.B.1. includes machines which have only a single roller designed to deform metal plus two auxiliary rollers which support the mandrel, but do not participate directly in the deformation process.

 Machine tools, as follows, and any combination thereof, for removing or cutting metals, ceramics, or composites, which, according to the manufacturer's technical specifications, can be equipped with electronic devices for simultaneous "contouring control" in two or more axes;

N.B.:

For "numerical control" units controlled by their associated "software", see Item 4-1 D.3

a. Machine tools for turning, that have "positioning accuracies" with all compensations available better (less) than 6 μ m according to ISO 230/2 (1988) along any linear axis (overall positioning) for machines capable of machining diameters greater than 35 mm;

Note

Item 4-1.B.2.a. does not control bar machines (Swissturn), limited to machining only bar feed thru, if maximum bar diameter is equal to or less than 42 mm and there is no capability of mounting chucks. Machines may have drilling and/or milling capabilities for machining parts with diameters less than 42 mm.

- b. Machine tools for milling, having any of the following characteristics:
 - "Positioning accuracies" with all compensations available better (less) than 6 μm according to ISO 230/2 (1988) along any linear axis (overall positioning);
 - 2. Two or more contouring rotary axes; or
 - 3. Five or more axes which can be coordinated simultaneously for "contouring control".

Note:

Item 4-1.B.2.b. does not control milling machines having both of the following characteristics:

- 1. X-axis travel greater than 2 m; and
- Overall "positioning accuracy" on the x-axis worse (more) than 30 μm according to ISO 230/2 (1988).
- Machine tools for grinding, having any of the following characteristics:
 - "Positioning accuracies" with all compensations available better (less) than 4 μm according to ISO 230/2 (1988) along any linear axis (overall positioning);
 - 2. Two or more contouring rotary axes; or
 - 3. Five or more axes which can be coordinated simultaneously for "contouring control".

Note:

Item 4-1.B.2.c. does not control grinding machines as follows:

- Cylindrical external, internal, and external-internal grinding machines having all the following characteristics:
 - Limited to a maximum workpiece capacity of 150 mm outside diameter or length; and
 - b. Axes limited to x, z, and c.
- Jig grinders that do not have a z-axis or a w-axis with an overall "positioning accuracy" less (better) than 4 microns. "Positioning accuracy" is according to ISO 230/2 (1988).
- d. Non-wire type Electrical Discharge Machines (EDM) that have two or more contouring rotary axes and that can be coordinated simultaneously for "contouring control".

Notes:

 Stated "positioning accuracy" levels derived under the following procedures from measurements made according to ISO 230/2 (1988) or national equivalents may be used for each machine tool model if provided to, and accepted by, national authorities instead of individual machine tests.

Stated "positioning accuracy" are to be derived as follows:

- a. Select five machines of a model to be evaluated;
- b. Measure the linear axis accuracies according to ISO 230/2 (1988);
- Determine the accuracy values (A) for each axis of each machine.
 The method of calculating the accuracy value is described in the ISO 230/2 (1988) standard;
- d. Determine the average accuracy value of each axis. This average value becomes the stated "positioning accuracy" of each axis for the model (\hat{A}_{X} , \hat{A}_{y} ...);
- e. Since Item 4-1.B.2. refers to each linear axis, there will be as many stated "positioning accuracy" values as there are linear axes;
- f. If any axis of a machine tool not controlled by Items 4-1.B.2.a., 4-1.B.2.b., or 4-1.B.2.c. has a stated "positioning accuracy" of 6 µm or better (less) for grinding machines, and 8 µm or better (less) for milling and turning machines, both according to ISO 230/2 (1988), then the builder should be required to reaffirm the accuracy level once every eighteen months.
- Item 4-1.B.2. does not control special purpose machine tools limited to the manufacture of any of the following parts;
 - a. Gears
 - b. Crankshafts or cam shafts
 - c. Tools or cutters
 - d Extruder worms

Technical Notes.

 Axis nomenclature shall be in accordance with International Standard ISO 841, 'Numerical Control Machines - Axis and Motion Nomenclature'.

- Not counted in the total number of contouring axes are secondary parallel contouring axes (e.g., the w-axis on horizontal boring mills or a secondary rotary axis the centerline of which is parallel to the primary rotary axis).
- Rotary axes do not necessarily have to rotate over 360 degrees.
 A rotary axis can be driven by a linear device, e.g., a screw or a rack-and-pinion.
- 4. For the purposes of 4-1.B.2. the number of axes which can be coordinated simultaneously for "contouring control" is the number of axes along or around which, during processing of the workpiece, simultaneous and interrelated motions are performed between the workpiece and a tool. This does not include any additional axes along or around which other relative motions within the machine are performed, such as:
 - a. Wheel-dressing systems in grinding machines:
 - b. Parallel rotary axes designed for mounting of separate workpieces:
 - c. Co-linear rotary axes designed for manipulating the same workpiece by holding it in a chuck from different ends.
- A machine tool having at least 2 of the 3 turning, milling, or grinding capabilities (e.g., a turning machine with milling capability) must be evaluated against each applicable entry, 4-1.B.2.a., 4-1.B.2.b. and 4-1.B.2.c.
- 6. Items 4-1.B.2.b.3. and 4-1.B.2.c.3. include machines based on a parallel linear kinematic design (e.g., hexapods) that have 5 or more axes none of which are rotary axes.
- Dimensional inspection machines, instruments, or systems, as follows:
 - a. Computer controlled or numerically controlled dimensional inspection machines having both of the following characteristics:
 - 1. Two or more axes: and
 - 2. A one-dimensional length "measurement uncertainty" equal to or better (less) than (1.25 + L/1000) µm tested with a probe of an "accuracy" of better (less) than 0.2 µm (L is the measured length in millimeters) (Ref.: VDI/VDE 2617 parts 1 and 2);
 - b. 'Linear displacement' measuring instruments, as follows:
 - Non-contact type measuring systems with a "resolution" equal to or better (less) than 0.2 μm within a measuring range up to 0.2 mm;
 - linear variable differential transformer (LVDT) systems having both of the following characteristics:
 - a. "Linearity" equal to or better (less) than 0.1% within a measuring range up to 5 mm; and
 - b. Drift equal to or better (less) than 0.1% per day at a standard ambient test room temperature $\pm 1K$;
 - Measuring systems having both of the following characteristics:
 - a. Contain a laser; and
 - b. Maintain for at least 12 hours, over a temperature range of $\pm 1~K$ around a standard temperature and a standard pressure:
 - 1. A "resolution" over their full scale of 0.1 μm or better; and
 - 2. With a "measurement uncertainty" equal to or better (less) than (0.2 + L/2000) µm (L is the measured length in millimeters);

Note:

Item 4-1.B.3.b.3. does not control measuring interferometer systems, without closed or open loop feedback, containing a laser to measure slide movement errors of machine tools, dimensional inspection machines, or similar equipment.

Technical Note:

In item 4-1.B.3.b. 'linear displacement' means the change of distance between the measuring probe and the measured object.

 c. Angular displacement measuring instruments having an "angular position deviation" equal to or better (less) than 0.00025°;

Note:

Item 4-1.B.3.c. does not control optical instruments, such as autocollimators, using collimated light (e.g., laser light) to detect angular displacement of a mirror.

- d. Systems for simultaneous linear-angular inspection of hemishells, having both of the following characteristics:
 - 1. "Measurement uncertainty" along any linear axis equal to or better (less) than 3.5 µm per 5 mm; and
 - 2. "Angular position deviation" equal to or less than 0.02°.

Notes:

- Item 4-1.B.3. includes machine tools that can be used as measuring machines if they meet or exceed the criteria specified for the measuring machine function.
- Machines described in Item 4-1.B.3. are controlled if they exceed the threshold specified anywhere within their operating range.

Technical Notes:

- The probe used in determining the "measurement uncertainty" of a dimensional inspection system shall be as described in VDI/VDE 2617 parts 2. 3 and 4.
- All parameters of measurement values in this item represent plus/minus, i.e., not total band.
- Controlled atmosphere (vacuum or inert gas) induction furnaces, and power supplies therefor, as follows:
 - a. Furnaces having all of the following characteristics:
 - 1. Capable of operation at temperatures above 1123 K (850 °C)
 - 2. Induction coils 600 mm or less in diameter; and
 - 3. Designed for power inputs of 5 kW or more;

Note:

Item 4-1.B.4.a. does not control furnaces designed for the processing of semiconductor wafers.

- Power supplies, with a specified output power of 5 kW or more, specially designed for furnaces specified in Item 4-1.B.4.a.
- 5. 'Isostatic presses', and related equipment, as follows:
 - a. 'Isostatic presses' having both of the following characteristics:
 - Capable of achieving a maximum working pressure of 69 MPa or greater; and
 - A chamber cavity with an inside diameter in excess of 152 mm;
 - b. Dies, molds, and controls specially designed for the 'isostatic presses' specified in Item 4-1.B.5.a.

Technical Notes:

- In Item 4-1.B.5. 'Isostatic presses' means equipment capable of pressurizing a closed cavity through various media (gas, liquid, solid particles, etc.) to create equal pressure in all directions within the cavity upon a workpiece or material.
- 2. In Item 4-1.B.5. the inside chamber dimension is that of the chamber in which both the working temperature and the working pressure are achieved and does not include fixtures. That dimension will be the smaller of either the inside diameter of the pressure chamber or the inside diameter of the insulated furnace chamber, depending on which of the two chambers is located inside the other.
- Vibration test systems, equipment, and components as follows:
 - a. Electrodynamic vibration test systems, having all of the following characteristics:
 - Employing feedback or closed loop control techniques and incorporating a digital control unit;
 - 2. Capable of vibrating at 10 g RMS or more between 20 and 2000 Hz; and

- Capable of imparting forces of 50 kN or greater measured 'bare table';
- b. Digital control units, combined with "software" specially designed for vibration testing, with a real-time bandwidth greater than 5 kHz and being designed for a system specified in Item 4-1.B.6.a.;
- c. Vibration thrusters (shaker units), with or without associated amplifiers, capable of imparting a force of 50 kN or greater measured 'bare table', which are usable for the systems specified in Item 4-1.B.6.a.;
- d. Test piece support structures and electronic units designed to combine multiple shaker units into a complete shaker system capable of providing an effective combined force of 50 kN or greater, measured 'bare table', which are usable for the systems specified in Item 4-1.B.6.a.

Technical Note:

In Item 4-1.B.6. 'bare table' means a flat table, or surface, with no fixtures or fittings.

- 7. Vacuum or other controlled atmosphere metallurgical melting and casting furnaces and related equipment, as follows:
 - a. Are remelt and casting furnaces having both of the following characteristics:
 - 1. Consumable electrode capacities between 1000 and 20000 cm^3 ; and
 - Capable of operating with melting temperatures above 1973 K (1700°C);
 - Electron beam melting furnaces and plasma atomization and melting furnaces, having both of the following characteristics:
 - 1. A power of 50 kW or greater; and
 - Capable of operating with melting temperatures above 1473 K (1200°C);
 - Computer control and monitoring systems specially configured for any of the furnaces specified in Item 4-1.B.7.a. or 4-1.B.7.b.

4-1.C. Materials

None.

4-1.D. Software

1. "Software" specially designed for the "use" of equipment specified in Item 4-1.A.3., 4-1.B.1., 4-1.B.3., 4-1.B.5., 4-1.B.6.a., 4-1.B.6.b., 4-1.B.6.d., or 4-1.B.7.

Note

"Software" specially designed for systems specified in Item 4-1.B.3.d. includes "software" for simultaneous measurements of wall thickness and contour.

- 2. "Software" specially designed or modified for the "development", "production", or "use" of equipment specified in Item 4-1.B.2.
- 3. "Software" for any combination of electronic devices or system enabling such device(s) to function as a "numerical control" unit capable of controlling five or more interpolating axes that can be coordinated simultaneously for "contouring control".

Notes:

 "Software" is controlled whether exported separately or residing in a "numerical control" unit or any electronic device or system. Item 4-1.D.3. does not control "software" specially designed or modified by the manufacturers of the control unit or machine tool to operate a machine tool that is not specified in Item 4-1.B.2.

4-1.E. Technology

1. "Technology" according to the General Technology Note for the "development", "production" or "use" of equipment, material or "software" specified in 4-1.A. through 4-1.D.

4-2. Materials

4-2.A. Equipment, Assemblies and Components

- Crucibles made of materials resistant to liquid actinide metals, as follows:
 - a. Crucibles having both of the following characteristics:
 - A volume of between 150 cm³ (150 ml) and 8000 cm³ (8 liters); and
 - 2. Made of or coated with any of the following materials, having a purity of 98% or greater by weight:
 - a. Calcium fluoride (CaF₂);
 - b. Calcium zirconate (metazirconate) (CaZrO₃);
 - c. Cerium sulfide (Ce₂S₃);
 - d. Erbium oxide (erbia) (Er₂O₃);
 - e. Hafnium oxide (hafnia) (HfO₂);
 - f. Magnesium oxide (MgO);
 - g. Nitrided niobium-titanium-tungsten alloy (approximately 50% Nb, 30% Ti, 20% W);
 - h. Yttrium oxide (yttria) (Y₂O₃); or
 - i. Zirconium oxide (zirconia) (ZrO₂);
 - b. Crucibles having both of the following characteristics:
 - 1. A volume of between 50 cm³ (50 ml) and 2000 cm³ (2 liters); **and**
 - 2. Made of or lined with tantalum, having a purity of 99.9% or greater by weight;
 - c. Crucibles having all of the following characteristics:
 - 1. A volume of between 50 cm³ (50 ml) and 2000 cm³ (2 liters);
 - 2. Made of or lined with tantalum, having a purity of 98% or greater by weight; **and**
 - Coated with tantalum carbide, nitride, boride, or any combination thereof.
- 2. Platinized catalysts specially designed or prepared for promoting the hydrogen isotope exchange reaction between hydrogen and water for the recovery of tritium from heavy water or for the production of heavy water.
- 3. Composite structures in the form of tubes having both of the following characteristics:
 - a. An inside diameter of between 75 and 400 mm; and
 - b. Made with any of the "fibrous or filamentary materials" specified in Item 4-2.C.7.a. or carbon prepreg materials specified in Item 4-2.C.7.c.

4-2.B. Test and Production Equipment

 Tritium facilities or plants, and equipment especially designed or prepared for the production, recovery, extraction, concentration

- or handling of tritium, tritium compounds or mixtures, including equipment for:
- a. Hydrogen or helium refrigeration units capable of cooling to 23 K (-250°C) or less, with heat removal capacity greater than 150 W;
- Hydrogen isotope storage or purification systems using metal hydrides as the storage or purification medium.
- Lithium isotope separation facilities or plants, and equipment therefor, as follows:
 - a. Facilities or plants for the separation of lithium isotopes;
 - b. Equipment for the separation of lithium isotopes, as follows:
 - Packed liquid-liquid exchange columns specially designed for lithium amalgams;
 - 2. Mercury or lithium amalgam pumps;
 - 3. Lithium amalgam electrolysis cells;
 - 4. Evaporators for concentrated lithium hydroxide solution.

4-2.C. Materials

- 1. Aluminum alloys having both of the following characteristics:
 - a. 'Capable of' an ultimate tensile strength of 460 MPa or more at 293 K (20°C); and
 - b. In the form of tubes or cylindrical solid forms (including forgings) with an outside diameter of more than 75 mm.

Technical Note:

In Item 4-2.C.1. the phrase 'capable of' encompasses aluminum alloys before or after heat treatment.

Beryllium metal, alloys containing more than 50% beryllium by weight, beryllium compounds, manufactures thereof, and waste or scrap of any of the foregoing.

Note

Item 4-2.C.2. does not control the following:

- a. Metal windows for X-ray machines or for bore-hole logging devices;
- Oxide shapes in fabricated or semi-fabricated forms specially designed for electronic component parts or as substrates for electronic circuits;
- Beryl (silicate of beryllium and aluminum) in the form of emeralds or aquamarines.
- 3. Bismuth having both of the following characteristics:
 - a. A purity of 99.99% or greater by weight; and
 - b. Containing less than 10 parts per million by weight of silver.
- 4. Boron enriched in the boron-10 (¹⁰B) isotope to greater than its natural isotopic abundance, as follows: elemental boron, compounds, mixtures containing boron, manufactures thereof, waste or scrap of any of the foregoing.

Note:

In Item 4-2.C.4. mixtures containing boron include boron loaded materials. **Technical Note:**

The natural isotopic abundance of boron-10 is approximately 18.5 weight percent (20 atom percent).

- 5. Calcium having both of the following characteristics:
 - Containing less than 1000 parts per million by weight of metallic impurities other than magnesium; and
 - b. Containing less than 10 parts per million by weight of boron.
- 6. Chlorine trifluoride (ClF₃).
- 7. "Fibrous or filamentary materials", and prepregs, as follows:
 - a. Carbon or aramid "fibrous or filamentary materials" having either of the following characteristics:
 - 1. A 'specific modulus' of 12.7 x 10⁶ m or greater; **or**
 - 2. A 'specific tensile strength' of 23.5×10^4 m or greater;

Note:

Item 4-2.C.7.a. does not control aramid "fibrous or filamentary materials" having 0.25% or more by weight of an ester based fiber surface modifier

- b. Glass "fibrous or filamentary materials" having both of the following characteristics:
 - 1. A 'specific modulus' of 3.18×10^6 m or greater; and
 - 2. A 'specific tensile strength' of 7.62×10^4 m or greater;
- c. Thermoset resin impregnated continuous "yarns", "rovings", "tows" or "tapes" with a width of 15 mm or less (prepregs), made from carbon or glass "fibrous or filamentary materials" specified in Item 4-2.C.7.a. or Item 4-2.C.7.b.

Technical Note:

The resin forms the matrix of the composite.

Technical Notes:

- In Item 4-2.C.7. 'Specific modulus' is the Young's modulus in N/m² divided by the specific weight in N/m³ when measured at a temperature of 296 ± 2 K (23 ± 2°C) and a relative humidity of 50 ± 5%.
- In Item 4-2.C.7. 'Specific tensile strength' is the ultimate tensile strength in N/m² divided by the specific weight in N/m³ when measured at a temperature of 296 ± 2 K (23 ± 2 °C) and a relative humidity of 50 ± 5%.
- 8. Hafnium metal, alloys containing more than 60% hafnium by weight, hafnium compounds containing more than 60% hafnium by weight, manufactures thereof, and waste or scrap of any of the foregoing.
- 9. Lithium enriched in the lithium-6 (⁶Li) isotope to greater than its natural isotopic abundance, and products or devices containing enriched lithium, as follows: elemental lithium, alloys, compounds, mixtures containing lithium, manufactures thereof, waste or scrap of any of the foregoing.

Note:

Item 4-2.C.9. does not control thermoluminescent dosimeters.

Technical Note:

The natural isotopic abundance of lithium-6 is approximately 6.5 weight percent (7.5 atom percent).

- 10. Magnesium having both of the following characteristics:
 - Containing less than 200 parts per million by weight of metallic impurities other than calcium; and
 - b. Containing less than 10 parts per million by weight of boron.
- 11. Maraging steel 'capable of' an ultimate tensile strength of 2050 MPa or more at 293 K (20 $^{\circ}$ C).

Note:

Item 4-2.C.11. does not control forms in which all linear dimensions are 75 mm or less.

Technical Note:

In Item 4-2.C.11. the phrase 'capable of' encompasses maraging steel before or after heat treatment.

12. Radium-226 (²²⁶Ra), radium-226 alloys, radium-226 compounds, mixtures containing radium-226, manufactures thereof, and products or devices containing any of the foregoing. *Note:*

Item 4-2.C.12. does not control the following:

- a. Medical applicators;
- b. A product or device containing less than 0.37 GBq of radium-226.
- 13. Titanium alloys having both of the following characteristics:
 - a. 'Capable of' an ultimate tensile strength of 900 MPa or more at 293 K (20°C); and
 - b. In the form of tubes or cylindrical solid forms (including forgings) with an outside diameter of more than 75 mm.

Technical Note:

In Item 4-2.C.13 the phrase 'capable of' encompasses titanium alloys before or after heat treatment.

- 14. Tungsten, tungsten carbide, and alloys containing more than 90% tungsten by weight, having both of the following characteristics:
 - a. In forms with a hollow cylindrical symmetry (including cylinder segments) with an inside diameter between 100 and 300 mm; and
 - b. A mass greater than 20 kg.

Note:

Item 4-2.C.14. does not control manufactures specially designed as weights or gamma-ray collimators.

15. Zirconium with a hafnium content of less than 1 part hafnium to 500 parts zirconium by weight, as follows: metal, alloys containing more than 50% zirconium by weight, compounds, manufactures thereof, waste or scrap of any of the foregoing.

Item 4-2.C.15. does not control zirconium in the form of foil having a thickness of 0.10 mm or less.

16. Nickel powder and porous nickel metal, as follows:

NR

For nickel powders which are especially prepared for the manufacture of gaseous diffusion barriers see Group 3, Item 3-2.5.3.

- a. Nickel powder having both of the following characteristics:
 - 1. A nickel purity content of 99.0% or greater by weight;
 - A mean particle size of less than 10 μm measured by the ASTM B 330 standard;
- b. Porous nickel metal produced from materials specified in Item 4-2.C.16.a.

Technical Note:

Item 4-2.C.16.b. refers to porous metal formed by compacting and sintering the material in Item 4-2.C.16.a. to form a metal material with fine pores interconnected throughout the structure.

Note:

Item 4-2.C.16. does not control the following:

- a. Filamentary nickel powders;
- Single porous nickel metal sheets with an area of 1000 cm² per sheet or less
- 17. Tritium, tritium compounds, mixtures containing tritium in which the ratio of tritium to hydrogen atoms exceeds 1 part in 1000, and products or devices containing any of the foregoing.

Item 4-2.C.17. does not control a product or device containing less than 1.48×10^3 GBq of tritium.

18.Helium-3 (³He), mixtures containing helium-3, and products or devices containing any of the foregoing.

Note:

Item 4-2.C.18. does not control a product or device containing less than 1 q of helium-3.

- 19. Alpha-emitting radionuclides having an alpha half-life of 10 days or greater but less than 200 years, in the following forms:
 - a. Elemental;
 - b. Compounds having a total alpha activity of 37 GBq per kg or greater;
 - Mixtures having a total alpha activity of 37 GBq per kg or greater;
 - d. Products or devices containing any of the foregoing.

Item 4-2.C.19. does not control a product or device containing less than 3.7 GBq of alpha activity.

4-2.E. Technology

1. "Technology" according to the General Technology Note for the "development", "production" or "use" of equipment, material or "software" specified in 4-2.A. through 4-2.D.

4-3. Uranium Isotope Separation Equipment and Components (Other than listed in Group 3)

4-3. A. Equipment, Assemblies and Components

 Frequency changers or generators having all of the following characteristics:

N.B.:

Frequency changers and generators especially designed or prepared for the gas centrifuge process are controlled under Group 3, Item 3-2.5.1.

- Multiphase output capable of providing a power of 40 W or greater;
- b. Capable of operating in the frequency range between 600 and 2000 Hz;
- c. Total harmonic distortion better (less) than 10%; and
- d. Frequency control better (less) than 0.1%.

Technical Note:

Frequency changers in Item 4-3.A.1. are also known as converters or inverters.

- 2. Lasers, laser amplifiers and oscillators as follows:
 - a. Copper vapor lasers having both of the following characteristics:
 - 1. Operating at wavelengths between 500 and 600 nm; and
 - 2. An average output power equal to or greater than 40 W;
 - b. Argon ion lasers having both of the following characteristics:
 - 1. Operating at wavelengths between 400 and 515 nm; and
 - 2. An average output power greater than 40 W;
 - c. Neodymium-doped (other than glass) lasers with an output wavelength between 1000 and 1100 nm having either of the following:
 - 1. Pulse-excited and Q-switched with a pulse duration equal to or greater than 1 ns, and having either of the following:
 - a. A single-transverse mode output with an average output power greater than 40 W; or
 - b. A multiple-transverse mode output with an average output power greater than 50 W; or
 - 2. Incorporating frequency doubling to give an output wavelength between 500 and 550 nm with an average output power of greater than 40 W;
 - d. Tunable pulsed single-mode dye laser oscillators having all of the following characteristics:
 - 1. Operating at wavelengths between 300 and 800 nm;
 - 2. An average output power greater than 1 W;
 - 3. A repetition rate greater than 1 kHz; and
 - 4. Pulse width less than 100 ns;

- Tunable pulsed dye laser amplifiers and oscillators having all of the following characteristics:
 - 1. Operating at wavelengths between 300 and 800 nm;
 - 2. An average output power greater than 30 W;
 - 3. A repetition rate greater than 1 kHz; and
 - 4. Pulse width less than 100 ns;

Note:

Item 4-3.A.2.e. does not control single mode oscillators.

- f. Alexandrite lasers having all of the following characteristics:
 - 1. Operating at wavelengths between 720 and 800 nm;
 - 2. A bandwidth of 0.005 nm or less;
 - 3. A repetition rate greater than 125 Hz; and
 - 4. An average output power greater than 30 W;
- g. Pulsed carbon dioxide lasers having all of the following characteristics:
 - 1. Operating at wavelengths between 9000 and 11000 nm;
 - 2. A repetition rate greater than 250 Hz;
 - 3. An average output power greater than 500 W; and
 - 4. Pulse width of less than 200 ns;

Note:

Item 4-3.A.2.g. does not control the higher power (typically 1 to 5 kW) industrial $\rm CO_2$ lasers used in applications such as cutting and welding, as these latter lasers are either continuous wave or are pulsed with a pulse width greater than 200 ns.

- h. Pulsed excimer lasers (XeF, XeCl, KrF) having all of the following characteristics:
 - 1. Operating at wavelengths between 240 and 360 nm;
 - 2. A repetition rate greater than 250 Hz; and
 - 3. An average output power greater than 500 W;
- Para-hydrogen Raman shifters, designed to operate at 16 µm output wavelength and at a repetition rate greater than 250 Hz.
- 3. Valves having all of the following characteristics:
 - a. A nominal size of 5 mm or greater;
 - b. Having a bellows seal; and
 - wholly made of or lined with aluminum, aluminum alloy, nickel, or nickel alloy containing more than 60% nickel by weight.

Technical Note:

For valves with different inlet and outlet diameter, the nominal size parameter in Item 4-3.A.3.a. refers to the smallest diameter.

- 4. Superconducting solenoidal electromagnets having all of the following characteristics:
 - a. Capable of creating magnetic fields greater than 2 T;
 - b. A ratio of length to inner diameter greater than 2;
 - c. Inner diameter greater than 300 mm; and
 - d. Magnetic field uniform to better than 1% over the central 50% of the inner volume.

Note:

Item 4-3.A.4 does not control magnets specially designed for and exported 'as part of' medical nuclear magnetic resonance (NMR) imaging systems.

N.B.

'As part of', does not necessarily mean physical part in the same shipment. Separate shipments from different sources are allowed, provided the related export documents clearly specify the 'as part of' relationship.

- 5. High-power direct current power supplies having both of the following characteristics:
 - a. Capable of continuously producing, over a time period of 8 hours, 100 V or greater with current output of 500 A or greater; and

- b. Current or voltage stability better than 0.1% over a time period of 8 hours.
- 6. High-voltage direct current power supplies having both of the following characteristics:
 - a. Capable of continuously producing, over a time period of 8 hours, 20 kV or greater with current output of 1 A or greater; and
 - b. Current or voltage stability better than 0.1% over a time period of 8 hours.
- 7. Pressure transducers capable of measuring absolute pressures at any point in the range 0 to 13 kPa and having both of the following characteristics:
 - a. Pressure sensing elements made of or protected by aluminum, aluminum alloy, nickel, or nickel alloy with more than 60% nickel by weight; and
 - b. Having either of the following characteristics:
 - 1. A full scale of less than 13 kPa and an "accuracy" of better than \pm 1% of full scale; **or**
 - 2. A full scale of 13 kPa or greater and an "accuracy" of better than \pm 130 Pa.

Technical Notes:

- In Item 4-3.A.7. pressure transducers are devices that convert pressure measurements into an electrical signal.
- In Item 4-3.A.7. "accuracy" includes non-linearity, hysteresis and repeatability at ambient temperature.
- 8. Vacuum pumps having all of the following characteristics:
 - a. Input throat size equal to or greater than 380 mm;
 - b. Pumping speed equal to or greater than 15 m³/s; and
 - c. Capable of producing an ultimate vacuum better than 13.3 mPa. *Technical Notes*
 - The pumping speed is determined at the measurement point with nitrogen gas or air.
 - The ultimate vacuum is determined at the input of the pump with the input of the pump blocked off.

4-3.B. Test and Production Equipment

- 1. Electrolytic cells for fluorine production with an output capacity greater than 250 g of fluorine per hour.
- 2. Rotor fabrication or assembly equipment, rotor straightening equipment, bellows-forming mandrels and dies, as follows:
 - a. Rotor assembly equipment for assembly of gas centrifuge rotor tube sections, baffles, and end caps;
 Note:

Item 4-3.B.2.a. includes precision mandrels, clamps, and shrink fit machines.

b. Rotor straightening equipment for alignment of gas centrifuge rotor tube sections to a common axis;

Technical Note:

In Item 4-3.B.2.b. such equipment normally consists of precision measuring probes linked to a computer that subsequently controls the action of, for example, pneumatic rams used for aligning the rotor tube sections.

 Bellows-forming mandrels and dies for producing singleconvolution bellows.

Technical Note:

The bellows referred to in Item 4-3.B.2.c. have all of the following characteristics:

- 1. Inside diameter between 75 and 400 mm;
- 2. Length equal to or greater than 12.7 mm;
- 3. Single convolution depth greater than 2 mm; and
- Made of high-strength aluminum alloys, maraging steel, or high strength "fibrous or filamentary materials".
- 3. Centrifugal multiplane balancing machines, fixed or portable, horizontal or vertical, as follows:
 - a. Centrifugal balancing machines designed for balancing flexible rotors having a length of 600 mm or more and having all of the following characteristics:
 - 1. Swing or journal diameter greater than 75 mm;
 - 2. Mass capability of from 0.9 to 23 kg; and
 - Capable of balancing speed of revolution greater than 5000 rpm;
 - b. Centrifugal balancing machines designed for balancing hollow cylindrical rotor components and having all of the following characteristics:
 - 1. Journal diameter greater than 75 mm;
 - 2. Mass capability of from 0.9 to 23 kg;
 - 3. Capable of balancing to a residual imbalance equal to or less than 0.010 kg x mm/kg per plane; **and**
 - 4. Belt drive type.
- Filament winding machines and related equipment, as follows:
 - Filament winding machines having all of the following characteristics:
 - Having motions for positioning, wrapping, and winding fibers coordinated and programmed in two or more axes;
 - Specially designed to fabricate composite structures or laminates from "fibrous or filamentary materials"; and
 - 3. Capable of winding cylindrical rotors of diameter between 75 and 400 mm and lengths of 600 mm or greater;
 - b. Coordinating and programming controls for the filament winding machines specified in Item 4-3.B.4.a.;
 - c. Precision mandrels for the filament winding machines specified in Item 4-3.B.4.a.
- Electromagnetic isotope separators designed for, or equipped with, single or multiple ion sources capable of providing a total ion beam current of 50 mA or greater.

Notes:

 Item 4-3.B.5. includes separators capable of enriching stable isotopes as well as those for uranium.

N.B:

A separator capable of separating the isotopes of lead with a one-mass unit difference is inherently capable of enriching the isotopes of uranium with a three-unit mass difference.

Item 4-3.B.5. includes separators with the ion sources and collectors both in the magnetic field and those configurations in which they are external to the field.

Technical Note:

A single 50 mA ion source cannot produce more than 3 g of separated highly enriched uranium (HEU) per year from natural abundance feed.

 Mass spectrometers capable of measuring ions of 230 atomic mass units or greater and having a resolution of better than 2 parts in 230, as follows, and ion sources therefor: N.B.:

Mass spectrometers especially designed or prepared for analyzing on-line samples of uranium hexafluoride are controlled under Group 3.

- a. Inductively coupled plasma mass spectrometers (ICP/MS);
- b. Glow discharge mass spectrometers (GDMS);
- c. Thermal ionization mass spectrometers (TIMS);
- d. Electron bombardment mass spectrometers which have a source chamber constructed from, lined with or plated with materials resistant to UF₆;
- e. Molecular beam mass spectrometers having either of the following characteristics:
 - A source chamber constructed from, lined with or plated with stainless steel or molybdenum, and equipped with a cold trap capable of cooling to 193 K (-80°C) or less; or
 - 2. A source chamber constructed from, lined with or plated with materials resistant to UF₆;
- Mass spectrometers equipped with a microfluorination ion source designed for actinides or actinide fluorides.

4-3.C. Materials

None.

4-3.D. Software

1. "Software" specially designed for the "use" of equipment specified in Item 4-3.B.3. or 4-3.B.4.

4-3.E. Technology

4-4.A. Equipment, Assemblies and Components

- Specialized packings which may be used in separating heavy water from ordinary water, having both of the following characteristics:
 - Made of phosphor bronze mesh chemically treated to improve wettability; and
 - b. Designed to be used in vacuum distillation towers.
- Pumps capable of circulating solutions of concentrated or dilute potassium amide catalyst in liquid ammonia (KNH₂/NH₃), having all of the following characteristics:
 - a. Airtight (i.e., hermetically sealed);
 - b. A capacity greater than 8.5 m³/h; and
 - c. Either of the following characteristics:
 - 1. For concentrated potassium amide solutions (1% or greater), an operating pressure of 1.5 to 60 MPa; **or**
 - 2. For dilute potassium amide solutions (less than 1%), an operating pressure of 20 to 60 MPa.

- Turboexpanders or turboexpander-compressor sets having both of the following characteristics:
 - a. Designed for operation with an outlet temperature of 35 K (-238°C) or less; and
 - Designed for a throughput of hydrogen gas of 1000 kg/h or greater.

N.B.:

For columns which are especially designed or prepared for the production of heavy water, see Group 3.

- Water-hydrogen sulfide exchange tray columns, having all of the following characteristics:
 - 1. Can operate at pressures of 2 MPa or greater;
 - Constructed of carbon steel having an austenitic ASTM (or equivalent standard) grain size number of 5 or greater; and
 - 3. With a diameter of 1.8 m or greater;
- Internal contactors for the water-hydrogen sulfide exchange tray columns specified in Item 4-4.B.1.a.

Technical Note:

Internal contactors of the columns are segmented trays which have an effective assembled diameter of 1.8 m or greater; are designed to facilitate countercurrent contacting and are constructed of stainless steels with a carbon content of 0.03% or less. These may be sieve trays, valve trays, bubble cap trays or turbogrid trays.

- Hydrogen-cryogenic distillation columns having all of the following characteristics:
 - a. Designed for operation at internal temperatures of 35 K (-238°C) or less;
 - b. Designed for operation at internal pressures of 0.5 to 5 MPa;
 - c. Constructed of either:
 - Stainless steel of the 300 series with low sulfur content and with an austenitic ASTM (or equivalent standard) grain size number of 5 or greater; or
 - Equivalent materials which are both cryogenic and H₂-compatible; and
 - d. With internal diameters of 1 m or greater and effective lengths of 5 m or greater.
- Ammonia synthesis converters or synthesis units, in which the synthesis gas (nitrogen and hydrogen) is withdrawn from an ammonia/hydrogen high-pressure exchange column and the synthesized ammonia is returned to said column.

- Flash X-ray generators or pulsed electron accelerators having either of the following sets of characteristics:
 - a. 1. An accelerator peak electron energy of 500 keV or greater but less than 25 MeV; and
 - 2. With a figure of merit (K) of 0.25 or greater; or
 - b. 1. An accelerator peak electron energy of 25 MeV or greater, and
 - 2. A peak power greater than 50 MW.

Note:

Item 4-5.B.1. does not control accelerators that are component parts of devices designed for purposes other than electron beam or X-ray radiation (electron microscopy, for example) nor those designed for medical purposes. **Technical Notes:**

- 1. The figure of merit K is defined as: $K=1.7 \times 10^3 \ V^{2.65}Q$. V is the peak electron energy in million electron volts. If the accelerator beam pulse duration is less than or equal to 1 μ s, then Q is the total accelerated charge in Coulombs. If the accelerator beam pulse duration is greater than 1 μ s then Q is the maximum accelerated charge in 1 μ s. Q equals the integral of i with respect to t, over the lesser of 1 μ s or the time duration of the beam pulse (Q=idt) where i is beam current in amperes and t is the time in seconds.
- Peak power = (peak potential in volts) x (peak beam current in amperes).
- In machines based on microwave accelerating cavities, the time duration of the beam pulse is the lesser of 1 µs or the duration of the bunched beam packet resulting from one microwave modulator pulse.
- In machines based on microwave accelerating cavities, the peak beam current is the average current in the time duration of a bunched beam packet.
- Multistage light gas guns or other high-velocity gun systems (coil, electromagnetic, and electrothermal types, and other advanced systems) capable of accelerating projectiles to 2 km/s or greater.
- Mechanical rotating mirror cameras, as follows, and specially designed components therefor:
 - a. Framing cameras with recording rates greater than 225,000 frames per second;
 - b. Streak cameras with writing speeds greater than 0.5 mm/ μ s. Note:

In Item 4-5.B.3. components of such cameras include their synchronizing electronics units and rotor assemblies consisting of turbines, mirrors, and bearings.

- 4. Electronic streak cameras, electronic framing cameras, tubes and devices, as follows:
 - a. Electronic streak cameras capable of 50 ns or less time resolution;
 - b. Streak tubes for cameras specified in Item 4-5.B.4.a.;
 - c. Electronic or electronically shuttered) framing cameras capable of 50 ns or less frame exposure time;
 - d. Framing tubes and solid-state imaging devices for use with cameras specified in Item 4-5.B.4.c., as follows:
 - Proximity focused image intensifier tubes having the photocathode deposited on a transparent conductive coating to decrease photocathode sheet resistance;
 - 2. Gate silicon intensifier target (SIT) vidicon tubes, where a fast system allows gating the photoelectrons from the photocathode before they impinge on the SIT plate;
 - 3. Keff or Pockels cell electro-optical shuttering;
 - Other framing tubes and solid-state imaging devices having a fast image gating time of less than 50 ns specially designed for cameras specified in Item 4-5.B.4.c.
- Specialized instrumentation for hydrodynamic experiments, as follows:
 - a. Velocity interferometers for measuring velocities exceeding 1 km/s during time intervals of less than 10 μs ;

Item 4-5.B.5.a. includes velocity interferometers such as VISARs (Velocity interferometer systems for any reflector) and DLIs (Doppler laser interferometers).

- b. Manganin gauges for pressures greater than 10 GPa;
- c. Quartz pressure transducers for pressures greater than 10 GPa.
- 6. High-speed pulse generators having both of the following characteristics:
 - a. Output voltage greater than 6 V into a resistive load of less than 55 ohms; and
 - b. 'Pulse transition time' less than 500 ps.

Technical Note:

In Item 4-5.B.6.b. 'pulse transition time' is defined as the time interval between 10% and 90% voltage amplitude.

 - b. Arrangements using single or multiple detonators designed to nearly simultaneously initiate an explosive surface over an area greater than 5000 mm² from a single firing signal with an initiation timing spread over the surface of less than 2.5 µs.

Note:

Item 4-6.A.1. does not control detonators using only primary explosives, such as lead azide.

Technical Note:

In Item 4-6.A.1. the detonators of concern all utilize a small electrical conductor (bridge, bridge wire, or foil) that explosively vaporizes when a fast, high-current electrical pulse is passed through it. In nonslapper types, the exploding conductor starts a chemical detonation in a contacting high-explosive material such as PETN (pentaerythritoltetranitrate). In slapper detonators, the explosive vaporization of the electrical conductor drives a flyer or slapper across a gap, and the impact of the slapper on an explosive starts a chemical detonation. The slapper in some designs is driven by magnetic force. The term exploding foil detonator may refer to either an EB or a slapper-type detonator. Also, the word initiator is sometimes used in place of the word detonator.

- Firing sets and equivalent high-current pulse generators, as follows:
 - Explosive detonator firing sets designed to drive multiple controlled detonators specified by Item 4-6.A.1. above;
 - b. Modular electrical pulse generators (pulsers) having all of the following characteristics:
 - 1. Designed for portable, mobile, or ruggedized-use;
 - 2. Enclosed in a dust-tight enclosure;
 - 3. Capable of delivering their energy in less than 15 µs;
 - 4. Having an output greater than 100 A;
 - 5. Having a 'rise time' of less than 10 μ s into loads of less than 40 ohms;
 - 6. No dimension greater than 25.4 cm;
 - 7. Weight less than 25 kg; and
 - 8. Specified to operate over an extended temperature range of 223 to 373 K (-50 $^{\circ}$ C to 100 $^{\circ}$ C) or specified as suitable for aerospace applications.

Note:

Item 4-6.A.2.b. includes xenon flashlamp drivers.

Technical Note:

In Item 4-6.A.2.b.5. 'rise time' is defined as the time interval from 10% to 90% current amplitude when driving a resistive load.

- 3. Switching devices as follows:
 - a. Cold-cathode tubes, whether gas filled or not, operating similarly to a spark gap, having all of the following characteristics:
 - 1. Containing three or more electrodes;
 - 2. Anode peak voltage rating of 2.5 kV or more;
 - 3. Anode peak current rating of 100 A or more; and
 - 4. Anode delay time of 10 μs or less;

Note

Item 4-6.A.3.a. includes gas krytron tubes and vacuum sprytron tubes.

- b. Triggered spark-gaps having both of the following characteristics:
 - 1. Anode delay time of 15 µs or less; and
 - 2. Rated for a peak current of 500 A or more;
- c. Modules or assemblies with a fast switching function having all of the following characteristics:
 - 1. Anode peak voltage rating greater than 2 kV;
 - 2. Anode peak current rating of 500 A or more; and
 - 3. Turn-on time of 1 µs or less.
- Pulse discharge capacitors having either of the following sets of characteristics:
 - a. 1. Voltage rating greater than 1.4 kV;
 - 2. Energy storage greater than 10 J;
 - 3. Capacitance greater than 0.5 µF; and
 - 4. Series inductance less than 50 nH; or
 - b. 1. Voltage rating greater than 750 V;
 - 2. Capacitance greater than 0.25 μF ; and
 - 3. Series inductance less than 10 nH.
- 5. Neutron generator systems, including tubes, having both of the following characteristics:
 - a. Designed for operation without an external vacuum system;
 and
 - Utilizing electrostatic acceleration to induce a tritiumdeuterium nuclear reaction.

4-6.B. Test and Production Equipment

None.

4-6.C. Materials

- 1. High explosive substances or mixtures, containing more than 2 % by weight of any of the following:
 - a. Cyclotetramethylenetetranitramine (HMX) (CAS 2691-41-0);
 - b. Cyclotrimethylenetrinitramine (RDX) (CAS 121-82-4);
 - c. Triaminotrinitrobenzene (TATB) (CAS 3058-38-6);
 - d. Hexanitrostilbene (HNS) (CAS 20062-22-0); or

Definitions of Terms used in Groups 3 and 4

"Accuracy"

Usually measured in terms of inaccuracy, defined as the maximum deviation, positive or negative, of an indicated value from an accepted standard or true value.

"Active tooling unit"

Device for applying motive power, procress energy or sensing to the workpiece.

"Angular position deviation"

The maximum difference between angular position and the actual, very accurately measured angular position after the workpiece mount of the table has been turned out of its initial position. (Ref.: VID/VDE 2617, Draft: 'Rotary table on coordinate measuring machines').

"Basic scientific research"

Experimental or theoretical work undertaken principally to acquire new knowledge of the fundamental principles of phenomena and observable facts, not primarily directed toward a specific practical aim or objective.

"Contouring control"

Two or more "numerically controlled" motions operating in accordance with instructions that specify the next required position and the required feed rates to that position. These feed rates are varied in relation to each other so that a desired contour is generated (Ref.: ISO/DIS 2806-1980 as amended).

"Development"

Is related to all phases prior to "production", such as: design, design research, design analysis, design concepts, assembly and testing of prototypes, pilot production schemes, design data, process of transforming design data into a product, configuration design, integration design, layouts.

"End-effectors"

Are grippers, "active tooling units", and any other tooling that is attached to the baseplate on the end of a "robot" manipulator arm.

"Fibrous or filamentary materials"

Means continuous 'filament', 'monofilaments', 'yarns', 'rovings', 'tows', or 'tapes'.

NB.

'Filament' or 'monofilament' is the smallest increment of fibre, usually several μm in diameter.

'Roving' is a bundle (typically 12-120) of approximately parallel 'strands'. 'Strand' is a bundle of 'filaments' (typically over 200) arranged approximately parallel.

Tape' is a material constructed of interlaced or unidirectional 'filaments', 'strands', 'rovings', 'tows', or 'yarns', etc., usually preimpregnated with resin. 'Tow' is a bundle of 'filaments', usually approximately parallel.

'Yarn' is a bundle of twisted 'strands'.

"In the public domain"

"In the public domain", as it applies herein, means "technology" or "software" that has been made available without restrictions upon its further dissemination (Copyright restrictions do not remove "technology" or "software" from being "in the public domain").

"Linearity"

(Usually measured in terms of nonlinearity) is the maximum deviation of the actual characteristic (average of upscale and downscale readings), positive or negative, from a straight line so positioned as to equalize and minimize the maximum deviations.

"Measurement uncertainty"

The characteristic parameter which specifies in what range around the output value, the correct value of the measurable variable lies, with a confidence level of 95%. It includes the uncorrected systematic deviations, the uncorrected backlash, and the random deviations (Ref.: VDI/VDE 2617).

"Microprogram"

A sequence of elementary instructions, maintained in a special storage, the execution of which is initiated by the introduction of its reference instruction into an instruction register.

"Numerical control"

The automatic control of a process performed by a device that makes use of numeric data usually introduced as the operation is in progress (Ref.: ISO 2382).

"Positioning accuracy"

Of "numerically controlled" machine tools is to be determined and presented in accordance with Item 4-1.B.2., in conjunction with the requirements below:

a. Test conditions (ISO 230/2 (1988), paragraph 3):

- For 12 hours before and during measurements, the machine tool and accuracy measuring equipment will be kept at the same ambient temperature. During the premeasurement time, the slides of the machine will be continuously cycled identically to the way they will be cycled during the accuracy measurements;
- 2. The machine shall be equipped with any mechanical, electronic, or "software" compensation to be exported with the machine;
- Accuracy of measuring equipment for the measurements shall be at least four times more accurate than the expected machine tool accuracy;
- 4. Power supply for slide drives shall be as follows:
 - a. Line voltage variation shall not be greater than $\pm 10\%$ of nominal rated voltage;
 - Frequency variation shall not be greater than ±2 Hz of normal frequency;
 - c. Lineouts or interrupted service are not permitted.

b. Test Program (paragraph 4):

1. Feed rate (velocity of slides) during measurement shall be the rapid traverse rate;

N.B.:

In the case of machine tools which generate optical quality surfaces, the feed rate shall be equal to or less than 50 mm per minute;

- Measurements shall be made in an incremental manner from one limit of the axis travel to the other without returning to the starting position for each move to the target position;
- Axes not being measured shall be retained at mid-travel during test of an axis.
- c. Presentation of test results (paragraph 2): The results of the measurements must include:
 - 1. "positioning accuracy" (A) and
 - 2. The mean reversal error (B).

"Production"

Means all production phases, such as: construction, production engineering, manufacture, integration, assembly (mounting), inspection, testing, quality assurance.

"Program"

A sequence of instructions to carry out a process in, or convertible into, a form executable by an electronic computer.

"Resolution"

The least increment of a measuring device; on digital instruments, the least significant bit. (Ref.: ANSI B-89.1.12)

"Robot"

A manipulation mechanism, which may be of the continuous path or of the point-to-point variety, may use "sensors" and has all the following characteristics:

- a. Is multifunctional;
- Is capable of positioning or orienting material, parts, tools or special devices through variable movements in threedimensional space;
- c. Incorporates three or more closed or open loop servo-devices which may include stepping motors; and
- d. Has "user-accessible programmability" by means of teach/playback method or by means of an electronic computer which may be a programmable logic controlled; (i.e. without mechanical intervention).

N.B.:

The above definition does not include the following devices:

- Manipulation mechanisms which are only manually/teleoperator controllable:
- b. Fixed sequence manipulation mechanisms which are automated moving devices operating according to mechanically fixed programmed motions. The "program" is mechanically limited by fixed stops, such as pins or cams. The sequence of motions and the selection of paths or angles are not variable or changeable by mechanical, electronic or electrical means:
- c. Mechanically controlled variable sequence manipulation mechanisms which are automated moving devices, operating according to mechanically fixed programmed motions. The "program" is mechanically limited by fixed, but adjustable, stops such as pins or cams. The sequence of motions and the selection of paths or angles are variable within the fixed "program" patterns. Variations or modifications of the "program" pattern (e.g. changes of pins or exchanges of cams) in one or more motion axes are accomplished only through mechanical operations:
- d. Non-servo-controlled variable sequence manipulation mechanisms which are automated moving devices, operating according to mechanically fixed programmed motions. The "program" is variable, but the sequence proceeds only by the binary signal from mechanically fixed electrical binary devices or adjustable stops;
- e. Stacker cranes defined as Cartesian coordinate manipulator systems manufactured as an integral part of a vertical array of storage bins and designed to access the contents of those bins for storage or retrieval.

"Roving"

See "Fibrous and filamentary materials".

"Sensors

Detectors of a physical phenomenon, the output of which (after conversion into a signal that can be interpreted by a controller) is able to generate "programs" or modify programmed instructions or numerical "program" data. This includes "sensors" with machine vision, infrared imaging, acoustical imaging, tactile feel, inertial position measuring, optical or acoustic ranging or force or torque measuring capabilities.

"Software"

A collection of one or more "programs" or "microprograms" fixed in any tangible medium of expression.

"Tape"

See "Fibrous or filamentary materials".

"Technical assistance"

May take forms, such as: instruction, skills, training, working knowledge, consulting services.

N.B.:

"Technical assistance" may involve transfer of "technical data".

"Technical data"

May take forms such as blueprints, plans, drawings, photoprints or negatives, diagrams, models, formulae, tables, engineering designs and specifications, manuals and instructions, whether in written form or recorded on other media or devices such as disk, tape, read-only memories.

"Technology"

Specific information required for the "development", "production" or "use", of an item. This information may take the form of "technical data" or "technical assistance".

"Tow"

See "Fibrous and filamentary materials".

"I Ise

Operation, installation (including on-site installation), maintenance (checking), repair, overhaul and refurbishing.

"User-accessible programmability"

The facility allowing a user to insert, modify of replace "programs" by means other than:

- a. A physical change in wiring or interconnections; or
- b. The setting of function controls including entry of parameters.

"Yarn'

See "Fibrous and filamentary materials".

Group 5 - Miscellaneous Goods

Medical Products

5001. Pancreas glands of cattle and calves. (All destinations)

5011. Human serum albumin. (All destinations)

Forest Products

5101. Logs of all species of wood. (All destinations)

5102. Pulpwood of all species of wood. (All destinations)

5103. Blocks, bolts, blanks, boards and any other material or product of red cedar that is suitable for use in the manufacture of shakes or shingles. (All destinations)

5104. Softwood Lumber Products

- 1. Softwood lumber products set out in Annex 1A to the softwood lumber agreement, excluding item 5(e).
- 2. 5201. Peanut Butter that is classified under tariff item No. 2008.11.10 of Schedule I to the Customs Tariff. (All destinations)

5202. Roe Herring

Roe herring from which the roe has not been extracted and that were caught in those parts of the following areas adjacent to the coast of British Columbia:

a. the territorial sea of Canada as determined under section 4 of the *Oceans Act*

- b. the internal waters of Canada as determined under section 6 of that Act: or
- c. the fishing zones of Canada as determined under section 16 of that Act and prescribed by regulations made under paragraph 25(b) of that Act

(All destinations)

5203. Sugar-containing Products

Sugar-containing products that are classified under subheadings 1701.91.54, 1704.90.74, 1806.20.75, 1806.20.95, 1806.90.55, 1901.90.56, 2101.10.54, 2101.20.54, 2106.90.78 and 2106.90.95 of *Harmonised Tariff Schedule of the United States (1995)* (United States International Trade Commission Pub. 2831, 19 U.S.C. § 1202 (1988)). (*United States*)

5204. Sugars, Syrups and Molasses

Sugars, Syrups and Molasses that are classified under subheadings 1701.12.10, 1701.91.10, 1701.99.10, 1702.90.10, and 2106.90.44 of *Harmonised Tariff Schedule of the United States (1995)* (United States International Trade Commission Pub. 2831, 19 U.S.C. § 1202 (1988)). (United States)

United States Origin Goods

5400. United States Origin Goods

All goods that originate in the United States, unless they are included elsewhere in this List, whether in bond or cleared by Canada Border Services Agency, other than goods that have been further processed or manufactured outside the United States so as to result in a substantial change in value, form or use of the goods or in the production of new goods.

(All destinations other than the United States)

Goods in Transit

5401. Goods in Transit

- All goods that originate outside Canada that are included in this List, whether in bond or cleared by Canada Border Services Agency, other than goods that are in transit in bond on a through journey on a billing that originates outside Canada where the billing
 - a. indicates that the ultimate destination of the goods is a country other than Canada; (All destinations other than the United States) and
 - b. in the case of goods that are shipped from the United States, is accompanied by a certified true copy of the United States Shipper's Export Declaration that does not contain terms which conflict with those of the billing and is presented to Canada Border Services Agency.

(All destinations other than the United States)

Other Military and Strategic Goods

5501. Blinding Laser Weapons.

Laser weapons that are specifically designed, as their sole combat function or as one of their combat functions, to cause permanent blindness to the naked eye or to the eye with corrective eyesight devices. (All destinations).

5502. Nuclear Fusion Reactors.

- Subject to subitem 2., systems, equipment, material, components, software and technology for use in research, development, design, testing, demonstration, or training related to nuclear fusion or the construction and operation of a nuclear fusion reactor, including:
 - reactor assemblies incorporating toroidal and poloidal field coils;
 - b. independent electrical and magnet power supply systems;
 - c. high-power microwave radio frequency systems; and
 - d. feedback, control and data acquisition systems.

(All destinations)

- 2. This item does not apply to data:
 - a. that is contained in published books or periodicals or that is otherwise available to the public; or
 - that has been made available without restrictions on its further dissemination.

5503. Anti-personnel Mines.

Anti-personnel mines as defined in section 2 of the *Anti-Personnel Mines Convention Implementation Act*. (All destinations)

5504. Strategic Goods

- 1. In this item the terms "development", "production", "software", "spacecraft", "technology" and "use" have the same meaning as in the "Definitions for Terms in Groups 1 and 2" of the Guide.
- 2. Strategic goods as follows:
 - a. goods controlled by Group 1 of the Guide as follows:
 - Global navigation satellite systems receiving equipment controlled by item 1-7.A.5. of the Guide, the associated software controlled by item 1-7.D. of the Guide, and the associated technology controlled by item 1-7.E. of the Guide and
 - ii. propulsion and space-related equipment controlled by items 1-9.A.4. to 1-9.A.11. of the Guide, the associated software controlled by item 1-9.D. of the Guide, and the associated technology controlled by item 1-9.E. of the Guide;

- subject to the General Software note in Group 1 of the Guide, software that is specially designed or modified for the development or use of the goods controlled by paragraphs d. to i.:
- subject to the General Technology note in Group 1 of the Guide, technology that is specially designed or modified for the development or production of the goods controlled by paragraphs d. to i.;
- d. payloads specially designed or modified for "spacecraft", and specially designed components therefor not controlled elsewhere by Group 1 of the Guide;
- e. ground control stations for telemetry, tracking and control of space launch vehicles or "spacecraft", and specially designed components therefor;
- f. chemiluminescent compounds specially designed or modified for military use, and specially designed components therefor;
- g. radiation-hardened microelectronic circuits that meet or exceed all of the following, and specially designed components therefor, namely:
 - i. a total dose of 5 x 10⁵ Rads (SI);
 - ii. a dose rate upset of 5 x 108 Rads (SI)/s;
 - iii. a neutron dose of 1 x 10¹⁴ N/cm²;
 - iv. a single event upset of 1 x 10⁻⁷ or less error/bit/day; and
 - v. single event latch-up free and having a dose rate latch-up of 5 x 10⁸ Rads (SI)/s or greater;

(All destinations other than United States)

- h. nuclear weapons design and test equipment, as follows:
 - any article, material, equipment or device which is specially designed or modified for use in the design, development or fabrication of nuclear weapons or nuclear explosive devices;

(All destinations)

ii. any article, material, equipment or device which is specially designed or modified for use in the devising, carrying out or evaluating of nuclear weapons tests or other nuclear explosions;

(All destinations)

and

any other articles not specifically set out in paragraphs a. to h.
or in Group 2 or Group 6 that are United States origin goods,
which have been determined under Parts 120 to 130 of Title
22 of the International Traffic in Arms Regulations of the
Code of Federal Regulations (United States) as having
substantial military applicability, and which have been
specially designed or modified for military purposes.

(All destinations other than United States)

5505. Goods for Certain Uses (Catch-all)

All goods not listed elsewhere in this List

- a. that are intended for use in
 - the development, production, handling, operation, maintenance, storage, detection, identification or dissemination of chemical, biological or nuclear weapons, or of materials or equipment that could be used in such weapons,

- ii. the development, production, handling, operation, maintenance or storage of missiles capable of delivering chemical, biological or nuclear weapons, or of materials or equipment that could be used in such missiles, **or**
- iii. any chemical, biological or nuclear weapons facility or missile facility; ${f or}$
- b. in respect of which there are reasonable grounds to suspect that the goods are intended for use in
 - the development, production, handling, operation, maintenance, storage, detection, identification or dissemination of chemical, biological or nuclear weapons, or of materials or equipment that could be used in such weapons,
 - ii. the development, production, handling, operation, maintenance or storage of missiles capable of delivering chemical, biological or nuclear weapons, or of materials or equipment that could be used in such missiles, or
 - any chemical, biological or nuclear weapons facility or missile facility.

(All destinations other than Argentina, Australia, Austria, Belgium, Brazil, Bulgaria, the Czech Republic, Denmark, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Japan, Luxembourg, the Netherlands, New Zealand, Norway, Poland, Portugal, the Republic of Korea, Romania, the Russian Federation, the Slovak Republic, South Africa, Spain, Sweden, Switzerland, Ukraine, the United Kingdom, and the United States; provided that the final destination of the goods is one of these countries).

Group 6 - Missile Technology Control Regime List

Note

Terms in "double quotation marks" are defined terms. Refer to Definitions at the end of Group 6.

General Technology Note:

The transfer of "technology" directly associated with any goods controlled in Group 6 is controlled according to the provisions in each Item to the extent permitted by national legislation. The approval of any Group 6 item for export also authorizes the export to the same end-user of the minimum "technology" required for the installation, operation, maintenance, and repair of the item.

Note:

Controls do not apply to "technology" "in the public domain" or to "basic scientific research".

General Software Note:

Group 6 does not control "software" which is either:

- 1. Generally available to the public by being :
 - a. Sold from stock at retail selling points without restriction, by means of:
 - 1. Over-the-counter transactions;
 - 2. Mail order transactions; or
 - 3. Telephone call transactions; and
 - Designed for installation by the user without further substantial support by the supplier; or
- 2. "In the public domain".

Note

The General Software Note only applies to general purpose, mass market "software".

Chemical Abstracts Service (CAS) Numbers:

In some instances chemicals are listed by name and CAS number. Chemicals of the same structural formula (including hydrates) are controlled regardless of name or CAS number. CAS numbers are shown to assist in identifying whether a particular chemical or mixture is controlled, irrespective of nomenclature. CAS numbers cannot be used as unique identifiers because some forms of the listed chemical have different CAS numbers, and mixtures containing a listed chemical may also have different CAS numbers.

 - b. Re-entry vehicles, and equipment designed or modified therefor, usable in the systems specified in 6-1.A., as follows, except as provided in the Note below 6-2.A.1. for those designed for non-weapon payloads:
 - Heat shields, and components thereof, fabricated of ceramic or ablative materials;
 - Heat sinks and components thereof fabricated of lightweight, high heat capacity materials;
 - Electronic equipment specially designed for re-entry vehicles;
 - Solid propellant rocket motors or liquid propellant rocket engines, usable in the systems specified in 6-1.A., having a total impulse capacity equal to or greater than 1.1 x 10⁶ Ns; Note:

Liquid propellant apogee engines specified in 6-2.A.1.c., designed or modified for satellite applications, may be treated as Category II, if the subsystem is exported subject to end-use statements and quantity limits appropriate for the excepted end-use stated above, when having all of the following parameters:

- a. Nozzle throat diameter of 20 mm or less: and
- o. Combustion chamber pressure equal to or less than 15 bar.
- d. 'Guidance sets', usable in the systems specified in 6-1.A., capable of achieving system accuracy of 3.33% or less of the "range" (e.g., a 'CEP' of 10 km or less at a "range" of 300 km), except as provided in the Note below 6-2.A.1. for those designed for missiles with a "range" under 300 km or manned aircraft;

Technical Notes:

- 1. A 'guidance set' integrates the process of measuring and computing a vehicle's position and velocity (i.e. navigation) with that of computing and sending commands to the vehicle's flight control systems to correct the trajectory.
- 2. 'CEP' (circle of equal probability) is a measure of accuracy, defined as the radius of the circle centred at the target, at a specific range, in which 50% of the payloads impact.
- e. Thrust vector control sub-systems, usable in the systems specified in 6-1.A., except as provided in the Note below 6-2.A.1. for those designed for rocket systems that do not exceed the "range"/"payload" capability of systems specified in 6-1.A.;

Technical Note:

6-2.A.1.e. includes the following methods of achieving thrust vector control:

- a. Flexible nozzle;
- b. Fluid or secondary gas injection;
- Movable engine or nozzle;
- Deflection of exhaust gas stream (jet vanes or probes);
- Use of thrust tabs.
- f. Weapon or warhead safing, arming, fuzing, and firing mechanisms, usable in the systems specified in 6-1.A., except as provided in the Note below 6-2.A.1. for those designed for systems other than those specified in 6-1.A.

Note:

The exceptions in 6-2.A.1.b., 6-2.A.1.d., 6-2.A.1.e. and 6-2.A.1.f. above may be treated as Category II if the subsystem is exported subject to end-use statements and quantity limits appropriate for the excepted end-use stated above.

6-2.B. Test and Production Equipment

- 1. "Production facilities" specially designed for the subsystems specified in 6-2.A.
- 2. "Production equipment" specially designed for the subsystems specified in 6-2.A.

6-2.C. Materials

None.

6-2.D. Software

- 1. "Software" specially designed or modified for the "use" of "production facilities" specified in 6-2.B.1.
- 2. "Software" specially designed or modified for the "use" of rocket motors or engines specified in 6-2.A.1.c.
- "Software" specially designed or modified for the "use" of 'guidance sets' specified in 6-2.A.1.d.

6-2.D.3. includes "software", specially designed or modified to enhance the performance of 'guidance sets' to achieve or exceed the accuracy specified in 6-2.A.1.d.

- 4. "Software" specially designed or modified for the "use" of subsystems or equipment specified in 6-2.A.1.b.3.
- "Software" specially designed or modified for the "use" of systems in 6-2.A.1.e.
- 6. "Software" specially designed or modified for the "use" of systems in 6-2.A.1.f.

Subject to end-use statements appropriate for the excepted end-use, "software" controlled by 6-2.D.2. to 6-2.D.6. may be treated as Category II as follows:

- Under 6-2.D.2. if specially designed or modified for liquid propellant apogee engines, designed or modified for satellite applications as specified in the Note to 6-2.A.1.c.:
- Under 6-2.D.3. if designed for missiles with a "range" of under 300 km or manned aircraft:
- Under 6-2.D.4. if specially designed or modified for re-entry vehicles designed for non-weapon payloads;
- Under 6-2.D.5. if designed for rocket systems that do not exceed the "range" "payload" capability of systems specified in 6-1.A.;
- Under 6-2.D.6. if designed for systems other than those specified in 6-1.A.

6-2.E. Technology

1. "Technology", in accordance with the General Technology Note, for the "development", "production" or "use" of equipment or "software" specified in 6-2.A., 6-2.B. or 6-2.D.

CATEGORY II

6-3. Propulsion Components **Equipment**

6-3.A. Equipment, Assemblies and Components

- 1. Lightweight turbojet and turbofan engines (including turbocompound engines), that are small and fuel efficient, as
 - a. Engines having both of the following characteristics:
 - 1. Maximum thrust value greater than 400 N (achieved un-installed) excluding civil certified engines with a maximum thrust value greater than 8.89 kN (achieved un-installed); and
 - 2. Specific fuel consumption of 0.15 kg N⁻¹ h⁻¹ or less (at maximum continuous power at sea level static and standard conditions);
 - b. Engines designed or modified for systems specified in 6-1.A., regardless of thrust or specific fuel consumption.

Note:

Governments may permit the export of engines specified in 6-3.A.1. as part of a manned aircraft or in quantities appropriate for replacement parts for a manned aircraft.

- 2. Ramjet/scramjet/pulsejet/combined cycle engines, including devices to regulate combustion, and specially designed components therefor, usable in the systems specified in 6-1.A.
- 3. Rocket motor cases, 'insulation' components and nozzles therefor, usable in the systems specified in 6-1.A.

Technical Note:

In 6-3.A.3. 'insulation' intended to be applied to the components of a rocket motor, i.e. the case, nozzle inlets, case closures, includes cured or semi-cured compounded rubber components comprising sheet stock containing an insulating or refractory material. It may also be incorporated as stress relief boots or flaps.

Refer to 6-3.C.2. for 'insulation' material in bulk or sheet form.

- 4. Staging mechanisms, separation mechanisms, and interstages therefor, usable in the systems specified in 6-1.A.
- Liquid and slurry propellant (including oxidisers) control systems, and specially designed components therefor, usable in the systems specified in 6-1.A., designed or modified to operate in vibration environments greater than 10 g rms between 20 Hz and 2 kHz.

Notes:

- 1. The only servo valves and pumps specified in 6-3.A.5. are the following:
 - Servo valves designed for flow rates equal to or greater than 24 litres per minute, at an absolute pressure equal to or greater than 7 MPa, that have an actuator response time of less than 100 ms;
 - b. Pumps, for liquid propellants, with shaft speeds equal to or greater than 8,000 rpm or with discharge pressures equal to or greater than 7 MPa.
- Governments may permit the export of systems and components specified in 6-3.A.5. as part of a satellite.
- 6. Hybrid rocket motors and specially designed components therefor, usable in the systems specified in 6-1.A., 6-19.A.1. or 6-19.A.2.
- Radial ball bearings having all tolerances specified in accordance with ISO 492 Tolerance Class 2 (or ANSI/ABMA Std 20 Tolerance Class ABEC-9 or other national equivalents), or better and having all the following characteristics:
 - a. An inner ring bore diameter between 12 and 50 mm;
 - b. An outer ring outside diameter between 25 and 100 mm; and
 - c. A width between 10 and 20 mm.
- 8. Liquid propellant tanks specially designed for the propellants controlled in Item 6-4.C. or other liquid propellants used in the systems specified in 6-1.A.1.

6-3.B. Test and Production Equipment

- 1. "Production facilities" specially designed for equipment or materials specified in 6-3.A.1., 6-3.A.2., 6-3.A.3., 6-3.A.4., 6-3.A.5., 6-3.A.6. or 6-3.C.
- 2. "Production equipment" specially designed for equipment or materials specified in 6-3.A.1., 6-3.A.2., 6-3.A.3., 6-3.A.4., 6-3.A.5., 6-3.A.6. or 6-3.C.
- 3. Flow-forming machines, and specially designed components therefor, which:
 - According to the manufacturers technical specification can be equipped with numerical control units or a computer control, even when not equipped with such units at delivery; and
 - b. Have more than two axes which can be co-ordinated simultaneously for contouring control.

Technical Note:

Machines combining the function of spin-forming and flow-forming are, for the purpose of this item, regarded as flow-forming machines.

This item does not include machines that are not usable in the "production" of propulsion components and equipment (e.g. motor cases) for systems specified in 6-1.A.

6-3.C. Materials

 'Interior lining' usable for rocket motor cases in the systems specified in 6-1.A. or specially designed for systems specified in 6-19.A.1. or 6-19.A.2.

Technical Note:

In 6-3.C.1. 'interior lining' suited for the bond interface between the solid propellant and the case or insulating liner is usually a liquid polymer based dispersion of refractory or insulating materials e.g. carbon filled HTPB or other polymer with added curing agents to be sprayed or screeded over a case interior.

 'Insulation' material in bulk form usable for rocket motor cases in the systems specified in 6-1.A. or specially designed for systems specified in 6-19.A.1. or 6-19.A.2.

Technical Note:

In 6-3.C.2. 'insulation' intended to be applied to the components of a rocket motor, i.e. the case, nozzle inlets, case closures, includes cured or semicured compounded rubber sheet stock containing an insulating or refractory material. It may also be incorporated as stress relief boots or flaps specified in 6-3.A.3.

6-3.D. Software

- "Software" specially designed or modified for the "use" of "production facilities" and flow forming machines specified in 6-3.B.1. or 6-3.B.3.
- 2. "Software" specially designed or modified for the "use" of equipment specified in 6-3.A.1., 6-3.A.2., 6-3.A.4., 6-3.A.5. or 6-3.A.6.

Notes:

- Governments may permit the export of "software" specially designed or modified for the "use" of engines specified in 6-3.A.1. as part of a manned aircraft or as replacement "software" therefor.
- Governments may permit the export of "software" specially designed or modified for the "use" of propellant control systems specified in 6-3.A.5. as part of a satellite or as replacement "software" therefor.
- 3. "Software" specially designed or modified for the "development" of equipment specified in 6-3.A.2., 6-3.A.3. or 6-3.A.4.

6-3.E. Technology

1. "Technology", in accordance with the General Technology Note, for the "development", "production" or "use" of equipment, materials or "software" specified in 6-3.A.1., 6-3.A.2., 6-3.A.3., 6-3.A.4., 6-3.A.5., 6-3.A.6., 6-3.B., 6-3.C. or 6-3.D.

6-4. Propellants, Chemicals and Propellant Production

6-4. A. Equipment, Assemblies and Components

None.

6-4.B. Test and Production Equipment

- 1. "Production equipment", and specially designed components therefor, for the "production", handling or acceptance testing of liquid propellants or propellant constituents specified in 6-4.C.
- 2. "Production equipment", other than that described in 6-4.B.3., and specially designed components therefor, for the production, handling, mixing, curing, casting, pressing, machining, extruding or acceptance testing of solid propellants or propellant constituents specified in 6-4.C.

- 3. Equipment as follows, and specially designed components therefor:
 - a. Batch mixers with provision for mixing under vacuum in the range of zero to 13.326 kPa and with temperature control capability of the mixing chamber and having all of the following:
 - 1. A total volumetric capacity of 110 litres or more; and
 - 2. At least one mixing/kneading shaft mounted off centre;
 - b. Continuous mixers with provision for mixing under vacuum in the range of zero to 13.326 kPa and with a temperature control capability of the mixing chamber and having any of the following:
 - 1. Two or more mixing/kneading shafts; or

6-4.B.3.d. includes:

- Electroburst equipment usable for obtaining sputtered or spherical metallic powders with organization of the process in an argonwater environment;
- Equipment usable for the "production" of spherical aluminium powders by powdering a melt in an inert medium (e.g. nitrogen).

Notes:

- The only batch mixers, continuous mixers, usable for solid propellants or propellants constituents specified in 6-4.C., and fluid energy mills specified in 6-4.B., are those specified in 6-4.B.3.
- 2. Forms of metal powder "production equipment" not specified in 6-4.B.3.d. are to be evaluated in accordance with 6-4.B.2.

6-4.C. Materials

- 1. Composite and composite modified double base propellants.
- 2. Fuel substances as follows:
 - a. Hydrazine with a concentration of more than 70%;

6-4.C.2.b. does not control the following derivatives:

- c. Spherical aluminium powder with particles of uniform diameter of less than 200 x 10^{-6} m (200 μ m) and an aluminium content of 97% by weight or more, if at least 10% of the total weight is made up of particles of less than 63 μ m, according to ISO 2591:1988 or national equivalents such as JIS Z8820;

Technical Note:

A particle size of 63 µm (ISO R-565) corresponds to 250 mesh (Tyler) or 230 mesh (ASTM standard E-11).

d. Zirconium, beryllium, magnesium and alloys of these in particle size less than 60 x 10⁻⁶ m (60 μm), whether spherical, atomised, spheroidal, flaked or ground, consisting of 97% by weight or more of any of the above mentioned metals;

Technical Note:

The natural content of hafnium in the zirconium (typically 2% to 7%) is counted with the zirconium.

- e. Boron and boron alloys in particle size less than 60 x 10⁻⁶ m (60 μm), whether spherical, atomised, spheroidal, flaked or ground with a purity of 85% by weight or more;
- f. High energy density materials such as boron slurry, having an energy density of 40×10^6 J/kg or greater.
- 3. Oxidisers/Fuels as follows:

Perchlorates, chlorates or chromates mixed with powdered metals or other high energy fuel components.

There are a range of compositions that can be denoted as MONi or MONij where i and j are integers representing the percentage of Nitric Oxide in the mixture (e.g. MON3 contains 3% Nitric Oxide, MON25 25% Nitric Oxide. An upper limit is MON40, 40% by weight).

Note:

Item 6-4.C.4.a.6. does not control Nitrogen Trifluoride (NF $_3$) in a gaseous state as it is not usable for missile applications.

- b. Solid oxidiser substances as follows:
 - 1. Ammonium perchlorate;
 - 2. Ammonium dinitramide (ADN);
 - 3. Nitro-amines (cyclotetramethylene tetranitramine (HMX); cyclotrimethylene trinitramine (RDX);

 - a. Carboxy terminated polybutadiene (CTPB);

 - e. Polybutadiene Acrylic Acid Acrylonitrile (PBAN).
- 6. Other propellant additives and agents as follows:
 - a. Bonding agents as follows:
 - 1. Tris (1-(2-methyl)aziridinyl) phosphine oxide (MAPO);
 - 2. Trimesoyl-1 (2-ethyl) aziridine (HX-868, BITA);
 - Tepanol (HX878), reaction product of tetra-ethlylenepentamine, acrylonitrile and glycidol;
 - Tepan (HX-879), reaction product of tetraethlylenepentamine and acrylonitrile;
 - Polyfunctional aziridine amides with isophthalic, trimesic, isocyanuric, or trimethyladipic backbone also having a 2-methyl or 2-ethyl aziridine group (HX-752, HX-874 and HX-877);

- b. Curing agent and catalysts as follows: Triphenyl bismuth (TPB);
- c. Burning rate modifiers as follows:
 - Carboranes, decaboranes, pentaboranes and derivatives thereof;
 - 2. Ferrocene derivatives, as follows;
 - a. Catocene;
 - b. Ethyl ferrocene;
 - c. Propyl ferrocene;
 - d. n-Butyl ferrocene;
 - e. Pentyl ferrocene;
 - f. Dicyclopentyl ferrocene;
 - g. Dicyclohexyl ferrocene;
 - h. Diethyl ferrocene;
 - i. Dipropyl ferrocene;
 - j. Dibutyl ferrocene;
 - k. Dihexyl ferrocene;
 - 1. Acetyl ferrocenes;
 - m. Ferrocene Carboxylic acids;
 - n. Butacene;
 - Other ferrocene derivatives usable as rocket propellant burning rate modifiers.
- d. Nitrate esters and nitrated plasticisers as follows:
 - 1. Triethylene glycol dinitrate (TEGDN);
 - 2. Trimethylolethane trinitrate (TMETN);
 - 3. 1,2,4-butanetriol trinitrate (BTTN);
 - 4. Diethylene glycol dinitrate (DEGDN);
- e. Stabilisers as follows:
 - 1. 2-Nitrodiphenylamine;
 - 2. N-methyl-p-nitroaniline.

6-4.D. Software

 "Software" specially designed or modified for the "use" of equipment specified in 6-4.B. for the "production" and handling of materials specified in 6-4.C.

6-4.E. Technology

1. "Technology", in accordance with the General Technology Note, for the "development", "production" or "use" of equipment or materials specified in 6-4.B. and 6-4.C.

6-5. RESERVED FOR FUTURE USE

6-6. Production of Structural Composites, Pyrolytic Deposition and Densification, and Structural Materials

6-6.A. Equipment, Assemblies and Components

1. Composite structures, laminates, and manufactures thereof, specially designed for use in the systems specified in 6-1.A. and the subsystems specified in 6-2.A.

- 2. Resaturated pyrolised (i.e. carbon-carbon) components having all of the following:
 - a. Designed for rocket systems; and
 - b. Usable in the systems specified in 6-1.A.

6-6.B. Test and Production Equipment

- Equipment for the "production" of structural composites, fibres, prepregs or preforms, usable in the systems specified in 6-1.A., as follows, and specially designed components, and accessories therefor:
 - a. Filament winding machines of which the motions for positioning, wrapping and winding fibres can be co-ordinated and programmed in three or more axes, designed to fabricate composite structures or laminates from fibrous or filamentary materials, and co-ordinating and programming controls;
 - Tape-laying machines of which the motions for positioning and laying tape and sheets can be co-ordinated and programmed in two or more axes, designed for the manufacture of composite airframes and missile structures;
 - Multi-directional, multi-dimensional weaving machines or interlacing machines, including adapters and modification kits for weaving, interlacing or braiding fibres to manufacture composite structures;

Note:

6-6.B.1.c. does not control textile machinery not modified for the end-uses stated.

- d. Equipment designed or modified for the production of fibrous or filamentary materials as follows:
 - 1. Equipment for converting polymeric fibres (such as polyacrylonitrile, rayon, or polycarbosilane) including special provision to strain the fibre during heating;
 - Equipment for the vapour deposition of elements or compounds on heated filament substrates;
 - Equipment for the wet-spinning of refractory ceramics (such as aluminium oxide);
- e. Equipment designed or modified for special fibre surface treatment or for producing prepregs and preforms, including rollers, tension stretchers, coating equipment, cutting equipment and clicker dies.

Note:

Examples of components and accessories for the machines specified in 6-6.B.1. are moulds, mandrels, dies, fixtures and tooling for the preform pressing, curing, casting, sintering or bonding of composite structures, laminates and manufactures thereof.

- Nozzles specially designed for the processes referred to in 6-6.E.3.
- 3. Isostatic presses having all of the following characteristics:
 - a. Maximum working pressure equal to or greater than 69 MPa;
 - Designed to achieve and maintain a controlled thermal environment of 600°C or greater; and
 - Possessing a chamber cavity with an inside diameter of 254 mm or greater.
- Chemical vapour deposition furnaces designed or modified for the densification of carbon-carbon composites.
- 5 Equipment and process controls, other than those specified in 6-6.B.3. or 6-6.B.4., designed or modified for densification and pyrolysis of structural composite rocket nozzles and re-entry vehicle nose tips.

6-6.C. Materials

 Resin impregnated fibre prepregs and metal coated fibre preforms, for the goods specified in 6-6.A.1., made either with organic matrix or metal matrix utilising fibrous or filamentary reinforcements having a specific tensile strength greater than 7.62 x 10⁴ m and a specific modulus greater than 3.18 x 10⁶ m. Note:

The only resin impregnated fibre prepregs specified in 6-6.C.1. are those using resins with a glass transition temperature (Tg), after cure, exceeding 145°C as determined by ASTM D4065 or national equivalents.

- 2. Resaturated pyrolised (i.e. carbon-carbon) materials having all of the following:
 - a. Designed for rocket systems; and
 - b. Usable in the systems specified in 6-1.A.
- 3. Fine grain graphites with a bulk density of at least 1.72 g/cc measured at 15°C and having a grain size of 100 x 10⁻⁶ m (100 μm) or less, usable for rocket nozzles and re-entry vehicle nose tips which can be machined to any of the following products:
 - a. Cylinders having a diameter of 120 mm or greater and a length of 50 mm or greater;
 - Tubes having an inner diameter of 65 mm or greater and a wall thickness of 25 mm or greater and a length of 50 mm or greater; or
 - c. Blocks having a size of 120 mm x 120 mm x 50 mm or greater.
- Pyrolytic or fibrous reinforced graphites usable for rocket nozzles and re-entry vehicle nose tips usable in systems specified in 6-1.A.
- Ceramic composite materials (dielectric constant less than 6 at any frequency from 100 MHz to 100 GHz for use in missile radomes usable in systems specified in 6-1.A.
- 6. Bulk machinable silicon-carbide reinforced unfired ceramic usable for nose tips usable in systems specified in 6-1.A.
- 7. Tungsten, molybdenum, and alloys of these metals in the form of uniform spherical or atomised particles of 500 x 10⁻⁶ m (500 μm) diameter or less with a purity of 97% or higher for fabrication of rocket motor components, i.e. heat shields, nozzle substrates, nozzle throats, and thrust vector control surfaces, usable in systems specified in 6-1.A.
- 8. Maraging steels having an ultimate Tensile Strength equal to or greater than 1.5 GPa, measured at 20°C, in the form of sheet, plate or tubing with a wall or plate thickness equal to or less than 5.0 mm usable in systems specified in 6-1.A.

Technical Note:

Maraging steels are generally characterised by high nickel, very low carbon content and use substitutional elements or precipitates to produce age-hardening.

- 9. Titanium-stabilized duplex stainless steel (Ti-DSS) usable in the systems specified in 6-1.A. and having all of the following:
 - a. Having all of the following characteristics:
 - 1. Containing 17.0 23.0 weight percent chromium and 4.5 7.0 weight percent nickel;
 - 2. Having a titanium content of greater than 0.10 weight percent nickel; and
 - 3. A ferritic-austenitic microstructure (also referred to as a two-phase microstructure) of which at least 10% is austenite by volume (according to ASTM E-1181-87 or national equivalents); and

- b. Any of the following forms:
 - 1. Ingots or bars having a size of 100 mm or more in each dimension;
 - 2. Sheets having a width of 600 mm or more and a thickness of 3 mm or less; **or**
 - 3. Tubes having an outer diameter of 600 mm or more and a wall thickness of 3 mm or less.

6-6.D. Software

- 1. "Software" specially designed or modified for the "use" of equipment specified in 6-6.B.1.
- 2. "Software" specially designed or modified for the equipment specified in 6-6.B.3., 6-6.B.4. or 6-6.B.5.

6-6.E. Technology

- "Technology", in accordance with the General Technology Note, for the "development", "production" or "use" of equipment, materials or "software" specified in 6-6.A., 6-6.B., 6-6.C. or 6-6.D.
- "Technical data" (including processing conditions) and procedures for the regulation of temperature, pressures or atmosphere in autoclaves or hydroclaves when used for the production of composites or partially processed composites, usable for equipment or materials specified in 6-6.A. or 6-6.C.
- 3. "Technology" for producing pyrolytically derived materials formed on a mould, mandrel or other substrate from precursor gases which decompose in the 1,300°C to 2,900°C temperature range at pressures of 130 Pa (1 mm Hg) to 20 kPa (150 mm Hg) including "technology" for the composition of precursor gases, flow-rates, and process control schedules and parameters.

6-7. RESERVED FOR FUTURE USE

6-8. RESERVED FOR FUTURE USE

6-9. Instrumentation, Navigation and Direction Finding

6-9.A. Equipment, Assemblies and Components

- Integrated flight instrument systems which include gyrostabilisers or automatic pilots, designed or modified for use in the systems specified in 6-1.A., and specially designed components therefor.
- Gyro-astro compasses and other devices which derive position or orientation by means of automatically tracking celestial bodies or satellites, and specially designed components therefor.
- 3. Linear accelerometers, designed for use in inertial navigation systems or in guidance systems of all types, usable in the systems specified in 6-1.A., 6-19.A.1. or 6-19.A.2., having all of the following characteristics, and specially designed components therefor:
 - a. 'Scale factor' 'repeatability' less (better) than 1250 ppm; and
 - b. 'Bias' 'repeatability' less (better) than 1250 micro g.

Technical Notes:

- 'Bias' is defined as the accelerometer output when no acceleration is applied.
- 'Scale factor' is defined as the ratio of change in output to a change in the input.
- The measurement of 'bias' and 'scale factor' refers to one sigma standard deviation with respect to a fixed calibration over a period of one year.
- 'Repeatability' is defined according to IEEE Standard 528-2001 as follows:

'The closeness of agreement among repeated measurements of the same variable under the same operating conditions when changes in conditions or non-operating periods occur between measurements'.

Note:

Item 6-9.A.3. does not control accelerometers specially designed and developed as Measurement While Drilling (MWD) sensors for use in downhole well service operations.

4. All types of gyros usable in the systems specified in 6-1.A., 6-19.A.1. or 6-19.A.2., with a rated 'drift rate' 'stability' of less than 0.5 degrees (1 sigma or rms) per hour in a 1 g environment and specially designed components therefor.

Technical Notes:

- 'Drift rate' is defined as the time rate of output deviation from the desired output. It consists of random and systematic components and is expressed as an equivalent angular displacement per unit time with respect to inertial space.
- 'Stability' is defined as the standard deviation (1 sigma) of the variation of a particular parameter from its calibrated value measured under stable temperature conditions. This can be expressed as a function of time.
- 5. Continuous output accelerometers or gyros of any type, specified to function at acceleration levels greater than 100 g, and specially designed components therefor.
- 6. Inertial or other equipment using accelerometers specified in 6-9.A.3. or 6-9.A.5. or gyros specified in 6-9.A.4. or 6-9.A.5., and systems incorporating such equipment, and specially designed components therefor.
- 7. 'Integrated navigation systems', designed or modified for the systems specified in 6-1.A., 6-19.A.1. or 6-19.A.2. and capable of providing a navigational accuracy of 200 m CEP or less.

Technical Note:

An 'integrated navigation system' typically incorporates all of the following components:

- a. An inertial measurement device (e.g., an attitude and heading reference system, inertial reference unit, or inertial navigation system);
- One or more external sensors used to update the position and/or velocity, either periodically or continuously throughout the flight (e.g. satellite navigation receiver, radar altimeter, and/or Doppler radar); and
- c. Integration hardware and software.

N.B

For integration "software", see Item 6-9.D.4.

6-9.B. Test and Production Equipment

1. "Production equipment", and other test, calibration and alignment equipment, other than that described in 6-9.B.2., designed or modified to be used with equipment specified in 6-9.A.

Note:

Equipment specified in 6-9.B.1. includes the following:

- a. For laser gyro equipment, the following equipment used to characterise mirrors, having the threshold accuracy shown or better:
 - 1. Scatterometer (10 ppm);
 - 2. Reflectometer (50 ppm);
 - 3. Profilometer (5 Angstroms);

- b. For other inertial equipment:
 - 1. Inertial Measurement Unit (IMU) Module Tester;
 - 2. IMU Platform Tester;
 - 3. IMU Stable Element Handling Fixture;
 - 4. IMU Platform Balance Fixture;
 - 5. Gyro Tuning Test Station;
 - 6. Gyro Dynamic Balance Station;
 - 7. Gyro Run-In/Motor Test Station;
 - 8. Gyro Evacuation and Filling Station;
 - 9. Centrifuge Fixture for Gyro Bearings;
 - 10. Accelerometer Axis Align Station;
 - 11. Accelerometer Test Station.

2. Equipment as follows:

- a. Balancing machines having all the following characteristics:
 - 1. Not capable of balancing rotors/assemblies having a mass greater than 3 kg;
 - Capable of balancing rotors/assemblies at speeds greater than 12.500 rpm;
 - 3. Capable of correcting unbalance in two planes or more; \mathbf{and}
 - 4. Capable of balancing to a residual specific unbalance of 0.2 g mm per kg of rotor mass;
- Indicator heads (sometimes known as balancing instrumentation) designed or modified for use with machines specified in 6-9.B.2.a.;
- c. Motion simulators/rate tables (equipment capable of simulating motion) having all of the following characteristics:
 - 1. Two axes or more;
 - Slip rings capable of transmitting electrical power and/or signal information; and
 - 3. Having any of the following characteristics:
 - a. For any single axis having all of the following:
 - 1. Capable of rates of 400 degrees/s or more, or 30 degrees/s or less; and

 - b. Having a worst-case rate stability equal to or better (less) than plus or minus 0.05% averaged over 10 degrees or more; or
 - c. A positioning accuracy equal to or better than 5 arc second;
 - d. Positioning tables (equipment capable of precise rotary positioning in any axes) having the following characteristics:
 - 1. Two axes or more; and
 - A positioning accuracy equal to or better than 5 arc second;
 - e. Centrifuges capable of imparting accelerations above 100 g and having slip rings capable of transmitting electrical power and signal information.

Notes:

- The only balancing machines, indicator heads, motion simulators, rate tables, positioning tables and centrifuges specified in Item 6-9. are those specified in 6-9.B.2.
- 6-9.B.2.a. does not control balancing machines designed or modified for dental or other medical equipment.
- 6-9.B.2.c. and 6-9.B.2.d. do not control rotary tables designed or modified for machine tools or for medical equipment.

Definitions

For the purpose of Group 6, the following definitions apply:

"Basic scientific research"

Experimental or theoretical work undertaken principally to acquire new knowledge of the fundamental principles of phenomena or observable facts, not primarily directed towards a specific practical aim or objective.

"Development"

Is related to all phases prior to "production" such as:

- design
- design research
- design analysis
- design concepts
- assembly and testing of prototypes
- pilot production schemes
- design data
- process of transforming design data into a product
- configuration design
- integration design
- layouts

"In the public domain"

This means "software" or "technology" which has been made available without restrictions upon its further dissemination. (Copyright restrictions do not remove "software" or "technology" from being "in the public domain".)

"Microcircuit"

A device in which a number of passive and/or active elements are considered as indivisibly associated on or within a continuous structure to perform the function of a circuit.

"Microprogrammes"

A sequence of elementary instructions maintained in a special storage, the execution of which is initiated by the introduction of its reference instruction register.

"Payload"

The total mass that can be carried or delivered by the specified rocket system or unmanned aerial vehicle (UAV) system that is not used to maintain flight.

Note:

The particular equipment, subsystems, or components to be included in the payload depends on the type and configuration of the vehicle under consideration.

Technical Notes:

1. Ballistic Missiles

- a. "Payload" for systems with separating re-entry vehicles (RVs) includes:

- 1. Munitions of any type (e.g., explosive or non-explosive);
- Supporting structures and deployment mechanisms for the munitions that can be removed without violating the structural integrity of the vehicle;
- 3. Mechanisms and devices for safing, arming, fuzing or firing;
- Any countermeasures equipment (e.g., decoys, jammers or chaff dispensers) that can be removed without violating the structural integrity of the vehicle.

2. Space Launch Vehicles

"Payload" includes:

- a. Satellites (single or multiple);
- Satellite-to-launch vehicle adapters including, if applicable, apogee/perigee kick motors or similar manoeuvering systems.

3. Sounding Rockets

"Payload" includes:

- Equipment required for a mission, such as data gathering, recording or transmitting devices for mission-specific data;
- b. Recovery equipment (e.g., parachutes) that can be removed without violating the structural integrity of the vehicle.

4. Cruise Missiles

"Payload" includes:

- a. Munitions of any type (e.g., explosive or non-explosive);
- Supporting structures and deployment mechanisms for the munitions that can be removed without violating the structural integrity of the vehicle;
- c. Mechanisms and devices for safing, arming, fuzing or firing;
- d. Countermeasures equipment (e.g., decoys, jammers or chaff dispensers) that can be removed without violating the structural integrity of the vehicle;
- Signature alteration equipment that can be removed without violating the structural integrity of the vehicle.

5. Other UAVs

- c. Countermeasures equipment (e.g., decoys, jammers or chaff dispensers) that can be removed without violating the structural integrity of the vehicle;

- e. Equipment required for a mission such as data gathering, recording or transmitting devices for mission-specific data;
- Recovery equipment (e.g., parachutes) that can be removed without violating the structural integrity of the vehicle.

"Production"

- assembly (mounting)
- inspection
- testing
- quality assurance

"Production equipment"

Means tooling, templates, jigs, mandrels, moulds, dies, fixtures, alignment mechanisms, test equipment, other machinery and components therefor, limited to those specially designed or modified for "development" or for one or more phases of "production".

"Production facilities"

Means equipment and specially designed "software" therefor integrated into installations for "development" or for one or more phases of "production".

"Programmes"

A sequence of instructions to carry out a process in, or convertible into, a form executable by an electronic computer.

"Radiation hardened"

Means that the component or equipment is designed or rated to withstand radiation levels which meet or exceed a total irradiation dose of 5×10^5 rads (Si).

"Range"

The maximum distance that the specified rocket system or unmanned aerial vehicle (UAV) system is capable of travelling in the mode of stable flight as measured by the projection of its trajectory over the surface of the Earth.

Technical Notes:

- The maximum capability based on the design characteristics of the system, when fully loaded with fuel or propellant, will be taken into consideration in determining "range".
- The "range" for both rocket systems and UAV systems will be determined independently of any external factors such as operational restrictions, limitations imposed by telemetry, data links or other external constraints.
- For rocket systems, the "range" will be determined using the trajectory that maximises range, assuming ICAO standard atmosphere with zero wind.
- For UAV systems, the range will be determined for a one-way distance using the most fuel-efficient flight profile (e.g., cruise speed and altitude), assuming ICAO standard atmosphere with zero wind.

"Software"

A collection of one or more "programmes", or "microprogrammes", fixed in any tangible medium of expression.

"Technology"

Means specific information which is required for the "development", "production" or "use" of a product. The information may take the form of "technical data" or "technical assistance".

"Technical assistance"

May take forms such as:

- instruction
- skills
- training
- working knowledge
- consulting services

"Technical data"

May take forms such as:

- blueprints
- plans
- diagrams
- models
- formulae
- engineering designs and specifications
- manuals and instructions written or recorded on other media or devices such as:
 - disk
 - tape
 - read-only memories

"Use"

Means:

- operation
- installation (including on-site installation)
- maintenance
- repair
- overhaul
- refurbishing

Terminology

Where the following terms appear in Group 6, they are to be understood according to the explanations below:

- a. "Specially designed" describes equipment, parts, components or "software" which, as a result of "development", have unique properties that distinguish them for certain predetermined purposes. For example, a piece of equipment that is "specially designed" for use in a missile will only be considered so if it has no other function or use. Similarly, a piece of manufacturing equipment that is "specially designed" to produce a certain type of component will only be considered such if it is not capable of producing other types of components.
- b. "Designed or modified" describes equipment, parts or components which, as a result of "development", or modification, have specified properties that make them fit for a particular application. "Designed or modified" equipment, parts, components or "software" can be used for other applications. For example, a titanium coated pump designed for a missile may be used with corrosive fluids other than propellants.
- c. "Usable in", "usable for", "usable as" or "capable of" describes equipment, parts, components, materials or "software" which are suitable for a particular purpose. There is no need for the equipment, parts, components or "software" to have been configured, modified or specified for the particular purpose. For example, any military specification memory circuit would be "capable of" operation in a guidance system.
- d. "Modified" in the context of "software" describes "software" which has been intentionally changed such that it has properties that make it fit for specified purposes or applications. Its properties may also make it suitable for purposes or applications other than those for which it was "modified".

Notes:

- Terms in "double quotation marks" are defined terms. Refer to "Group 7 - Definitions".
- In items 7-3. and 7-4. the numbers in brackets following the chemical name in each item is the Chemical Abstracts Service Registry number for that chemical as listed in the Chemical Abstracts Service Registry Handbook published by the American Chemical Society, Washington, D.C.
- Mixtures containing any quantity of CWC Schedule 1A and 1B chemicals/precursors (Items 7-3.1. and 7-3.2.) are also controlled.
- 4. Mixtures containing any quantity of chemicals/precursors listed in the CWC Schedules 2A, 2B, 3A and 3B (items 7-3.3. through 7-3.6.) and Australia Group (item 7-4.) are controlled unless the listed chemical is an ingredient in a product identified as a consumer good packaged for retail sale or packaged for personal use.
- Items 7-1. and 7-3. are based on the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on their Destruction. (known as the Chemical Weapons Convention or CWC.) The other items in the Group are based on the Australia Group (AG).

Note:

 The objective of these controls should not be defeated by the transfer of any non-controlled item containing one or more controlled components where the controlled component or components are the principal element of the item and can feasibly be removed or used for other purposes.
 NB:

Governments may weigh the factors of quantity, value, and technological know-how involved and other special circumstances which might establish the controlled component or components as the principal element of the item being procured when judging whether the controlled component or components are to be considered the principal element.

- The objective of these controls should not be defeated by the transfer of a whole plant, on any scale, which has been designed to produce any CW agent or AG-controlled precursor chemical.
- Reaction Vessels, Reactors or Agitators, Storage Tanks, Containers or Receivers, Heat Exchangers or Condensers, Distillation or Absorption Columns, Valves, Multi-walled Piping, and Pumps, as follows:
 - a. Reaction Vessels or Reactors, with or without agitators, with a total internal (geometric) volume greater than $0.1~\text{m}^3$ (100 l) and less than $20~\text{m}^3$ (20,000 l);
 - b. Agitators for use in reaction vessels or reactors; and impellers, blades or shafts for such agitators listed in Item 7-2.1.a;
 - Storage Tanks, Containers or Receivers, with a total internal (geometric) volume greater than 0.1 m³ (100 l);
 - d. Heat exchangers or Condensers with a heat transfer surface area of greater than 0.15 m², and less than 20 m²; and tubes, plates, coils, or blocks (cores) designed for such heat exchangers or condensers;

- e. Distillation or Absorption Columns of internal diameter greater than 0.1 m, and vapour distributors, liquid distributors or liquid collectors designed for such distillation or absorption columns;
- f. Valves with normal sizes greater than 1.0 cm (3/8") and casings (valve bodies) or preformed casing liners designed for such valves;
- g. Multi-walled Piping incorporating a leak detection port;
- h. Multiple-seal and seal-less pumps with manufacturer's specified maximum flow-rate greater than 0.6 m³/h, or vacuum pumps with manufacturer's specified maximum flow-rate greater than 5 m³/h (under standard temperature (273 K (0°C)) and pressure (101.3 kPa) conditions), and casings (pump bodies), preformed casing liners, impellers, rotors or jet pump nozzles designed for such pumps.

Technical Note:

Items listed in 7-2.1.a. through h. are included in this Item only if all surfaces of any of the Items coming in direct contact with the chemical(s) being processed or contained are made from any of the following materials:

- 1. Nickel or alloys with more than 40% nickel by weight;
- 2. Alloys with more than 25% nickel and 20% chromium by weight;
- 3. Fluoropolymers
- 4. Glass or glass-lined (including vitrified or enameled coating);
- Graphite or carbon graphite* (applies only to heat exchangers, condensers, distillation and absorption columns, multi-walled piping and pumps);
 - *Carbon graphite is a composition consisting of amorphous carbon and graphite, in which the graphite content is 8% or more by weight.

'Disinfected' denotes the destruction of potential microbial infectivity in the equipment through the use of chemical agents with a germicidal effect. 'Disinfection' and 'sterilization' are distinct from 'sanitization', the latter referring to cleaning procedures designed to lower the microbial content of quipment without necessarily achieving elimination of all microbial infectivity or viability.

This entry does not control spraying or fogging systems and components as specified in paragraph 8 above that are demonstrated not to be capable of delivering biological agents in the form of infectious aerosols. Pending definition of international standards, the following guidelines should be followed:

Droplet size for spray equipment or nozzles specially designed for use on aircraft of UAVs should be measured using either of the following methods:

- a. Doppler laser method
- b. Forward laser diffraction method

Development is related to all phases before "production" such as: design, design research, design analysis, design concepts, assembly of prototypes, pilot production schemes, design data, process or transforming design data into a product, configuration design, integration design, and layouts.

"In the public domain"

"In the public domain", as it applies herein, means "technology" that has been made available without restrictions upon it's further dissemination. (Copyright restrictions do not remove technology from being in the public domain).

"Lighter than air vehicles"

Balloons and airships that rely on hot air or on lighter-than-air gases such as helium or hydrogen for their lift.

"Production"

Means all production phases such as: construction, production engineering, manufacture, integration, assembly (mounting), inspection, testing, and quality assurance.

"Technical assistance"

May take forms, such as: instruction, skills, training, working knowledge, consulting services.

N.B.:

"Technical assistance" may involve transfer of "technical data".

"Technical data"

May take forms such as blueprints, plans, diagrams, models, formulae, tables, engineering designs and specifications, manuals and instructions written or recorded on other media or devices such as disk, tape, read-only memories.

"Technology"

Specific information necessary for the "development", "production" or "use" of a product. The information takes the form of "technical data" or "technical assistance".

"UAVs"

Unmanned Aerial Vehicles.

"Use"

Operation, installation (including on-site installation), maintenance (checking), repair, overhaul and refurbishing.

"VMD"

Volume Median Diameter.
