Profile of the 2000 Taxfiler Farm Family Data July 2003





Taxfiler farm family data is collected from personal income tax returns and is compiled by Statistics Canada. The data refers to the income of families (husbandwife, common-law and lone-parent) involved in a single unincorporated farm with gross operating revenue of \$10,000 or more. The Taxation Data Program is funded jointly by Agriculture and Agri-Food Canada and Statistics Canada. This *Profile of the 2000 Taxfiler Farm Family Data* provides highlights and comparisons of farm level revenues and expenses as well as off-farm employment income for farm families by farm type, by revenue class and by province. In order to provide more timely fundamental information, this overview will be produced on a regular basis as new data are released.

Introduction

The 2000 farm family data presented in this document includes only those families operating a single unincorporated farm with gross operating revenue of \$10,000 or more and for which 51% or more of their farm sales come from agricultural activities unless otherwise specified.


Total farm family income is composed of net operating income (before depreciation) and off-farm income (excluding taxable capital gains) for members of the farm family. Off-farm income includes wages and salaries and net self-employment income from non-farm sources as well as income from investment, pensions and other off-farm income including government social transfers and NISA withdrawals.

Average Total Farm Family Income, Canada 1990-2000





Small/Medium Farms




Average Off-farm Income* per Family, by Source, 2000


