**DECLARATION OF VARIETY**

IN ACCORDANCE with the terms of the Ineligible Varieties Protocol agreed to by grain handling companies and the Canadian Wheat Board requiring the execution of a Declaration of Variety by each producer prior to the delivery of wheat; and

IN THE MATTER of the Canadian Wheat Board Act, Canada Grain Act and Canada Seeds Act, and the Regulations and Orders made pursuant to those Acts:

**DO DECLARE THAT:**

- 1 I am the producer and have entered into a delivery contract with the Canadian Wheat Board under Canadian Wheat Board Producer ID # \_\_\_\_\_, to deliver wheat.
- 2 Any and all deliveries of wheat made by me or on my behalf to the Producer Car Administrator are eligible for delivery for the class of wheat for which payment is being requested and are also of a registered variety of that class of wheat in accordance with the Canadian Wheat Board Act, Canada Grain Act, Canada Seeds Act, and all Regulations and Orders made pursuant to those Acts, (collectively, the "Acts").
- 3 If a non-registered or ineligible variety of wheat is delivered by me or on my behalf to the Producer Car Administrator and it is represented to be eligible for delivery for the class of wheat for which payment is being requested or to be of a registered variety of that class of wheat in accordance with the Acts, I acknowledge and agree that the Producer Car Administrator and/or the Canadian Wheat Board may consider the representation to have been made fraudulently and/or negligently. I further acknowledge and agree that The Canadian Wheat Board may consider me to be in default of my delivery contracts and, in addition to any other remedies available to it, it may cancel my contracts. In addition, the Producer Car Administrator may claim against me for all claims, damages, losses and costs (including legal fees) that may result.
- 4 I acknowledge and agree that the Producer Car Administrator may exchange with the Canadian Grain Commission and the Canadian Wheat Board relevant information (including personal information) regarding suspected deliveries of non-registered and/or ineligible varieties of wheat by me or on my behalf to the Producer Car Administrator.
- 5 This Declaration is made and intended to apply to all deliveries of wheat by me or on my behalf to the Producer Car Administrator from and including the date indicated below until the end of the current crop year, whether this Declaration is made by me or on my behalf or until this Declaration is replaced or withdrawn by me by written notice acknowledged by both the Canadian Wheat Board and the Producer Car Administrator.
