PURPOSE OF THE SURVEY

The purpose of this survey is to obtain information on the supply of, and demand for, energy in Canada. This information serves as an important indicator of Canadian economic performance, and is used by all levels of government in establishing informed policies in the energy area. In the case of public utilities, it is used by governmental agencies to fulfil their regulatory responsibilities. The private sector also uses this information in the corporate decision-making process.

CONFIDENTIALITY

Statistics Canada is prohibited by law from publishing any statistics which would divulge information obtained from this survey that relates to any identifiable business. The data reported will be treated in strict confidence, used for statistical purposes and published in aggregate form only. The confidentiality provisions of the *Statistics Act* are not affected by either the *Access to Information Act* or any other legislation. An exception to the general rule of confidentiality under the *Statistics Act* is the disclosure, at the discretion of the Chief Statistician, of identifiable information relating to the public utilities, which includes undertakings supplying petroleum or petroleum products by pipeline, and undertakings supplying, transmitting or distributing gas, electricity or steam. This applies to the dissemination of aggregate survey results at the provincial or territorial level where only one or two public utilities may have reported data or where one dominates the industry in a particular province or territory.

DATA SHARING AGREEMENTS

To reduce response burden and to ensure uniform statistics, Statistics Canada has entered into data sharing agreements with various agencies and government departments for the joint collection and sharing of data from this survey. The information provided in this survey pertaining to individual respondents cannot be divulged, in any way, by the parties with which Statistics Canada has agreements.

Agreement exists under Section 11 of the *Statistics Act* to share information with the statistical agencies of Nova Scotia, Quebec, Saskatchewan and Alberta regarding business establishments located or operating in their respective province. These provincial *statistical* agencies have been established under provincial legislation authorizing them to collect this information on their own or jointly with Statistics Canada. The provincial legislation in these provinces also *contains* the same confidentiality protection and outlines similar penalties for disclosure of confidential information as the federal *Statistics Act*.

Under Section 12 of the *Statistics Act*, agreements exist with Natural Resources Canada and Environment Canada. Section 12 agreements shall not apply to your return if an officer of your company objects in writing to the Chief Statistician and mails the letter to the Manufacturing, Construction and Energy Division of Statistics Canada together with the completed questionnaire. **Please specify the section 12 agency listed above from which data shall be withheld.**
