Example

You are a wholesale broker located in New Brunswick. One of the commodities for which you arrange purchase and sale transactions on a commission basis is fresh citrus fruit. During the period for which you are reporting, you arranged transactions between suppliers in California and Florida and buyers in New Brunswick, Nova Scotia and Prince Edward Island. The value of the fruit sold in these transactions was \$5 million (Canadian dollars) and you earned total commissions of \$250,000 on these transactions. Your records indicate that 65% of the value of the fruit sold went to buyers in New Brunswick, 27% to Nova Scotia and 8% to Prince Edward Island.

The commodity block **0103 Fruits and vegetables** would be completed as follows:

Note: Intermediate shipping points do not affect the origin or destination of a commodity. If, in the above example, the fruit from California and Florida had been flown to Chicago, then transferred and flown to Halifax, then trucked to the buyers, the origin would still have been 100% USA (the location of the immediate suppliers) and **not** Nova Scotia (the last shipment point before the goods reached the buyers).
