The data are to be used for statistical purposes only and published in aggregate form in the Surface and Marine Service Bulletin, Catalogue No. 50-002-XPB and in Trucking in Canada, Catalogue No. 53-222-XPB. **The data are kept confidential, as outlined in the confidentiality provisions of the Statistics Act.** The confidentiality provisions of the Statistics Act are not affected by either the Access to Information Act or any other legislation.
