### New Assets, Renovations, Retrofits

- modifications, additions and major renovations to your own buildings and equipment;

- subsidies;
- capitalized interest charges on loans with which capital projects are financed;
- work done by your own labour force;
- additions to work in progress.

#### How to Treat Leases:
