## **PROVINCIAL AND TERRITORIAL FUNDING PROGRAMS FOR AUTISM THERAPY**

The following document provides a table summarizing provincial and territorial programs for the treatment of autism.<sup>(1)</sup> The table includes information on autism therapy, such as Applied Behavioural Analysis (ABA) or Intensive Behavioural Intervention (IBI), as well as on family services and supports. The terminology used is usually that employed by each jurisdiction. It should be noted that this table is not intended to be comprehensive, but simply to offer some useful comparisons among provinces and territories.

Autism or “Autistic Disorder” (AD) is part of a group of five “Pervasive Developmental Disorders” (PDD), which also comprises Asperger’s Syndrome (AS), Pervasive Developmental Disorders – Not Otherwise Specified (PDD-NOS), Rett’s Syndrome (RS) and Childhood Disintegrative Disorder (CDD). Both RS and CDD are rare disorders. The three other disorders – AD, AS and PDD-NOS – are often collectively referred to as “Autism Spectrum Disorders” (ASD), although this term is not defined in international medical classification codes.
