CUSTOMS NOTICE 660

Summary of the Regulations Implementing the United Nations Resolution on the Democratic People's Republic of Korea

1. The purpose of this notice is to inform exporters and importers of the key provisions of the *Regulations Implementing the United Nations Resolution on the Democratic People's Republic of Korea* (Regulations) that relate to the prohibition of goods exported to and imported from the Democratic People's Republic of Korea (DPRK). The Canada Border Services Agency (CBSA) will assist Foreign Affairs and International Trade Canada (FAITC) in administering the Regulations.

2. The authority to prohibit the export to and import from the DPRK of specific goods is contained in sections 3 and 5 of the Regulations.

Prohibitions

3. These regulations prohibit a person in Canada and Canadians outside Canada from exporting, selling, supplying, transferring or shipping the following items to the DPRK, directly or indirectly:

(a) battle tanks, armoured combat vehicles, large calibre artillery systems, combat aircraft, attack helicopters, warships, missiles or missile systems, or related material and spare parts, or other arms and related material as determined subsequently by the Security Council of the UN;

(b) goods contributing to the DPRK's weapons program, as listed in UN documents S/2006/814, S/2006/815 and S/2006/853; and

(c) luxury goods, such as jewellery, gems, precious metals, watches, cigarettes, alcoholic beverages, perfume, designer clothing and accessories, furs, sporting goods, private aircraft, gourmet foods and ingredients, lobster, computers, televisions and other electronic devices.

4. These regulations prohibit a person in Canada and Canadians outside Canada from importing, buying or procuring the following items:

(a) battle tanks, armoured combat vehicles, large calibre artillery systems, combat aircraft, attack helicopters, warships, missiles or missile systems, or related material and spare parts, or other arms and related material as determined subsequently by the Security Council of the UN; and

(b) goods contributing to the DPRK's weapons program, as listed in UN documents S/2006/814, S/2006/815 and S/2006/853.

5. No person in Canada and no Canadian outside Canada shall knowingly do anything that causes, assists or promotes, or is intended to cause, assist or promote, any act or thing covered by paragraphs 3 and 4 above (as prohibited by sections 3 and 5 of the DPRK Regulations).

Note of Caution

6. Border services officers are to contact FAITC to determine whether specific goods may be exported (or otherwise go) to the DPRK, or be imported (or otherwise come) from the DPRK. This also applies to any questions regarding definitions (i.e., luxury goods, arms and related material, and goods contributing to the DPRK's weapons program) or other areas where interpretation may be required.

7. This notice provides only a brief summary of your obligations under the Regulations. CBSA recommends that you consult the Regulations for further details. The complete text of these regulations and related prohibitions may be found on FAITC's Web site at www.dfait.gc.ca.
