## Information you need to calculate a reduction

The **acquisition date** is the date the trust last acquired or reacquired a property, or December 31, 1971, whichever is later. For the purpose of the calculation below, the trust is not considered to have disposed of and immediately reacquired the property as a result of the capital gains election.

**Note**: If the trust was not a resident of Canada during the entire period it owned the designated property, contact us at **1-800-959-8281**. The period of non-residence may reduce or eliminate the availability of the principal residence exemption.
