Wage Settlements

Wage Settlements Covering 500 or More Employees

April 2007

Major collective bargaining settlements reached in April 2007 provided base rate wage increases averaging 2.8% annually over the term of the contracts. These results are based on a review of 41 settlements with a coverage of 240,310 employees.


When the parties to these settlements previously negotiated, the resulting wage adjustments averaged 2.5%, a lower average than in current settlements. Contract duration in April 2007 averaged 38.7 months, compared to 37.8 months in the previous round of settlements.

In April, wage adjustments in the public sector averaged 2.7% for 74,210 employees in 12 agreements. Private-sector wage adjustments averaged 2.9% for 166,100 employees in 29 agreements.


The public-sector figures were influenced by a Canada Post agreement providing 48,000 mail carriers and inside workers with wage adjustments averaging 2.6%. The private-sector results were influenced in large part by 3 Quebec construction agreements, providing 128,310 employees with wage increases averaging 2.9% (2 contracts averaging 2.8% and 1 (roadworks) at 3.5%). These 3 major contracts in the Quebec construction industry and the Canada Post agreement accounted for 73% of the total employee coverage in major settlements.

On an industry basis, wage adjustments ranged from a low of 2.6% in both transportation and the information and culture sectors to 3.6% in the finance sector; the largest concentration of agreements and employees was in construction with wage adjustments averaging 3.0%. On a jurisdiction basis, wage adjustments ranged from a low of 2.0% in New Brunswick to 4.2% in Nova Scotia; the largest concentration of employees was in Quebec, where wage adjustments averaged 2.9%.

The employee coverage in April's major settlements was larger (almost double) than the coverage for the first quarter of 2007. Wage increases in the first quarter of 2007 averaged 3.1% for 126,895 employees in 44 major settlements. Wage adjustments in April dampened the overall year-to-date figure for 2007; wage adjustments in the first 4 months of 2007 (January through April) averaged 2.9% for 367,205 employees in 85 settlements.



Approximately 93% of employees covered in April settlements received increases in the 2.5 to 3.5% range; 4.7% received wage adjustments below that range and 2.5% were above it.



From January to April 2007, approximately 85% of all employees received wage adjustments in the 2.5 to 3.5% range; 6.7% received wage adjustments below that range and 8.6% were above it. Last year, 46% of all employees received wage increases in the 2.5 to 3.5% range, 44% were below that range, and 10% were above it.
