

# Substantial Similarity of Personal Information Protection Act

## October 25, 2004

The federal Cabinet has exempted any organization to which British Columbia's *Personal Information Protection Act* (PIPA) applies from application of the federal *Personal Information Protection and Electronic Documents Act* (PIPEDA) "in respect of the collection, use and disclosure of personal information that occurs within the Province of British Columbia."

The Cabinet order making this exemption came into force on October 12, 2004.

PIPEDA continues to apply to any "federal work, undertaking or business" as defined in section 1 of PIPEDA.

## ORGANIZATIONS IN THE PROVINCE OF BRITISH COLUMBIA EXEMPTION ORDER

### EXEMPTION

1. An organization, other than a federal work, undertaking or business, to which the Personal Information Protection Act, S.B.C. 2003, c. 63, of the Province of British Columbia, applies is exempt from the application of Part 1 of the Personal Information Protection and Electronic Documents Act, in respect of the collection, use and disclosure of personal information that occurs within the Province of British Columbia.
