**LEGISLATIVE ASSEMBLY OF NEW BRUNSWICK  
MEMBERS' INDEMNITIES AND ALLOWANCES  
AS AT JANUARY 1, 2007**

**Committee Allowances:**

Each Member (excluding Cabinet Ministers) who is a member of a Standing or a Select Committee of the House is eligible for the following (for each day on which the House is not sitting and the Member attends a Committee meeting):

- a non-accountable expense allowance, currently \$250 (\$300 for the committee chair) if the Member's residence is greater than 50 kilometres from Fredericton or \$170 (\$220 for the committee chair) if the Member's residence is less than 50 kilometres from Fredericton; and,
- a kilometric allowance per kilometre (if eligible).

**Sessional Allowances:**

During the period that the House is in session, each Member (excluding Cabinet Ministers) is eligible to receive the following:

- an accommodation allowance (currently \$70.00) for each day that the House is in session, if the Member's residence is greater than 50 kilometres from Fredericton;
- a subsistence allowance (currently \$40.00) for each day that the House is in session; and,
- a kilometric allowance per kilometre (if eligible). One trip from the Member's residence to Fredericton is allowed for each week the House is in session. If a Member's residence is less than 50 kilometres from Fredericton, the kilometric allowance is claimed daily instead of the accommodation allowance.

**Intersessional Travel Allowances:**

Each Member (excluding Cabinet Ministers) is eligible to claim travel costs for trips between the Member's home and Fredericton when the Legislative Assembly is not in session, up to a maximum of thirty-five (35) trips per fiscal year. The allowances that may be claimed are:

- a non-accountable expense allowance for each travel trip between the Member's home and Fredericton, currently \$250.00 if the Member's residence is greater than 50 kilometres from Fredericton or \$170.00 if the Member's residence is less than 50 kilometres from Fredericton; and,
- a kilometric allowance per kilometre (if eligible).

**Kilometric Allowances:**

Members whose residence is greater than 25 kilometres from Fredericton may claim a kilometric allowance of \$0.39 per kilometre.
