For example, report the program name, such as Biochemical Technology or Business Administration, not component courses such as Chemical Calculations or Business English.</li> <li>(iii) If a program is offered in both official languages, enter enrolment and graduates for each group separately, using appropriate English and French program names.</li> <li>(iv) If a program is offered as both a one-year Certificate and a two-year Diploma, enter enrolment and graduate figures for each group separately and note the duration in column 3.</li> <li>(v) Foreign student enrolment and graduates should be shown separately and also included in the total enrolment and graduate counts.</li> <li>(vi) Report the number of students who graduated during the academic year which ended in the spring of the year for which fall enrolment figures are being reported. <p><b>Full/part-time:</b> As there is no commonly accepted definition of a part-time student, please report registration status as defined by the respondent college.</p> <p><b>Career programs:</b> Career programs require secondary school completion or equivalent to enter, and are at least one academic year in duration (24 weeks or more).</p> <p><b>University level programs:</b> University level programs require a secondary school completion for entrance and consist of university transfer programs that provide a student with a standing equivalent to the first or second year of a degree program. In addition, however, some colleges and</p>	<p>university colleges offer three, four and five year degree and applied degree programs.</p> <p><b>Trade/vocational programs:</b> Trade/vocational programs in the past were generally not part of the survey request. However, if the program now requires a secondary school completion, as a result of changing entrance requirements, and is at least one academic year in duration, it should be included in the survey.</p> <p><b>Foreign students:</b> Students studying in Canada with a student authorization or special visa. Do not include Canadian citizens or permanent residents.</p>
