

## **About the OHS Guideline “Numbering”**

Guidelines are indexed to the divisions of Part 3 of the *Workers Compensation Act*, or to parts of the *OHS Regulation*. A guideline related or linked to a section of the *Act* is indexed as “G-Dx-yyy-z”. The “G” prefix identifies it as being a “Guideline”, rather than a Prevention Manual policy which uses a similar indexing system (which appears as “Dx-yyy-z”). The “Dx” portion means the relevant section of the *Act* is in division “x” of Part 3 of the *Act*. The “yyy” number identifies the section number in the *Act*. A number in the “z” space is used when necessary to differentiate between two or more guidelines related to section “yyy”. For example, a guideline with the number G-D3-115-2 would be one of at least two guidelines related to section 115 of the *Act*. Section 115 is found in Division 3 of Part 3 of the *Act*.

A guideline related to a part of the *OHS Regulation* is indexed as Gx.yyy-z”. “Gx” means the guideline relates to Part “x” of the *Regulation*. “x.yyy” is the *Regulation* section number. A number in the “z” space is used when necessary to differentiate between two or more guidelines related to section “x.yyy” of the *Regulation*. For example, a guideline with the number G4.9-2 would be one of at least two guidelines related to section 4.9 of the *OHS Regulation*. Section 4.9 is found in Part 4 of the *Regulation*.

Following as Appendix A is a list of the Divisions in Part 3 of the *Workers Compensation Act*, and as Appendix B, a list of the parts (or general table of contents) of the *OHS Regulation*. Not all divisions or parts have guidelines currently issued.
