The ILRR Change to User Authorization Form is used to request a change to the existing user authorization to “restricted” sensitive records. **Each user must complete the form using the following instructions:**

1. Identify the sensitive interest Data Access Group Name (from list above). For example, if user needs higher level access to Archaeology data – 160A is the appropriate group.
2. Provide the reason the user will require access to the sensitive record (codes are noted below):

A-Job Requirement to status land	B-Job Requirement to Administer/regulate rights on land
C-Job Requirement for land planning	D-Job Requirement to negotiate interests on land
E-Job Requirement to process referrals	O-Other (Please explain).

3. For each sensitive interest record, insert the access level code desired (codes in table, above right). For example user may need access to Archaeology geometry, in order to get this access the user would request – E (existence).
4. Read the attached appendices (Appendix A – Archaeology)
