## Role of the School Trustee

The school trustee represents the educational needs of the students and parents in the area that the board or district represents. Trustees participate actively in decisions of the school boards. Provincial law describes the responsibilities of the school trustee as:

- to attend meetings of the school boards and exercise the powers and the duties of a trustee in good faith.
- to comply with the requirements of the regulations concerning conflict of interest; and
- to comply with all the requirements of the *School Act*, School Board Regulations, as well as the Minister's Directives.

The trustee is not only a decision maker, acting in concert with the other trustees on the board, but also acts as an agent of the Minister of Education to ensure that the *School Act*, School Board Regulations and Minister's Directives are followed.

## Responsibilities

As noted in the *School Act*, the responsibilities of school boards are:

- to provide instruction in an educational program to all those enrolled and eligible.
- to provide for the management of staff and staff development needs.
- to provide for and manage facilities and equipment.
- to provide transportation for students.

- to manage the financial affairs of the school board.
- to monitor and evaluate the effectiveness of schools.
- to ensure the development and approval of school improvement plans.
- to encourage good relations among schools, parents and the community, and to promote awareness of the importance of education.

## Qualifications

The *School Act* requires that a school trustee must be:

- a Canadian citizen, 18 years of age or more on election day; and
- a resident in the school unit for at least six months prior to election day;

and cannot be an employee of any school board or the Department of Education.

A French Language School Board trustee must meet **one** of the following qualifications:

- must be the parent of a student receiving French first language instruction on PEI, or
- must be eligible to have a child receive French first language instruction, or
- must be eligible to have a child receive French first language instruction, if the candidate had a child.

## ***Nomination Process***

To be nominated as a candidate for school trustee, you must obtain the signatures of any 10 or more persons who also meet the trustee requirements, namely: Canadian citizens who are at least 18 years of age on or before the date of election, May 30, and who have been a resident in the board or district for at least six months. Please note that these 10 or more persons (nominators) must nominate a candidate for school trustee for the zone in which the nominators reside.

The nomination is made by filing, with the zone returning officer, a nomination paper in the form approved by the chief electoral officer, at any time between the beginning date of the election campaign (Monday, May 2) and 4 p.m. on nomination day (Friday, May 13). Nomination day will be Friday, the 17<sup>th</sup> day before ordinary polling day.

Following nomination day, the chief electoral officer determines the eligibility of candidates. The names of all eligible candidates will be published in provincial newspapers. ## ***Length of Term***

A school trustee is elected for a three year term. Where an election produces fewer than the prescribed number of trustees of a school board, the Lieutenant Governor in Council shall appoint, from those eligible to be candidates, the additional members necessary.
