IN THE MATTER OF Statutes of British Columbia Bill 18 - 2003

And

Commission Order 06-02 regarding an Application by British Columbia Ferry Services Inc. To reduce service on Designated Routes 10 and 11

BEFORE: Martin Crilly, Commissioner on July 14th, 2006

ORDER

WHEREAS:

- A. British Columbia Ferry Services Inc. ("BC Ferries"), in a letter dated May 10, 2006 (attached), applied to the Commissioner for authorization to reduce service on the above designated routes, pursuant to section 43 of the Act, for the period from May 18, 2006 to September 30, 2006 inclusive. BC Ferries has a contractual obligation under the Coastal Ferry Services Contract with the Province of British Columbia to provide core services, including service on the above two routes;
- B. BC Ferries provided a reduced service on the two routes, authorized by Commission Order 06-01, after the Queen of the North sank on March 22, 2006 until the return to service of the Queen of Prince Rupert on April 19, 2006. From that date to May 17, 2006 core service levels under the Coastal Ferry Services Contract were met through the use of the Queen of Prince Rupert as a replacement for the Queen of the North;
- C. BC Ferries advised the Commissioner, in its letter of May 10, 2006, of efforts to obtain a suitable replacement vessel for the Queen of the North and stated its conclusion that it was unlikely a replacement vessel would be available for service on the two routes for summer 2006;
- D. By Order 06-02 the Commissioner authorized a reduction in service for the period from May 18, 2006 to July 16, 2006, allowing time for an examination of BC Ferries search efforts to obtain a suitable replacement for the Queen of the North to permit the resumption of full summer service on the two routes in 2006;
- E. Under Section 43 (2) of the *Coastal Ferry Act* a ferry operator making an application to the Commissioner must justify a requested reduction in service and, under Section 43(3) the Commissioner may authorize a reduction "if the Commissioner is of the opinion that the reduction is for a temporary period and is for an extraordinary situation". Under

- Section 43(4) the Commissioner may authorize a reduction in service on a designated ferry route and may specify the period and terms and conditions of such reduction;
- F. If a reduction in service is authorized under Section 43, the Commissioner must, under Section 45 of the Coastal Ferry Act, review the price cap for the applicable route group and may adjust the price cap in the manner and to the extent considered reasonable;
- G. The Commissioner has examined, with the assistance of independent knowledgeable consultants, BC Ferries' efforts to obtain a replacement vessel for the Queen of the North for use in summer 2006;
- H. Based on the consultants' findings the Commissioner is satisfied that BC Ferries:
 - undertook a search for a replacement vessel within a very short time after March 22, 2006; and
 - made a thorough search for a suitable replacement vessel in a systematic and competent manner;
- I. The Commissioner has concluded that BC Ferries has made an adequate search for a replacement vessel for the Queen of the North, that a further extension of time in the reduction of service for routes 10 and 11 is justified under Section 43(3), and that the reduction in service is for a temporary period and is for an extraordinary situation;

NOW THEREFORE the Commissioner orders as follows:

- 1. An extension of the reduction in service previously authorized in Order 06-02 on Routes 10 and 11 is now authorized, pursuant to Section 43 (4) of the Act, to the service levels set out in Appendix A (attached) of the letter dated May 10, 2006 from BC Ferries, commencing July 17, 2006 until the end of summer service on September 30, 2006;
- 2. No adjustments are ordered to the price cap for the Northern route group; and
- 3. BC Ferries should continue to review options to engage alternative service providers to restore any portion of the reduced service levels, including alternative means of moving traffic.

SUBJECT: Request for Reduction of Service under Section 43 of CFA

On April 24, 2006, the BC Ferries Commissioner, under Order 06-01, authorized a reduction in service on Routes 10 and 11 for the period March 22, 2006 to May 17, 2006, inclusive. This authorization was made pursuant to section 43 of the *Coastal Ferry Act* which states:

43 (1) A ferry operator must not, except as permitted by the applicable Coastal Ferry Services Contract, reduce service on a designated ferry route below the core ferry services required for that designated ferry route unless the ferry operator first obtains the authorization of the commissioner.

Since the return to service of the Queen of Prince Rupert on April 19, 2006, BC Ferries has met core service levels on Routes 10 and 11. Effective May 18, 2006, core service levels under the Coastal Ferry Services Contract change to reflect the commencement of the spring season and envisage a two vessel operation on Routes 10 and 11. Despite significant effort, BC Ferries has been unable to find a replacement vessel to the Queen of the North and will not be in a position to meet core service levels on these routes for the period May 18, 2006 to September 30, 2006.

In response to the sinking of the Queen of the North, BC Ferries has assembled a team to identify potential replacement vessels worldwide that may have been suitable for the northern service. Of the 100 vessels that were initially identified by the team (or referred to the team by brokers, owners, or other interested parties from around the world), BC Ferries narrowed this down to a limited number of vessels based on Transport Canada stability issues, the condition and/or availability of the vessel. Of those identified as potentially suitable, BC Ferries then viewed each vessel. The Company continues to actively search the market for a suitable vessel. At this BC Ferries has concluded, however, that it is unlikely that a replacement vessel will be available to be brought into service for summer 2006.

Appendix A contains the detail of service that will be provided by BC Ferries on Routes 10 and 11 during spring and summer, 2006.

BC Ferries is requesting that pursuant to Section 43 of the CFA, the BC Ferries Commissioner authorize a reduction in service on Routes 10 and 11, to the service level set out in Appendix A for the period May 18, 2006 to September 30, 2006 inclusive.

BC Ferries has been in contact with stakeholders that would be affected by these changes, including, the local communities, the Ferry Advisory Committees and tourism associations. Going forward, BC Ferries will ensure open communications continue with the stakeholders impacted by this service.
