E-1	Election Act (Section 119 - Discretionary reporting by the CEO however; once the report is received by the Speaker it must be tabled.)
E-6.02	Employment Development Agency Act (Pursuant to Section 70(5) of the Financial Administration Act, the EDA must submit an annual report)
E-7	Energy Corporation Act (Section 10 - Annual Report)
E-9	Environmental Protection Act (Section 4(9) on tabling of

- F-6 Fathers of Confederation Buildings Act (Section 13 requires the tabling of Annual report of the Fathers of Confederation Buildings Trust.)

 Section 37.1(2) on transfers of monies
 Section 47 on short term borrowing

- G-5 Grain Elevators Corporation Act (Section 11 requires tabling of the annual report)
- H-6 Holland College Act (Section 13 requires the tabling of an annual report)
- H-11.1 Housing Corporation Act (Section 13 requires the tabling of an annual report)
- I-10.1 Island Investment Development Act (section 70(5) of the FAA requires the tabling of an annual report)
- L-5 Lands Protection Act (Section 17(2) requires exemptions to be tabled)
- L-7 Legislative Assembly Act (Section 46(7) requires the tabling of the annual report of the MLA Salaries and Indemnities Commission
- L-14 Liquor Control Act (Section 87(4) requires annual reports from the Commission to be tabled in the House.)
- L-17 Lotteries Commission Act (Section 14 requires an annual report to be tabled)
- L-18 Lucy Maud Montgomery Foundation Act (Section 12 requires an annual report to be tabled)
- M-1.3 Maritime Province Harness Racing Commission Act (Section 18(3) requires the tabling of an annual report)
- M-2 Maritime Provinces Higher Education Commission Act (Section 19(4) requires an annual report to be tabled)

- M-14 Museum Act (Section 13(2) requires an annual report from the Museum and Heritage Foundation to be tabled)
- N-3 Natural Products Marketing Act (Section 2(11) requires the tabling of an annual report from the PEI Marketing Council)
- P-8 Planning Act (Section 28(1.2) requires the tabling of certain Executive Council Orders)
- P-25 Provincial Court Act - Section 17 enables EC to make regulations relating to judicial remuneration. EC543/97 establishes a Judicial Remuneration Commission and the Commission must make its report to the Assembly for determination.
- P-29 Public Departments Act (Section 5(2) requires the tabling of Executive Orders effecting transfers and amalgamation of public departments)
- P-31.1 Public Libraries Act (Section 6 requires the tabling of an annual report from the Provincial Library Service)
- P-34 Public Works Act (Section 8 requires the tabling of all expenses incurred in public works projects)
- R-12 Rehabilitation of Disabled Persons Act (section 5 requires an annual report on the administration of the Act)
- R-15 Roads Act (Section 8 requires the tabling of a report on all road work on which public monies have been expended)
- S-2.1 School Act (Section 10 requires the tabling of an annual report from the Minister and the school boards)
- T-1 Teachers' Superannuation Act (Section 3(5) requires the tabling of a report from the Teachers' Superannuation Commission)
- U-3 Uniformity Commissioners Act (Section 3 requires the reporting of all transactions and recommendations of the Board of Commissioners)
- U-4 University Act (Section 19(2) requires an annual report from the UPEI Board of Governors)
- V-3.1 Victims of Crime Act (Section 36(3) requires a report on the administration of the Victims of Crime Program)
- W-3 Welfare Assistance Act (Section 10 requires an annual report on the administration of the Act)
