MOTIONS OTHER THAN GOVERNMENT:

Honourable Olive Crane moved, seconded by Jim Bagnall, the following Motion for a Resolution (Motion No. 5):

WHEREAS Prince Edward Island has a long and proud tradition of military service;

AND WHEREAS these brave men and women risk, and sometimes forfeit, their lives when asked to serve our country;

AND WHEREAS the 140 members of the Prince Edward Island Regiment come from all walks of life;

AND WHEREAS this year 15 members of the Prince Edward Island Regiment completed a six- month tour of military service in Afghanistan;

AND WHEREAS the province of Prince Edward Island does not have any legislation in place to protect the interests of Prince Edward Island Reservists and employers;

THEREFORE BE IT RESOLVED that members of this Assembly direct government to consult with interested parties and introduce legislation that would accommodate the interests of both the Prince Edward Island Reservists and employers.

Debate was commenced by the Mover (3:20); continued by the Seconder (3:35); and Honourable Carolyn Bertram (Communities, Cultural Affairs and Labour); who moved, seconded by the Hon. Premier, the following amendment:

THEREFORE BE IT RESOLVED that the Members of this Assembly unanimously embrace the spirit of this debate and agree to dissolve this House into the Committee of the Whole and move to Second Reading of *An Act to Amend the Employment Standards Act* (job protection for reservists).

Honourable Madam Speaker advised that the amendment was not in order as the question presently before the House was in the form of a motion. The House may only have one question under consideration at any one time, therefore it would have to first come to some decision on the motion before the House (pass the motion, defeat the motion or adjourn debate) before moving on to new business such as the consideration of a bill. The amendment as put would not bring debate on the question before the House in the form of a motion to conclusion and would, if passed, move the House to immediately to other proceedings without dispensing with the question before it. As a result, Madam Speaker ruled the amendment out of order.

Debate was motion was then resumed by Honourable Premier; there being no further speakers, the Mover closed the debate.

THEREFORE BE IT FURTHER RESOLVED that this Assembly urge Islanders to utilize the Confederation Trail to promote healthy lifestyles, education and discovery.
