MOTIONS OTHER THAN GOVERNMENT:

Honourable Olive Crane moved, seconded by Michael Currie, the following Motion for a Resolution (Motion No. 12):

WHEREAS the contributions of Prince Edward Island youth have a lasting impact on the fabric of our society;

AND WHEREAS communities from across Prince Edward Island have a strong tradition of supporting our youth;

AND WHEREAS volunteer groups, including recreational, cultural, service, social, business, educational and spiritual organizations, continue to provide many opportunities for the positive development of our youth;

AND WHEREAS the Official Opposition of Prince Edward Island supports numerous youth-based initiatives promoting leadership development, community involvement and healthy lifestyles;

THEREFORE BE IT RESOLVED that members of the Legislative Assembly of Prince Edward Island encourage all Islanders to recognize the unique and valuable contributions of our youth and future community leaders;

THEREFORE BE IT FURTHER RESOLVED that the Government of Prince Edward Island develop a long-term strategy to meet the needs of today's youth.

Debate was commenced by the Mover (3:16); continued by Jim Bagnall (Montague-Kilmuir) (3:46); Cynthia Dunsford (Stratford-Kinlock) (4:06); Honourable Doug Currie (Health, Social Services and Seniors) (4:10); Honourable Richard Brown (Development and Technology) (4:12); Honourable Carolyn Bertram (Communities, Cultural Affairs and Labour) (4:19); Robert Henderson (O'Leary-Inverness) (4:24); and Robert Mitchell (Charlottetown-

Sherwood) (4:31).

There being no further speakers, the Mover then closed the debate.

Honourable Madam Speaker put the Question which was **CARRIED UNANIMOUSLY** and resolved accordingly.

Honourable Olive Crane moved, seconded by Michael Currie, the following Motion for a Resolution (Motion No. 8):

WHEREAS Maritime Electric has applied to the Island Regulatory and Appeals Commission for price increases ranging from 9 to 19 percent;

AND WHEREAS the provincial government is considering the implementation of the Harmonized Sales Tax which will add a further increase of 8 percent to electricity rates;

AND WHEREAS higher electricity rates and the addition of a provincial tax on electricity will place an onerous burden on Prince Edward Island families and business owners;

AND WHEREAS the Harmonized Sales Tax will eliminate the tax-free benefit Prince Edward Island families and businesses enjoy under the current tax structure;

AND WHEREAS other tax measures which encourage the use of renewable energy include a PST rebate on hybrid vehicle purchases and PST-free status on household renewable energy equipment which will be jeopardized under a Harmonized Sales Tax;

AND WHEREAS the elimination of these tax incentives would serve to discourage increased use of renewable energy;

AND WHEREAS until recently, Prince Edward Island was recognized as a leader in the development of renewable energy projects in North America, becoming the first Canadian province to produce 15 percent of its electricity from renewable energy sources;

AND WHEREAS the Liberal administration will no longer take the lead in the future development of renewable energy projects;

THEREFORE BE IT RESOLVED that the members of this Assembly urge the provincial government to reclaim its leadership role in the development of renewable energy, thus reducing energy costs for all Islanders.

Debate was commenced by the Mover (4:38); continued by the Seconder (4:57); and, on his Motion, debate was adjourned.
