#### ORDER

### WHEREAS:

- A. On September 27, 2007 Planet Energy (B.C.) Corporation ("Planet") applied to the Commission for a Gas Marketer's Licence. The application included the payment of the \$1,000 application fee and a \$250,000 Letter of Credit pursuant to the requirements of Item 3 of the Licence application form; and
- B. The Commission has reviewed Planet's application and relying upon the information and representations made by Planet, finds that approval of a Gas Marketer Licence subject to conditions is warranted.

**NOW THEREFORE** pursuant to section 71.1(6) of the Utilities Commission Act the Commission orders as follows:

- 1. The Commission issues to Planet a Gas Marketers Licence for the period November 1, 2007 to October 31, 2008.
- 2. The Licence is subject to the following conditions:
  - 2.1 Planet will carry out the undertakings as set out in the application for a Licence to Market Natural Gas dated September 27, 2007 and the Rules for Gas Marketers.
  - 2.2 Planet will comply with the Code of Conduct for Gas Marketers and Rate Schedule 36 of Terasen Gas Inc.

- 2.3 Planet will maintain a Letter of Credit or acceptable substitute in full force and effect for the duration of the Licence.
- 2.4 Planet will maintain a Working Capital position of at least \$50,000 and a Current Ratio of current assets to current liabilities of at least 1.10.
- 2.5 The Commission may, at any time and without prior notice to Planet, withdraw the Gas Marketer Licence for reasons the Commission, in its sole discretion, deems and considers sufficient.
- 2.6 The Gas Marketer Licence and all copies of it shall remain the property of the Commission and Planet will return these documents forthwith upon written request from the Commission.
