INITIATIVE PROPONENT APPOINTMENT OF FINANCIAL AGENT - FORM 915

INSTRUCTIONS

An initiative proponent must deliver a copy of this appointment form to the Chief Electoral Officer (*Recall and Initiative Act*, sections 30 and 61).

PART A

1. Make a check mark in the appropriate box to indicate if the proponent is acting as their own financial agent or if another individual is being appointed as financial agent.
2. **Title of Initiative:** Enter the title of the initiative.
3. **Full Name of Proponent:** Enter the full name of the proponent for whom the financial agent is being appointed.

PART B

4. **Financial agent name and address:** Enter the financial agent's name, mailing address, phone numbers and fax number.
5. **Effective date of appointment:** Enter the date on which the individual assumed the position of financial agent.
6. **Signature of financial agent:** The individual being appointed must sign and date this declaration.

Note: The financial agent is responsible for administering the proponent's finances in accordance with the *Recall and Initiative Act*. For more information on the obligations of the financial agent, refer to Parts 4 and 5 of the *Recall and Initiative Act*.

The following individuals are disqualified from acting as financial agents:

- election officials, voter registration officials, or employees of Elections BC;
- individuals who do not have full capacity to enter into contracts;
- individuals who are disqualified (sections 53, 56, 79, or 82 of the *Recall and Initiative Act*);
- individuals who have been convicted of an offence under the *Recall and Initiative Act* or the *Election Act* within the last 7 years.

7. **Communication address and phone number:** Enter the address to which notices under the *Recall and Initiative Act* may be delivered to the financial agent or proponent.
8. **Signature of proponent:** The proponent must sign and date this declaration.
