Dear Madam Speaker:

I have the honour to submit the Report of the Chief Electoral Officer pursuant to Section 122 of the Election Act, R.S.P.E.I. 1974, Cap. E-1 as amended by S.P.E.I. 1984, Cap. 19.

In my report to the Legislative Assembly on the provincial general election of 27 September 1982, my main recommendation was that the Election Act should be amended to provide for an enumeration before every general election. Recommendations with respect to the use of the Social Insurance Number, proxy voting, and advance polls were also made. The Legislative Assembly saw fit to appoint a Committee of the House to study these and other recommendations. As a result of the Committee's deliberations, amendments were passed and proclaimed in force effective 29 September 1984.

I am pleased to report that the amendments have made the conduct and administration of an election much easier. In particular, providing for an enumeration before every election ensures up-to-date lists of electors and, thereby, reduces the workload for all parties involved in the electoral process.

A Writ of Election was issued on the 29th of October 1984 with Polling Day on the 26th of November 1984 to fill the vacant Assemblyman seat in the Fourth Electoral District of Kings.


It is interesting to compare the number of rejected ballots in this by-election with the number in the 1979 and 1982 general elections for the Fourth Electoral District of Kings (Assemblyman). The following chart illustrates my point.

Is it possible that having to cast two ballots (one for Councillor and one for Assemblyman) in the general elections results in confusion on the part of some electors?

I also wish to inform you, Madam Speaker, that I have submitted my resignation as Chief Electoral Officer to Premier James Lee. It is my opinion that the positions of Deputy Attorney General and Chief Electoral Officer are not compatible and that some other person should be appointed Chief Electoral Officer. I am, of course, prepared to assist the new Chief Electoral Officer in assuming his or her new duties. Accordingly, I would like to express my appreciation to the Members of the Legislative Assembly for their assistance and co-operation in performing my duties since I have been Chief Electoral Officer. In particular, I wish to express my appreciation to the sixteen Returning Officers, each of whom has worked long hours and, with efficiency and impartiality, administered elections in their respective electoral districts. The Province is well served by such able men and women.
