MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Mr. Mitchell (Motion #74)

THAT this House urges the Government of Yukon to take immediate action to address the serious environmental and economic effects of climate change on the Yukon.

2. Mr. Edzerza (Motion #26)

THAT this House urge the Yukon Government to assign the highest possible priority to expediting the review of the *Children's Act* so that the recommendations from the working group can be embodied in a new Act that reflects Yukoners' concerns without any further delay.

3. Mr. Cardiff (Motion #5)

THAT this House establish, pursuant to Standing Order 45(4), a Select Committee of the Legislative Assembly, consisting of equal representation from all three party caucuses in addition to a non-voting chair, to examine, consider and recommend options for territorial "whistleblower protection" legislation to be introduced no later than the 2008 Fall Sitting; and

That one of the primary duties of this committee shall be to ensure that the needs and wishes of workers are fully considered in the development of such legislation through meaningful consultation with employees and their representatives.

THAT this House urges the Government of Yukon to work collaboratively with the Government of Canada, the Government of the Northwest Territories, the Porcupine Caribou Management Board, all affected First Nations in Yukon and the Northwest Territories, and stakeholders, to develop a Porcupine Caribou Herd Harvest Management Strategy that ensures to the greatest extent possible, the conservation and protection of the Porcupine Caribou Herd.

2. Hon. Mr. Cathers (Motion #70)

THAT the honourable Members Hon. Brad Cathers, Hon. Elaine Taylor, Steve Nordick, Don Inverarity and John Edzerza be appointed to the Standing Committee on Appointments to Major Government Boards and Committees established pursuant to Standing Order 45.

3. Hon. Mr. Cathers (Motion #73)

THAT this House establish an all-party Select Committee on Anti-Smoking Legislation, with a mandate including touring the Yukon to consult with the public on legislative options for banning smoking in public places; and

THAT the motion establishing such a Committee be tabled and called for debate during the 2007 Spring Sitting of the Legislative Assembly, thus enabling consultation to be carried out in 2007.

MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Mr. Mitchell (Motion #88)

THAT this House urges the Government of Yukon to take immediate action to ensure the uninterrupted provision of dental services in Yukon communities.

2. Mr. Cardiff (Motion #89)

THAT this House urges the Yukon Government to immediately begin a process to amend the *Access to Information and Protection of Privacy Act*, including a review of the recommendations by the former Information and Privacy Commissioner, and to invite all persons who have used the Act to provide information in confidence regarding their experience with the Act and its administration.

3. Mr. Elias (Motion #90)

THAT this House urges the Government of Yukon to comply with the *Environment Act* section 46, sub-section 1, and table the Annual Report of the Yukon Conservation Strategy Council where the council reports on its annual review of the performance of the Government of Yukon in the implementation of the Yukon Conservation Strategy.

4. Mr. Inverarity (Motion #91)

THAT the Chair of the Yukon Workers' Compensation Health and Safety Board and the President of the Yukon Workers' Compensation Health and Safety Board appear as witnesses in Committee of the Whole during the 2007 Spring Sitting of the Legislative Assembly.

5. Mr. Edzerza (Motion #92)

THAT this House urges the Yukon Government to promote organ and tissue donations through a campaign of public awareness, including information about the organ and tissue donation option on their Yukon Health Care cards, and to give Yukoners the additional option of indicating on the drivers' licences that their organs or tissues may be used after death to help others who need them.

6. Mr. Edzerza (Motion #93)

THAT this House urges the Yukon Government to publicly report territorial statistics on alcohol consumption community-by-community, on a monthly basis, to determine what impact, if any, tourism has on such an unacceptably high rate of consumption.
