

Under the Natural Products Marketing Act, R.S.P.E.I. 1988, Cap. N-3, the Prince Edward Island Potato Marketing Plan Regulations, and the Agricultural Products Marketing Act (Canada), the Prince Edward Island Potato Board makes the following Order:

## DETENTION AND SEARCH OF VEHICLES ORDER

1. This Order applies to the operation of the Potato Quality Monitoring and Application Inspection facility in Borden-Carleton, and to the detention and search of vehicles at the Borden-Carleton and Wood Islands weigh scales for the purpose of ascertaining whether or not potatoes are being transported in violation of orders of the Prince Edward Island Potato Board.

2. In this Order the words used shall have the meanings set forth in the Definitions Natural Products Marketing Act, R.S.P.E.I. 1988, Cap. N-3 and regulations made thereunder and the Prince Edward Island Potato Marketing Plan Regulations.

3. All vehicles carrying potatoes that will exit Prince Edward Island via the Authority to require Confederation Bridge must report to the Potato Quality Monitoring and Inspection facility in Borden-Carleton prior to proceeding to the Borden-Carleton weigh scales.

4. The staff of the Board, and employees of the Canadian Food Inspection Authority to detain and search Agency, are authorized to:

- detain any vehicle which such staff and/or employees have (a) reasonable grounds to believe is transporting potatoes produced in Prince Edward Island;
- (b) require the driver of such vehicle to produce documentation to establish that the potatoes/potato packages are being transported in compliance with orders of the Board;
- (c) search the vehicle for the purpose of locating and identifying all potatoes/potato packages being transported and ensure that such

vehicles to report to Borden facility

vehicle is transporting potatoes/potato packages in compliance with the orders of the Board; and

- (d) inspect the potatoes/potato packages contained therein; and
- (e) seize and detain all potatoes/potato packages being transported in violation of orders of the Board, and issue a Notice of Detention in the form attached as Schedule A.

5. Board staff and/or employees of the Canadian Food Inspection Agency Detained potatoes detaining potatoes/potato packages according to Section 4 or Clause 7.(2) may attach thereto a numbered detention tag in the form attached as Schedule B and no person shall sell, offer for sale, move, allow or cause to be moved the potatoes or potato packages or remove the detention tag without written authority of the Board or the Canadian Food Inspection Agency.

6. Potatoes/potato packages detained according to Section 4 or Clause Release from detention 7.(2) may be released from detention once Board staff and/or employees of the Canadian Food Inspection Agency are satisfied that such potatoes or potato packages have been brought into compliance with the provisions of the Board Orders and have issued a Release from Detention Notice in the form attached as Schedule C.

7.(1) The employees of the Department of Transportation and Public Authority to detain and search and search Works employed at the weigh scales at Borden/Carleton and Wood Islands are authorized to:

- detain any vehicle which such employees have reasonable and (a) probable grounds to believe is transporting potatoes produced in Prince Edward Island;
- (b) require the driver of such vehicle to produce verification that he has reported to the Potato Quality Monitoring and Inspection Facility in Borden/Carleton (in the case of vehicles intending to exit P.E.I. via the Confederation Bridge), and documentation to establish that the potatoes being transported are being transported in compliance with orders of the Board;
- (c) if such employees have reasonable and probable grounds to believe that the vehicle is transporting potatoes in violation of orders of the Board, search the vehicle for the purpose of locating and identifying all potatoes being so transported; and
- seize and detain all potatoes being transported in violation of orders (d) of the Board, and immediately notify Board staff and/or employees of the Canadian Food Inspection Agency.
