The following order was approved by His Honour the Lieutenant Governor in Council dated 25 May 1999.

**EC1999-262**

**ENVIRONMENTAL PROTECTION ACT  
ISLAND WASTE  
MANAGEMENT CORPORATION**

1. There is hereby created a corporation named the Island Waste Management Corporation, ("the Corporation") constituted pursuant to section 18 of the *Environmental Protection Act* R.S.P.E.I. 1988, Cap. E-9.
2. The general powers of the Corporation shall be as set out in section 16 of the *Interpretation Act* R.S.P.E.I. 1988, Cap. I- 8.
3. The Corporation may acquire, construct, establish, alter, extend, control, manage, maintain or operate a waste management system to serve the province.
4. The waste management system shall be acquired, constructed, established, altered, extended, controlled, managed, maintained, or operated in substantial compliance with the requirements specified in a document entitled "Prince Edward Island Department of

Technology & Environment P.E.I. Waste Watch Management Project Request For Proposals (2nd Call) For The Development, Design, Construction, Financing, Operation And Maintenance Of A Privately Owned Waste Management Utility To Implement The Prince Edward Island Waste Management Strategy" and dated 4 February 1999.

5. Any significant departure from the requirements of the waste management system described in the said Request For Proposals (2nd Call) referred to in paragraph 4 above must be approved by the Lieutenant Governor in Council.

6. The functions of the Corporation shall include the following:

- (a) implementing the Waste Watch program across the province, including acquiring and distributing waste management carts, developing and managing waste disposal sites, conducting public education to assist citizens and agencies in effectively participating in the Waste Watch program, and engaging private operators to haul residential waste;
- (b) investigating
  - (i) the logistics of transferring waste, compostable materials and recyclable items among current and future sites; and
  - (ii) the feasibility and advisability of increasing the burning capacity of the Trigen Energy From Waste plant;

and reporting findings and recommendations through the Minister to the Lieutenant Governor in Council;

- (c) preparing a management plan respecting waste haulers;
- (d) subject to the approval of the Lieutenant Governor in Council, determining the annual fee to be charged for provision of a residential refuse collection system in the province;
- (e) developing budgets for both capital and operating expenditures, and a detailed schedule for Waste Watch implementation;
- (f) operating weigh scales at waste sites and collecting tippage fees;
- (g) establishing and monitoring quality control standards to ensure that Waste Watch requirements are being met;
- (h) conducting Environmental Impact Assessments essential for the selection or modification of waste disposal or treatment sites.

7. (1) The affairs of the Corporation shall be managed by a board of directors ("the board") consisting of five persons appointed by the Lieutenant Governor in Council.

(2) The Lieutenant Governor in Council shall designate one of the directors to be chairperson.

(3) The board shall elect a vice-chairperson and a secretary-treasurer from among its members.

(4) The chairperson shall be appointed for a term of three years, two directors shall be appointed for terms of three years and two directors shall be appointed for terms of two years. Following the initial appointments, all terms shall be for three years.

(5) Directors may be reappointed.

(6) The presence of a majority of the directors is necessary to constitute a quorum of the board.

8. The head office of the Corporation shall be in Prince Edward Island at a location to be determined by the Board.

9. Directors may be granted remuneration for their services in accordance with Treasury Board honoraria policy, and shall be entitled to reimbursement in accordance with Treasury Board travel policy for expenses incurred while attending meetings or travelling in the interests of the Corporation. Such remuneration and reimbursement shall be paid from the funds of the Corporation.

10. The voting procedure of the Corporation shall be as follows:

(a) all matters to be determined by the Corporation shall be determined by a majority vote;

(b) each director of the Corporation shall have one vote, except the chairperson who shall vote only in the case of a tied vote to break the tie.

11. (1) The Lieutenant Governor in Council may appoint a Chief Executive Officer of the Corporation.

(2) The Corporation may appoint such employees and engage such advisors and consultants as it considers necessary for the conduct of its affairs and may determine their remuneration and other terms and conditions of employment or engagement.

(3) The *Civil Service Act* R.S.P.E.I. 1988, Cap. C-14 shall not apply to any person employed or engaged by the Corporation.

12. The Corporation shall be responsible to, and shall report through, the Minister of Transportation and Public Works. The operations of the Corporation shall be monitored by the Minister of Technology and Environment pursuant to the *Environmental Protection Act* and associated waste management regulations.

13. The fiscal year of the Corporation shall be the fiscal year of the Province of Prince Edward Island.

14. All books of account, records, bank statements, documents, files and papers of the Corporation shall at all times be open to audit and inspection by the Minister of Transportation and Public Works, the Auditor General or any other person authorized by the Minister.

15. (1) A report of the affairs and operations of the Corporation, including audited financial statements, for the preceding twelve months shall be prepared annually by the board and shall be conveyed to the Minister of Transportation and Public Works for presentation to the Legislative Assembly.

(2) The accounts of the Corporation shall be audited annually by the Auditor General or a qualified auditor appointed by the Minister of Transportation and Public Works, and the results of the audit shall be published in an annual report.

16. The Corporation may enter into an agreement with the Province of Prince Edward Island respecting the collection of an annual charge to householders for the collection of refuse and the supply of refuse carts.

17. The Corporation shall not make any capital expenditure in excess of \$100,000 without the prior written approval of the Minister of Transportation and Public Works.

18. The Island Waste Management Commission, established via order-in-Council No. EC1998-300 of 28 April 1998, is hereby dissolved, and the appointments of its members hereby rescinded.

19. All staff, assets, liabilities and agreements of the Island Waste Management Commission shall be transferred to the Corporation.

20. The Corporation is the successor to the Island Waste Management Commission and any reference to the Island Waste Management Commission in an agreement or enactment shall be read and construed as a reference to the Corporation.

21. This Order comes into force effective 1 June 1999.
