## ENVIRONMENTAL PROTECTION ACT LITTER CONTROL REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 27 July 1999.)

Pursuant to section 25 of the *Environmental Protection Act* R.S.P.E.I. 1988, Cap. E-9, Council made the following regulations:

# **1.** Clause 1(k) of the Environmental Protection Act Litter Control Regulations (EC697/91) is revoked and the following substituted:

(k) "refillable container" means

refillable container

(i) a container which can be reused as a beverage container by the manufacturer and which is accepted for refilling with a beverage by the manufacturer, or

(ii) a container which is designed, according to a manufacturer's specification, for refilling with a beverage,

but does not include containers where the container or a label affixed bears the words, "non-refillable", "recyclable", "no deposit - no return", or "return for deposit where applicable";

#### 2. These regulations come into force on July 27, 1999.

## EXPLANATORY NOTE

This amendment redefines refillable container to clarify that refilling means refilling with a beverage and not another substance.

(2) The board may waive the requirement for guarantees of any or all waiver of the shareholders of a corporate borrower imposed by clause (1)(c). (3) In granting loans and taking security, the Agency Investment (a) shall take all reasonable measures to protect the investment of protection the Agency; and (b) shall not subsidize interest rates or provide any grant, subsidy or concession to any person. 5. The board shall issue final approval for write-offs, which write-offs Write-offs shall not affect any obligation of the borrower to repay the balance of any loan, together with any accrued interest, being written off. 6. A capital loan shall be repaid within any period of time the account Repayment manager responsible for the management of the loan or the Chief Executive Officer may direct, but in no case shall the period of time for repayment of a capital loan exceed 20 years. 7. For the purposes of subsection 9(2) of the Act, the interest rate policy Interest rate policy shall be (a) for operating credit and floating rate term loans, between 1% -2.75% above the Agency's floating base rate; and (b) for capital loans and leases, between 1% - 2.75% above the Agency's fixed term base rate. 8. (1) All expenses, including appraisal fees, legal fees, application fees Payment of expenses and other incidental costs that are incurred by and on behalf of a person in preparing, completing and submitting an application pursuant to subsection 9(1) of the Act for evaluation, and for the drawing of security documentation on approved and accepted loans, shall be paid by the person submitting the application. (2) All expenses, legal fees and other incidental costs that are incurred Expenses paid by by and on behalf of any existing borrower during the term of the loan, borrower shall be paid by the borrower.

**SECTION 2** provides that the maximum loan that may be approved by the board without the approval of the Lieutenant Governor in Council is \$2,500,000.

**SECTION 3** requires that any guarantee being provided by the Agency requires a resolution of the board.

**SECTION 4** specifies the minimum security to be provided in return for a loan or credit. The section also provides that the board may waive the requirement for guarantees of shareholders of a corporate borrower, and requires the Agency to take reasonable measures to protect the Agency's investment. The Agency is not permitted to subsidize interest rates or provide grants, subsidies, or other concessions.

**SECTION 5** requires the board to issue final approval for write-offs.

**SECTION 6** permits a capital loan to be repaid within any period of time not exceeding 20 years.

**SECTION 7** sets out the Agency's interest rate policy.

**SECTION 8** specifies how expenses regarding applications submitted to the Agency shall be paid.

**SECTION 9** requires the board to submit an annual audited financial statement to the Minister.

**SECTION 10** provides for definitions of the terms "agricultural sector", "fisheries and aquaculture sector", "manufacturing, processing and knowledge-based sector", "small business sector", and "tourism sector" as permitted pursuant to clause 13(c) of the Act.

**SECTION 11** revokes the Lending Authority Act Regulations.

SECTION 12 is a commencement section.

## VICTIMS OF CRIME ACT REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 27 July 1999.)

Pursuant to section 37 of the *Victims of Crime Act* R.S.P.E.I. 1988, Cap. V-3.1 Council made the following regulations:

**1.** Section **3** of the Victims of Crime Act Regulations (EC566/89) is amended by the deletion of the words "\$250" and the substitution of the words "\$1,000".

## 2. The schedule in section 4 is amended

(a) by the deletion of the heading and the substitution of the following: "Schedule of *Criminal Code* Offences"; and

#### (b) by the insertion of the following:

- 155 incest
- 249 dangerous operation of motor vehicles, vessels, and aircraft
- 252 failure to stop at scene of accident
- 253 operating while impaired
- 254 failure or refusal to provide sample
- 255 impaired driving causing bodily harm or death

**3.** The said regulations are amended by the insertion of the following:

**5.** For the purposes of subsection 25(1) of the Act, the maximum amount of compensation that may be awarded

(a) to all applicants in respect of the injury, or death of one victim is \$15,000;

(b) to all applicants in respect of one occurrence is \$30,000.

#### 4. The Victims of Crime Compensation Order (EC565/89) is revoked.

## 5. These regulations come into force on August 7, 1999.

#### EXPLANATORY NOTES

**SECTION 1** changes the prescribed amount for small claims and allows more claims to be processed in a shorter amount of time.

**SECTION 2** Reference to federal financial contributions is deleted from Schedule 1 because the federal/provincial cost-sharing agreement expired in 1992/93. Several offences are added to Schedule 1 of section 4, including incest and driving related offences.

**SECTIONS 3 and 4** revoke the existing Compensation Order (EC565/89) and establishes the maximum compensation under a regulation.
