4. Substitute the following for the definition of "Rate Class" in RSP B-3:

Rate Category      Grouping of Customers to which a specific rate schedule applies;  
e.g. Residential - Rural, Residential - Urban.

5. Add the following to RSP C-1, Agreements and Forms:

Landlord Service Application Form

6. Substitute the following for "Contracts" in RSP D-2:

Contracts            All applicants or customers requesting Industrial Service with an expected load of 750 kW or more are required to sign a contract. The contract must include the name, signature and title of the applicant's signing officer and the corporate seal if applicable.

7. Substitute "Other Rate Categories" for the expression "Other Classes" in RSP E-1.

8. Under the heading "Other Rate Categories" in RSP E-1 substitute:

All new General Service, Industrial, Street Lighting, Area Lighting, Unmetered and Rental Service customers will pay a deposit before connection or reconnection except:

for:

All new General Service and Industrial Customers will pay a deposit before connection or reconnection except:

9. Under the heading Deposit Amount in RSP E-1 substitute:

The amount of security deposit for all applicants/customers is the greater of two average operating months' estimated billing or \$100.

for:

The amount of security deposit for all applicants/customers is the greater of two operating months' estimated billing or \$50.

10. Under the heading "Deposit Duration and Interest" in RSP E-2 substitute the following:

Residential, General Service and Small Industrial accounts are reviewed periodically and deposits will be refunded as a credit to the account for which the deposit was held if the customer has established a satisfactory payment history. Residential Customer deposits are reviewed twelve months after a deposit is made, General Service and Small Industrial Customer deposits are reviewed thirty-six months after a deposit is made. If a satisfactory payment history has not been established then a security deposit extension may be required. Interest on security deposit extensions is calculated at the prevailing interest rate at the time of the extension.

for:

A residential account will be reviewed twelve months after a deposit has been made and the deposit will be refunded if the customer has established a satisfactory payment history.

General Service and Small Industrial Customer deposits can be held as long as the customer continues operation. However, if the customer has established a satisfactory history with Maritime Electric, the deposit will be refunded after thirty-six months.

11. Delete the following from RSP F-1 under the heading Metering Procedures:

Newly constructed apartment buildings must not combine the services of individual dwelling units on one meter; the supply of energy for common purposes outside the dwelling (i.e., hallways, laundry rooms) is recorded on an additional meter.

12. Delete the following from RSP F-1 under the heading Prorating of Bills:

Maritime Electric will ensure that any billing error is explained to the customer and a correct bill is issued.

Customers will be compensated at the greater of their demonstrated actual borrowing cost or the Bank Prime Lending Rate (based on the weighted average monthly prime rate). Interest is compounded monthly.

15. Under the heading Equalized Billing, Eligibility in RSP G-1, substitute:

Equalized billing is available to:

- Residential Customer;
- Special Care Establishments;
- General Service and Industrial Customers with less than 100 kW of maximum monthly metered demand or, if they have no demand meter, less than 25,000 kWh monthly energy use.

for:

Equalized billing is available to:

- Residential Customers except seasonal;
- Special Care Establishments;
- General Service and Small Industrial Customers with less than 100 kW or maximum monthly metered demand or, if they have no demand meter, less than 25,000 kWh monthly energy use.

16. Under the heading Equalized Billing, Start and Settlement Month in RSP G-2 substitute:

Customers may request and start equalized billing any time during the year. Residential Customers may pay any difference between equalized amounts and actual total charges in any month of their choice. General Service and Industrial Customers must settle in September.

for:

Customers may request and start equalized billing any time during the year. Residential Customers must pay any difference between equalized amounts and actual total charges in any month of their choice from April to September, inclusive. General Service and Industrial Customers must settle in September.

17. Under the heading Equalized Billing in RSP G-2 add the following:

**EC1999-449**

**ROADS ACT  
HIGHWAY ACCESS REGULATIONS  
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 17 August 1999.)

Pursuant to subsection 29(1) of the *Roads Act* R.S.P.E.I. 1988, Cap. R-15, Council made the following regulations:

**1. Section 13 of the Roads Act Highway Access Regulations (EC580/95) is amended**

**(a) by renumbering it as subsection (1); and**

**(b) by the addition of the following subsection:**

(2) All highways or parts thereof described in Schedule "A-4" are designated as arterial Class II highways. Arterial Class II highways

**2. The regulations are amended by the addition of the following:**

PART III.1 - ARTERIAL CLASS II HIGHWAYS

**21.1** (1) This Part applies to arterial Class II highways as described in Schedule "A-4". Applies to arterial Class II highways

(2) Notwithstanding subsection (1), this Part does not apply to any highway or portion thereof that is designated as a limited access arterial highway pursuant to Part IV of these regulations. Not applicable where limited access

**21.2** Where a municipality or the Minister of Community Services and Attorney General gives permission for a change of use of an existing entrance way, for which no entrance way permit has been issued, the existing entrance way or entrance ways to the parcel of land shall be closed and shall not be reopened until an entrance way permit has been issued by the Minister. Change of use requires closure until permit

**21.3** (1) Subject to section 21.4, the Minister may issue an entrance way permit to authorize placement of a new entrance way to a portion of an arterial Class II highway for the purposes of Reasons for permit

- (a) the establishment of a single family dwelling, commercial operation or a home occupation on an existing parcel of land where there is not an existing commercial operation;
- (b) enabling a change of use from one type of commercial operation to another; or
- (c) the creation of not more than one new parcel of land, subdivided from an existing parcel of land for the establishment of a new commercial operation or home occupation.

Conditions for permit

- (2) A permit issued pursuant to subsection (1) may be subject to
- (a) such conditions respecting traffic safety as the Minister may deem necessary; and
  - (b) the recovery by the Minister of the costs associated with the construction or improvement of the access.

Must meet criteria under Part III

**21.4** (1) The Minister may issue an entrance way permit for a portion of an arterial Class II highway if the entrance way meets the criteria for a permit issued pursuant to Part III.

Where access limited to right turn

- (2) Notwithstanding any other provision of this Part, if the entrance way to a commercial operation or a home occupation on an arterial Class II highway
- (a) is on the side of a highway that has more than one lane in the same direction on the same side as the entrance way, the access shall be restricted to a right turn only, for egress and ingress; or
  - (b) is on the side of a highway that has only one lane on the same side as the entrance way, full access may be permitted.

Single family dwelling

- (3) Notwithstanding any other provision of this Part, if an entrance way for single family dwelling use only is on a segment of arterial Class II highway having more than two lanes, full access may be permitted.

**3. Schedule “A-1” of the regulations is amended by the revocation of subsection 1(1) and the substitution of the following:**

- (1) Route 1, the Trans Canada Highway, from the western boundary of the former town of Borden (now part of the community of Borden-Carleton) to the intersection of Route 2 in the City of Charlottetown and from the intersection of Grafton Street in the City of Charlottetown to the intersection of Route 207 in the settlement of Eldon.

**4. The regulations are amended by the insertion of the following Schedule:**

SCHEDULE A-4

CLASS II ARTERIAL HIGHWAYS

**1. The following highways and parts thereof are designated as arterial Class II highways:**

(1) Route 1, the Trans Canada Highway, from the intersection with Route 207 in the settlement of Eldon to the Wood Islands Ferry Terminal.

**5. These regulations come into force on August 28, 1999.**

EXPLANATORY NOTES

These regulations change the classification of a portion of Route 1 and place that portion under a new classification of arterial highway called arterial Class II highways. The amendment enables new single family dwellings and new commercial operations access to properties along an arterial Class II highway.
