(Approved by His Honour the Lieutenant Governor in Council dated 11 January 2000.)

Pursuant to section 16 of the *Agricultural Insurance Act* R.S.P.E.I. 1988, Cap. A-8.2, Council approved the following regulations made by the Board of the Prince Edward Island Agricultural Insurance Corporation:

- 1. The Agricultural Insurance Act Agricultural Disaster Insurance Program Regulations (EC343/96) are revoked.**
- 2. These regulations are deemed to have come into force on January 1, 2000.**

**EXPLANATORY NOTES**

**SECTION 1** revokes the Agricultural Insurance Act Agricultural Disaster Insurance Program Regulations which have become unnecessary in view of recent enhancements to the National Agricultural Income Disaster Assistance Program.

**SECTION 2** provides that the revocation of the Agricultural Insurance Act Agricultural Disaster Insurance Program Regulations is effective as of January 1, 2000.

**EXPLANATORY NOTES**

These regulations exempt prefabricated buildings from the requirement of a building permit prior to their fabrication.
