EC2000-128

ELECTRICAL INSPECTION ACT CANADIAN ELECTRICAL CODE REGULATIONS

(Approved by His Honour the Lieutenant Governor in Council dated 29 February 2000.)

Pursuant to sections 2, 5, and 8 of the *Electrical Inspection Act* R.S.P.E.I. 1988, Cap. E-3, Council made the following regulations:

- 1. Section 1 of the Electrical Inspection Act Canadian Electrical Code Regulations (EC434/95) is amended
 - (a) by the deletion of the words "Seventeenth Edition" and the substitution of the words "Eighteenth Edition";
 - (b) by the deletion of the words "1994" and the substitution of the words "1998".
- 2. Section 2 of the regulations is revoked and the following substituted:
- **2.** For the purposes of these regulations, "Code" means the Eighteenth Edition of the Canadian Electrical Code, Part I, 1998, subject to the amendments, variations, additions, and deletions contained in these regulations.
- 3. The deletion and substitution of clause (a) of the Scope is revoked and the following substituted:

Clause (a) of the Scope is deleted and the following substituted:

- (a) Installations or equipment employed by an electric, a communication, or a community antenna distribution system utility in the exercise of its function as a utility, and that are located
 - (i) outdoors,
 - (ii) in buildings or sections of buildings used for that purpose, or
 - (iii) on public highways, streets, roads, etc.,

except those installations or equipment covered by Part III of these regulations.

4. The deletion and substitution of Rule 2-014 is revoked and the following substituted:

Rule 2-014 is deleted and the following is substituted:

If requested by the Inspection Department, plans and specifications shall be submitted by the owner or his agent for wiring installations as may be prescribed by the inspection department.

5. The amendment to Rule 6-112(2) is revoked and the following substituted:

- (2) The point of attachment of supply or consumer service conductors shall not exceed 9 m above grade or sidewalk, and shall be located such that the clearance of supply conductors at any point above finished grade shall not be less than the following:
 - (a) Across or along public streets, roads or driveways.......5.5 m

 - (c) Across commercial and industrial premises and across and along lanes and entrances thereto.......5.0 m

6. The deletion and substitution of Rule 6-206 is revoked and the following substituted:

(SEE APPENDICES B AND G)

Rule 6-206 Part 1 (e) is deleted and the following substituted:

(e) located at a point within the building so that service conductors not complying with the requirements of Rule 6-208 do not enter the building more than 3 m before terminating in the service over current devices.

The following is inserted as Parts 3 and 4:

- (3) A separate electrical room shall be provided for electrical services where:
 - (a) a building has a service capacity larger than 200 ampere, single or three phase and operating at up to 240 volts;
 - (b) a building has a service capacity is 200 amperes or larger operating at 600 volts or greater, for all services.
 - (4) Electrical rooms required by Part 3 shall
 - (c) be of sufficient size so that there shall be at least 1 metre of clear working space in front of the electrical equipment as required by rule 2-308; and
 - (d) have a fire rating of one hour.

7. The following is added to the regulations:

Sections 68-300 and 68-302 are amended as follows:

The installation of HYDRO MASSAGE bathtubs in residential bathrooms instead of the standard bathtub has become more common during the past few years.

Section 68 of the Code covers the general electric requirements for such installations. However, to clarify the overall requirements more fully, the following are the specific electrical requirements for the wiring of HYDRO MASSAGE bathtubs:

- (1) The pump motor for the HYDRO MASSAGE bathtub is to be supplied by a separate branch circuit to which no other electrical equipment is to be connected.
- (2) The branch circuit supplying the bathtub pump motor is to be protected by a GFCI breaker or other approved devices, a receptacle is not permitted.
 - (3) A disconnect switch is to be installed adjacent to the pump motor.
- (4) The pump motor under the bathtub enclosure must be left accessible for future maintenance, or removal. A hatch or a removable cover in the enclosure is to be provided for this purpose.
- (5) Except for types of controls that are specifically approved and factory assembled on the unit, the electric controls or timer are to be located not less than 1 metre from the hydro massage bathtub or be located behind a barrier.

The following is added as Part 3 of Rule 70-204:

70-204 SUPPORT POLE FOR OVERHEAD SUPPLY SERVICE CONDUCTORS TO MOBILE HOMES

(3) Except by special permission, the maximum distance permitted from the service mast on any mini or mobile home to the nearest supporting pole shall be 15 metres. This is subject to the required ground clearances and adequate mast support being obtained.

SECTION 72 MOBILE HOME AND RECREATIONAL VEHICLE PARKS

The following is added as Rule 72-113

72-113 POSTS FOR RECEPTACLES AND BOXES IN RECREATIONAL VEHICLE AND MOBILE HOME PARKS

It has been noted that in some cases the type of posts used for mounting the receptacles or junction boxes in recreational vehicle or mobile home parks are not of adequate size and are not buried to a sufficient depth to provide for permanent installation. For the installation to be acceptable, the following requirements will apply:

- (1) The posts are to be of the pressure treated type and have a minimum nominal dimension of 4 inches by 4 inches.
- (2) The posts shall be buried to a minimum depth of 3.5 feet in the earth.
- (3) The posts shall be of sufficient height above grade to provide for mounting the receptacles or boxes at a convenient height.
- (4) If the underground conductors supplying the equipment on the posts are of the cable type such as teck cable, they shall be protected from mechanical damage by the use of rigid PVC conduit. The recommended minimum height for the equipment installed on these posts is 2 feet from grade to the bottom of the equipment.
- (5) Electrical and water supply shall be installed on separate posts and be installed at a minimum of 2 feet apart. The requirement for separate posts may be eliminated by using Ground Fault Interrupter devices or breakers.

SECTION 76 - TEMPORARY WIRING

76-014 BRANCH CIRCUITS

Section 76-014 (1) is amended to read:

- (a) type NMWU or NMD is used; and
- 8. These regulations come into force on March 11, 2000.

EXPLANATORY NOTES

These regulations provide for the use of the Eighteenth Edition of the Canadian Electrical Code, Part I, 1998, pursuant to the *Electrical Inspection Act*. The previous Code used was the Seventeenth Edition (1994).

The regulations also provide for necessary amendments and alterations to the Eighteenth Edition of the Code.
