EC2000-155

EMERGENCY 911 ACT REGULATIONS

(Approved by His Honour the Lieutenant Governor in Council dated 7 March 2000.)

Pursuant to section 10 of the *Emergency 911 Act* Stats. P.E.I. 1999, c.23, Council made the following regulations:

1. In these regulations

Definitions

(a) "private road naming authority" means either the municipal or the private road naming provincial government responsible for civic addressing within a jurisdiction.

- 2. (1) Subsection 3(4) of the Act applies to every private roadway which Private roadway provides for common vehicular access to three or more
 - (a) dwellings;
 - (b) improved properties; or
 - (c) properties for which subdivision approval has been granted.
- (2) Where a private roadway passes or runs over several parcels of Naming of private property and title to these parcels is held by different persons, the property owner responsible for naming and signing the private roadway shall be the person who owns the land on which the private roadway meets

- (a) a public road, or
- (b) another private road.
- 3. (1) Every property owner responsible for naming and signing a private Approval of private roadway pursuant to the Act shall first obtain approval for the proposed roadway name from the appropriate private roadway naming authority.

roadway name

(2) Subject to subsection (4), where a private roadway is located within Private roadway a municipality which is responsible for civic addressing pursuant to subsection 3(1) of the Act, the appropriate private roadway naming authority is the municipal government.

within a

(3) Where a private roadway is located outside a municipality Private roadway responsible for civic addressing, the appropriate private roadway naming authority is the Department of Community Services and Attorney General, Planning and Inspections Division.

outside a municipality Final decision

(4) The name of a private roadway approved by a municipal government pursuant to subsection (2) is subject to final approval by the Department of Community Services and Attorney General, Planning and Inspections Division.

Application for approval

(5) The approval required pursuant to subsection (1) shall be obtained by application to the appropriate private roadway naming authority.

Application form

- (6) Every application to a private roadway naming authority shall
 - (a) be made on a form provided by the private roadway naming authority; and
 - (b) contain three proposed names for the private roadway.

Decision

4. (1) The private road naming authority shall inform the property owner in writing of its decision regarding the application to name a private roadway name and the reasons for the decision.

Identification by approved name

(2) Where approval of a private roadway name has been provided by a private roadway naming authority, the private roadway shall thereafter be identified by the approved name.

Re-naming

(3) A property owner responsible for naming and signing a private roadway pursuant to the Act may apply to the appropriate private roadway naming authority to have the name of a private roadway changed.

Process for renaming (4) Where a property owner required to name and sign a private roadway pursuant to the Act makes an application pursuant to subsection (3), the provisions of section 3 and subsections (1) and (2) apply.

"Private" designation **5.** Every approved private roadway name or sign designation shall include the word "private".

Signage requirements

6. Every approved private roadway shall be signed by the property owner in a manner which conforms to the prescribed standards for signing contained in Schedule A of these regulations.

Prohibition

7. No person shall erect a private roadway sign or display a private roadway name without first obtaining approval for the name from the appropriate private roadway naming authority.

SCHEDULE A

SIGN DESIGN & PLACEMENT

1. WOOD

Physical properties for <u>WOODEN</u> sign panel, lettering, and post shall be as follows:

- (a) panel material shall be a minimum 5/8" thick exterior GIS plywood;
- (b) panel size shall be 8" high x (overall length varies # of characters) and have a minimum length of 24";
- (c) panel preparation shall be an oil-based primer* (1coat), covering all edges & both sides;
- (d) panel finish shall be an oil-based finish** (2 coats) covering all edges & both sides;
- (e) lettering (including road name & suffix) shall be 3" upper-case / 2.5" lowercase, reflective, engineer-grade 3M (or equivalent sheeting):
- (f) the word "Private" shall be 1.5" upper-case engineer-grade 3M (or equivalent) sheeting, highway style "C", WHITE;
- (g) the post to which a panel is affixed shall be 4" x 4" pressure-treated wood (or suitable equivalent material), painted WHITE.

*Primer: CIL Exterior, Oil Base # 9421 (or equivalent quality)

**Finish: CIL Exterior, Oil Base # 19426 (or equivalent quality and colour)

CH CHURCHILL RD PRIVÉ / PRIVATE Standards for **WOODEN** sign display shall be as follows:

- (a) the road name presentation may be bilingual if so requested, however the format must comply with Diagram 1 above;
- (b) where applicable, the sign plates shall be placed on opposite sides of the post so as to be visible from vehicles approaching the road from either direction;
- (c) the sign post and sign shall be placed on the right side of the private roadway as a vehicle approaches the road of higher importance;
- (d) the sign post shall be placed at the right-of-way of the public road as it intersects with the private road;
- (e) sign posts shall be not less than 10 feet and not more than 12 feet from the edge of the private road;
- (f) the height of the sign, relative to the centerline grade of the public road (or the respective road of greater importance as determined by the private road naming authority), shall be a minimum of 8 feet above grade and a maximum of 10 feet above grade;
- (g) the complete word 'PRIVATE', in upper-case character, shall be below the road name to indicate the road is private and not public;
- (h) road signage material shall not be affixed to any material other than a material prescribed by these regulations.

2. METAL

Physical properties for <u>METAL</u> sign panel, lettering, and post shall be as follows:

- (a) panel material shall be a substrate material of 1/4" aluminium flatbar 6061-T6 with minimum yield strength of 37,500 psi;
- (b) panel size shall be 8" high x (overall length varies # of characters) and have a minimum length of 24";
- (c) panel preparation shall include degreasing and etching to promote adhesion of reflective materials;
- (d) panel finish shall be Level II GREEN engineer grade reflective sheeting ("Scotchlite" #3275) colour CIL # 19426;
- (e) road name and suffix shall have a character size of 3" upper-case / 2.5" lowercase;
- (f) the complete word "PRIVATE" shall be in 1.5" upper-case;
- (g) lettering shall be Level II SILVER engineer-grade reflective sheeting ("Scotchlite" #3260) colour WHITE;
- (h) the post shall be 4" x 4" pressure-treated wood (or suitable equivalent material), painted WHITE;
- (i) the attachment clip shall be an aluminium angle bracket, attached to bottom centre of the panel and predrilled for attachment to the top of the post.

The standards for <u>METAL</u> sign presentation shall be as follows:

- (c) sign posts and signs shall be placed on the right side of the private roadway as a vehicle approaches the public road;
- (d) sign posts shall be placed at the right-of-way of the public road as it intersects with the private road;
- (e) sign posts shall not be less than 10 feet and not more than 12 feet from the edge of the travelled portion of the private road;
- (f) the height of the sign, relative to the centerline grade of the public road (or the respective road of greater importance as determined by the private road naming authority) shall be a minimum of 8 feet above grade and a maximum of 10 feet above grade;
- (g) the complete word "PRIVATE", in upper-case character, shall be below the road name to indicate the road is private and not public;
- (h) road signage material shall not be affixed to any material other than a material prescribed by these regulations.
- **8.** These regulations come into force on March 18, 2000.

EXPLANATORY NOTES

These regulations provide for the naming and signing of private roadways for the purposes of the *Emergency 911 Act*. Specifically:

Section 1 defines a term used in the regulations.

Section 2 specifies the categories of private roadway that that must be named and signed.

Section 3 sets out the process for the approval of the name of a private roadway.

Section 4 provides for the use of an approved private roadway name and for the re-naming of a private roadway.

Section 5 requires the word "private" be included on every sign designating a private roadway.

Section 6 requires the property owner responsible for placing a sign designating a private roadway to ensure the sign conforms to the standards prescribed in Schedule A of the regulations.

Section 7 prohibits erection of a sign designating a private roadway without approval for the name of the private roadway.

Schedule A prescribes the standards required for signs designating private roadways.

Section 8 provides for the coming into force of these regulations.

HEALTH AND COMMUNITY SERVICES ACT REGIONAL AUTHORITIES REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 7 March 2000.)

Pursuant to sections 19 and 43 of the *Health and Community Services Act* R.S.P.E.I. 1988, Cap. H-1.1, Council made the following regulations:

1. Subsection 4(3) of the Health and Community Services Act Regulations (EC598/99) is revoked and the following substituted:

Exception

(3) Notwithstanding clauses (2)(b) and (d), where a vacancy exists in an appointed position on a board and the Minister receives a request from the board advising the Minister that there has been a formal motion of the board, approved by a majority of board members, that a physician be appointed to the board

- (a) the Minister shall notify the Lieutenant Governor in Council of the board's request; and
- (b) the Lieutenant Governor in Council may appoint a physician to the board.

2. These regulations come into force on July 1, 2000.

EXPLANATORY NOTES

The revocation and substitution of subsection (3) permits the Lieutenant Governor in Council to appoint a physician to a board where the board has a vacancy in an appointed position and the board has advised the Minister of Health and Social Services that a formal motion has been approved by the board requesting the appointment of a physician to the vacant position.

HIGHWAY TRAFFIC ACT ADMINISTRATIVE DRIVING PROHIBITION AND VEHICLE IMPOUNDMENT REGULATIONS

(Approved by His Honour the Lieutenant Governor in Council dated 7 March 2000.)

Pursuant to section 312 of the *Highway Traffic Act* R.S.P.E.I. 1988, Cap. H-5, Council made the following regulations:

1. The notice of impoundment prescribed by section 255.3 of the Notice of *Highway Traffic Act* R.S.P.E.I. 1988, Cap. H-5 shall contain the impoundment information set out in Schedule 1.

2. The statutory declarations prescribed by subsection 255.1(4) and statutory declaration clause 255.4(6)(b) of the *Highway Traffic Act* shall be in the form set out in Schedule 2 and Schedule 3 respectively.

3. The notice of driving prohibition prescribed by subsection 277.2 of the *Highway Traffic Act* shall contain the information set out in Schedule 4.

4. The statutory declaration prescribed by subsection 277.5(1)(c) of the Statutory declaration *Highway Traffic Act* shall be in the form set out in Schedule 5.

5. The certificate of service prescribed by subsection 277.4(c) of the Certificate of service *Highway Traffic Act* shall be in the form set out in Schedule 6.

Report of peace officer

6. The reports of the peace officer prescribed by clause 255.3(1)(c) and clause 277.4(d) of the *Highway Traffic Act* shall be in the form set out in Schedule 7 and Schedule 8 respectively.

Revocation

7. The Highway Traffic Act Administrative Driving Prohibition Regulations (EC349/98) are revoked.

Commencement

8. These regulations come into force on March 18, 2000.

If a motor vehicle impounded under section 255.1 of the *Highway Traffic Act* remains impounded for at least 90 days after the expiration of the impoundment period, the person who has custody of the motor vehicle shall not dispose of the motor vehicle by sale or otherwise without the approval of the Registrar.

The Registrar will require the Lienholder of the impounded motor vehicle to

- 1. Surrender to the Registrar any number plate, issued under the ${\it Highway\ Traffic\ Act}$, from the motor vehicle.
- 2. File with the Registrar the above statutory declaration.

HIGHWAY TRAFFIC ACT FEES REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 7 March 2000.)

Pursuant to section 65 of the *Highway Traffic Act* R.S.P.E.I. 1988, Cap. H-5, Council made the following regulations:

1. The Highway Traffic Act Fees Regulations (EC309/93) are amended by the addition of the following:

- **12.** (1) Subject to subsection (2), the prescribed fee for a review
- Prohibition and
- (a) of an impoundment pursuant to section 255.5, 255.8, or 255.9 of impoundment fees the Act; or
- (b) of a driving prohibition pursuant to section 277.5 of the Act, is \$50.
- (2) Where the person applying for a review requests an oral hearing, Fee, oral hearing the prescribed fee shall be
 - (a) the \$50 fee payable pursuant to subsection (1); and
- (b) an additional \$50,

for a total fee of \$100.

- (3) The prescribed fee for the release of a vehicle pursuant to Fee, release subsection 255.9(4) of the Act is \$50.
- 2. These regulations come into force on March 18, 2000.

EXPLANATORY NOTES

These amendments prescribe fees under the Highway Traffic Act with regard to administrative driving prohibition and impoundment of vehicles, oral hearings, and vehicle release.

PLANNING ACT REGULATIONS AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 7 March 2000.)

Pursuant to section 8 of the *Planning Act* R.S.P.E.I. 1988, Cap. P-8, Council made the following regulations:

1. The Planning Act Regulations (EC601/77) are amended by the addition of the following: $\frac{1}{2}$

Exception

- **38.1** Notwithstanding clause 38(d), the Minister may approve one additional lot that does not have frontage on a public road adjacent to an approved lot that does not have frontage on a public road where
 - (a) the additional lot is intended to contain a commercial or industrial development already in existence on the property being subdivided; and
 - (b) establishment of the additional lot is essential for financial reasons.
- 2. These regulations come into force on March 7, 2000.

EXPLANATORY NOTE

This regulation permits approval by the Minister of one additional lot without frontage on a public road adjacent to one existing similar

approved lot, where the additional lot is intended to contain an existing commercial or industrial development, and is essential for financial reasons.

PLANT HEALTH ACT POTATOES REGULATIONS **AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated 7 March 2000.)

Pursuant to section 6 of the *Plant Health Act* R.S.P.E.I. 1988, Cap. P-9.1 Council made the following regulations:

1. Subsection 6.1(1) of the Plant Health Act Potatoes Regulations (EC138/95) is revoked and the following substituted:

- **6.1** (1) Every person growing more than 0.1 hectares of potatoes shall, Application and no later that June 30 in the year of planting,
 - registration

- (a) make application to the Institute; and
- (b) be registered with the Institute,

as a potato grower, potato breeder, or potato evaluator.

(1.1) Every person who applies to be registered pursuant to subsection Provision of (1) shall provide the Institute with the information required pursuant to subsection (2) in a form acceptable to the Institute.

2. Section 11 of the regulations is amended

- (a) in subsection (1), by the deletion of the words "and verified by Agriculture and Agri-Food Canada";
- (b) by the addition of the following:
- (3.1) Subject to subsection (1) and notwithstanding subsection (2), any Exception person may, in the 2000 planting season only, plant certified class seed potatoes of the Russet Burbank variety where
 - (a) the seed potatoes are the progeny of Pre-Elite class seed potatoes planted in the 1995 or any subsequent planting season; and
 - (b) the sum of the post-harvest test of the seed potatoes required by section 14 does not exceed the level of 10%.

3. Section 14 of the regulations is amended

- (a) by the revocation of subsection (2.1);
- (b) in subsection (2.2), by the deletion of
 - (i) the words "in 2000", and
 - (ii) the words "to be" where they first occur;
- (c) in subsection (2.3), by the deletion of the word "2000" and the insertion of the word "2001".
- 4. These regulations come into force on March 18, 2000.

EXPLANATORY NOTES

SECTION 1 amends section 6.1 of the regulations to clarify the method of application to the Institute by potato growers, breeders, and evaluators.

SECTION 2 removes a reference in subsection 11(1) to Agriculture and Agri-Food Canada, and permits the planting of certified seed potatoes of the Russet Burbank variety subject to the conditions established by subsection (3.1).

SECTION 3 amends section 14 of the regulations to remove virus level restrictions on potatoes planted for non-seed purposes in 2000. The virus level restrictions will be reinstated in 2001. The section also makes some housekeeping amendments.
